# Jotings from Sokol and Slovak life

### Father George A. Torok, C.O. to be honored on Sunday, June 26

Our well-known and highly respected spiritual leader, cultural promoter and media specialist, the Very Rev. George A. Torok, C.O. will be honored on Sun-



day, June 26 at Hallel Communications Center in Sparkill, N.Y. He will be feted on the occasion of his 53rd anniversary of priestly ordination and 80th birthday. He will be principal celebrant of a Mass of Thanksgiving at 1:30 p.m. followed by a reception and luncheon given in his honor. Father George is our long-time Sokol of Assembly 182 in New York City and is a

past chaplain of Group 1 "Msgr. Stephen Krasula." Father George is the founder and current Provost(superior) of the New York Congregation of the Oratory of St. Philip Neri located in Old Tappan, N.Y. which he established in 2007.

A native of Slovakia, Father George was born in Zilina in 1931. He decided on the priesthood and entered the Salesians. He was a seminarian at the time when in 1950, the communist government of Czechoslovakia decided to suppress all religious houses. He was imprisoned with other seminarians and priests and interned in a labor camp. He was able to escape to Austria and fortunate enough to make his way to Rome. He completed his theological studies there and was ordained a Salesian priest in 1958. Because of his interest in drama and the media, he pursued studies in Italy which led to his becoming a professional filmmaker. Upon his arrival in the United States, where he initially served at St. John Nepomucene Parish in New York City, he continued his film endeavors. Over the years, he has made many religious and historical films, many of which have been acclaimed for their promotion of justice and peace themes. Many have been screened on PBS. In recent years, he established a studio which he named Hallel which means praise in ancient Aramaic. The studio is located on the grounds of the Motherhouse of the Dominican Sisters in Sparkhill.

Our congratulations and fraternal best wishes go out to Father George on this milestone in his very fruitful priestly ministry among us. May God continue to bless him with good health and happiness as he so beautifully mirrors our Cyrilo-Methodian heritage of faith. Ad multos annos and Zdar Boh!

Sokol USA had its beginnings in Chicago in 1896 when a group of Slovak immigrants gathered to establish the first Slovak Sokol organization in the United States. The Slovak Gymnastic Union Sokol promoted the traditional activities associated with the Sokol movement in a number of American cities. The Sokol movement came to the United States with the early Czech immigrants. A group of Czechs founded the first Sokol organization in St. Louis, Mo. in 1865. In subsequent years, additional Sokol organizations were founded among the various Slavic immigrant groups in both the United States and Canada. Our own Slovak Catholic Sokol, founded in 1905, was the last of the Sokol organizations to be established in the United States. Our congratulations and fraternal best wishes go out to Sokol USA President Joseph S. Bielecki, Supreme Secretary Milan Kovac, as well as Sokolfest Chairperson Bea Walko on the occasion of the 115th anniversary of the founding of their organization. May our both organizations continue to promote the high ideals of the Sokol movement in the years ahead. Zdar Boh!

### Thoughts from our Supreme Chaplain

### May: Month of the Blessed Virgin Mary

The Catholic practice of assigning a special devotion to each month goes back to the early 16th century. Since the best known of those devotions is probably the dedication of the month of May to the Blessed Virgin Mary, it



month of May to the Blessed Virgin Mary, it might come as a surprise that it wasn't until the late 18th century that this devotion arose among Jesuits in Rome. In the early years of the 19th century, it quickly spread throughout the Western Church, and, by the time of Pope Pius IX's declaration of the dogma of the Immaculate Conception in 1854, the devotion had become universal. May crowning and other special May events in honor of Mary, such as public recitation of the Rosary, stem from this time. Sadly, such com-

munal events are more rare today, but we can take the month of May as an opportunity to renew our own devotion to the Mother of God by dusting off our rosaries and adding a few more Marian prayers to our daily routine. Parents, in particular, should encourage Marian devotion in their children, since their encounters with non-Catholic Christianity today often downplay(if not denigrate) the role that the Blessed Virgin Mary played in our salvation through her fiat - her joyous "Yes" to the will of God.

Thou art my Mother, O Virgin Mary: keep me safe lest I ever offend thy dear Son, and obtain for me the grace to please Him always and in all things. Amen.

### Resolution of Assembly 261 of Reading, Pennsylvania On the Occasion of the Centennial of Our Official Publication

Addressed to Editor Daniel F. Tanzone and Slovak Catholic Sokol members,

Let it be known that another milestone in the rich history of the Slovak Catholic Sokol has been achieved recently. ### Jobless rate dropped slightly to 13.3 percent in March

The unemployment rate reached 13.13 percent in March, a decline of 0.03 percentage points on the month but representing an annual rise of 0.25 percentage points, the Labor, Social Affairs and the Family Center(UPSVaR) announced on April 20.

"This constitutes a reversal, a change in trend," said UPS-VaR head Ivan Juras in response to the March figures. The labor market is going through a revival, as the number of available vacancies rose.

A total of 392,483 people were registered at labor offices in February, of which 350,328 were immediately available to begin work.

The average unemployed person had been registered at a labor office for 13.81 months, down 0.04 months, month-on-month, but up 0.87 months, year-on-year.

### Government approves agreement between Slovakia and Hungary on R4

The Slovak government on April 20 approved a bilateral agreement between Slovakia and Hungary on the placement of the cross-border point of the R4 express road linking Kosice and Miskolc(Hungary).

"The aim of the agreement is to create a legal framework for construction of the linking of the R4 express road. The regulations include the site of the interconnection of the roads between the border signs, proceedings in the case of investment preparations, validity of the agreement, as well as the way of its termination," reads material submitted by the Transport Ministry and released on April 20.

The Slovak section should be financed from the EU Structural Funds and co-financed from the state budget.

### Gasoline prices in Slovakia are the highest in the region

Gasoline prices in Slovakia are the highest in the whole Visegrad Four region(Slovakia, the Czech Republic, Poland and Hungary) plus Austria, the natankuk.sk website reported on April 21. At present, the cost is nearly \$7.00 a gallon.

The prices of gasoline are under the most heavy burden of taxes and further fees in Slovakia compared to the aforementioned countries. When it comes to diesel, however, the tax burden on diesel is the second lowest among the countries, behind Poland. (The government last year significantly reduced the tax burden on diesel, following road hauliers' protests after the electronic rolls for lorries were introduced. - ed. note.)

At the same time, the price of gasoline is 8.3 cents per liter lower than the EU average, while the diesel price is 4.6 cents below the EU average.

### SACR: "Slovakia" brand suffers from low recognition

Slovakia as a brand still suffers from poor recognition due to the change of the country's position from a European perspective in the wake of the collapse of the Eastern bloc and the transformation to democracy plus the break-up of Czechoslovakia, reads the marketing strategy drafted by the Slovak Tourism Agency (SACR) that was released on April 21.

"The primary reason behind the lack of recognition of Slovakia brand is also a long-term absence of a systematic and coordinated presentation of the country," reads he material. It adds that recognizability represents one of the key factors influencing the tourism competitiveness of a country.

The process of building the brand "Slovakia" should be coordinated with all relevant subjects including the Foreign Affairs Ministry, its diplomatic representations in foreign countries or the Economy Ministry via the promotion of pro-investment and proexport policies. Also, an important role should be played by the Culture Ministry in promoting cultural values abroad.

### Government okays national reforms aimed at boosting economy

The Slovak government at its session on April 20 approved Slovakia's ongoing National Program of Reforms due to remain in practice until the middle of 2014, TASR learned on the same day.

The document introduces a package of measures targeting revival of the Slovak economy and improving the standards of life. Gradual compliance with the objectives set forth in Europe 2020 is also addressed.

The goals include boosting the unemployment rate of people aged 20-64 above 72 percent while curtailing the long-term jobless rate below 3 percent.

The government also has its eyes on improving business conditions to a level that will position the country among the top 15 countries in the World Bank's 'Doing Business' ranking by 2020.

In addition, the program also addresses vows such as surpassing the occurrence of corruption and favoritism practices.

Meanwhile, a total of 170,000 people ought to be extricated from the risk of poverty by 2020, according to the document.

### Reservations expressed by Slovak leaders regarding Hungarian Constitution

The spirit of the new Hungarian Constitution and some of its provisions indicate that Slovakia's southern neighbor has become fixated on its own national affairs and isn't interested in the reservations and concerns expressed about the extension of Hungarian law to the territory of neighboring states, said Slovak President Ivan Gasparovic at a conference on foreign affairs in Bratislava on April 28.

According to Gasparovic, such moves are leading Hungary in a different direction from the one Slovakia hoped to see a year ago. Slovakia, along with other foreign partners, is trying to find out why Hungary is so doggedly pushing its conception of the collective rights of national minorities, which isn't in line with the character of European legislation, he added.

"Europe said a long time ago that a citizen has to be free. When a citizen is free, we don't need to speak about collective rights. Why such an impassioned return to history, which has been changed by the results of the two biggest wars in the history of mankind? Why such an attempt to export Hungarian internal affairs to the territory of neighboring states?" asked Gasparovic.

According to him, historical experience teaches Slovaks not to view such issues as isolated from the historical and political context. He recalled his attendance at the same conference a year ago - the day after the parliamentary elections in Hungary.

"A political dialogue between Slovakia and Hungary has continued, the situation has calmed down slightly, bilateral cooperation continues, but none of the problematic issues has been resolved. Only the publishing of exchanges of opinion has been reduced," said Gasparovic.

Slovak Prime Minister Iveta Radicova(SDKU-DS) praised bilateral business cooperation, but expressed concern over the pillars of democracy. "We're watching the moves made by the Hungarian government with concern, whether these deal with Hungarian citizenship or the constitution," she said.

#### Mihal: We want to close gap between Austrian and Slovak salaries

Having the labor markets in Austria and Germany open to Slovaks is good news; however, it also increases the risk of brain drain, which would represent a huge loss for Slovakia, Labor Minister Jozef Mihal(Freedom and Solidarity/SaS) said on April 27

"Bolting for greener pastures is understandable, but we won't resign ourselves to it," said Mihal. "It's truly sad to see young graduates winding up either unemployed or leaving to get a job in Austria or Germany, where they can command much higher salaries...and then, they stay there, never to return. This is a huge loss for Slovakia, which funded their education from taxpayers' money."

Mihal stressed that the government's ambition is to decrease the gap between Slovak and Austrian salaries. "We hope that one day, Austrian salaries cease to be so tempting."

Mihal doesn't expect to see a huge migration from Slovakia after the markets open. "This is about liberalization of the labor market and cancellation of administrative barriers. Those who wanted to leave for higher-paying jobs have already done so," he reckons.

The average salary in Austria is approximately double that of Slovakia.

### Miskov: New investors will come to the Presov region thanks to Honeywell

Two new investors may come to the Presov region of Eastern Slovakia, said the Economy Minister Juraj Miskov(Freedom and Solidarity/SaS) at the HN Club on April 29.

"Based on the decision of the United States investor, Honeywell(to open an assembly plant in Slovakia), two other companies want to come to the same industrial park(1ZPZaborske)," said Miskov, refusing to reveal any further details about the two companies.

Honeywell wants to build a new assembly plant to produce turbochargers in Presov, and plans to create about 446 new jobs in the process. The overall investment should reach \$50 million. The government approved investment support reaching \$24 million for the company.

Miskov views the investment support as the right step. We've attracted the first important investor to the Presov region," said Miskov. "The return won't only come in the form of levies, but also via the development of the region, with such high(18.6 percent in 2010 - ed. note) unemployment," said Miskov.

### SACR releases new promotional film during hockey championship

The Slovak Tourism Agency(SACR) featured a new film promoting Slovakia on the mumbotrons at the Orange Arena in Bratislava and the Ladislav Trojak Arena in Kosice during the Ice-Hockey World Championship which began Friday, April 29, SACR general director Peter Belinsky announced on the same day.

The film should draw the fans into the vibrant centers of the two host cities, according to Belinsky. "We're going to show Slovakia as a really attractive tourist destination that offers many opportunities for active vacationing and relaxing in the unique environment of Slovak nature and a host of enchanting and picturesque towns and villages," said Belinsky.

The film featured shots of the spa in Rajecke Teplice(Zilina region of western Slovakia), the excellent golf course in Tale(Banska Bystrica region of central Slovakia) as well as river rafting in Liptov(also in the Zilina region). The beauties of Slovak nature dynamically alternate with views of castles steeped in history," said SACR's PR manager, Zuzana Nemcova.

### Expert: Danger of terrorist attacks in Slovakia remains after Bin Laden

The danger of Slovakia becoming a target of a terrorist attack hasn't been removed with the death of al-Quaeda chief Osama Bin Laden, said security expert Milan Zitny on May 3.

"Slovakia is in the same danger as before. The country is on the list of terrorists' targets due to our participation in Afghanistan," said Zitny.

"I know about the case of a Slovak citizen who converted to Islam. Islamist terrorists started trying to win him over in order to carry out their terrorist attacks in Slovakia, the Czech Republic and Poland," said Zitny, adding that the Slovak citizen in question worked in Germany for a long time. The terrorists wanted him to undergo training at a terrorist camp in Sweden, but he told this to the police. He has now gone into hiding.

Zitny stressed that this example only shows that Slovakia is vulnerable to a real terrorist threat. "We don't know whether the terrorists have found a replacement for this Slovak citizen. We're not prepared enough for attacks," he added.

### Czech and Slovak Cabinets to hold joint sessions on important issues

The governments of the Czech Republic and Slovakia will hold joint sessions to deal with selected bilateral issues and agendas of their common interest, Slovak Premier Iveta Radicova and her Czech counterpart Petr Necas agreed in Prague, where Radicova left for a working trip on May 5.

The first such meeting is expected to take place in Slovakia in the autumn. "We're preparing a new element in Czech-Slovak relations," commented Necas after meeting Radicova in Hrzansky Palace. "We have agreed on the date as well - October 28,"

added Radicova

(October 28 represents an important milestone in the history of both countries - it was on that day back in 1918 that the first Czechoslovak Republic was established. - editor's note).

According to Necas, the joint agendas could include that of dual citizenship, as well as important environmental, energy and military issues.

Continuing in her Prague program, Radicova also attended a conference devoted to the 60th anniversary of the American radio network Radio Free Europe which began broadcasting from Prague

### Miklos: budget is in line with expectations with updates in July

Slovakia's state budget and public finance as such were progressing in line with the Finance Ministry's expectations over the first four months of this year, with the deficit shrinking by one-third in annual terms, Finance Minister Ivan Miklos annunced at a press conference on May 10.

Nevertheless, some structural aspects of the budget have shown several features that will have an impact on further budgetary developments - some positive and some negative, noted Miklos.

Due to this, the ministry plans to present the government with an updated budget prognosis for 2011 before the end of July, said Miklos.

Compared to the budget setting as approved last year, the recently-adopted plan to revitalize the state-owned railway companies is now expected to have the most negative impact on the budget - with the costs climbing up to nearly \$285 million, said Miklos. He added that healthcare and environment agendas are also likely to swallow up some extra resources.

The minister went on to say that there are several positive budget features to counterbalance the negatives. The positives have been calculated to bring in an additional \$338 million into the budget, and the ministry is also envisaging higher tax revenues than was originally planned. However, Miklos said they have been unable to quantify the extent of the added revenues for the moment.

### Wreath-laying ceremony at Slavin marks day of victory over fascism

A wreath-laying ceremony took place on May 9th at the Slavin monument in Bratislava to mark the 66th anniversary of the victory over fascism and the end of World War II in Europe.

The ceremony, dedicated to the 7,000 Soviet soldiers who were killed during the liberation of Bratislava and were buried at Slavin, was attended by Deputy Premier Rudolf Chmel, Defense Minister Lubomir Galko, as well as officials from the Russian Embassy in Bratislava, other diplomats based in Slovakia and war veterans.

Minister Galko in his address at the ceremony, said that the events surrounding the liberation of Bratislava in 1945 are a milestone in Slovakia's history.

"The war claimed a disastrous 60 million lives. Despite the fact that the end of the war meant the defeat of fascism, our country wasn't really liberated, with the following decades of Communism leaving a scar on the fate of this country and its citizens. Despite the totalitarian regime, we managed to win freedom and democracy in November 1989. The horrors caused by totalitarian regimes must remind us of the fact that peace and freedom shouldn't necessarily be taken for granted." said Galko.

### Slovak museums and galleries have special Saturday offer

Museums and art galleries in Slovakia promised special experiences for Saturday, May 14, when they prepared a special program for visitors of all ages beginning at 10 a.m. and concluding at midnight. Visitors enjoyed access to otherwise off-limit areas, while benefiting from the reduced admission for

"This was a European project that has already become a tradition in Slovakia. It's an interesting offer also for regular museum visitors, as everything looks different at night," Culture Minister Daniel Rrajcer said at a press conference on May 10.

### Lunik IX protest fizzles out, meets with negative reactions

The Roma protest at the Lunik IX borough, a section of Kosice, organized by the Roma(gypsy) Parliament(an assem-

bly incorporating some 160 Roma organizations - ed. note) chairman Ladislav Fizik, has turned out to be a bit of a fiasco, with only about 50 curious children showing up at the agreed time in front of the local municipal hall.

After repeated calls, some adult inhabitants of Lunik IX appeared too, but they were attracted by the presence of journalists more than by any discussion. According to their answers, many had no idea there was supposed to be a protest nor what they would be protesting against.

Lunik IX mayor Dionys Slepcik informed journalists that the greatest problem for the neighbor hood is the reduction in the per-capita contribution from income taxes paid by the state which has led to an untenable financial situation.

However, this statement was sharply rejected by Kosice's Vice Mayor Renata Lanartova, who implied that the city of Kosice plans major changes in its approach towards Lunik IX. "We want to change this long-term problem, where decent inhabitants of Kosice have been discriminated against by the unadaptable Lunik IX inhabitants. This borough or section of the city has been given \$40.00 per person from the income taxes, while other sections of the city have received benefits totalling only \$27.00," she said.

Kosice municipal administrators have announced that nobody will stand above the law - not even Lunik IX. "And this tenet will be thoroughly implemented in order to put an end to this state of affairs, in which all citizens of Kosice suffer as a result of the notorious borough Lunik IX," said Lenartova.

Some discussion followed as to bringing all Slet participants to the sports complex whether they are in gymnastics or not. The facility is large enough to have a volleyball and or basketball tournament at the same time as the gymnastic competition. The facility also has an area for kids to play in with bounce houses and jungle gyms. Paramount Sports Complex will get back to us with prices for renting the facility and Brothers Dorich, Moeller and Manyak along with Sisters Blosser and Laury will determine if this is feasible depending on pricing. Brother Manyak has secured buses for travel to the gym facility.

The track and field competition will use the automatic timing supplied by the university. The Kutztown track coach will run the timers and use his track students to assist in the timing and field events. An attempt will be made to award the track medals directly after the finish of each event including the field events. The men's shot put will be changed to a 12-pound shot for all competitors ages 16 and older. New elimination distance for the shot will follow. Brother Moeller will look into hiring the athletic trainer at the university to help with injuries at the track. Water will be supplied at the track for the competition. Sister Blosser asked for donations from the "Water Guy" distributor for free water for the competition but was denied. Brother Tom Cengeri from Group 12 is looking into this company or another company to help donate some or all of the water needed this year.

Brother Dorich and Sister Blosser are seeking volunteers to help with judging the drill competition. The Dance Group will again be the outside judges for the competition and will supply four judges as in the past. The inside judges have not been finalized as the SPFB is searching for judges who have not judged in the past, giving a new insight to the competi-

The closing ceremonies will be held a little earlier, time wise, than in the past to allow for a more formal dance following the closing of the competition. It has been recommended by many Groups that a more formal dress code be employed at the closing dance and this will be done this year. The dress for the dance is business casual. Nice shirts and shorts or pants for the boys as well as skirts or summer dresses for the girls.

Under Old Business, members of the Supreme Physical Fitness Board were reminded that their four-year activity reports were due at the Home Office by May 11, 2011 in anticipation of the 31st Quadrennial Convention scheduled for Pittsburgh, July 30 - August

Under New Business, Brother Moeller informed the Board about working with other Slovak fraternal organizations in hosting joint sporting events. It was noted that not all of the fraternals have bowling, golf, basketball, volleyball or softball tournaments, so we are looking to combine with other fraternal groups to form one tournament. Currently, we are looking at both a joint bowling and golf tournament in 2012. Sister Blosser will organize bringing drillers to perform at the 31st Quadrennial National Convention in Pittsburgh.

Supreme President Larry M. Glugosh then thanked Brother James Matlon for all his efforts in helping to make the annual review of fraternal activities issue for 2010 a success. Brother Glugosh also thanked the members of the Supreme Physical Fitness Board for their positive increase in members over the last few months. Our organization is on an upswing for the first time in many years. With the help of Facebook, more members are finding each other and staying in touch as well as when other friends read Facebook postings they are asking questions about the Slovak Catholic Sokol. What a great way to bring

Following a two and a half hour meeting session of updates and positive discussion, Sister Blosser moved to adjourn the meeting, seconded by Brother Suess. The meeting was adjourned by Brother Edward Moeller at 4:30 p.m. Zdar Boh!





### Radičová chce od Putina pozývací list z roku 1968

Rusko by malo Slovensku vrátiť pozývací list, na ktorého základe vojská Varšavskej zmluvy v roku 1968 okupovali Československo. 12. mája oň požiadala premiérka Iveta Radičová, ktorá v Bratislave prijala ruského predsedu vlády Vladimira Putina.

"Vyslovil ochotu, pokiaľ takéto dokumenty v Moskve existujú, dať ich k dispozícii," povedala po stretnutí Radičová.

Aj pre chýbajúci list na Slovensku doposiaľ nebol nik odsúdený za okupáciu. Vyšetrovatelia nedávno prerušili trestné stíhanie vplyvného komunistického funkcionára Vasiľa Bilaka. Jedným z dôvodov bolo, že Slovensko nemá originál pozývacieho listu, z ktorého by sa dalo určiť, či ho Bilak podpísal. Rusko v minulosti odmietlo dokument sprístupniť s tým, že ide o historickú pamiatku.

Putin podľa Radičovej sľúbil, že sa nezopakuje plynová kríza z roku 2009. Pre spory s Ukrajinou Rusi vtedy dva týždne nedodávali plyn Slovensku a ďalším európskym štátom.

Okrem stretnutia s Radičovou a prezidentom Ivanom Gašparovičom sa Putin v Bratislave zúčastnil na kongrese hokejovej federácie, ktorý rozhodol, že Moskva v roku 2016 usporiada majstrovstvá sveta v hokeji.

# Mesto Martin získalo cenu OSN za boj proti korupcii



Organizácia spojených národov (OSN) zverejnila zoznam víťazov a finalistov najprestížnejšieho medzinárodného uznania za verejnú službu. Mesto Martin získalo prvé miesto v kategórii Prevencia a boj proti korupcii.

Mesto túto prestížnu cenu získalo ako vôbec prvé v rámci Slovenska za projekt Transparentné mesto. Súťažilo v konkurencii množstva projektov v regióne Európa a Severná Amerika, v ktorých sa nachádzajú krajiny s najvyspelejšou demokraciou. V minulom roku ich bolo okolo 210 z vyše štyridsiatich krajín.

Mesto Martin začalo projekt Transparentné mesto rozvíjať v roku 2008.

Projektu predchádzal audit, ktorý pre mesto robilo Transparency International Slovensko. Spoločne s vedením mesta vytipovali 17 oblastí života a riadenia mesta, ktoré dnes už podliehajú princípom transparentnosti. Nie je to len oblasť elektronických aukcií, ktoré sa dajú vyhodnotiť jednoznačnými úsporami, ale ai vytvorenie možností, prostredníctvom ktorých obyvatelia mesta môžu, ak chcú, kontrolovať samosprávu, navrhovať zmeny a byť informovaní o všetkom, čo sa na úrade, v zastupiteľskom zbore či v spoločnostiach zriadených mestom deje. Od spustenia elektronických aukcií v roku 2009 mesto za zákazkach ušetrilo približne 300-tisíc eur.

Prihláška do súťaže bola podmienená množstvom úloh. Musela obsahovať opis situácie v meste, kľúčové prínosy projektu, jeho realizáciu, strategické ciele, kľúčové kroky v plnení projektu a spôsob, akým ich chce martinská samospráva splniť, museli byť vyčíslené dopady aj v merateľných údajoch a podobne.

Jej súčasťou bola aj minuloročná bilboardová kampaň na celom Slovensku, ktorá propagovala projekt za hranicami mesta a získavala záujem oň aj v iných regiónoch Slovenska. Na oficiálnej stránke OSN sa uvádza, že cenu získalo Slovensko.

O projekt Transparetné mesto v celej šírke záberu tak, ako ho rozvíja Martin, už prejavili záujem samosprávy v Banskej Bystrici, Trenčíne a Prievidzi, jeho časťou sa inšpirovala už aj vláda, keď zaviedla povinnosť uverejňovať objednávky, faktúry a zákazky na internetových stránkach obcí a miest.

Ocenenie Organizácie spojených národov za verejnú službu je najprestížnejším medzinárodným uznaním inovátorstva a kvality vo verejnej službe. Udeľuje sa verejnému sektoru, samosprávam od miestnej cez regionálnu až po vládnu úroveň, ministerstvám, úradom vlád a neziskovým organizáciám.

Prestížne ocenenie za 1.miesto si primátor mesta Andrej Hrnčiar prevezme 23. júna 2011 na medzinárodnej konferencii OSN v Tanzánii za účasti najvyšších predstaviteľov a prezidentov z celého sveta a OSN.

### Úrady práce v SR evidovali 111-tisíc mladých bez práce

Úrady práce a sociálnych vecí evidovali ku koncu marca tohto roku najviac nezamestnaných vo veku od 20 do 29 rokov. Išlo o 111,1 tisíc osôb. Druhou najpočetnejšou skupinou ľudí bez práce boli osoby vo veku od 30 do 39 rokov, a to v počte 92,2 tisíc. Vo veku 40 až 49 rokov zaznamenali úrady práce ku koncu prvého štvrťroku tohto roka 84,6 tis. uchádzačov o zamestnanie a vo veku 50 až 59 rokov nemalo prácu 88,8 tis. ľudí. Do kategórie nezamestnaných vo veku do

19 rokov sa zaradilo takmer 7,7 tis. osôb a vo veku nad 60 rokov išlo takmer o 8,1 tis. ľudí bez práce. Vyplýva to z podrobných štvrťročných štatistík o nezamestnanosti na Slovensku, ktoré zverejnilo Ústredie práce, sociálnych vecí a rodiny SR.

Najviac nezamestnaných mladých ľudí vo veku od 20 do 29 rokov je v prešovskom a košickom kraji. Najmenej mladých ľudí bez práce bolo ku koncu prvého štvrťroku v bratislavskom, trnavskom a trenčianskom kraji.

### V niektorých oblastiach Slovenska žijú ľudia kratšie

Takmer tretina Slovákov žije v narušenom až silne narušenom životnom prostredí. Geologická stavba územia SR je veľmi rôznorodá, čo je odrazom rozdielneho výskytu chemických prvkov priaznivých alebo nevhodných z hľadiska ľudského zdravia.

Takmer tretina obyvateľov žije v narušenom až silne narušenom životnom prostredí. Toto narušenie je podmienené najmä kontamináciou geologických zložiek.

Vysoká úroveň kontaminácie pôd, prírodných vôd, hornín, riečnych sedimentov a nepriaznivo zvýšené parametre prírodnej rádioaktivity boli geochemickým mapovaním dokumentované na viac ako desiatich percentách územia.

Ako poukazuje správa envirorezortu, ktorú vláda vzala na vedomie, na Slovensku sa vyskytujú viaceré oblasti, v ktorých je priemerná dĺžka života obyvateľstva o päť až desať rokov a často aj viac kratšia, a v ktorých sa pozoruje zvýšený výskyt rôznych onkologických či kardiovaskulárnych ochorení.

Napríklad rakovina je najmenším problémom v oblasti Kysúc, Oravy, Spiša, naopak, vysoká úmrtnosť na rakovinu je v Bratislave, Košiciach a na južnom Slovensku.

Najviac srdcovocievnych ochorení sa zaznamenáva v oblastiach južného a stredného Slovenska s kontaminovaným geologickým prostredím.

"Výskyt významných, najmä rudných ložísk a stáročia trvajúca banská a úpravnícka činnosť v historických banských oblastiach Slovenska na jednej strane, a na druhej strane rozsiahly a ekologicky nekontrolovaný rozvoj hospodárstva Slovenska v 20. storočí spôsobili značné škody na životnom prostredí," upozornilo ministerstvo.

### V Bratislave otvorili výstavu o ŠtB

Skryté fotoaparáty, šifrovacie zariadenie, vyznamenania, mapa konšpiračných bytov v Bratislave, fotografie, dokumenty a ďalšie dôkazy o činnosti komunistickej Štátnej bezpečnosti (ŠtB) odhalí výstava Prísne tajné, ktorú otvorili 12. mája v Slovenskom národnom múzeu v Bratislave. Výstavu pripravil Ústav pamäti národa (ÚPN). Obsahuje obdobie od počiatkov ŠtB – 40. rokov, až do pádu režimu v roku 1989.

Návštevníci výstavy majú možnosť prezrieť si zoznam rezidentúr, ktoré pôsobili vo svete, dokumenty týkajúce sa príslušníkov i spolupracovníkov tajnej polície. Ukazuje spôsoby sledovania ľudí, obdobie normalizácie, ale aj pádu režimu a skartácie dokumentov v decembri 1989. Sú tam aj panely venované portrétom obetí – ľudí, ktorých prenasledovali – a sú doplnené aj o videoukážky z ich svedektých výrovedí.

- 4. mája v noci vyčíňal v Košiciach a okolí silný vietor, ktorý strhával strechy, vyvracal stromy a prívesy nákladných áut.
- ◆Veľké množstvo kokaínu v soškách vtákov zadržali 29. apríla colníci na bratislavskom lestisku M.R. Štefánika, keď kontrolovali zásielku z Brazílie. Hodnota zaistenej drogy bola 5 920 000 eur. Colníci zadržali aj osobu, ktorá mala zásielku prebrať. Je ním 45-ročný konateľ slovenskej spoločnosti založenej iba pred mesiacom. Celkovo išlo o 32 kilogramov kokaínu, z ktorých by vyrobili minimálne 550-tisíc dávok.
- ◆Podľa posledného prieskumu, ktorý sa konal v rámci európskeho projektu EDUMIGROM, chce takmer každý štvrtý žiak vo veku 15 rokov v dospelosti odísť zo Slovenska do cudziny. Odborníci to pripisujú zlej ekonomickej situácii, čo slovenskú mládež zrejme vedie k presvedčeniu, že v zahraničí nájdu lepšiu prácu a uplatnenie.
- ◆ V porovnaní s prvým kvartálom minulého roku sa v tomto roku predalo na Slovensku takmer o 50 percent viac bytov. Podľa vyjadrenia odborníkov by mal narastajúci záujem pokračovať aj ďalej. Najviac bytov a predáva počas mesiacov máj až jún a v období letných prázdnin.
- ♦ Slovensku hrozí nedostatok zdravotných sestier. Dôchodkový vek dosahuje ročne 1200 až 1600 zdravotných sestier, pričom do systému prichádza asi 200 až 250 sestier, napriek tomu, že štúdium ukončí 500 sestier. Viac ako polovica z nich po ukončení štúdia odíde pracovať do zahraničia.
- ◆ Japonské deti z oblastí zasiahnutých zemetrasením a cunami budú môcť stráviť prázdniny na Slovensku. Túto formu pomoci ponúkol 10. mája minister vnútra SR Daniel Lipšic veľvyslancovi Japonska Yoshiovi Nomotovi, ktorý bude túto po-

- nuku tlmočiť japonskej vláde. Výdavky spojené s pobytom a dopravou na Slovensko by hradila slovenské strana.
- ◆ 10. mája sa v popradskej nemocnici narodili trojčatá - Miriam, Bibiana a Martin. Všetky tri deti aj matka sú v nemocničnom ošetrení a sú zdraví. Novorodenci boli dočasne umiestnení v inkubátore.
- Najväčší počet vajec exotických vtákov v histórii Európskej únie sa podarilo zadržať slovenskej polícii v spolupráci s kolegami z Rakúska a Nemecka. Dvaja Slováci sa pokúšali doviezť v kokosovom orechu z Jamajky 74 vajec amazonských papagájov, ktoré plánovali predať záujemcom z celej Európy. Nitrianska polícia sledovala pašerákov už dlhšie. Sú známi medzi chovateľmi v Česku, Nemecku a Rakúsku.
- ◆ Na Slovensku sa 13. mája začalo sčítanie obyvateľstva, ktoré potrvá do 6. júna. Štatistický úrad SR ponúka obyvateľom po prvý raz v histórii možnosť vyplniť sčítacie formuláre aj cez internet. Elektronické sčítacie formuláre sú v slovenčine, angličtine a jazykoch národnostných menšín.
- Odbornící predpokladajú, že ani tohoročné sčítanie obyvateľov zrejme neprinesie reálne údaje o počte slovenských Rómov. Pri poslednom sčítaní sa k rómskej národnosti prihlásilo 89 920 obyvateľov. V porovnaní so sčítaním v roku 1991 sa počet občanov rómskeho pôvodu zvýšil o 14 000. Obe štatistiky sú však nepresné, podľa odhadov žije na Slovensku 280- až 400-tisíc Rómov. Väčšina z nich žije v 620 osadách, kde starostovia predpokladajú najväčšie problémy pri sčítaní obyvateľstva. Narážajú na nedostatok vyškolených sčítacích komisáarov, ktorí komunity dobre poznajú, majú prehľad o ich obyvateľoch a dokážu s nimi komunikovať v ich rodnom ja-
