

Jotings from Sokol and Slovak life

Joseph J. Hornack, Slovak cultural activist, honored in Cleveland

Well-known American Slovak cultural activist, Joseph J. Hornack of Independence, Oh. was honored at a dinner given in his honor on April 22 in Cleveland, Oh. Hosted by the Cleveland Chapter of the Czechoslovak Society of Arts & Sciences, Brother Hornack, who is our long-time Sokol of Wreath 34, was feted for his many efforts in promoting the rich history, traditions and heritage of Slovakia and the Czech Republic. In attendance at the dinner was Brother Hornack's wife of 59 years, Dolores as well as their children and grandchildren in addition to his many friends and admirers. Since 2002, Brother Hornack has served as the associate director of The Slovak Institute located at the Benedictine Abbey of St. Andrew Svorad in Cleveland. Through his hard work and expertise, he has helped to rejuvenate and reorganize this great museum and archival center of the American Slovak community.

Born in Cleveland in 1933, Joe's paternal grandparents were natives of Krakovny in western Slovakia, while his maternal grandparents hailed from southern Bohemia. near Ceske Budejovice. A graduate of Benedictine High School, Joe served in the military during the Korean War. He served in research with Republic Steel which became LTV Steel, before retiring in 1989. Joe and his wife, Dolores grew up in the same Buckeye Road Slovak neighborhood of Cleveland and were schoolmates at the former St. Benedict School. As children, they participated in Christmas pageants and later attended Slovak picnics and dances. They both grew up in households where Slovak customs were celebrated. Over the years, Joe has enjoyed a keen interest in genealogy and archival study. He has been a member of the Czechoslovak Genealogical Society International since 1989 and has been a speaker at several conferences hosted by the society including Chicago in 1995, Minneapolis in 1997 and Cleveland in 2009 where he also served as a co-organizer. Through his efforts, a number of important books on Slovak history have been translated into English and he himself has penned numerous articles over the years on Slovak culture and history, especially related to the Cleveland

area community. He serves as a delegate of the Slovak Cultural Garden as part of the Cleveland Cultural Garden Federation.

On the local level, Brother Joe was an early supporter of the work of the Cleveland, Ohio - Bratislava, Slovakia Sister Cities group and participated in the founding of the Surname Location Reference project as well as a variety of projects of the Western Reserve Historical Society. In her remarks at the dinner, Paula Tilisky summed up Brother Joe's dedication to the Slovak community and its many projects.

A proud Slovak fraternalist, in addition to the Slovak Catholic Sokol, Brother Joe enjoys membership in the First Catholic Slovak Union and the First Catholic Slovak Ladies Association. He is a credit to the high ideals of the fraternal benefit system in general and in Slovak fraternalism in particular. As a faith-filled individual, Brother Joe is a daily communicant and serves as a Eucharistic Minister at his home parish of St. Michael the Archangel in Independence, Oh. We join his many friends and admirers in offering sincere congratulations and best wishes to him as he anticipates celebrating his 80th birthday later this year. His contribution to the American Slovak community is immense. We thank him for his dedication and pray that God will continue to bless him with good health and happiness in the years ahead, Zdar Boh!

Scholarly symposium honors Slovak Institute jubilee

The Pontifical Slovak College of SS. Cyril and Methodius in Rome in cooperation with the Theological Faculty of SS. Cyril and Methodius of Komenius University in Bratislava, will host an international symposium chronicling the 50th anniversary of the dedication of the Slovak Institute of SS. Cyril and Methodius, May 17-18, 2013. The two-day conference will bring together scholars from a number of countries includ-

ing the United States, Slovakia, Austria and Italy. The conference will review not only the history of the Slovak Ustav and college but of the historical, scholarly entity which developed in the Eternal City, necessitated by the Communist takeover of all Catholic institutions



in the then, Czechoslovakia. The Slovak Institute has evolved into an international body of Slovak scholars who have promoted the advancement and study of Slovak history and culture over the past half-century. The Slovak Institute has published the annual Slovak Studies series over the years.

The conference opens on May 17 in the aula of the Ponitifical Slovak College located on Via M.D.Brun Barbantini in Rome. The opening session begins with the welcome by the Rev. Msgr. Vladimir Stahovec, rector. He will introduce the first presenter, Cardinal Jozef Tomko who will discuss the history of the Slovak Institute and its place in Slovak history. Cardinal Tomko, retired Prefect of the Congregation for the Evangelization of Peoples, was a founder of the Slovak Institute a half century ago. Emilia Hrabovec of Austria will present a study on the relations between the Holy See and geo-political demographics which led to the founding of the Slovak Institute. Stefan Turansky will present the history of the formation of the minor seminary which was staffed by the Salesians of St. John Bosco in the early years of the Slovak Institute. A presentation by Zlatko Kubanovic will detail the history of the Slovak Salesian fathers and brothers who faithfully staffed the Institute over the years

A special feature of the conference will be the lecture by Professor Anthony Bonta of Calumet College of St. Joseph in Whiting, Ind. Professor Bonta will recall the close cooperation and support of the American Slovak community in the establishment and construction of the (Continued on page 13)

New Bishop appointed to Presov Archeparchy

On Apil 19, Pope Francis appointed the Rev. Milan Lach, S.J. as the new Auxiliary Bishop of the Byzantine Catholic Archdiocese of Presov. He will seve as auxiliary to Metropolitan Archbishop Jan Babyak, S.J. The 39-year-old will be Slovakia's youngest bishop

be Ślovakia's youngest bishop.

A native of Kezmarok, Bishopdesignate Milan was born there Nov. 18, 1973. In 1992, he entered the Byzantine Catholic Seminary in Presov. In 1995, he entered the novitiate of the Society of Jesus in Trnava. On Nov. 11, 2000 he was ordained a Deacon. On July 1, 2001, Byzantine Catholic Bishop Milan Chautur, C.Ss.R. ordained him a priest in the Cathedral of the Nativity of the Mother of God in

Kosice. In 2006, he received a licentiate in Eastern Church History from the Pontifical Oriental Institute in Rome. He served as the assistant spiritual director at the Russicum and worked at Vatican Radio. Since Dec. 1, 2011, he has been the director of the Center of Spirituality - East and West in Kosice.

Bishop-designate Milan will be consecrated a Bishop with Archbishop Jan Babyak, S.J. presiding on June 1 at the Byzantine Catholic Basilica in Lutine in eastern Slovakia. With his appointment, Slovakia will now have four active Byzantine Catholic bishops. Our congratulations and prayerful best wishes go out to Bishop-designate Milan. Na mnohaja a blahaja lieta!

Mother's Day should be more than just one day

Mother's Day is a celebration honoring mothers and motherhood, maternal bonds, and the influence



of mothers in society. It is celebrated on various days in many parts of the world, most commonly in March, April or May. It complements Father's Day, a

similar celebration honoring fathers.

Mother's Day is an American invention. It is not directly descended from the many celebrations of mothers and motherhood that have occurred throughout the world over thousands of years, such as the Greek cult to Cybele, the Roman festival of Hilaria, or the Christian Mothering Sunday celebration. Despite this, in some countries Mother's Day has become synonymous with these older traditions.

The modern holiday of Mother's Day was first celebrated in 1908, when Anna Jarvis held a memorial for her mother in America. She then began a campaign to make "Mother's Day" a recognized holiday in the United States. Although she was successful in 1914, she was already disappointed with it commercializa-

tion by the 1920s. Jarvis' holiday was adopted by other countries and it is now celebrated all over the world. In this tradition, each person offers a gift, card, or remembrance toward their mothers, grandmothers, and/or maternal figure on mother's day.

When someone believes in us, when someone is in our corner, we feel strengthened. We feel encouraged. We feel confident. We believe we can make it, and we experience victory. When that someone is our Mother, we are even more joyfully confident.

May 27: Remember Them

The Memorial Day custom of decorating the graves of the dead with flowers dates back to classical times

In Greece, women who were the closest relatives to dead persons paid their last respects by crowning the head with flowers. In Rome, mourning friends and relatives carried wreaths of flowers to the home of the dead person, covering his couch with leaves and blossoms.

In the United States women who brought flowers to the graves of soldiers killed in the Civil War were responsible for giving the custom national prominence.

In 1863 women from Columbus, Missouri laid flowers on the graves of both Union and Confederate soldiers. In April, 1865 women led by Mrs. Sue Landon Vaughn, a descendant of the second President, John Adams, decorated the graves of soldiers at Vicksburg.

In June, other women from Virginia honored the dead at the Confederate Cemetery in Winchester which is said to be the first cemetery for dead soldiers in the South.

The first official observance of Memorial Day was conducted by the Grand Army at Arlington Cemetery in 1868. However, it was not until years later that the individual states declared Memorial Day a legal holiday.

Today, Memorial Day always falls on the last Monday in May, and that means another long holiday

The Slovak Garden Celebrates its 61st Anniversary

In March of 2013, one of the great Slovak American institutions, The Florida Slovak Garden hosted its 61st annual meeting and Slovak Day celebration. This report will cover both events held at the Garden, a home for retired American Slovaks in Winter Park, just outside Orlando, Fla.

This year, for just the second time in its recorded history, the Slovak Garden broke with the order of these events. In the hope of increasing the number of young people in attendance, the Board of Directors held the annual meeting prior to the Slovak Day observance. In the past, the annual meeting followed the Slovak Day on a Monday. The following are my observations of the highlights of the proceedings of the weekend.

Annual Meeting

Keeping with other traditions, the Slovak Garden's large social hall was the site of its 61st annual meeting held on Saturday, March 2, 2013. President Jerry Krupa called the meeting to order and led in the opening prayer. Auditor Justine Wesnak, a former president, led in the singing of the National Anthem with Director Nick Badida leading the Slovak National anthem.

Highlights of the meeting included the presentation of several reports of the Garden's financial position and atmosphere at this time. A favorable financial report was given by the Treasurer Anna Valucek. She stated that it was due to the vigilance of the president and the board, as well as the security of the income from rents, especially that of the large social hall. The senior Auditor Peter Salling indicated that he found all records up to date and in good condition due in large part to the officers and accounting staff incorporating the procedures he had suggested last year

for the continued security of the Garden. Peter indicated that his term as auditor concluded and that he would not seek reelection. This was due to the fact that his own additional responsibilities at work along with his desire to spend more time with his family.

As the immediate past president of the Garden as well as during the past few years serving with Peter as an auditor. I have had the opportunity to observe Peter at work. He is a wizard at auditing and finance. The Garden is fortunate to have his service. Fortunately, I was able to successfully convince him that his talents are needed for the continued success of the Garden He was in fact reelected unanimously. Nearly 20 presidents accept invitation to summit in Bratislava

Close to 20 heads of state have already accepted invitations to attend a summit of presidents of Central and Eastern European countries due to take place in Bratislava on June 12-13, Slovak President Ivan Gasparovic's spokesman Marek Trubac told TASR on April 26.

The gathering will be held under the theme "Growth Strategy Towards Post-crisis Recovery." According to the statement, the Central European region has the potential to play a positive role both in consolidation as well as in the creation of a new place for Europe in the post-crisis period.

According to the president, the meeting in Bratislava will be a suitable opportunity to discuss key political, economic, social and security issues relating to the development of the region.

The summit will also be an opportunity to mark the 20th anniversary of Slovakia's independence. "It will be the most important and, in terms of the number of attendees, the largest meeting of presidents in Slovakia in over 20 years," said Trubac.

SBA: stability of Slovak banks is 4th in Eurozone, thanks to profits

Slovakia's banking sector belongs among the most stable among the European monetary Union countries, according to a statement issued by the Slovak Banking Association(SBA) on April 25 based on a survey carried out by the World Economic Forum(WEF).

According to SBA, Slovak banks, especially benefit from their favorable liquidity position and ability to generate profits.

"Slovak banks belong among the four most stable ones in the eurozone," SBA stated, adding that Finland is number one with the eurozone.

SBA pointed out, however, that it views the assessment by WEF as rather subjective. However, any subjectivity is overshadowed by the so-called stability index, which takes into consideration profitability, liquidity, capital adequacy and credit quality of banks.

Slovakia was in fifth place in terms of the stability in-

Fico attends Maypole festival, praises importance of traditions

The symbolic erecting of the Maypole is worth doing, and I would be happy if we preserved this kind of tradition, said Prime Minister Robert Fico at one such event in Bratislava on April 28.

"This is how we commemorate nice things from history in Slovakia...We import all sorts of foreign festivities too often," he added.

The setting up of the Maypole is related to May Day, or Labor Day, said Fico, pointing to the shortage of jobs in Slovakia. This is the case throughout Europe, however, he said, while giving assurances that the Cabinet will do its best to boost employment, including with the use of EU funds and incentives such as tax relief.

"I'm one of the people who look on Slovakia in a highly optimistic light, and I refuse to paint a black picture of Slovakia all the time," said the premier, adding that the real situation and figures aren't as disastrous as some try to depict.

Brezezinski: Europe gives up ambitions, relies too much on the United States

Europe of the 21st century stands ahead of a challenge to demonstrate its determination to continue in the concept of the West as a leading global force, Zbigniew Brzezinski, a leading international political and security expert, said at he GLOBSEC conference in Bratislava on April 18. Brezezinski is the former security advisor to U.S. President Jimmy Carter

Brzezinski pointed out that the EU appears to be giving up it ambitions, while relying too much on the United States. At the same time, it is losing its global visions, and is focusing on tackling acute current problems instead. He also pointed to the problem of the historical low-point in European's pro-EU sentiment.

Burian meets Dirioz, discusses challenges for NATO

Slovak Foreign and European Ministry State Secretary and former Slovak Ambassador to the U.S., Peter Burian met NATO Assistant Secretary General for Defense Policy and Planning Huseyin Dirioz to discuss current challenges for NATO on the sidelines of the international security policy conference GLOBSEC 2013 in Bratislava on April 19.

Special attention at the meeting was paid to building defense capacities and development of NATO's partnership policies in the wake of the NATO summit that took place in Chicago a year ago. Burian at the talks highlighted the joint declaration of the Visegrad Four(Slovakia, the Czech Republic, Poland and Hungary) signed by its foreign ministers at GLOBSEC on April 18.

The declaration calls for boosting the efficiency and visibility of the common European defense policy, strengthening of the EU's defense capacities and its military industry, and in related research. This should represent a view on creating a more efficient NATO at a time of overall cuts in defense budgets, according to Slovak Foreign and European Affairs Minister Miroslav Lajcak.

Burian confirmed the V4's commitment to bolster military and civilian capacities via projects that have already been bearing fruit, such as NATO centers of excellence, a multinational logistics coordination center and multinational military police battalion within NATO. In addition, the V4 is building a joint combat group to be ready in 2016.

Dirioz, for his part, highly appreciated Slovakia's engagement in Afghanistan.

Women earn 20 percent less than men in Slovakia

The gap between salaries received by men and women in Slovakia has narrowed over the past decade by 7 percent, but women are still being paid 20.5 percent less on average than men, Olga Pietruchova of the Labor, Social Affairs and the Family Ministry gender equality department said at a press conference on April 4.

This means that women in Slovakia need to work more than two months more on average to receive the same salary as their male counterparts.

As Pietruchova said, the actual reduction in the salary gap is a consequence of the economic crisis and a drop in salaries in general. She added that the smallest difference is between men and women who have lower salaries. "The greatest gap between women and men is among the university-graduates with top senior posts."

While the salary gap between men and women in Slovakia accounts for roughly one-fifth, women in the European Union earn 16.2 percent less than men on average.

Also speaking at the press conference, director of the Labor and the Family Research Institute Silvia Porubanova asserted that there's sufficient scope for ambitious women on the labor market to increase their salaries. In fact, women can fight for the amount of their financial reward as early as during job interviews.

Papal delegates named to Cyrilo-Methodian celebrations

Pope Francis acknowledged the invitation of the Bishops Conference of Slovakia to attend the official 1,150th anniversary of the arrival of SS. Cyril and Methodius in Slovakia set for July 5 in Nitra. While he himself cannot attend, he named Cardinal Franc Rode, C.M., prefectemeritus of the Congregation for the Institutes of Consecrated Life and Societies of Apostolic Life as his representative. A Slovenian, Cardinal Rode will be principal celebrant of the jubilee liturgy scheduled to be celebrated outof-doors in Nitra on Friday, July 5. Nitra was the center of the evangelization mission of SS. Cyril and Methodius who arrived in the area beginning in the summer of 863. Established in 880, Nitra is the oldest diocese on the territory of the western Slavs.

In addition, since the celebration honoring the Apostles of the Slavs in the Czech Republic is also set for July 5 in Velehrad in eastern Moravia, he also named a Papal legate in the person of Cardinal Josip Bozanic, Archbishop of Zagreb in Croatia. SS. Cyril and Methodius arrived in Great Moravia in 863 in what is today western Slovakia and the eastern area of the Czech Republic.

Both celebrations are scheduled for July 5th, the traditional observance of the feast of SS. Cyril and Methodius in the former Czechoslovakia While the universal Church observed their feast on July 7th until the reform of the Church calendar by Pope Paul VI in 1967, the feast was then transferred to February 14th, the day on which St. Cyril died in Rome in 869. When Czechoslovakia was created in 1919, the Free-thinking government established July 6th as the holiday honoring the Czech reformer, Jan Hus. The Church thus chose to observe the feast of the Apostles of the Slavs on July 5th a day before the Hus holiday. This tradition continues until to-

Obituaries...

John Hvasta, 85, was devoted Slovak activist

John Hvasta of St. Augustine, Fla. passed away peacefully in his sleep on March 28. He was 85.

A native of Miglesov in eastern Slovakia, he was born there June 2. 1927 son of Michael and Elizabeth Roman Hvasta. He emigrated to the U.S. at the age of 11 settling in Hillside, N.J. where he attended local schools. Following his U.S. military service, he decided to return to his native country to attend Charles University. He began working at the U.S. Consulate in Bratislava in 1948 with U.S. Consul Clairborne D. Pell, later U.S. Senator of Rhode Island. He was arrested on false espionage charges and sentenced by the newly-installed Communist government to 25 years in prison and was sent to the infamous Leopoldov prison. He was able to escape and over a three-year period found his way to Prague and the U.S. Embassy there. He was finally freed with the help of John Foster Dulles and returned to the United States.

Upon his return to the U.S., John engaged in a nation-wide public speaking tour and was awarded his under graduate degree at the University of Southern California. In 1956, he married the former Helen Loya in Duquesne, Pa., who survives.

He became a freelance filmmaker of documentary films and after moving to Washington, D.C. was actively politically working for several congressmen and senators. He labored tirelessly on behalf of the Slovak cause and never gave up hope that Communism would fall and that Slovakia would become independent. He was a founder and long-time advocate of the Slovak World Congress and helped organize many conferences and gatherings promoting the cause of the Slovaks and their quest to be free of Communist rule. Following the fall of the Berlin Wall, he returned to Slovakia and was interviewed many times on radio and TV. He was present on January 1, 1993 when Slovakia declared its independence. He worked for Slovak Telecommunications for a number of years and then moved to St. Augustine, Fla. for his retirement. An active Byzantine Catholic, he promoted numerous projects in support of the Greek Catholic Church in Slovakia.

The Stephen Haky Funeral Home in Uniontown, Pa. was in charge of arrangements. A funeral Divine Liturgy was celebrated on April 4 at St. Nicholas Byzantine Catholic Church in Perryopolis, Pa. with his brotherin-law, the Rev. Daniel Loya and cousins, Rev. Thomas Loya and Rev. Joseph Loya officiating. Interment followed at Mt. St. Macrina Cemetery in Uniontown, Pa.

In addition to his wife, Helen, John is survived by sons, John Thadeus, Michael Stephen and Mark Francis Hvasta; a daughter, Marianne Margaret Hvasta and six grandchildren. May this servant of God, patriotic American and faithful son of the Slovak nation now rest in peace. Vechnaya pamyat!

Rev. Cassian Yuhaus, C.P. Hazleton, Pa. native

Well-known Passionist priest, Rev. Cassian Yuhaus passed away peacefully on February 14, the feast of SS. Cyril and Methodius, in Wilkes-Barre, Pa. He was 90.

A native of Hazleton, Pa., he was bom July 12, 1922, son of the late Adam and Elizabeth Alasko Yuhaus. He was raised in St. Joseph's Parish, the oldest Slovak parish in the United States. He professed his vows as a member of the Congregation of the Passion religious community on August 15, 1944, and was ordained a priest for the Passionist order on February 27, 1951. He celebrated his first Mass in St. Joseph's Church in Hazleton, Pa.

Father Yuhaus was awarded a doctorate in church history and the Papal gold medal for excellence from the Pontifical Gregorian University in Rome in 1962. He served in leadership positions in the Passionist community, coordinated the Religious Life Program for the Center for Applied Research in the Apostolate(CARA) in Washington, D.C. from 1975 to 1980, and served as president of CARA during 1980-1984.

In the years following the Second Vatican Council, Father Yuhaus became an internationally recognized consultant for many men's and women's religious communities. Renowned in religious circles as a dynamic speaker, retreat master and scholar, he wrote Compelled to Speak, a history of the Passionist community in the United States. He served on the boards of several outreach organizations, including Amnesty International, World Futures Society, Bread for the World and Pax Christi USA.

Father Yuhaus served as rector of St. Ann's Monastery and Basilica in Scranton, Pa. from 1998 until 2002. The funeral liturgy was celebrated at St. Ann's Basilica on February 18 with the Very Rev. Robert Joerger as principal celebrant. Interment followed at St. Ann's Monastery Cemetery.

Father Yuhaus was an outstanding priest and spiritual leader and a credit to the American Slovak community. He beautifully mirrored our Cyrilo-Methodian heritage of faith. May his priestly soul enjoy the beatific vision. May he rest in peace.

Minutes of the Annual Meeting of Group 4, "Bishop Stefan Moyzes"

The annual meeting of Group 4, Chicago, Ill., under the patronage of Bishop Stefan Moyzes, took place on Saturday, September 22, 2012 at the Casa Capri Restaurant in Kenosha. Wis.

V pondelok 6. mája 2013 si zádušnou svätou omšou pripomenuli v Spišskej Kapitule úmrtie emeritného spišského biskupa Mons. Františka Tondru, ktorý pred rokom zomrel. Zádušnú svätú omšu slúžil v spišskej Katedrále sv. Martina diecézny biskup Mons. Štefan Sečka, ktorý na začiatku vyzval prítomných k modlitbe za zosnulého biskupa, k vernosti jeho odkazu a k nasledovaniu jeho dobrých skutkov. Na svätú omšu prišlo 60 kňazov, prítomní boli aj bohoslovci, rehoľné sestry a mnohí veriaci - príbuzní i známi zosnulého biskupa Františka.

V homílii sa prihovoril spišský pomocný biskup a generálny vikár Mons. Andrej Imrich, ktorý zdôraznil, že biskup František musel neraz robiť rozhodnutia, ktoré boli krokom do neistoty a rizika, pričom sa vždy spoliehal na Božiu pomoc. Kazateľ všetkým pripomenul zmysel tohto stretnutia, keď povedal: "Prišli sme všetci spomínať, ďakovať a prosiť." V duchu týchto slov priblížil v krátkosti život, utrpenie i dielo zosnulého biskupa Františka, vyzval ku vďačnosti Bohu za dar jeho života i kňazského povolania a nakoniec povzbudil k modlitbám a prosbám, aby sa všetci mohli s ním stretnúť v nebi.

Spomienka na Milana R. Štefánika na Bradle



Spomienková slávnosť pri príležitosti 94. výročia od smrti Milana Rastislava Štefánika sa 3. mája konala na vrchu Bradlo v okrese Myjava.

Vence k Štefánikovej mohyle položili predseda vlády Robert Fico, ministri Martin Glváč, Dušan Čaplovič, viacerí poslanci Národnej rady SR, predstavitelia cirkví a samospráv. Súčasťou slávnosti bolo zapálenie štyroch vatier na každej svetovej strane mohyly.

Robert Fico vo svojom príhovore k účastníkom večernej spomienky pripomenul Štefánikovo presvedčenie, že slovenský národ môže prejsť cez úskalia dejín len vtedy, ak sa nebude vzdávať.

"Ak v dnešných časoch pocitujete pochybnosti, skúste si pomyslieť na svojho krajana Štefánika, ako by sa postavil k dnešnej kríze. Som presvedčený, že by zdôraznil svoje vlastné krédo: Ja sa prebijem, lebo sa prebiť chcem," povedal Fico, ktorý mal nad podujatím záštitu.

Ešte v piatok popoludní v Štefánikovej rodnej obci Košariská odhalili repliky dvoch pylónov z tichomorského ostrova Vava'u, ktoré obec dostala do daru od známeho slovenského cestovateľa Františka Keleho. Štefánik na ostrove v roku 1911 pozoro-

val zatmenie Slnka, pylóny mu slúžili ako statív.

M. R. Štefánik sa narodil 21. júla 1880 v rodine evanjelického kňaza. Vyštudoval astronómiu na pražskej Univerzite Karlovej. Počas 1. svetovej vojny bojoval ako pilot vo francúzskej armáde, kde dosiahol hodnosť brigádneho generála.

Štál pri zrode 1. Československej republiky. V prvej vláde novej republiky vyhlásenej 28. októbra 1918 zastával post ministra vojny. Zahynul pri návrate do vlasti 4. mája 1919 po havárii lietadla neďaleko Bratislavy. O týždeň neskôr ho pochovali spolu s jeho talianskou posádkou nad rodnými Košariskami na Bradle v dočasnom spoločnom hrobe so zapusteným pomníkom – kamenným krížom.

O päť rokov po jeho smrti 4. mája 1924 bol položený základný kameň pamätníka navrhnutého architektom Dušanom Jurkovičom, známym slovenským architektom, Štefánikovým priateľom z detstva. Údajne on sa prihovoril, aby generála pochovali po tragickej smrti spolu s jeho posádkou.

So stavbou sa začalo 11. júla 1927. Mohylu dokončili v septembri 1928. Zhotovená je z kvádrov travertínu, ktorého bolo na Bradle privezeného zo Spišských Vlachov 194 vagónov. Na stavbe mohyly pracovalo v rokoch 1927-1928 až 200 robotníkov a práce trvali iba neuveriteľných 280 pracovných dní.

Celá mohyla bola zubom času značne poškodená, a tak roku 1988 začala jej generálna oprava. 4. mája 1996 pri príležitosti 77. výročia smrti M. R. Štefánika odovzdal obnovenú mohylu verejnosti vtedajší predseda NR SR I. Gašparovič. V roku 2009 sa stala oficiálne súčasťou európskeho kultúrneho dedičstva.

Charakteristická bielo sa skvejúca terasová stavba so štyrmi obeliskami predstavuje typickú čistotu architektonického prejavu Dušana Jurkoviča v zosúladení s okolitou krajinou. Celá stavba je postavená z travertínových blokov. Po čelných a bočných schodištiach sa dá vykráčať až k hrobu velikána slovenských národných dejín. Z celého pomníka je krásny výhľad do kopaničiarskeho kraja. Mohyla na Bradle sa skladá z dvoch terás (spodná má dĺžku 93 m a šírku 62 m, uprostred vyššia, druhá, obvod 45 m a 32 m), nad ktorými sa vypína vlastná náhrobná stavba. Obidve terasy sa dvíhajú šikmými stenami, vybudovanými z hrubých kvádrov. Z druhej

Konferencia biskupov Slovenska poslala pozvanie na návštevu Benediktovi XVI. i jeho následníkovi Františkovi.

Svätý otec František vymenoval svojho mimoriadneho vyslanca - pápežského legáta, ktorý sa zúčastní na vyvrcholení osláv 1150. výročia príchodu svätých Cyrila a Metoda na Veľkú Moravu 5. júla 2013 v Nitre. Stal sa ním emeritný prefekt Kongregácie pre inštitúty zasväteného života a spoločnosti apoštolského života slovinský kardinál Franc Rodé.

Súčasťou pápežskej delegácie budú aj ďalší dvaja cirkevní predstavitelia, ktorých mená budú zverejnené týždeň pred 5. júlom, informoval hovorca Konferencie biskupov Slovenska Jozef Kováčik.

Biskupi pozvali ešte Bene-

dikta XVI. do Bratislavy, Nitry, Žiliny a Prešova v súvislosti s jubilejným rokom svätých Cyrila a Metoda.
