

### Patron of our Group 7 2014 Marks the 150th anniversary of the birth of the Rev. Joseph Murgas

February 17, 2014 marked the sesquicentennial of the birth of the Rev. Joseph Murgas, one of the most dynamic, prolific and gifted Slovak

America. He was a spiritual mover and shaker as well as a pioneer in wireless telegraphy. The 150th anniversary of Father Murgas' birth is certainly

worthy of note. Father Murgas was born on February 17, 1864, son of Jozef and Mary Murgas in Tajov, a village located in the heart of Slovakia, just outside Banska Bystrica. He was a man of diverse talents. During his high school years, he took an interest in the fine arts and electricity. He began his theological studies for the priesthood as well as studies at the celebrated Academy of Art in Munich. In 1886, he began his studies and experimentation in wireless telegraphy. During these years, he gained knowledge of French, German, advanced physics and astronomy. He was ordained a priest of the Diocese of Banska Bystrica in 1888. He continued his studies in drawing and painting. Father Murgas' reputation as an artist grew and he was recognized as one of the finest in the Kingdom of Hungary, where the Slovaks were among the subject minorities. He was commissioned to create great murals in the newly completed parliament building in Budapest. As a Slovak, he refused to create these murals which depicted a fallacy of history. They portrayed the duplicity of the Hungarians and the prostration of the Slovaks. Because of his pro-Slovak sentiments, his works were banned. Some of his paintings were covered or painted over.

Father Murgas knew of the spiritual needs of the many Slovaks who were emigrating to the United States. At the age of 32, he embarked on his journey to America. He arrived in New York on April 6, 1896, and journeyed to the Diocese of Scranton. He stayed briefly in Pittston, Pa. but then moved to Wilkes-Barre. He completed a church that was already started by his friend. Father Matthew Jankola, and became the founding pastor of Sacred Heart of Jesus Par-

ish. A new gothic church was dedicated in 1908 and he himself created many of the interior paintings and decorations. That year, he invited the Sisters of SS. Cyril and Methodius to staff his new parish school, the first mission of the then fledging congregation. In 1911, he founded the Slovak Catholic Federation, the representative body of American Slovak Catholics.

On the parish property, he built a private laboratory and at his own expense erected two transmitting and receiving towers for wireless communication. His experiments led to the discovery of the radio spark gap, which became a basic device in radio transmission. Father Murgas' invention was patented in 1905. His experiments with wireless telegraphy preceded those of Marconi. As a matter of fact, G. Marconi made a special visit to Wilkes-Barre to study Father Murgas's system.

In addition to his scientific and spiritual activities, Father Murgas labored on behalf of the Slovaks who were then part of the Austro-Hungarian Empire. He played and important role in the emancipation of the Slovaks from Hungarian rule following the First World War. He was a signator of the Pittsburgh

Agreement, signed in the presence of Thomas G. Masaryk in 1918 which would guarantee the rights of the Slovaks within the framework of the newly proposed Republic of Czecho-Slovakia. At that time, Masaryk himself invited Father Murgas to return home and be a part of the new republic which he helped to establish. He spearheaded the drive of the Slovak League of America and raised more than one million dollars on behalf of Czecho-Slovakia. In 1920, Father Murgas traveled to Czecho-Slovakia. During his visit to Prague, he sought an audience with President Masaryk, who had initially invited him to be a part of the new state. He was dismayed to learn that Masaryk refused to receive him.

Upon his return to America, Father Murgas devoted his final years of service and leadership within the Slovak community, supporting the work of our Slovak fraternals as well as the Slovak Catholic Federation and the Slovak League of America. Group 7 of the Slovak Catholic Sokol chose Father Murgas as its patron. He died at Sacred Heart Rectory in Wilkes-Barre on May 15, 1929. His funeral on May 18 was one of the largest in the city's his-

### Plans for Year of Consecrated announced by Pope Francis

Pope Francis has called for a special yearlong focus on consecrated life, asking the Church's religious sisters, brothers and priests to "wake up the world" with their testimony of faith, holiness and hope, a Vatican official said.

"Consecrated men and women are aware that besides recounting the great stories they have written in the past, they are called to write a no-less-beautiful and great story in the future," said Cardinal JoaoBraz de Aviz, prefect of the Congregation for Institutes of Consecrated Life and Societies of Apostolic Life.

At a news conference January 31, the cardinal spoke about plans for the 2015 Year for Consecrated Life, which Pope Francis announced in November.

The congregation hopes Pope Francis will celebrate the year's opening Mass November 21, when the Church marks a day of prayer for cloistered religious. The events would conclude one year later on the 50th anniversary of the promulgation of the Second Vatican Council decree "Perfectae Caritatis" on the appropriate renewal of the religious life.

The Vatican's Statistical Yearbook reported that at the end of 2011, there were more than 903,300 religious priests, brothers and sisters in the world; however, that figure includes those with temporary vows.

### Burian meet Sedgwick, debate Iran recall anniversary of joining NATO

Slovak Foreign and European State Secretary Peter Burian met with United States Ambassador to Slovakia, Theodore Sedgwick on February 6 to discuss current bilateral and multilateral issues, including support for involvement of the International Atomic Energy Agency to deal with the Iranian nuclear issue, the ministry's press department told TASR on the same day.

Burian confirmed Slovakia's support for carrying out the Joint Plan of Action on Iran adopted in Geneva in November 2013.

Burian and Sedgwick further discussed preparations of events to mark the upcoming 10th anniversary of Slovakia joining the North Atlantic Treaty Organization(NATO), cooperation between Slovakia and the National Guard of the state of Indiana, and the annual GLOBSEC 2014 security conference set to take place in Bratislava in mid-May. Peter Burian is the former Ambassador of Slovakia to the United States.

### Fico announces presidential bid, aims to be patriotic head of state

Prime Minister and Smer-SD party chief Robert Fico officially announced his bid for president in late December.

At the same time as the premier made the announcement, he publicly presented his evaluation of the government's achievements over the past year in the historic building of Parliament in downtown Bratislava.

"The decision of myself and of the Smer-SD party was preceded by considerations that the sitting government is enjoying one of the strongest political mandates in the European Union," said the premier and thanked Smer's 36-strong presidium for its support.

He added that he's aiming to use his long political experience and good ties with the other two constitutional officials - President Ivan Gasparovic and Parliamentary Chairman Pavol Paska.

"What would vital cooperation between President, Parliamentary Chairman and Prime Minister look like when one of the candidates calls Smer-SD's a party of extremists?" said Fico.

(The actor-turned politician Milan Knazko has said in an interview for the SME daily that most Smer officials are Communists who have nothing in common with social democracy. He noted that Communism is a form of extremism. - ed. note)

Fico also noted that the other presidential bidders want to act as a kind of counterpoise to the government - in other words, to fight against it. According to the premier, however, such an approach would only complicate Slovakia's standing in international terms, including the Visegrad Four grouping(which besides Slovakia features the Czech Republic, Poland and Hungary.)

It would be wrong if the elected president was only a political parvenu(one who acquires power quickly) who is there to gather experience. "He(the president) has to offer predictability in terms of their decisions...has to provide guarantees for our commitments towards European and transatlantic structures," he added.

"I want to be a patriotic president. I'm one of two active politicians who voted for the Declaration of Independence of Slovakia and the Slovak Constitution in 1992," he said, referring to the Declaration of Sovereignty as approved in the Slovak Parliament on July 17, 1992, with the break-up of then Czechoslovakia to become a reality as of January 1, 1993. The parliament was chaired by incumbent President Ivan Gasparovic at the time.

Having said that, Fico also expressed his readiness to be the president not only of all Slovaks but of ethnic minorities as well.

The first round of the presidential election in Slovakia will take place on March 15 with the second round taking place on March 29, Parliamentary Chairman Pavol Paska announced recently. The presidential vote will be carried out via plebiscite in two rounds. In the first round, if a candidate receives an absolute majority of valid votes then no second round is necessary. More likely, the two top candidates will meet head-to-head in the second round for the right to serve the five year term - with the possibility of being reelected once. All citizens age 18 and older are eligible to vote in the presidential election.

### Audit finds shortcomings in Kosice European Capital of Culture

An audit carried out by the Office of the Kosice City Main Auditor has found serious shortcomings in the way that the Kosice-European Capital of Culture 2013 independent organization has been run over the past year, TASR learned in late December.

According to the audit's findings, services in some cases were purchased without tenders even though public procurement processes were required under the law due to the sums involved. Furthermore, many invoices didn't provide information on the extent of the services rendered.

The organization's director Jan Sudzina rejected the audit report and refused to sign it. Sudzina concedes only formal shortcomings that he claims have already been remedied. He maintains that the law wasn't violated in the sphere of public procurements.

Main Kosice City Auditor Hana Jakubikova has submitted her report on the audit results to the Kosice City Council.

"Someone isn't telling the truth here, either one side or the other," said the mayor of Kosice Richard Rasi(Smer-SD).

### Asselborn: Slovakia can't develop in isolation, but as part of the EU

As a small country, Slovakia can't evolve in isolation, but as part of the European Union, the Foreign Minister of Luxembourg Jean Aselborn, stated after meeting his Slovak counterpart Miroslav Lajcak in Bratislava on February 3, appealing to all Slovaks to cast their votes in the upcoming election to the European Parliament.

As revealed by Lajcak at a briefing following the meeting, both diplomats agreed on "further, yet meaningful integration," within the EU.

Also discussed during their meeting was the upcoming presidencies of Luxembourg and Slovakia of the Council of the European Union - in July to December 2015 and July to December 2016, respectively. Lajcak revealed in this respect that Slovakia would be most grateful to take up the offer extended by Luxembourg. We've agreed that one or two Slovak diplomats can become a part of the Luxembourgian team during the Luxembourgian presidency in the second half of 2015," said Lajcak.


In addition, the talks of the two diplomats revolved around the activities of the two countries within the UN Security Council and their efforts to eliminate the abuse of children caught up in conflicts and wars. The politicians also discussed the topic of the current developments in the Balkans.

The High Tatras, Europe's second highest mountain range, form the natural border between Poland and Slovakia. About two-thirds of the range lie in Slovakia with about one third located geographically in Poland. Slovakia and Poland in a joint effort have applied to host the 2022 Olympic Winter Games. The area provides excellent venues for the winter games. The most popular and most famous peak of the High Tatras is the Lomnicky Peak. The triangular top of the peak is connected to three ridges. The northwestern ridge joins the main ridge of the High Tatras passing Pysny and Baranie Saddle. In the northeast direction, it is followed by a crotch passing the Kezmarsky and Maly Kezmarsky Peak. The third ridge - Lomnicky Ridge, passes Lomnicke Saddle in the south, south-east of the Lomnicky Peak. The first tourist ascent was completed by the English traveler, Robert Townson in 1793. The peak has been accessible by a cable car from Tatranska Lomnica since 1940. It is the most visited peak of the High Tatras. The cable car station on the top of the peak is connected to the highest Astronomical and Meteorological Observatory in Slovakia. At the summit, a TV transmission station was built in 1957 and an electric power line was brought in 1965.

### Slovakia's GDP rose by 1.5 percent, y-o-y, in 4Q13

Slovakia's Gross Domestic Product in the final quarter of 2013 increased by 1.5 percent year-onyear, and by 0.4 percent quarter-onquarter, according to a preliminary estimate released by the Statistics Office on February 14.

After seasonal effects are taken into account, the country's GDP grew by 1.3 percent, year-on-year in the fourth quarter of 2013. The gross domestic product in current prices in the third quarter of 2013 stood at \$21.5 billion.

A total of 2,196,000 people were employed in Slovakia in the period, with the overall level of employment increasing by 0.1 percent, year-on-year.

When seasonal effects are taken into account, overall employment in Slovakia staved flat, year-onyear, rising by 0.3 percent, quarteron-quarter.

The Statistics Office also announced that a more detailed report on GDP growth and employment in the fourth quarter of 2013 will be released by March 5.

### Blood Donors: Ultimate Givers

Ultimate Givers Due to publicity about techniques that allow patients to donate their own blood and receive it back when they need surgery, some people may feel it is no longer necessary to donate blood to the community supply. In fact, according to the American Association of Blood Banks, the need for blood is constant, and volunteer blood donors contribute at least 95 percent of blood used in the United States.

If all those who are eligible would donate on a regular basis, blood needs would be met and shortages would be a thing of the past. Even in today's high technology medical environment, the need for human blood continues.

### Lajcak: OSCE should serve as mediator in Ukraine

(Continued from page 12) fairs Minister Miroslav Lajcak told members of the parliamentary Foreign Affairs Committee on February 13.

"It's no secret that Russia accuses the EU of being biased and supporting anti-government protesters. In Ukraine, the EU is not perceived as an unbiased player and as soon as your impartiality is in doubt, your role as mediator is over," said Lajcak as to why the EU can't play the role of a go-between in Ukraine.

Lajcak believes that Ukraine respects the OSCE, as Ukraine is an OSCE member and even held the organization's presidency until the end of 2013. Therefore Kiev should have few reservations about its acceptance. "At the moment, the OSCE presidency is held by Switzerland, a neutral country with experience in delicate missions. I recommended to my Swiss colleague that OSCE should assume this role - if an agreement among all parties involved is reached, which would be good," he added.

Lajcak considers the situation in Ukraine to be quite complex. He is promoting political dialogue as the best course of action, while showing respect for democratic principles and steering clear of violence. "As a direct neighbor, we need to avoid being seen as biased. It's up to Ukrainians to elect their new government," claimed Lajcak, adding that Slovakia is ready to share its experience with Ukraine in its democratization.

A total of 722 people deprived of Slovak Passports due to citizenship act

For three and a half years with the State Citizenship Act in effect(June 17, 2010 - February 4, 2014), it has deprived a total of 722 people of their Slovak citizenship, according to the statistics of the Interior Ministry.

Out of the total, there were 310 men and 412 women. Most of them(289 people) lost their citizenship due to accepting Czech citizenship. Next came people receiving German(143), Austrian(94), British(62), Hungarian(47), U.S.(17), Dutch(13), Norwegian(12), Belgian(7), Irish(6), Italian (and Swiss citizenship(both 5), French, Canadian and

Australian(all three 4), Icelandic, Chinese and Swedish(all three 2), Ukrainian, Russian, Danish and New Zealand(all 1 person).

The Slovak Citizenship Act was passed by the first government of Robert Fico(2006-10) in response to the controversial Hungarian Dual Citizenship Act, which gave an unprecedented opportunity for Hungarians living in neighboring countries like Slovakia and Romania to enjoy the benefits of Hungarian citizenship while living abroad. According to the Slovak legislation, all people who become citizens of a foreign country, lose their Slovak citizenship.

In addition, the legislation is being looked into by the Interior Ministry, which has been engaged in drafting a milder version of the law. The revisited amendment to the Act is expected to be submitted for interministerial comments in the first half of this year. Interior Minister Robert Kalinak envisages in this respect that the amendment could grant the people who lost their Slovak citizenship an opportunity to claim it back under certain circumstances.

The Slovak legislation is being looked into by the Constitutional Court. This process was initiated by Gabor Gal(Most-Hid MP), according to whom the law is unconstitutional.

- are pronounced "Shish"ky
- 2 eggs
- 1 tablespoon sugar

Americká spravodajská stanica CNN v cestovateľskej sekcii na svojej internetovej stránke zverejnila článok s rebríčkom deviatich najlepších dovolenkových destinácií pre záujemcov o chudnutie. 

### Najstaršia slovenská tlačená kniha má 433 rokov



Najstaršou slovenskou tlačenou knihou je Bardejovský katechizmus z roku 1581.

Originál 433-ročnej knihy vytlačil významný tlačiar Dávid Gutgesell v Bardejove. Preto sa katechizmus, napísaný v slovakizovanej češtine, nazýva bardejovský.

Bardejovský katechizmus bol v 16. storočí čítankou, z ktorej sa učili čítať nielen deti, ale aj dospelí. Zachoval sa však iba jediný výtlačok, takže ho starostlivo opatrujú v trezore Slovenskej národnej knižnice v Martine. Odtiaľ ho dokonca vyberajú len príležitostne.

Keďže originál je poškodený, odborníci urobili teraz jeho presnú kópiu. Nová kniha je výsledkom päťročnej práce vedcov a reštaurátorov. Kópia je dokonca rozsiahlejšia ako originál.

### Ako bude vyzerať Starý Most v Bratislave po rekonštrukcii

Starý Most v Bratislave začalo mesto rekonštruovať koncom minulého roka. Prestavba Starého mosta je spolu s vybudovaním električkovej trate zo Šafárikovho námestia po Bosákovu ulicu súčasťou prvej etapy budovania Nosného dopravného systému v Bratislave.

Most pre verejnosť uzavreli 2. decembra 2013 a začali skladať starú konštrukciu.

Novú konštrukciu plánujú stavať na jar na petržalskom brehu Dunaja a odtiaľ ho potom budú vysúvať ponad koryto Dunaja.

Projekt bude stáť 58,8 milióna eur. Mesto na projekt požiadalo o nenávratný finančný príspevok. Na financovaní projektu sa bude z 85 percent podieľať Európska únia, desať percent prispeje štát a päť percent zaplatí mesto. Jednou z podmienok na čerpanie nenávratného príspevku je, že Starý most i električková trať Šafárikovo námestie – Bosákova musia byť hotové do konca roka 2015.

### Spomienka na Jozefa Murgaša

O nás Slovákoch sa všeobecne hovorí, ako o národe s malým vlasteneckým cítením a ešte menším sebavedomím. Možno



stáročia nemali svoj vlastný štát a boli sme v silnom područí. Napriek tomu sa nestratili a vo svete sme

aj preto sme

sa dokázali vždy presadiť.

Slováci to dokázali možno práve svojou skromnosťou, pracovitosťou a húževnatosťou, talentom, umom a vzdelanosťou. Je našou povinnosťou, aby sme si osobnosti, ktoré to dokázali, pripomínali a predkladali ich výnimočnosť verejnosti, hlavne mladej generácii, ktorej aj tieto informácie môžu pomáhať pri získavaní sebavedomia a hrdosti na svoju identitu.

V týchto dňoch si pripomíname 150. výročie narodenia svetového vynálezcu Jozefa Murgaša (17. februára1864). Už v čase absolvovania základnej školy v rodnej obci a gymnázia v Banskej Bystrici ho zaujalo maliarstvo a v rokoch 1889 - 1890 ho študoval v Budapešti. Ďalšie štyri roky pokračoval v štúdiu v Mníchove. O elektrotechniku sa začal zaujímať na štúdiách v Ostrihome. Rodina Murgašovcov dlho čakala na narodenie svojho dieťaťa, a preto Murgašova mama na znak vďaky pri kríži sľúbila, že jej syn pôjde za kňaza. Keď mal Jozef 24 rokov, vysvätili ho za kňaza. V roku 1896 odišiel do novozaloženej baníckej obce Wilkes-Barre, Pa., kde žilo 300 slovenských rodín, ktoré potrebovali kňaza.

Tu sa Murgaš začal hlbšie zaujímať o elektrotechniku. Už v roku 1903 podal vo Washingtone svoj prvý patent a o rok neskôr mu federálny úrad uznal patenty dva. Vynašiel zariadenie na bezdrôtovú telegrafiu a ako druhý spôsob prenášania správ bezdrôtovou telegrafiou. Na základe týchto patentov vznikla vo Philadelphii účastinná spoločnosť Universal Aetheur Telegraph co., ktorá produkovala ďalšie patenty. Vlhkomer (1907), elektrický transformátor (1907), zariadenie na výrobu elektromagnetických vĺn (1909), prístroj na výrobu elektrických oscilácií (1911), navijak na rybársky prút (1912), spôsob na výrobu elektrických oscilácií (1916).

V rámci bezdrôtového prenosu sa mu vôbec prvý raz podarilo v roku 1905 rádiové spojenie, ktoré medzi obcami Scranton a Wilkes-Barre vzdialených od seba 30 km umožnilo rozhovor

Veža bezdrôtového vysielania, ktorú používal Rev. Jozef Murgaš vo Wilkes-Barre, Pa.

ich starostov, ktorí to písomne potvrdili.

V čase prvej svetovej vojny sa Murgaš angažoval pri vytvorení spoločného štátu Čechov a Slovákov. Bol jedným zo signatárov Pittsburgskej dohody. Mal blízko aj k Milanovi Rastislavovi Štefánikovi. Medzi americkými Slovákmi zorganizoval zbierku jedného milióna dolárov - základný valutový fond ČSR. V roku 1920 sa Murgaš vrátil na Slovensko a mal záujem usadiť sa a vyučovať elektrotechniku. No úrady mu to neumožnili, a tak sa vrátil spať do USA. Zomrel 11. mája 1929 vo Wilkes -Barre.

Vynálezcu bezdrôtovej telegrafie ocenil aj americký prezident Theodore Roosevelt a vážil si ho aj sám Thomas Alva Edison. Jozef Murgaš dal svetu bezdrôtovú komunikáciu, nebyť jeho vynálezov, svet by nepoznal internet, možnosti dnešných mobilov a iných komunikačných kanálov. Preto môžeme byť právom hrdí. - Daniel Zemančík

### Za tri a pol roka prišlo o slovenské občianstvo 722 ľudí

Zákon o štátnom občianstve pripravil za tri a pol roka (od 17. júla 2010 do 14. februára 2014) o slovenský pas 722 ľudí, z toho 310 mužov a 412 žien. Najviac z nich (289) stratilo slovenské občianstvo pre prijatie českého, vyplýva to zo štatistík Ministerstva vnútra SR.

Slovenský pas strácajú ľudia na základe zákona o štátnom občianstve, ktorý prijala prvá vláda Roberta Fica. Niekdajší kabinet reagoval právnou normou v roku 2010 na maďarský zákon, ktorý od roku 2011 zjednodušuje udeľovanie dvojakého občianstva zahraničným Maďarom.

Na základe súčasného zákona prichádzajú o slovenský pas tí, ktorí prijali občianstvo iného štátu.

Demitra zahynul 7. septembra 2011 vo veku 36 rokov pri páde lietadla v Rusku. Pri tragédii zahynulo 43 členov hokejového klubu Lokomotiv

Najhoršia zimná sezóna za 16 rokov. Takú zlú sezónu si prevádzkovatelia lyžiarskych stredísk už takmer ani napamätajú. Teplé počasie sťažovali aj umelé zasnežovanie na slovenských horách. Lyžiarske strediská zaznamenali najmenej tretinový pokles lyžiarov v porovnaní s minulým rokom.

 Podľa meraní ovzdušia v Európe z roku 2011 je spomedzi európskych krajín najhoršie na tom Bulharsko. Na druhom mieste sa umiestnilo Poľsko, na treťom Slovensko. Štvrtú priečku v meraní obsadilo Maďarsko a za ním nasleduje Česká republika na piatom mieste. O výsledkoch meraní 20. februára informoval Miroslav Šuta z Centra pre životné prostredie a zdravie v Českej republike na dvojdňovej medzinárodnej konferencii, ktorá sa konala v Bratislave.

✤ 24. februára spadol z 10-metrovej výšky 47-ročný robotník, ktorý pracoval na rozoberaní bratislavského Starého mosta. Amazon zvažuje otvoriť distribučné centrum v Malackách

Je čoraz pravdepodobnejšie, že najväčší internetový obchod na svete Amazon otvorí svoje distribučné centrum pri Malackách

Mestské zastupiteľstvo v Brne totiž v piatok po sedemhodinovej debate neschválilo podmienky, za akých by americký Amazon mohol svoj sklad postaviť tam. A alternatívou pre juhomoravské mesto sú práve Malacky.

Brnianski poslanci sa nevedia zhodnúť na tom, za akých podmienok predajú developerovi pôdu za 214 miliónov korún, na ktorej majú sklady pre Amazon vvrásť.

Miestni politici totiž začali predaj podmieňovať tým, aby Amazon prispel na výstav-

diaľničného privádzača. bu Američania súhlasili so sumou 56 miliónov korún, no niektorí poslanci by chceli viac.

Manažér firmy CTP Tomáš Budař zdôrazňuje, že napojenie na diaľnicu nežiada Amazon, ale Brno. "Privádzač totiž nie je nevyhnutnou súčasťou projektu, distribučné centrum by vedelo fungovať aj bez neho," povedal SMĔ.

Americká firma nežiada od Čiech ani úľavy na daniach či dotácie za nové pracovné miesta. Tých má v centre vzniknúť dvetisíc, ďalších štyritisíc ľudí si môže Amazon prenajímať počas sezóny. Celkovo má vybudovanie skladov s rozlohou asi 124-tisíc štvorcových metrov vyjsť na 100 miliónov eur.
