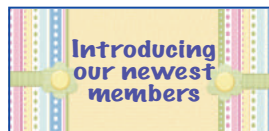
I would like to remind all Groups, Assemblies and Wreaths that Saturday, May 5, 2018 is the day known

2018 Law Day Message from our General Counsel

On May 1, 2018, America observes Law Day, a celebration of our nation's great heritage of liberty, justice, and equality under law. Law



Day underscores how law and the legal process have contributed to the freedoms that Americans share. As we commemorate the 60th Anniversary of Law Day's establishment, this year's theme is "Separation of Powers: Framework for Freedom." Interestingly, the phrase, "separation of powers" does not appear anywhere in the text of the U.S. Constitution. However, it is likely to be one of the most important concepts in understanding how the United States government is designed to defend the liberties that Americans had fought so hard to achieve. The principle of separation of powers speaks to a system of shared power known as checks and balances. This timely theme exemplifies how the branches represent separate powers that, together, form a dynamic system that works for the common good. In addition, the crux of the theme is central to building an understanding of the rule of law, which has always been a primary purpose of Law Day.

SEPARATION OF POWERS AND THE UNITED STATES CONSTITUTION

In the words of Justice Louis Brandeis, "The doctrine of the separation of powers was adopted by the

Convention of 1787, not to promote efficiency, but to preclude the exercise of arbitrary power." Our founding fathers were concerned that the government they established not have all its power concentrated in the hands of a few officials. Government functions best when its powers are not concentrated in a single authority, but are instead divided among different branches. The founders were also concerned that the powers granted to one branch would be balanced by powers granted to others. Congress's power to legislate, for example, is balanced by the Executives power to veto legislation and by the judiciary's power to declare legislation unconstitutional. This system of checks and balances ensures that each branch is separate from the other, but each would retain distinct powers that the other branch did not have. The philosopher Montesquieu further stated if "the right of making and of enforcing the laws is vested in one and the same man, or the same body of men ... there can be no liberty."

The three (3) branches of government and their respective powers are defined as follows:

1. The Legislative branch is composed of the Congress (made up of the House of Representatives and the Senate.) This branch is responsible for making laws.

2. The Executive branch is made up of the president, vice president, cabinet members, and specific agencies. It is the job of the Executive branch to make sure that laws are carried out.

3. The Judicial branch is composed of the Supreme Court and the lower federal courts.

The Judicial branch interprets laws or explains laws.

The first three (3) Articles of the Constitution define the powers given to the above stated three (3) branches. Article I defines the Congress, Article II defines the Executive Branch, and Article III defines the Judiciary.

SEPARATION OF POWERS AND CONGRESS

The Constitution gives Congress numerous powers including the following:

1. Power over the budget and the authority to raise taxes, borrow money, and spend money;

2. Power to declare war and to raise and support military forces;

3. Power to regulate immigration, the mail, patents and copyrights, and commerce between the states and with foreign countries; and

4. Power to establish federal courts below the United States Supreme Court.

The Constitution divides legislative power in the Congress between the House of Representatives and the Senate. Both Houses must agree on proposed legislation before it becomes law. Congress also has the power to pass any laws that are "necessary and proper" to give effect to its named powers. Checks and balances on the power of our Congress are (a) the Presidential veto power on proposed legislation; however, a two-thirds majority of both the House and Senate is required to override a veto.

Centennial of the Pittsburgh Agreement set for May 31

All is in readiness for the 100th anniversary of the signing of the historic Pittsburgh Agreement set for May 31. The commemorative program will be held at the Heinz History Center in Pittsburgh, Pa. beginning at 6 p.m. The program will include presentations by various government officials from Slovakia and the Czech Republic. A reception will follow the formal program.

The signing of the Pittsburgh Agreement on May 31, 1918, was an important step in the course of events which led to the establishment of an independent Czecho-Slovak state after the First World War. Hosted by the Slovak League of America, the Czech National Alliance and Slovak American fraternal organizations, the group invited Professor Thomas G. Masaryk to Pittsburgh, who later became the first president of Czechoslovakia, to discuss the issue of Slovak autonomy for the new republic.

Admission for this memorable event is \$35.00 per person (no tickets will be printed). Admission can be purchased from Carol Hockman at carolh254@aol.com or from the Honorary Slovak Consul Joseph T. The medal as well as a 11/17-inch poster of the Pittsburgh Agreement at the cost of \$10.00 will also be available at the event or by contacting the contacts above.

In conjunction with the celebration, a symposium is scheduled for the afternoon of May 31 from 1:30-3:30 p.m. at the University of Pittsburgh in room 4130 of Posvar Hall. All are welcome to attend. The panel will include speakers familiar with Czech, Slovak and U.S. history during the years surrounding the signing of the Pittsburgh Agreement. Panelists will include Dr. Milada Polisenka from Anglo American University in Prague, Dr. Slavomir Mihalek from the Institute of History of the Slovak Academy of Sciences and Dr. Hugh Agnew from George Washington University.

Minutes from the SKS 2020 Committee Meeting March 7, 2018 – Conference Call

The meeting was called to order at 5:30 EST by chairperson Julie Ann Dobbs. Sister Dobbs opened with a prayer, followed by the Pledge of Allegiance led by committee member Kevin Conway. All committee members were in attendance.

Following a brief welcome from Sister Dobbs the SKS 2020 Committee Meeting Minutes from January 25, 2018 were reviewed and approved.

In preparation for this meeting, Sister Dobbs shared the updated data template and a focused document specific to the Board of Director roles for each comparison organization. The committee began by spending a great deal of time reviewing each organization's make up, and role specific information including:

- Board representation
- Elected/Hired/Appointed
- Full Time/Part Time
- Term length and if there are term limits
- Voting rights

This initial exercise of data review led to additional questions and desire for information. The committee agreed to gather data regarding salary, position qualifications (if any) to be shared prior to our next conference call. Generally speaking, it became clear that the current Slovak Catholic Sokol board structure is not too dissimilar to the comparison organizations with the exception of two outliers that are much larger in size. While there were identified differences in structure or attribute between even the like sized organizations the committee decided to acknowledge those differences and address them later in the process while preparing our final review and recommendation to the convention.

Sister Dobbs referred the members to the convention bylaw committee's proposed board structure changes including rationale statements. These were considered and discussed as follows:

1. Tax Exempt Status of the Fraternal Benefit System- a large number of states are challenging our status on an ongoing basis which would require the payment of taxes.

The tax exempt status and risk of revocation for fraternal organizations has been discussed for many years, both by the American Fraternal Alliance and our own leaders. The committee could not directly correlate this particular concern with need for change in governance.

2. Board Governance- this is a state by state occurrence that will eventually require all insurance companies to comply with the rules established by the NAIC.

The board felt that this statement may have led convention attendees to believe that the Slovak Catholic Sokol was not complying with currently established NAIC (National Association of Insurance Commissioners) rules. The following represents the requirements and our response:

• "Upon state adoption of the NAIC models and as early as June 1, 2016, each U.S. insurer or the in-

surance group in which the insurer is a member, must submit, a Corporate Governance Annual Disclosure (CGAD) to its lead state or domestic regulator on an annual basis."

An annual report of this nature has been required of the SCS for many years. The State of New Jersey requires this level of disclosure and it is also made available to other states (in which we are licensed) upon request.

• In the CGAD, insurers must document highly confidential information about their corporate governance framework, including the structure and policies of their boards of directors and key committees, the frequency of their meetings, and procedure for the oversight of critical risk areas and appointment practices, among other things. Insurers must also disclose the policies and practices used by their board of directors for directing senior management on critical areas, including a description of codes of business conduct and ethics, and processes for performance evaluation, compensation practices, corrective action, succession planning and suitability standards. This information will be utilized by insurance regulators to understand, review and assess the corporate governance practices of insurers to promote effective oversight on an ongoing basis.

The goal of the NAIC and the State of New Jersey is to ensure that there are qualified members on our Board of Directors and that the organization is in good hands. The State of New Jersey conducts regular scheduled examinations of our organization and has the authority to do so without notice. During these examinations, they review our bylaws and decision making processes. There has never been concern raised during these audits as to the governance structure of our organization. Additionally, we employ our actuary and accountant whose job it is to bring forward concern regarding the direction of our organization.

Question: Are we confident in the qualifications of our board members/positions to make sound financial decision for our organization?

Answer: We will review qualifications and compare them to our state of organizations. To that end, by employing our PNC investment advisors, we have added an additional layer of protection that several of our comparison organizations do not have. Our BOD makes financial decisions based on the sound advice of our advisors who add to our governance model. Lastly, over time we have engaged other financial advisors/organizations to provide their review of our financial investments, which in essence becomes yet another check and balance.

Supreme President Michael Horvath reminded us that one of the groups that we were asked to interface with were the Board of Directors, our auditor, accountant and financial advisor. Brother Michael suggested that this could be accomplished during next weekends' BOD meeting in Passaic, NJ. Sister

quired to override a veto; and (b) the Supreme Court's power to review the constitutionality of a law if it is challenged in a case brought before the Court.

SEPARATION OF POWERS AND THE EXECUTIVE

The Executive branch of our government is vested with the power as Commander-in-Chief of the armed forces; power to make treaties; nominate judges to the federal judiciaries, and appoint officers of the government subject to the advice and consent of the Senate; power to pardon individuals convicted of crimes; and oversight of federal agencies that implement laws passed by Congress. The President of the United States serves as the Chief Executive and is elected by the people for no more than two (2) terms. The checks and balances on the Executive power are (a) the Senate's power to ratify treaties the President has signed and to consent to the President's nominees for federal judge-ships and other governmental positions; (b) the power of Congress to impeach and convict for "treason, bribery, or other high crimes and misdemeanors;" and (c) the federal judiciary's power to declare executive actions unconstitutional if they are challenged in court.

SEPARATION OF POWERS AND THE FEDERAL JUDICIARY

The Judiciary's independence from political interference by the Legislature or the Executive branch is protected in the Constitution by life tenure during good behavior and a guaranteed salary. The judiciary's

power to review the constitutionality of Executive actions or laws passed by Congress is called judicial review. The judiciary's power is limited to the "cases and controversies" brought before the Court. There are numerous constraints within the Judiciary on the power of individual judges. Judges are required to explain their decisions in written opinions; they are required to follow the precedents established by the decisions of higher courts; and judges' decisions are subject to review by courts of appeals. The Executive and Legislative branches each have powers that check and balance the Judiciary. For example, the federal courts are staffed by judges nominated by the President. The courts rely upon the Executive branch for enforcement of their decisions. Congress has control over the judiciary's budget and has the power to impeach federal judges who misbehave in office. Congress also has the power of amending the Constitution if it disagrees with the Judiciary's interpretation of the Constitution.

IMPORTANCE OF LAW DAY

Separation of powers is a hallmark of most democratic governments, yet we seldom reflect upon the critical significance of the separation of powers to the rule of law. In fact, recent news concerning executive orders, court rulings, presidential nominations and confirmation hearings have brought questions about the roles of the three (3) branches of government to the center of national discourse. Our system of separation of powers and checks and balances has safeguarded our liberties and helped to ensure that

we remain a government of laws. As we think about the concept, we realize the interaction between the three (3) branches of government. The branches have their separate spheres and separate powers, but, collectively work together for the common good. Other institutions outside government also serve as checks and balances on the powers of the Executive, the Legislature, and the judiciary. These include the free press that can investigate and report on government actions, non-governmental organizations that advocate for different interests, and the power of the people in whom government authority ultimately rests. Consequently, each of us as individuals has a responsibility to act to ensure that our government works properly and protects us. Making the effort to be an informed citizen; contacting your local, state, and national representatives about issues that are important to you; attending town hall meetings; and most importantly, voting all help to ensure that all levels of our government serve the people.

CONCLUSION

The Law Day 2018 theme enables us to reflect on the principles of separation of powers and our role in the government as citizens. Let us take this opportunity to reflect and consider how power is shared in our government and how we can work together to preserve our liberties and advance our rights. On this Law Day, I urge you to embrace the separation of powers as your heritage. Respect it. Protect it. And on Law Day, celebrate it.

Section 4.1 of the Constitution and Bylaws lists the duties, obligations and responsibilities of the office of the Supreme President.

I want to begin by asking us all to remember and pray for all members of the Slovak Catholic Sokol, our family members and friends who have died in 2017. May their souls rest in eternal peace!

In the 112th year of the existence of the Slovak Catholic Sokol here listed for your review and approval is my report that summarizes my activities, meetings and events I represented the Slovak Catholic Sokol at as your Supreme President in 2017.

For the past 112 years the main mission of the Slovak Catholic Sokol has remained the same; provide financial security to its members via outstanding and competitive insurance and annuity products. While this is the mission our goal is to assure the membership the Society is financially sound and solvent. In 2017 I am proud to report the mission and goal were achieved. This is attributed to the leadership and guidance of our Supreme Secretary, Scott T. Pogorelec, F.I.C. and the dedicated Home Office staff he manages.

Our Supreme Secretary's ability to work with the Slovak Catholic Sokol professional advisors: PNC Bank, investment and portfolio manager, CPS Actuaries, insurance management manager, and Vision Financial Group CPA's LLP, accounting services has enabled the Society to increase our investments, assure our compliance, reporting and profitability and keeping financial concerns in order has proven to be the key to our success.

The Home Office staff does an outstanding job on a day-to-day basis to manage the Society's operations to assure excellent service to its members, Groups, Assemblies, Wreaths and independent sales force. This is a testament to their professionalism and dedication. I extend a very appreciative "Thank You" to all of you at the Home Office on behalf of the Supreme Assembly and all the members for the work you do behind the scenes for the Society.

2017 was an interesting year; the rhetoric of national and global news seemed to change daily making it sometime difficult to chart a clear direction. However, the stock market charted its own direction and started a course of record growth. The robust rise in the stock market proved to be a positive outcome for our Society. The Slovak Catholic Sokol saw its investment portfolio grow in 2017 from \$78,282,142 to \$85,490,534. However, our membership declined again by 295 in the same period. This membership decline is something the Board of Directors again has to watch in 2018 and look for ways to correct this trend. In 2017, new members continued to purchase higher insurance coverage which produces higher premium income.

As all know, the Slovak Catholic Sokol can only grow when new business is brought in every year. This new business also has to exceed the business that is lost. The new business that was brought in 2017 was through the efforts of our members and network of independent agents. I thank all of you and encourage you to continue the trend in 2018.

Let us remember, the Slovak Catholic Sokol is considered a small fraternal society by the American Fraternal Alliance's standards, but it excels over the large and ultra-large fraternal societies when it comes to membership activities and events. This makes the Society shine and is something all should be very proud of. The Slovak Catholic Sokol has to compete with all of the other fraternal societies for sales. Fraternal sales are not easy and with changing regulatory requirements by the State Insurance Departments make fraternal sales even harder. The equalizer in all of this is; all fraternal societies face the same inherited problems. These are the challenges our Director of Sales and Marketing, Albert J. Suess, Jr., F.I.C. faces as he works on product development, implementing regulatory statutes, maintaining the independent sale force network and Assembly and Wreath sales campaigns. Thank you Brother Al for all you did in 2017 for the Society.

In 2017 the Society solved one of its problems; it was able to find a renter for the first floor rental unit. In September all details were worked out with a Day Care organization to rent the space on the first floor. This will generate additional income for the Society to help with our Home Office overhead costs. Another update, there were several investors interested in the Ambridge, PA property this year but the property remained unsold. The Society is still working with the real estate agent and our local representatives to find a buyer for the property.

First Quarter - I attended the annual meeting of the Supreme Physical Fitness Board, January 20-22, 2017 in Cleveland, OH. At the meeting I extended greeting to the Supreme Physical Fitness Board on behalf of the Board of Directors and participated in their discussions. The SPFB meeting gave me and our Supreme Secretary, Scott T. Pogorelec, F.I.C. the opportunity to do hotel site inspections to prepare for our 33rd quadrennial Convention in 2019.

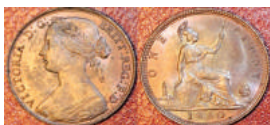

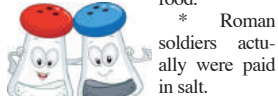

Teach your children money basics

April is Financial Literacy Month. It is the time to teach our children the financial facts of life. Here are six simple ways to help your kids be smart about money in everyday moments:

You need money to buy things

Take a trip to a store with your children this month, rather than buying online. While you're there, tell them what you're doing. Kids as young as 3 can understand basic money concepts like exchange (you give the cashier money, you get the stuff you want) and value (a car costs more than a carton of milk).

You get money by working

Money can seem like magic to kids, especially when we use cards or apps. So it's important to explain that it doesn't appear out of thin air. You work hard to earn the money to pay for food, clothes, and everything else. Talk about the different jobs people have—teacher, doctor, firefighter. And if you can swing it, take your child to work this month. It will be fun for you—and an eye-opener for your child.

You need to wait and save up for something you want

Show them how patience pays off. We wait for our turn on the swings. We wait for our birthday. Encourage your kid to forgo small purchases (candy, stickers) and

instead put cash in a piggybank to save up for a bigger toy (a Lego set!) he or she really wants.

Buy what you need before you buy what you want

While you're shopping, point out the differences between needs and wants: "We need milk and veggies; we want chocolate milk and potato chips." Then it's your kid's turn. As you walk down the aisles, ask: "Want or need?" Needs go in the cart. All but one or two wants stay on the shelves.

A bank is the safest place to keep your money

By age 5, your kid is ready to open a bank savings account. Look for an actual brick-and-mortar bank, so he or she can get the full experience. And before you pay a visit, make sure you find a no-fee account. (A number of banks have these for young savers—or will offer them if you bank with them, too.)

You should only buy what you can afford.

Use cash in front of your kids—and show them that you need to make choices in a store. If you give your kid an allowance, do so with dollars—not debit cards. Not only does cash help with counting and math skills, but research shows people spend less when they use actual dollars rather than plastic.

Bratislava Boys Choir in Concert at New York Slovak Church



New York's United Parish of St. John Nepomucene, St. John Martyr and St. Frances Xavier Cabrini hosted Slovakia's renowned Bratislava Boys Choir at a wonderful concert on Saturday evening, March 10. The acoustically-splendid Church of St. John Nepomucene made for the perfect venue for the concert.

The Bratislava Boys Choir was founded in 1982 by Magdalena Rovnakova. Since then the ensemble, has performed across Europe as well as in Russia, Japan, Canada and the United States. This is the third visit to the United States by the choir

and the first one to perform in New York City. The concert was hosted by the office of the Slovak Consul General in New York. The choir performs across Slovakia and while in the country's capital at various venues, however the Reduta, home of the Slovak Philharmonic Orchestra is generally its home base. At the New York concert, the 27-voice ensemble performed an array of classical, contemporary and folk works in Latin, German, English and Slovak.

The concert concluded with the choir singing beloved Slovak folk

songs to the delight of the near-capacity crowd who join in at the historic Slovak church. Shown on the photo are the Rev. Richard D. The Grassalkovich Palace (Slovak: Grasalkovicov palác) is a palace in Bratislava and is the residence of the president of Slovakia. The building is a Rococo-late Baroque summer palace with a French garden. The building was finished in 1760, by architect Anton Mayerhofer for the Croatian noble and Croatian aristocrat Antal Grassalkovich, a close friend of empress Maria Theresa. It features many rooms and an impressive staircase. During the 1939–1945 period, the palace became the seat of the president of the First Slovak Republic Jozef Tiso. In 1950, the building was turned into the "Klement Gottwald House of Pioneers and Youth" (Dom pionierov a mladeze Klementa Gottwalda), which was an activity center for Bratislava's schoolchildren, all of whom were so-called pioneers at that time. The schoolchildren caused extensive damage to the palace, and the necessary restoration only became possible following the transition from Communism in late 1989 with the Velvet Revolution. The restoration of Grassalkovich Palace during the early 1990s was overseen by the inaugural First Lady of Slovakia, Emilia Kováčová. Following its restoration, the palace became the residence of Slovakia's president on September 30, 1996. Its once-large gardens are now a public park, complete with a statue of Bratislava-born composer Jan Nepomuk Hummel.

FICO RESIGNS AS PRIME MINISTER, PELLEGRINI TO FORM NEW CABINET

On Thursday, March 15 Robert Fico (Smer-SD) stepped down from the post of Slovak prime minister, as he handed over his resignation to President Andrej Kiska.

Fico's Government resigns as well, with the ministers keeping their posts until a new cabinet is appointed.

At the same time Kiska tasked Vice-premier Peter Pellegrini (Smer-SD) with setting up a new government. Pellegrini earlier on Thursday delivered to Kiska signatures from 79 MPs supporting the new government.

Fico decided to step down from his post after a two-week coalition crisis that emerged following the murders of investigative journalist Jan Kuciak and his girlfriend Martina Kusnirova. Marek Madaric was first to resign on the post of culture minister over the murder, while the resignation of Robert Kalinak as the interior minister followed a week later.

PRESIDENT KISKA APPOINTS NEW GOVERNMENT LED BY PETER PELLEGRINI

Peter Pellegrini (Smer-SD) has become the new prime minister of the Slovak Republic, replacing Robert Fico (Smer-SD) in this post. President Andrej Kiska appointed Pellegrini to the post on Thursday, March 22. Subsequently, he also appointed the remaining members of the new Government.

Pellegrini has assumed the top executive post after taking an oath prescribed by the Constitution.

As part of the reshuffling of personnel, aside from the new prime minister, Richard Rasi (Smer-SD) has become new vice-premier for investments and informatisation, Tomas Drucker (a Smer-SD nominee) interior minister, Andrea Kalavská (a Smer-SD nominee) health minister, Lubica Lassakova (Smer-SD) culture minister and Gabor Gal (Most-Hid) justice minister.

Other ministries have not seen changes at their helm. Peter Kazimir (Smer-SD) remains the finance minister and concurrently holds a vice-premier post. Miroslav Lajcak (a Smer-SD nominee) remains the Foreign and European Affairs Minister, Peter Ziga (Smer-SD) economy minister and Jan Richter (Smer-SD) the labour, social affairs and the family minister.

Gabriela Matecna (a Slovak National Party/SNS nominee) remains at the helm of the Agriculture and Rural Development Ministry, while Peter Gajdos (SNS) continues to lead the Defence Ministry and Martina Lubyova (a SNS nominee) the Education, Science, Research and Sport Ministry. Arpad Ersek (Most-Hid) remains the transport and construction minister and Laszlo Solymos (Most-Hid) the environment minister. Solymos has also become a vice-premier in the new Government.

Subsequently, the new Cabinet will meet at its first session and pass its Government Manifesto. The confidence vote in the new Government in Parliament took place on Friday (March 23).

The reshuffling of personnel came as a result of the government crisis that occurred after the murders of journalist Jan Kuciak and his girlfriend, as well as other circumstances including the release of information on top governing politicians' alleged links to the Calabrian Mafia.

PELLEGRINI DISCUSSES INVESTIGATION INTO JOURNALIST'S MURDER IN BRUSSELS

The investigation into the murders of journalist Jan Kuciak and his fiancée Martina Kusnirova is a complex case, yet the Government will do its utmost to have it resolved, Prime Minister Peter Pellegrini (Smer-SD) said on Thursday after arriving to what is his first EU summit in Brussels in

his new role.

When asked by foreign journalists about the progress of the investigation into the double murder, Pellegrini conceded that he's not familiar with the details at this moment.

"It's the most massive investigation in the history of Slovakia. This case has seen the greatest amount of police officers assigned to it since the creation of Slovakia, almost all elements are busy with it," said Pellegrini.

Pellegrini added that Slovak investigators on the case are also engaged in cooperation with international organisations, Italian police and other partners, all of whom "want to help us".

"It's a complex case and finding the perpetrators will be extremely important. We'll do our utmost to make it happen, as that's important not only to the Government, but also to people and the bereaved that we find the truth," he claimed.

SLOVAK PRODUCTS SHOWCASED AT WORLD'S LARGEST FOOD EXPO IN DUBAI

A total of nine Slovak food companies for the first time ever presented their products at the world's largest food and beverages exhibition entitled Gulfood Dubai, which took place between February 18-22 in Dubai.

"If we want our food producers to be successful, it won't be possible without marketing and presentation. We have decided to be much more active and help our food and drink producers to present themselves abroad and introduce them on new markets. We have managed to get nine Slovak food companies to Dubai where their products are showcased on the spot," stated Agriculture and Rural Development Minister Gabriela Matecna (a Slovak National Party/SNS nominee) at the exhibition.

"As part of our business mission, we are accompanied by representatives from another 18 (Slovak) companies that have had an opportunity to establish important contacts here. Even though Slovakia can not compete in the amount of production, it surely can in the quality of food," she added.

Michal Feik of the Agriculture Ministry further told TASR that as many as 5,000 companies from more than 120 countries worldwide exhibited their products at the food fair. This year, for the first time ever, Slovakia had a national exhibition at the event. It was organised by the Slovak Investment and Trade Development Agency (SA-RIO) in cooperation with the Agriculture Ministry.

Matecna also held talks in Dubai with Cabinet members of the United Arab Emirates (UAE), including UAE's Deputy Prime Minister and Presidential Affairs Minister Mansour bin Zayed Al Nahyan. The talks focused mainly on investments and research in the field of food security and food monitoring, cooperation in horse breeding, equitation and falconry as well as environmental, water quality and energy issues.

63% OF FOREIGN COMPANIES POSITIVELY ASSESS SLOVAKIA'S ECONOMIC SITUATION

A survey presented at a press conference by the Slovak-German Trade and Industry Chamber (SNOPK) on March 26 showed that the current economic situation in Slovakia was evaluated positively by 63 percent of the foreign companies polled, up by 18 percent compared to a year ago.

Only 3 percent assess the situation as bad. Some 41 percent of businesses expect the economic situation to further improve over the year. Half of the survey participants

expect an unchanged overall economic situation.

Expectations of development in individual companies are even more optimistic, with 44 percent of companies counting on better deals, and only 8 percent of companies preparing for a worse economic year. Approximately 47 percent of companies would subsequently want to increase the number of their workers and 41 percent also want to increase their investments.

On a limestone cliff of 711 m over Stará Lubovna in the north-east of Spis stands Lubovna Castle. The castle was built at the turn of the 13th and 14th century, when it became a part of the boundary castles system in the north of the Hungarian Kingdom. Besides the protection of the former Polish-Old Hungarian border, its task was to secure the important trade route passing along the valley of the Poprad river to Poland. Through a reconstruction accomplished after a great fire in 1553, the Lubovna Castle obtained a modern shape of a Renaissance fortress. After the return of the Spis towns to Old Hungary, the role of the Castle diminished and the Castle itself fell into decay. Later on the Castle was successfully reconstructed and the castle museum exhibitions have been installed there. In 1991, the castle chapel was reconstructed and re-consecrated. Regular church services are still held there. An independent museum exhibition is presented by an open air museum in the area at the foot of the castle hill. It consists of a set of folk buildings that form a picturesque settlement around the Castle.

The amount of Premium Income received during the year was \$7,397,231 of which \$2,042,970 was for life insurance premiums and \$5,354,261 was received as annuity premiums. The face amount of insurance written totaled \$16,028,098 and the total amount of insurance in force was \$228,596,320. The Society has 28,006 members with 30,695 certificates in force and 91 Assemblies/Wreaths. Assets as of 12/31/2017 were \$84,206,925 and the Unassigned Funds total \$8,273,599. The Solvency ratio is a financially strong 111%.

ACTIVITIES AND DUTIES

During the year 2017, I was able to enroll 16 new members into our organization with a total face amount of \$127,000 in insurance.

REPORT OF THE GENERAL COUNSEL

In accordance with Section 4.13(j) of the Slovak Catholic Sokol Constitution and By-laws, this report is hereby submitted to the Board of Directors for the purpose of advising of the activities of the Office of the General Counsel during calendar year 2017. I have endeavored to fulfill all duties and obligations of my office to the best of my ability for the good and welfare of the Slovak Catholic Sokol.

As General Counsel, I continue to render legal opinions to our Supreme President, Supreme Secretary and other Supreme officers upon their request concerning day to day operations of our home office. When it becomes necessary, I have prepared memorandums, opinions, and communications relative to the business of the Slovak Catholic Sokol with various levels of government. Earlier this year, at the request of Supreme Secretary Scott T. Pogorelec, F.I.C., and Albert Suess, Director of Sales and Marketing, I drafted and prepared a legal opinion concerning the issue of fraternal agent licensing requirements and exemptions for the states that the Sokol conducts business or is proposing to conduct business. In that opinion, I analyzed on a jurisdictional basis the licensing exemptions for fraternal agents based on 1) the status of an agent (full time vs. part time), 2) the number of policies sold by an agent, and/or 3) the amount of insurance sold annually by an agent.

During the past year, my office continued to review new state and federal legislation concerning policy and development pertaining to fraternal benefit societies. I review the legislative bulletins which report on the regular sessions held by Legislatures in the various states in order to determine whether pending legislation will have an adverse effect on our ability to do business within a particular state.

On the national level, major tax changes approved by Congress in the Tax Cuts and Jobs Act became law on December 22, 2017. The good news for fraternal benefit societies is that our long standing tax exempt status is preserved and maintained in the various tax reform measures. Fortunately, during policy discussions, debates and deliberations, the United States Congress recognized the value of fraternal contributions to the American economy and social fabric. The history of fraternal benefit societies and the significant religious and benevolent activities fraternal members engage in through their local lodges help explain why Congress originally A exempted organizations like the Sokol from income tax in 1909.

Now that the century-old provision remains in place, we need only be concerned that there remain no political threats emanating on the state level where fiscal pressures may force local legislatures to look for new income sources to balance budgets. A threat to the tax exemption in any state is a threat to our business model everywhere. With that said, it is anticipated that the Slovak Catholic Sokol can continue to serve its members in each state where we are licensed to do business with tax exempt resources.

In addition, it is my responsibility to ensure that our organization is in compliance with federal and state controlling legal authorities and that our Directors and Officers understand the provisions of each particular act. In the regulatory field of law, this year the Department of Labor has begun to implement the first phase of a series of new regulations commonly referred to as the Fiduciary Rule. These rules were promulgated to improve consumer access to retirement information to help Americans achieve their financial security goals. The law specifically applies to our organization's sales agents, when involved in transactions pertaining to funds from an IRA or other retirement plans subject to Title I of the Employment Retirement Income Security Act of 1974 ("ERISA"). With regard to compliance, fiduciary advisors have an obligation to adhere to an Impartial Conduct Standard when making investment recommendations. Simply stated, this means advice by agents must be in the best interests of the members regardless of the interests of the agent or the society; no false or misleading statements; and reasonable compensation.

Throughout the year, the practical application and enforcement of the law has led to multiple legal challenges, numerous policy debates and mounting political pressures stemming from opponents in the financial services industry and advocates favoring stronger consumer protection laws. Consequently, late last year, the Department of Labor postponed the applicability date of the rule's compliance deadline until July 1, 2019 in order to solicit further public comment and to re-examine the law's impact on access to retirement information. This could lead to significant revisions to the regulatory framework governing financial advisors, brokers and insurance agents. I will continue to closely monitor developments and advise the Board of Directors accordingly.

In matters concerning litigation, there were no lawsuits filed during the past year. I previously informed you that the lawsuit concerning the assets of Assembly 206 in Ambridge, Pennsylvania has been settled. Nevertheless, the Board of Directors continues its diligent efforts to market and sell the property owned by Assembly 206. With the assistance of a listing

agent retained in Pennsylvania, I continue to receive updates concerning prospective inquiries and showings. I have participated in numerous telephone calls, electronic mail communications and discussions with all interested parties. I have further reviewed and approved as to form and legality the updated commercial listing contracts and I anticipate that market activity will increase this year. Through continued collaborative efforts, I am hopeful that 2018 will be the year that the property is sold.

Last year, I reported on the successful efforts to secure a new tenant to occupy the first floor of our home office for the use of a children's day care facility. I am pleased to report that the lease was officially finalized and executed this past year, that the tenant has assumed occupancy and possession and is current with monthly rental payments.

The Slovak Catholic Sokol continues to offer a mortgage program to the membership and lodges in an effort to further the good will and fraternalism among our members. When a mortgage loan is granted, it is my duty to supervise and review all necessary paperwork to ensure that the Slovak Catholic Sokol has a first lien on the property. Currently, our portfolio has three (3) existing mortgages. All mortgage payments are current and being received on time. No new applications have been received for presentation during the past year. Since our rates of interest and terms are indeed competitive with commercial lenders, it is recommended that our members consider securing a mortgage through the Slovak Catholic Sokol.

As a member of the Board of Directors, I have attended all of the quarterly meetings called by our Supreme President. One (1) quarterly meeting was conducted by conference call in an effort to reduce expenses. I also had the pleasure of attending this year the biennial meeting of the Group Presidents. My participation at the meetings is well documented in the minutes of these meetings published in our Sokol paper, the Slovak Catholic Falcon. During the course of its meetings and deliberations, the Board of Directors has been carefully evaluating costs in order to reduce expenses wherever possible. Our expenditures on our fraternal programs exceed the income we are receiving from our investments and our insurance premiums paid by the membership. Nevertheless, the governing body has been adhering to the fiscal recommendations of our professional advisors in order to improve the growth, progress, and success of the organization. Based on the foregoing, the Slovak Catholic Sokol continues to remain a solid financial institution.

The stock market had an impressive year and our financial portfolio remains strong and continues to grow. The Federal Reserve raised interest rates three (3) times in 2017. Recently released minutes of the Federal Open Market Committee reflect optimism about future economic growth in the wake of the recent appointment of the new Federal Reserve Chairman. In addition, three (3) more interest rate increases are expected in 2018. Our investments should continue to benefit notwithstanding the market volatility, as we begin a new era in monetary policy.

As I have in the past, I attended the American Fraternal Alliance Annual Meeting in Phoenix, Arizona. The opportunity to gather with the officers of other fraternal organizations fostered an expansion of knowledge and appreciation of fraternalism that is crucial to the growth of our own organization. In addition, I had the pleasure of attending this past year the biennial meeting of Group Presidents in Cleveland, Ohio. Topics discussed included group activity, fraternal programs, interaction with the home office and groups, spiritual matters, and new ideas to energize the groups. The interaction between all group presidents resulted in a lively meeting which was a complete success. In addition, I continue to attend as many Sokol functions as time permits, and am active in my local Assembly and Group, holding the office of President in both. Throughout the year, I have submitted articles and reports to our Sokol newspaper for publication to keep our membership advised of ongoing activities within the fraternal benefit system.

In conclusion, as we proudly celebrate our 113th Anniversary, I wish to extend my thanks to my fellow Supreme Officers for their contributions to strengthen our organization by making decisions in the best interest of our beloved Slovak Catholic Sokol. May the Board of Directors conduct all deliberations in the spirit of fraternalism.

Historic Church of St. Margaret of Antioch in Kopčany, Slovakia



The Church of St. Margaret of Antioch, near Kopčany, Slovakia, is one of still standing churches for which the Greater Moravian origin is considered. It is among the oldest churches in Slovakia. The church was built probably in the 9th or 10th century and was first mentioned in 1329. It was used until the 18th century when a new church was built in the village of Kopčany.

The church is an original pre-Romanesque building. It is a single-cell church with small rectangular chancel to the east chancel. The recent excavations have shown that the original church had a rectangular narthex at the west end of the church, and this contained a large stone lined tomb for the founding

figure of the church. When the narthex was pulled down, the Gothic arch which formed the entry at the west end was inserted.

Since 1995, the church has been listed under Slovak cultural heritage. The outside of the church is openly accessible to the public. It stands in a field to the east of Kopčany and it is about 1 mile from the major Greater Moravian site at Mikulčice, which is on the other side of the Morava river. It is approached by a road and is fairly close to the ruins of a 16th-17th-century building which may have been a farm or manor house.

The small church near the Czech-Slovak border has long been considered a baroque chapel and its

dating had a stormy development. The first architectural survey of the church was conducted in 1964 and refined dating to gothic period. In 1996, Viktor Ferus published a hypothesis about the Great Moravian origin of the building. During investigations in 2004, three graves and jewelry from the time of Great Moravia were found outside the church. The position of graves already respected the position of the church and the graves contained mortar from the building and the size and shape of fragments indicates that they originate from the construction phase and not later destruction. In that times, the church was considered to be the only one still standing Great Moravian building in Czech and Slovak republics. The key challenge is to validate if the mortar could be introduced to the older horizon during excavating of the younger graves. In 2013, a collective of authors analysed a piece of wood from the building by dendrochronology, declaring that it can be dated to 951 what shifts the construction phase to the 2nd part of the 10th century, between the fall of Great Moravia and the foundation of the Kingdom of Hungary. Neither of these results were universally accepted and are under further validation.

Currently, archaeological research is focused on the reconstruction of the historical landscape and its settlements. Also during this period the church has undergone further restoration work and the old render has been stripped from the walls. This now shows that the two arched windows on the north side of the nave are original while the windows on the south side were altered in the later Romanesque period. – Wikipedia

According to the investors, Slovakia is a typical state for EU membership: it has a productive workforce, the willingness to deliver performance at a relatively low cost, as well as the availability and quality of local suppliers.

Slovakia was generally viewed by the survey participants as the second most attractive investment site in Central and Eastern Europe. As in previous years, the Czech Republic ended up in first place, and Estonia and Slovenia ranked third and fourth. The share of companies that would invest again in Slovakia, even under the current conditions, remains stable at 80 percent.

Regarding negatively perceived factors, no improvement has been observed by the investors. Workforce availability is still perceived critically. Many companies are increasingly worried about the development of labour costs. In addition to labour shortages, the pressure on salary levels is also caused by a significant increase in the minimum wage and bonuses for night and weekend work.

Regarding the status of Slovakia's fight against corruption, the investors are very dissatisfied. They presented the worst evaluation in this regard since the survey's introduction in 2004.

In addition to SNOBK, the survey was also organised by the Dutch Chamber of Commerce in Slovakia, the Swedish Chamber of Commerce in Slovakia, the Slovak-Austrian Chamber of Commerce, and Advantage Austria Bratislava in February and March 2018. The survey polled 131 companies operating in Slovakia.

COURT RULES THAT UBER MUST STOP OPERATING AND MEDIATING TAXI SERVICE

The company Uber must stop operating its taxi service in Slovakia, as it uses persons and vehicles that fail to meet requirements set by Slovak legislation, TASR learned from the Civic Association of Licensed Taxi Drivers (OZKT) on Tuesday, March 27.

Uber is not allowed to mediate its taxi service with drivers that fail to meet the same conditions required from taxi drivers, according to a Bratislava I District Court verdict issued in mid-February. This means that the company will have to switch off its mobile application in Slovakia.

The court's decision was the result of a complaint filed by the OZKT against Uber in January. The OZKT welcomed the valid and enforceable verdict on taking immediate action against Uber. "We find this verdict to be the logical outcome of our several-month-long fight for equality in business in the field of taxi services. The court fully identified itself with our claims, thus confirming the fact that Uber was mediating taxi services through drivers and vehicles that are at odds with Slovak legislation and harm the business environment," OZKT representatives have told TASR.

Uber must stop providing its taxi services immediately, as the deadline for appeal has already lapsed, which means the verdict is valid and there's no possibility to contest it.

Over 100,000 users have registered with the Uber application in the more than two years of its operation on the Slovak market. Bratislava taxi drivers have repeatedly protested against Uber since its arrival, claiming that it was ignoring Slovak legislation. With its extremely low prices, the service was distorting the business environment. Taxi drivers have been declaring for long time that they do not oppose these mobile applications as such, but that they only want equal business conditions and adherence to the law by all.

April 22 is Earth Day

Earth Day is an annual event celebrated on April 22. Worldwide, various events are held to demonstrate support for environmental protection. First celebrated in 1970, Earth Day events in more than 193 countries are now coordinated globally by the Earth Day Network.

On Earth Day 2016, the landmark Paris Agreement was signed by the United States, China, and some 120 other countries. This signing satisfied a key requirement for the entry into force of the historic draft climate protection treaty adopted by consensus of the 195 nations present at the 2015 United Nations Climate Change Conference in Paris.

In 1969 at a UNESCO Conference in San Francisco, peace activist John McConnell proposed a day to honor the Earth and the concept of peace, to first be celebrated on March 21, 1970, the first day of spring in the northern hemisphere. This day of nature's equinox was later sanctioned in a proclamation written by McConnell and signed by Secretary General U Thant at



the United Nations. A month later a separate Earth Day was founded by United States Senator Gaylord Nelson as an environmental teach-in first held on April 22, 1970. Nelson was later awarded the Presidential Medal of Freedom award in recognition of his work. While this April 22 Earth Day was focused on the United States, an organization launched by Denis Hayes, who was the original national coordinator in 1970, took it international in 1990 and organized events in 141 nations.

Numerous communities celebrate Earth Week, an entire week of activities focused on the environmental issues that the world faces.

Potraviny, ktoré znižujú vysoký tlak

Vysoký krvný tlak často nebýva sprevádzaný žiadnymi príznakmi. Preto sa nazýva aj „tichý zabijak“. Môže poškodiť organizmus mnohými spôsobmi. Predovšetkým zvyšuje náhamu srdca a ciev. Pretože srdce musí po dlhé obdobie pracovať ťažšie ako za normálnych okolností, má snahu zväčšiť sa – steny hrubnú (hypertrofia srdcového svalu). Mierne zväčšené srdce môže pracovať dobre, ale ak sa zväčší príliš, môže to spôsobiť veľké problémy. Jedným z najčastejších príznakov je dýchavica po fyzickej námahe. Za optimálny vysoký tlak sa považujú hodnoty nižšie ako 120/80. Pri tlaku 130-139/85-89 hovoríme o prehypertenzii a je vysoká pravdepodobnosť, že sa vyvinie skutočná hypertenzia.

Liečivé účinky potravín

U mnohých potravín sa zistilo, že pomáhajú znižovať krvný tlak. Patri k nim aj sója, obilné vločky, čerstvá šťava z červenej repy zmiešaná s medom, zeler, uhorka, prípadne uhorková šťava, zelená listová strava, kiwi, hrozno a červený melón.

Cibula znižuje vysoký krvný tlak a obsah tuku v krvi, navyše rozpúšťa krvné zrazeniny.

Pravidelné užívanie cesnaku prináša výrazné a často úplne uspokojivé zníženie tlaku. Za rozumnú dávku sa uvádza 1

strúčik na osobu a deň alebo po 2-3 týždne 1-2 strúčiky cesnaku s týždennou prestávkou.

Chorým s vysokým krvným tlakom sú odporúčané grapefruity, pretože je v nich veľa draslíka, ktorý pôsobí proti hypertenzii. Na poprednom mieste medzi potravinami určenými osobám trpiacim vysokým krvným tlakom patria banány s veľkým množstvom dôležitého draslíka. Jeden banán obsahuje dostatočné denné množstvo draslíka, potrebné k udržaniu normálneho krvného tlaku a funkcie srdca.

Včeli med nie je len sladidlom do čaju, ale aj potravinou s liečivým účinkom. Okrem hodnotných minerálnych látok obsahuje aj enzýmy, napr. acetylcholin, znižujúci krvný tlak.

Obmedzenie konzumácie tukov, najmä živočíšnych, by malo mať vplyv na zníženie vysokého tlaku. Vyhnajte sa tiež príliš sladkým pokrmom, zákuskom a sladeným nápojom. Pozor na kofeín a alkohol! Obmedzte pitie kávy, všetkých kofeínových nápojov a alkoholu, pretože mnohé štúdie potvrdzujú, že majú vplyv na zvýšenie krvného tlaku.

Ak máte nadváhu, snažte sa schudnúť. Cvičenie i relaxačné techniky sú overené spôsoby, ako znížiť riziká všetkých cievnych a srdcových ochorení.

Kým počas vlaňajšej sezóny nezahynul žiaden skialpinista, v tejto sezóne si hory vzali životy až piati. Najviac smrteľných nehôd v Nízkyh Tatrách. Najviac obetí si vyžiadali Nízke Tatry, kde zahynuli traja skialpinisti. Počas tejto zimy zasahovali 116-krát aj pri turistoch, najviac vo Vysokých Tatrách.

Na filmovom festivale vo Washingtone premietali aj snímku o Tatrách

Vo Washingtone D.C. sa 18. marca začal najväčší festival enviro filmov na svete - Environmental Film Festival in the Nation's Capital. Medzi vyše stovkou filmov z celého sveta sa priamo v premiére predstavil aj jeden slovenský - Tatra Mountains: Life on the Edge. Jeho autor Erik Baláž.

Cieľom filmu je ukázať citlivé vysokohorské prostredie najmenších veľhôr na svete a poukázať na potrebu jeho ochrany.

Cieľom anglickej verzie filmu je podobne ako v prípade slovenských filmov ukázať citlivé vysokohorské prostredie najmenších veľhôr na svete a poukázať na potrebu jeho ochrany. Zachytáva život kamzíkov, svišťov, medvede, orlov a ďalších zvierat, pričom najzávažnejšie sú zábery

rysov vo vysokohorskom prostredí.

Film nakrútili tri roky. Spolu 1500 dní v teréne. Bolo to extrémne náročné a občas aj nebezpečné.

Film mal na festivale premiéru v jednom z hlavných premietacích časov - v nedeľu popoludní v jednej z hlavných budov festivalu, v Carnegie Institution for Science. Po premietaní nasledovala diskusia, na ktorej sa Erik Baláž zúčastnil spolu s riaditeľom Ekotopfilmu Petrom Límom.

Festival trval do 25. marca a zúčastnilo sa ho viac než 30.000 návštevníkov. Environmental Film Festival in the Nation's Capital je nielen najväčším svojho druhu na svete, ale aj najstarším v USA. Konal sa už po 26. raz.

V Demänovskej doline objavili unikátnu jaskyňu



Územie Slovenska je mimoriadne bohaté na jaskynné priestory, ktoré vznikali počas miliónov rokov pôsobením kameňa, vody a vzduchu.

V Demänovskej doline sa v súčasnosti nachádza zhruba 300 jaskýň a väčšina z nich má súvis s viac ako 40 kilometrov dlhým Demänovským jaskynným systémom. Jednou z nich je aj jaskyňa Chladivý dych, ktorú nedávno objavili a preskúmali členovia Jaskyniarskeho klubu Demänovská Dolina. Viac ako 600 metrov dlhá jaskyňa vo svojich útrobách ukrýva tajomstvá

staré milióny rokov.

Na Slovensku je sice približne 80 jaskýň dlhších alebo rovnako dlhých, podľa predsedu speleoklubu Pavla Hericha je však z vedeckého pohľadu veľmi zaujímavá, napríklad z hľadiska klímy. Vzduch tam totiž v určitom období silne pulzuje. Existuje len málo jaskýň, ktoré majú takúto klímu. Navyše je kryogénne silno porušená, čo znamená, že v ľadových dobách bola pravdepodobne vyplnená ľadom a deštrukcia sintrových nátekov, kvapľov, stalagmitov, stalaktitov a pagod bola mimoriadna.

Vyšla nová vedecká ročenka Slováci v zahraničí



Takmer 400 stranová vedecká ročenka Slováci v zahraničí vyšla vo Vydavateľstve Matice slovenskej už po 34. krát. Recenzie ročenku posúdili doc. PaedDr. Pavol Parenička, CSc. a PhDr. Peter Mulík, PhD. Zostavovateľsky sa pod ňou podpísali Gabriela Hamranová a Zuzana Pavelcová.

Tridsiaty štvrtý ročník zborníka je osobitý najmä vďaka vyššej vedeckej úrovni, ktorú zabezpečila stať venovaná 110. výročiu založenia Slovenskej ligy v Amerike. Táto kapitola je písomnou reflexiou odborného vedeckého seminára s medzinárodnou účasťou, ktorý v júni 2017 usporiadalo Krajanské múzeum Matice slovenskej.

Kapitola zachytáva nielen zdravicu z pera generálnej tajomníčky Slovenskej ligy v Amerike, Niny Holej, ale i spomienkový príspevok Jána Holého, čestného predsedu tejto inštitúcie. Stať obsahuje šesť odborných štúdií zaoberajúcich sa prevažne dejinami Slovenskej ligy v Amerike.

Ďalšiu kapitolu zborníka s názvom Štúdie otvára príspevok Petra Karpinského. Analyzuje text publikácie Praktický slovensko-anglický tlumač, ktorú v roku 1905 vydal v USA Pavol K. Kádák. Anna Kováčová sa zaoberá dejinami Slovákov v Angyalfölde, ktoré zachytili dobové periodiká. Štúdia Jany Sivičkovéj sa zaoberá analýzou myslenia vojvodinského Slováka Andreja Siráckeho prostredníctvom jeho článkov publikovaných v Slovenskej jednote v období 1942

– 1943. Patrik Šenkár poukazuje na dôležitosť súdobých ideí spoločenskej situácie Slovákov v dualistickom Rakúsko-Uhorsku. Uvádza životné peripetie Ondreja Seberíniho, ktorý svoj život prežil na Dolnej zemi. Príspevok Ivana Šušu sa orientuje na súčasnú slovenskú literatúru v prekladovom kontexte. Autor sa zaoberá dejinným exkurzom do prekladov slovenskej literatúry do taliančiny, okrajovo autormi, ktorí čerpali z talianskeho prostredia a prenosom slovensko-talianskych motívov do oboch literatúr.

Kapitola Pramene a materiály uvádza príspevok Claudeho Baláža. Ponúka prierez legislatívou európskych štátov, rozvídza genézu legislatívnych procesov a vznik zákonov v súvislosti s vysťahovalectvom, migráciou, emigráciou od čias Rakúsko-Uhorska po dnešok. Autor Ján Marko sa na príklade svojich predkov z rodov Aláč a Aranyi venuje dejinám Slovákom v Maďarsku. Pramenný materiál Jána Jančovica sa zameriava na prvé dve storočia zachovávanie slovenskosti osídlencov a zakladateľov terajšieho mesta Piliš v Peštianskej župe zo začiatku 18. storočia až po koniec 19. storočia. Príspevok Agáty Jedrzejczykovej sa zaoberá dejinami Miestnej skupiny Spolku Slovákov v Novej Belej (Poľsko).

Zborník uzatvára kapitola Výročia, jubileá, správy a recenzie. Spomienkové príspevky Petra Cabaďaja sa zaoberajú osobnosťami Františka J. Fugu a Ladislava Jankoviča. Recenzia Gabriely Hamranovej podáva hodnotiace stanovisko publikácie Slovenské písomníctvo v Maďarsku po roku 1989, v autorstve Alžbety Uhrinovej. Dušan Mikolaj svoj príspevok venuje životnému jubileu Claudeho Baláža. Katarína Mosnáková (Pokračovanie na str. 23)

Spoločnosť tak ešte viac posilní svoje postavenie najväčšieho súkromného zamestnávateľa. S novými pracovníkmi by totiž mal celkový počet zamestnancov prekročiť od budúceho roka hranicu 14-tisíc.

○ Len za posledné tri roky pritom Volkswagen Slovakia vytvoril 2 900 nových pracovných miest. Pre porovnanie, britsko-indická automobilka Jaguar Land Rover plánuje vo svojom novom závode pri Nitre do roku 2020 zamestnať 2 800 pracovníkov. Vlni za týmto účelom spustila náborovú kampaň, v rámci ktorej hľadá tisíc ľudí. Bratislavský Volkswagen ku koncu vlaňajška zamestnával už 13 700 ľudí.

○ Sociálna poisťovňa evidovala ku koncu januára tohto roka vyše 1,39 milióna dôchodcov na Slovensku. V porovnaní s januárom minulého roka ide

o nárast o 10,7 tisíc penzistov. Od konca januára 2008, teda počas desiatich rokov, sa počet dôchodcov zvýšil o 142,6 tisíc.

○ Reťazec rýchleho občerstvenia Burger King sa vracia na Slovensko. V nasledujúcich piatich rokoch plánuje na slovenskom trhu otvoriť pätnásť prevádzok. Burger King prvý krát otvoril na Slovensku v roku 2010. Reštaurácie prevádzkovala firma Tekaz s českým majiteľom, ktorá primárne podnikala v stavebníctve. Burger King pod jej vedením nevydržal na slovenskom trhu ani dva roky. Dve bratislavské a jedna žilinská reštaurácia skončili na sklomku roka 2011.

○ Miera evidovanej nezamestnanosti na Slovensku ku koncu februára tohto roka klesla na 5,72 percenta. Medziročne bola miera nezamestnanosti vo februári nižšia o 2,67 percenta.

○ Vo februári 2018 bol pokles miery evidovanej nezamestnanosti (Pokračovanie na str. 23)
