*Why You Need Title Insurance***The Importance of Protecting Title and Your Home investment****By John D. Pogorelec, Jr., Esq., General Counsel**

The purchase of a home is one of the most emotional and expensive transactions a person may experience in a lifetime, As a real estate attorney who represents many first-time home buyers, I am asked to explain many things, but most of all I entertain questions concerning title insurance. Often I am asked by prospective buyers, "Why do I need title insurance?" To understand why title protection is essential, one needs to appreciate the strong sense of security in knowing that the property a buyer is about to purchase will safely and rightfully belong to him or her. Just as fire insurance protects one against losses from a fire and automobile insurance guards one against the cost of damages in an accident, title insurance protects a purchasers ownership interest in real estate that he or she is about to acquire.



In order to understand why one needs title insurance, one should understand what the term "title" means. By definition, title is the complete ownership to the property. It is a history of the property that reflects previous deeds, mortgages, easements, judgments and other possible liens, like a municipal tax lien due to the failure to pay property taxes, Unfortunately, even the most diligent search of the public records could fail to disclose a plethora of title defects. These defects could include matters such as forged deeds; a married person conveying real estate without the consent of a spouse; errors in the indexing of public records; or inheritance issues such as an improperly probated will or missing heirs.

At the time of the house closing, a deed is executed by the seller which conveys title to the purchaser. The deed, itself, does not prove that the purchaser owns the property completely without potential adverse claims. In essence, a deed is simply a document transferring the right of ownership to the buyer. However, that right of ownership may be encumbered by title wrinkles such as liens and judgments outstanding against the property. Such defects will not be shown on a deed. Hence, the last thing purchasers need to worry about is finding out that they made substantial mortgage payments on a home which has title defects and thus, may not legally be theirs due to a problem in the past history of ownership. Therefore, if there is an issue with the title to the property, a purchaser may not be getting what he or she is paying for at the time of closing. This is why it is essential that a buyer obtains title insurance - to protect a purchaser from unknown title defects.

Before offering to issue a title insurance policy, a title insurance professional performs a search to assess what is on public record that may adversely affect title. The agent will identify any outstanding claims or possible problems that could arise in the future. Once these title issues have been resolved, the title agent will issue a title insurance policy insuring that the purchaser has clear title to the property. By acquiring title insurance, a purchaser is safeguarding his or her investment against these above mentioned horrors. Therefore, the title protection, through the vehicle of an owners title policy, will insulate a purchaser from any later determined mistakes or defects in the chain of title that might otherwise result in financial loss to a buyer. Consequently, if a title defect surfaces after the closing, the title insurance company will cover costs and legal fees in connection with defending against an alleged title claim. The policy

**Thoughts from our Supreme Chaplain,
Rev. Andrew S. Hvozdivic****Our Lady of Compassion**

The Feast of Our Lady of Sorrows grew in popularity in the 12th century, although under various titles. Some writings would place its roots in the eleventh century, especially among the Benedictine monks. The first altar to the Mater Dolorosa was set up in 1221 at the Cistercian monastery of [Schönau](#).

The formal feast of Our Lady of Sorrows was originated by a provincial synod of [Cologne](#) in 1423. It was designated for the Friday after the third Sunday after Easter and had the title: Commemoration angustiae et doloris B. Mariae V. Its object was the sorrow of Mary during the Crucifixion and Death of Christ. Before the sixteenth century this feast was limited to the dioceses of North Germany, Scandinavia, and Scotland.

According to Fr. William Saunders, "... in 1482, the feast was officially placed in the Roman Missal under the title of Our Lady of Compassion, highlighting the great love our Blessed Mother displayed in suffering with her Son. The word compassion derives from the Latin roots cum and patior which means "to suffer with".

After 1600 it became popular in France and was set for the Friday before Palm Sunday. By a Decree of 22 April 1727, Pope [Benedict XIII](#) extended it to the entire Latin Church, under the title "Septem dolorum B.M.V." In 1954, it still held the rank of major double (slightly lower than the rank of the September feast) in the [General Roman Calendar](#). Pope [John XXIII](#)'s 1960 [Code of Rubrics reduced](#) it to the level of a [commemoration](#).

The Seven Sorrows (or Dolours) are events in the life of the Blessed Virgin Mary that are a popular devotion and are frequently depicted in art.

These Seven Sorrows should not be confused with the five [Sorrowful Mysteries of the Rosary](#).

1. The Prophecy of Simeon. ([Luke 2:34-35](#))
2. The escape and Flight into Egypt. ([Matthew 2:13](#))
3. The Loss of the [Child Jesus](#) in the Temple of Jerusalem. ([Luke 2:43-45](#))
4. The Meeting of Mary and Jesus on the [Via Dolorosa](#).
5. [The Crucifixion of Jesus](#) on Mount Calvary. ([John 19:25](#))
6. The Piercing of the Side of Jesus with a spear, and His [Descent from the Cross](#). ([Matthew 27:57-59](#))
7. The [Burial of Jesus](#) by [Joseph of Arimathea](#). ([John 19:40-42](#))
8. It is a common practice for Catholics to say daily one [Our Father](#) and seven [Hail Marys](#) for each.

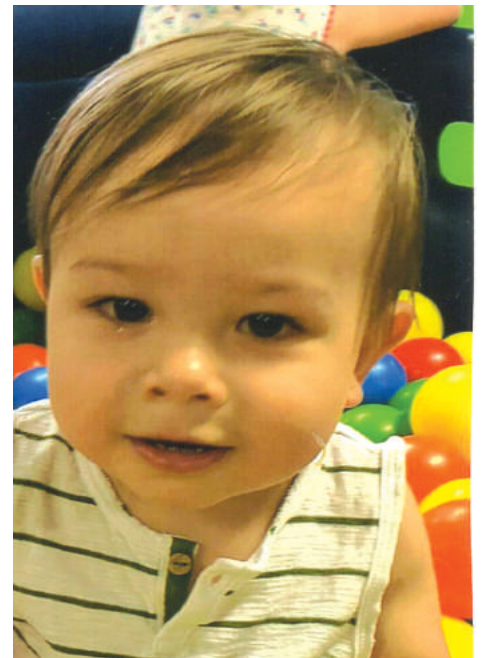

Anna Kolesarova, a Slovak teen, Beatified in Kosice on Sept. 1

A 16-year-old peasant girl was beatified as a martyr in Slovakia on Sept. 1, seven decades after she was shot in front of her family resisting rape by a drunken Soviet soldier.



More than 30,000 turned out for the beatification ceremony in Lokomotiva Stadium in Kosice presided over by Giovanni Cardinal Beccu, prefect of the Vatican's Congregation for Saints' Causes. Joining him at the historic rite were bishops from across Slovakia.

Anna Kolesarova "embodies the faithful layperson living in their family, regularly receiving the sacraments, praying the rosary and approaching God through good works. Her heroic testimony, drawn from a sincere spiritual life, is something every Catholic and believer can aspire to," Archbishop Bernard Bober of Kosice, Slovakia told Catholic News Service on August 21.

He said honoring Miss Kolesarova whose "reputation for holiness" had inspired young Slovaks, would give the local Church a unique chance for spiritual growth. "The story of 16-year-old Anna Kolesarova offers a strong message, of course for the younger generation," he said.

Kolesarova was born July 14, 1928, in Vysoka nad Uhom, near the present Slovak-Ukrainian border. When she was 13, her mother died, so she took over household duties and regularly attended Mass and rosary services with her father and elder brother.

When the Red Army captured the village Nov. 22, 1944, witnesses said Kolesarova had donned her mother's black dress to disguise her youth; she took refuge in the cellar. Asked to find food when a drunken soldier entered the house, Miss Kolesarova broke free when he tried to rape her. She was shot twice through the head in front of her father and neighbors.

The 16-year-old was buried at night in a makeshift coffin but was given a formal funeral a week later by Father Anton Lukac, who recorded that she had received confession and Communion before her death and made a "sacrifice of holy purity."

In a website statement of the Kosice Archdiocese, accounts of her testimony had been secretly gathered in the 1950s by Jesuit Father Michal Potocky. The statement said her grave had become a place of pilgrimage only after the 1989 collapse of communist rule. — Jonathan Luxmoore, CNS

CENTENNIAL OF CZECHOSLOVAKIA'S FOUNDING SET IN CLEVELAND, OH

A celebration marking the 100th anniversary of the establishment of Czechoslovakia will be held in Cleveland, Oh. the weekend of October 26-28. Festivities will be held at the Bohemian National Hall located at 4939 Broadway Avenue in downtown Cleveland.

The large Cleveland area Czech and Slovak communities were active in the liberation movement of their fellow brethren at home in the years following the start of World War I in 1914. What the Czechs and Slovaks in America believed their fellow countrymen would accept in the event of their liberation was set forth in a document known as the Cleveland Agreement, signed on October 25, 1915 taking its name from the city where American Czech and Slovak leaders met. In short, the agreement provided for autonomy for both the Czech lands and Slovakia. The provisions of this agreement became the foundation of the Pittsburgh Agreement signed in May 1918 by Thomas G. Masaryk. Czechoslovakia, originally spelled with hyphen to emphasize the duality of the country, declared its independence on October 28, 1918. Masaryk was elected as the country's first president on November 14 of that year.

Complete details of the Cleveland celebration will be forthcoming.

KORCOK IN USA WANTS TO INTENSIFY RELATIONS AT HIGHEST LEVEL

Slovak President Andrej Kiska on Tuesday, August 28 handed over credentials to Ivan Korcok, the designated Slovak ambassador to the United States.



Korcok in the USA wants to protect the interests of both Slovakia and the EU and intensify relations at the highest level.

"There's a need for our top political leaders to meet," he said after receiving the credentials.

Kiska considers Korcok to be a top diplomat, and he likes the fact that Korcok isn't afraid to fight for values. "The world is complicated, and there are plenty of questions nowadays about the direction in which we're heading. It's therefore even more important that you will represent our country to such an important partner as the United States," Kiska told Korcok.

The new ambassador would like to contribute towards strengthening already positive American-Slovak relations. Korcok's personal challenge is "to try to leave a positive trace of Slovakia in this huge country". This can be achieved via Slovak culture, he added.

Korcok acted as deputy for Slovakia's Foreign and European Affairs Minister Miroslav Lajcak during the period when Lajcak served as the president of the 72nd UN General Assembly in the USA. The Government hasn't yet approved Korcok's successor in the post of Foreign Affairs Ministry state secretary. According to Lajcak, Frantisek Ruzicka, who led Lajcak's team at the UN, is the only candidate for the post, however.

NATO LAMBASTES SLOVAK ARMED FORCES IN ITS EVALUATION REPORT

The North Atlantic Alliance (NATO) in its summarizing evaluation report reproaches the Slovak Armed Forces, saying that the building of a heavy infantry brigade, which was supposed to be Slovakia's main priority, has been too slow and that the number of soldiers and military doctors is insufficient, TASR learned from Martin Dubeci of the non-parliamentary Progressive Slovakia (PS) party, who published the review on Facebook.

According to the report, NATO also recommends that Slovakia should double its efforts in the field of meeting the Alliance's objectives in terms of quantity, quality and time, as well as to boost the management of the armed forces, especially in the field of defence planning.

The NATO report further points out that NATO defence ministers agreed in 2017 that Slovakia should give priority to the development of an infantry brigade. A medium-sized infantry brigade should have been fully available this year, but this goal has not been met. As for a fully-capable heavy infantry brigade, Slovakia committed itself to building it until 2030, which NATO considers to be insufficient.

In 2017 the Slovak Government agreed to purchase the 4x4 and 8x8 military armored vehicles to replace obsolete military equipment. However, no decision has yet been made regarding the chassis on which the armored vehicles should be. As a result, it remains unclear whether the armored vehicles will meet the requirements of a heavy infantry brigade, reads the NATO review report.

The Defence Ministry responded that NATO's criticism directed towards the Slo-

vak Armed Forces is nothing new for the ministry and that the long-term shortage of funding as well as neglecting the defence area as such are mainly behind the poor state of the Slovak Armed Forces.

PREMIER: EMPLOYING FOREIGNERS IN SLOVAKIA MUST BE SPEEDED UP

Due to the shortage of labour in the country, Slovakia needs to adopt a number of measures in the area of the controlled import of labour, including a measure that will cut the time needed for companies to hire foreigners, stated Prime Minister Peter Pellegrini (Smer-SD) on Tuesday after talks about the lack of labour in the country.

"Our factories need to respond very quickly to demand, so individual ministers were given specific tasks at the meeting. Over the next two weeks all the state authorities that have something to do with approving the influx of labour from abroad, including the Foreign Police, the Interior Ministry, the Labour Ministry and the Foreign Affairs Ministry, are set to submit a package of further measures aimed at facilitating the whole process without these being strictly of a legislative nature," said the premier.

"The situation in Slovakia is rather critical at the moment," added Pellegrini, noting that if the country doesn't speed up processes for accepting foreign employees, Slovakia could lose its competitiveness vis-a-vis surrounding countries.

"However, we won't adopt measures that would deteriorate the conditions for Slovak employees, which means that we won't tolerate any social dumping..." said the premier, adding that the import of foreign labour will be monitored, and companies will have to employ foreigners under the same conditions as those provided to Slovak employees and only in professions for which Slovakia lacks labour. The premier went on to say that he hopes that the short-term measures that will soon be introduced will make a significant and positive contribution to Slovakia's industry and its employers.

Pact troops at a memorial plaque in front of the Comenius University in Bratislava on August 21.

"We are at a place where three people died and today we'll also honor all the others who died as victims of the occupation," said Confederation of Political Prisoners (KPVS) chairman Peter Sandtner, welcoming the guests of the event which is organized annually by the institution.

"More political prisoners went to prisons, the very first of them for their active participation on August 21. A number of people were also jailed for protesting on the first anniversary of the occupation in 1969," said Sandtner, explaining why this date is so important for KPVS. "De facto, all of us were victims of the occupation, except for a bunch of collaborators," added MP for OLaNO and former political prisoner Jan Budaj.

The commemoration was also attended by Parliamentary Chair Andrej Danko (Slovak National Party/SNS), Parliamentary Vice-chair Bela Bugár (Most-Híd), Defence Minister Peter Gajdos (SNS), Education, Science, Research and Sports Minister Martina Lubyova (SNS), Agriculture and Rural Development Minister Gabriela Matecna (SNS), state secretaries, coalition and Opposition MPs, MEP Ivan Stefanec, Bratislava Region Governor Juraj Droba (Freedom and Solidarity/SaS), several ambassadors, representatives of embassies and high military officers. Victims of the occupation were also hon-

ored by Romanian Foreign Affairs Minister Teodor-Viorel Melescanu, who is paying a two-day visit to Slovakia.

In addition to politicians, ambassadors and soldiers, representatives of several movements and initiatives, including the 'For a Decent Slovakia' initiative, attended the event. "The courageous sacrifice of the innocent, who weren't scared off by the occupiers, is a challenge and motivation for us to continue in the struggle for a decent Slovakia," they said on this occasion.

FILM TLMOČNIK TO COMPETE IN 2019 OSCARS RACE

The Slovak Film and Television Academy (SFTA) has selected a road movie called *Tlmočník* (The Interpreter, 2018) as the national nominee for the category of best foreign language film at the 2019 Academy Awards in February.

Directed by Slovak director Martin Sulik, the movie follows the story of two elderly men who are on their journey throughout Slovakia, partly linked and partly divided by the common past. The road movie starring German actor Peter Simonischek, known especially for his German drama *Toni Erdmann* (Maren Ade, 2016), and legendary Czech director Jiri Menzel was premiered at the Berlinale film festival in February and is also set to compete in the European Film Awards, sometimes called the European Oscars.

Tlmočník was selected out of 12 Slovak movies, including the historical drama *Dubček* (directed by Laco Halama), the documentary *Meciar* (directed by Tereza Nvotova) as well as the thriller *Doverný nepriateľ* (Intimate Enemy, directed by Karel Janak).

TOURISM IN SLOVAKIA CONSTANTLY GROWING 4TH YEAR IN ROW

More than 2.5 million tourists spent at least one night in Slovakia in the first half of 2018, up by almost 4 percent compared to the same period last year, TASR learned from the Transport and Construction Ministry, which manages the tourism sector.

According to Transport Ministry spokesperson Karolina Ducka, Slovakia's tourism has been steadily growing over the past four years.

"The number of tourists has been growing and tourism is becoming an important part of our economy, which makes us very happy. It's important for us to continue this trend, improve our services and

offer the potential we have here to the tourists. So that visitors can have only the most beautiful experience of Slovakia and have reasons to come back again," said Transport Minister Arpad Ersek.

In the first six months of this year tourists spent in Slovakia about 6.9 million nights, an increase of 3.8 percent. The Zilina, Bratislava and Presov regions were among the most preferred.

Of the total number of tourists, Slovaks made up 61 percent (more than 1.5 million individuals) whereas foreign tourists made up the remaining 39 percent (around 1 million individuals). The number of Slovak tourists went up by almost 3 percent year-on-year, while the number of tourists from abroad increased by almost 5 percent y-o-y in the first half of 2018, stated Ducka.

The water well is connected to the legend of the Turkish prince Omar and his great love for the beautiful Fatima, whom he had to redeem by digging a well in the rock.



Well-known Honorary Supreme Officer

Frank E. Macey life-long Sokol activist passed away at age 85 in Reading, Pa.

Frank E. Macey passed away peacefully at his residence in Shillington, Pa. during the evening hours of August 6. He was 85.



He was a life-long member of our organization and served a total of 24 years as a member of the Supreme Assembly. His warm smile and upbeat attitude won him friends and admirers throughout his life.

A native of Reading, Pa., he was born there September 22, 1932, son of the late Imrich and Helen Vanek Macey. He was a 1950 graduate of Reading Central Catholic High School and a 1953 graduate of the Wyomissing Polytechnical Institute. He started his career at the textile Machine Works and later at Western Electric as a toolmaker from 1954 to 1966. He retired from Continental Can and Sonoco Fiber Drum Co. as plant supervisor after 23 years of employment in 1989.

A lifelong, active member of SS. Cyril and Methodius Slovak Parish in Reading, he served as a lector there for the past 40 years. He was very proud of his Slovak heritage and was active in the area's Slovak community all his life. He was enrolled as a member of the Slovak Catholic Sokol at birth by his father, Emerick who was a founder of Assembly 261 in Reading. He competed at his first national Slet in Philadelphia in 1941 at the age of nine. This began his love, interest and commitment to the Slovak Catholic Sokol and became his way of life. As a youth, he served as the Sports Director of Group 12 during which time the Group captured the Championship Flag at six consecutive Slets from 1969 to 1979. He helped revive the bowling, basketball and volleyball competitions of the Eastern District and helped organize the Reading Sokol Youth Club. Over the years, he served in various leadership capacities in our former Jr. Assembly 333 as well as in Assembly 261, including that of president and was active in Group 12. He also served as president of the Slovak Catholic Sokol Home Associa-

tion. He was a driving force in the building of the new Reading Sokol Club in 2011.

Brother Macey had been a delegate to our quadrennial conventions since 1959 when it was held in Reading. The 20th national convention in 1963 in Youngstown, Oh. first elected him as a member of the Supreme Physical Fitness Board. He was re-elected to this position at the 21st and 22nd conventions. In 1979, he was elected as Supreme Director of Sports and Athletics and a member of the Board of Directors. He was subsequently reelected to this position in 1983 and 1987. The 26th quadrennial convention elected him an Honorary Supreme Officer in 1991. In 2004, Brother Macey was named Slovak Catholic Sokol Fraternalist of the Year. He also was a life member of the Slovak Catholic Federation and enjoyed membership in the Knights of Columbus, Council#793, the Polish Falcons of America

and the Slovak League of America as well as local civic and outreach organizations.

Brother Frank was predeceased by his wife of 32 years, the former Stella I. Dybalski who passed away on September 10, 2015. He is survived by his loving daughter, Susan L. Macey, Esq. and her husband, Matthew G. Parsell of Denver, Co. Also surviving are a granddaughter, Macey L. Henderson, Ph.D. of Baltimore, Md. as well as several nieces, nephews and great-nieces and nephews. In addition to his parents and wife, he was preceded in death by a sister Helen B. Reinig.

Family, friends and fellow fraternalists paid their respects to Brother Frank at the Kopicki-Bradley Funeral Home in Reading. Heading the group of Sokol mourners at the funeral rites were Supreme Secretary Scott T. Pogorelec, F.I.C., Supreme President Michael J. Horvath and Honorary Supreme Officer Steven M. Colonel Nicholas John Babiak(USAF, Retired) passed away peacefully on August 16 in Arlington, Va. He was 70.

A native of Suffern, N.Y., he was born there Dec. 16, 1947 to Theodore and Julia(Blasko) Babiak. He grew up in Spring Valley, N.Y. He



was a 1972 graduate of the University of Buffalo, where he earned his undergraduate degree in Electrical Engineering. He was awarded a Master of Arts in Business Management from Central Michigan University and a Doctor of Business Administration from Chelsea

University in London. He served 20 years in the Air Force, retiring in 1992 as a Colonel and serving in several critical Science & Technology roles during his distinguished career. While in the Air Force, he served in key positions of increasing responsibility, culminating in his final military assignment as the Deputy Director, Systems Center, Defense Mapping Agency, where he was responsible for the multi-billion dollar research, development, rest and evaluation systems acquisition and logistics support of the Agency. He married the former Joyce K. Stouffer in 1987.

An active Catholic layman throughout his life, Dr. Babiak was a firm believer in the role of his faith so beautifully mirrored throughout his life's mission. In 2007, he was invested in the Equestrian Order of the Holy Sepulchre of Jerusalem at New York's St. Patrick's Cathedral and later elevated to the rank of Knight Commander with Star. He has been active in a number of Catholic philanthropic foundations and societies, including the Franciscan Foun-

ation for the Holy Land. In October 2017, he received the Pro Ecclesia et Pontifice cross(for the Church and the Pontiff) from Pope Francis for outstanding service to the universal Church. He was presented with the papal award by Archbishop Christophe Pierre, Apostolic Nuncio in the United States at a reception at the Apostolic Nunciature in Washington, D.C. He was active in his local parish, St. Ann's Church in Arlington, Va., serving in multiple capacities including chairman of the building and grounds committee and the security committee among many other positions. His stellar life of community service were in the best traditions of the fraternal benefit system. Dr. Babiak was a long-time member of Slovak Catholic Sokol Assembly 219.

In addition to his parents, Dr. Babiak was preceded in death by a brother Stephen in 2011.

50. výročie okupácie Československa vojskami Varšavskej zmluvy

V dňoch 20. a 21. augusta si každoročne pripomínáme okupáciu Československa z augusta 1968.

Rok 1968 sa zapísal do dejín komunistického Československa pokusom o nastolenie socializmu s ľudskou tvárou, čo v praxi znamenalo snahu o demokratizáciu komunistického systému.

Okupácia začala v noci z 20. na 21. augusta 1968. Okrem vojakov Sovietskeho zväzu sa jej zúčastnili aj jednotky Maďarska, Bulharska, Poľska a NDR. Celková sila invázičných vojsk bola 27 divízií, čo predstavovalo vyše 500 000 vojakov a asi 6 300 tankov, 2 000 diel a 800 lietadiel.

Soviety si ešte pred inváziou zabezpečili tzv. pozývací list podpísaný niektorými dogmatickými československými komunistami, v ktorom títo žiadali „bratské socialistické štáty“ o pomoc proti „kontrarevolúcii“ a za udržanie socializmu v Československu. Vedenie KSC vďaka svojmu stanovisku odvysielanom v rozhlase počas prvých hodín invázie demaskovalo túto akciu ako vojenskú okupáciu a porušenie medzinárodného práva.

Hoci možnosť ozbrojeného odporu komunistické vedenie odmietlo, na mnohých miestach sa spontánne postavili neozbrojení ľudia do cesty sovietskym tankom. Snažili sa ich zastaviť alebo aspoň spomaliť ich postup strhávaním orientačných tabúľ či názvov ulíc. Na takéto akcie odpovedali vojaci okupačných armád na niekoľkých miestach strelbou do davu protestujúcich, ktorej výsledkom boli obeť na ľudských životoch.

Vedúci československí predstavitelia

Dubček, Smrkovský, Černík a ďalší boli zatknutí a internovaní. Verejnosť v priebehu prvého týždňa vyjadrovala silný odpor k takémuto konaniu tzv. spriateľených krajín. Uskutočnili sa protesty, ktoré viedli na viacerých miestach k pouličným bojom avšak čs. armáda na rozkaz ministra Džúra a potom aj prezidenta republiky Svobodu do bojov nezasiahla.

Podpísanie Moskovského protokolu 26. augusta 1968 legalizovalo pobyt vojsk, čo následne znamenalo potlačenie československého pokusu o socializmus s ľudskou tvárou, obrodného procesu známeho ako Pražská jar. Invázne jednotky Sovietskej armády zostali v krajine až do roku 1991. Išlo o vojenskú okupáciu v tej dobe suverénnej krajiny jej spojencami, napriek nesúhlasu jej zákonne zvolených predstaviteľov a žiadostiam o pomoc iných krajín, dokonca aj na pôde Bezpečnostnej rady OSN.

Podľa najnovších výskumov zahynulo v dôsledku okupácie v Československu najmenej 108 ľudí, z toho 37 na Slovensku, ďalšie stovky boli ťažko ranených. Viacerí zomreli po autonehodách spôsobených vojenskou technikou, takmer 20 ľudí zabili guľky. Najmladšou obeťou bolo 15-ročné dievča. Okupácia zastavila proces demokratizácie a pomaly odštartovala normalizáciu, ktorá zrušila všetky výdobytky socializmu s ľudskou tvárou. Toto obdobie je spojené s osudmi tisícov stotočných Čechov a Slovákov, ktorí kvôli svojmu slobodnému názoru prišli o zamestnanie, ich deti sa nedostali na vysokú školu, sledovala ich komunistická ŠtB, viacerí skončili za mrežami alebo ušli na Západ.

KRÁTKE SPRÁVY ZO SLOVENSKA



Slovensko poslalo do mesta Mósul v Iraku humanitárnu pomoc vo výške viac ako 212-tisíc eur. V oblasti trpia núdzou a nedostupnosťou zdravotníckej starostlivosti takmer dva milióny ľudí. Slovensko posla do zdevastovanej oblasti zdravotnícke prístroje pre anesteziológov a servoventilátory slovenského výrobcu, spacie vaky, uteráky, prikrývky a posteľe.

Investícia automobilky Jaguar Land Rover zdvihla ceny nehnuteľností v Nitre a okolí o desiatky percent. Podľa pracovníkov realitných kancelárií sa však už začiatkom tohto roka začala situácia upokojovať a hodnota realít sa blíži k cenovému stropu. V rokoch 2016 a 2017 bol nárast cien výrazný a dosiahol úroveň približne 20 až 30 percent. Zdraželi najmä malé byty - garsónky a jednoizbové byty. Kým pred príchodom Jaguara sa garsónka predávala v Nitre za približne 29.000 eur, v čase najväčšieho boomu to bolo aj 54.000 eur. Ten nárast bol enormný. Jednoizbové byty stúpili z 35.000 eur a priblížili sa k sume 70.000 eur. Na tejto hranici sa však už prestali predávať, takže cenový strop dosiahli na úrovni okolo 65.000 eur.

Slovenská republika prevzala od 1. septembra zodpovednosť za Sektor 4 v rámci medzinárodnej misie UNFICYP na Cypre. Ozbrojené sily Slovenskej republiky pôsobia v mierovej misii UNFICYP na Cypre od roku 2001 na základe uznesenia Národnej rady SR, pričom v tom istom roku prevzali velenie v Sektore 4. Okrem 88 príslušníkov Ozbrojených síl SR pôsobilo v sektore aj 54 maďarských, 43 srbských a dvaja ukrajinskí vojaci. V súlade s Rezolúciou Bezpečnostnej rady OSN v zmysle jednoliatosti (one Troop Contributing Country) z tohto roku sa Slovenská republika stáva jediným pôsobiacim štátom v sektore. Celkový počet príslušníkov OS SR v rámci misie UNFICYP tak postupne stúpne zo 141 na 243.
