Message from our Supreme President

March was a busy month and April is being just as busy. In March the 1st quarterly Board of Directors meeting was held March 22-23, 2019 at the Airport Marriott in Cleveland, Ohio. The Board of Directors reviewed the Society's business for 2018 and discussed a variety of issues that are currently ongoing and will be coming up during the year.



The Society's Director of Sales, Albert J. Suess, Jr. F.I.C., gave a detailed presentation on the insurance and annuity sales for 2018. He showed there were increases in the amount of insurance in force but again the downside was there was a decrease in membership due to deaths and surrenders. He provided the Board with 2019 goals which can be reached with every member doing their part to sign up new members.

The Chairperson of the Auditors, James G. Jerek informed the Board the annual audit went well and pointed out some issues they would like to see improved.

The Board heard from the Physical Fitness Board which went over the activities they have planned for 2019; the Bowling Tournament in May, the Reunion in June, the Slet in July and the Golf Tournament in August. These activities prove that the Slovak Catholic Sokol will have a busy summer and provides activities for its member to enjoy.

Our Vice President, Edward D. Moeller updated the Board on the Scholarship results. He gave an encouraging report on the number of applications received and stated there are more to come as the deadline approaches. Some other issues were discussed which will improve the application process for 2020.

Our Supreme Secretary, Scott T. Pogorelec, F.I.C., presented to the Board his report for 2018. He showed again he kept expenses in check and the Society's Assets grew by \$1,000,000.

He also went over the State of New Jersey, Department of Banking and Insurance report that was issued after their examination of the Slovak Catholic Sokol for the past five years. The report showed all was in order and they were satisfied with our operations, investments and reserves.

PNC Institutional Advisory Solutions manager, Thomas Calimano, gave a review of the Society's investment portfolio for 2018 and for the January and February 2019. He reported 2018 ended up on the down side but has shown improvement in 2019. He indicated to the Board 2019 will be a better year.

The Board then heard from Parkway Advisors of Abilene, Texas. Parkway Advisors in a consulting company that specializes in various services for the insurance business sector. They reviewed our investment portfolio and provided ways they think it can be improved. They also provided the Board with an analysis of our investment risks. Their overall comments are we are doing well and there are minor adjustments they feel we can take.

The Slovak Catholic Sokol Board of Directors are working hard to keep the Society on a positive path that is financially strong and solvent.

Our Supreme Secretary and I attended the Slovak Catholic Federation's 2019 spring meeting which was held April 2, 2019 at the Slovak Catholic Sokol Home Office in Passaic, NJ. The Federation is an important organization since it provides financial assistance to the Slovak Pontifical College in Rome. The financial assistance helps with the educational cost for priests from Slovakia with their studies in Rome. I encourage all members to become a member of the Federation which will help with this important cause and mission.

The Washington, D.C. Cherry Blossom bus trip, Saturday April 6, 2019! This bus trip to our nation's Capital was organized by Group 7, Wilkes-Barre, PA. It was a long day with lots to see. Along the banks of the Potomac River, the tidal basin and in other areas of the Mall it was a sea of Cherry Blossom Pink. What a sight. In addition to the beauty of the pink blossoms was the beautiful sea of humanity. As I walked Wharf and paths I heard the voice of people speaking in many languages and am sure they were in awe of nature's way of expressing harmony. If seeing the Cherry Blossom in Washington, D.C. is on your bucket list go next year but be prepared for the slow casual walking and long lines.

I want to thank all members who were elected by their Assemblies and Wreaths to be a delegate to the Slovak Catholic Sokol 33rd Quadrennial Convention which

Thoughts from our Supreme Chaplain,
Rev. Andrew S. HvozdoVIC
PEER INTO THE EMPTY TOMB

Years ago when I was in seminary, I was fortunate enough to be able to go on a pilgrimage to the Holy Land. It's one of the most extraordinary places I've ever been. During our visit to Jerusalem each morning we would attend Mass, rotating around the holy places. One such morning our Mass was in



the Church of the Holy Sepulcher, which is a church that contains the sites of Calvary and the tomb of Christ. I was very excited because our group had made a reservation to say Mass in the tomb itself. The chapel in the tomb is very small, so if you attend Mass in there, you can't help but be pressed up right up against the altar. During the Eucharistic Prayer, as I was kneeling, I could see into the space where the body of Jesus had been laid to rest. And it was empty.

Now, I knew it would be empty. I believe in the resurrection of Christ. But still, there is something strange about peering into an empty tomb, since death is a fundamental part of the human experience, hanging over everything. The spirit of the world tries to convince us that the tomb is the end, that there is nothing on the other side of death. But the empty grave of Christ testifies against that. His appearance to the disciples testifies against that. He came to them, not as a ghost, but in the flesh. He spoke to them, breathed upon them, touched them, and ate with them. Such things, the world tells us, are not supposed to happen.

But the truth is that death was not supposed to happen. Adam and Eve were not supposed to die. With their sin came death – both for them and for us. It is with the death and resurrection of Christ that we are freed from slavery to sin and offered eternal life. Jesus was supposed to be in the tomb Easter morning, but He wasn't. We live in a world in which a man rose from the dead.

That morning in Jerusalem when I attended Mass and peered into the empty tomb of Jesus – it was a remarkable feeling. Because there, just above the grave that held the dead Jesus, the priest made present the living Jesus. The Eucharist is the Body of Jesus crucified, Jesus resurrected, Jesus glorified. And He was there with us, alive in His empty tomb.

COPING WITH BEING AWAY FROM HOME

A famous Sokol once said, "I went to the Slet expecting to make new friends, but I ended up with a new family".

Many of you have seen this article in the paper before. Several years ago, I wrote a similar article because I understand how difficult it can be for a child to be away from home for the first time. I can also appreciate the difficulty that the parents experience when sending their son or daughter away without them.

For some children, the Slet is more than just a competition; it is the first time that they are spending more than one night away from mom and dad. Being away from home and staying in a dorm can be a difficult for kids of all ages, but especially for our juniors. Hopefully, this experience will be a positive one that will help your child feel more comfortable when you are not with him or her. Being at the Slet without a parent offers a wonderful opportunity for both you and your children to practice "letting go" -- an experience that can contribute to the development of healthy independence. Learning to let go allows children to develop autonomy and a stronger sense of self. Here are some ways to help your child feel more secure about being away from home:

- Listen to and talk about concerns. As the day of departure arrives, some children understandably experience uneasiness about going off to the Slet. It is important to talk about their fears and try to put them at ease. Rather than acting on what you believe his or her feelings to be, ask good questions such as "We've been busy packing your gear. What are your thoughts about heading off to the Slet in a few days?"
- Give him or her confidence. Communicate your confidence in his or her ability to handle being away from home and remind him or her about "small victories," successes that he or she has experienced in other situations.
- Let your son or daughter know that being away from home is part of growing up. Sometimes children struggle with leaving mom and dad because they know you are struggling with letting them grow. If you are anxious about your child leaving, you will make it harder for him or her to feel comfortable.
- Pack a special note or card. Hide a card or small note in his or her suitcase so that when he or she arrives at the college and unpacks, there is a nice surprise waiting.
- Make sure he or she is ready to take care of his or her own hygiene. It is important for your son or daughter to know how to shower, brush his or her own teeth, comb his or her own hair, etc. Remind him or her that hygiene is important, especially after a long day at the track.
- Tell your child that you are only a phone call away. He or she can call you each night.
- Bring a little piece of home. Have your child choose to bring along one special thing that reminds him or her of home (a picture, teddy bear, action figure, blanket).
- Tell your child to have FUN. Discuss how much fun it will be to hang out on a college campus with friends. Talk about competing, sharing a room with someone else, eating breakfast, lunch, and dinner together, having late night pizza, etc.
- Support you child. If you are going to be at the Slet, remind him or her that you will be there at the daily events. If you will not be there, tell your son or daughter that you will be thinking about him or her.
- Prepare your child for the possibility that he or she may

not "win". This is probably the most difficult thing for many kids. In today's society, many children have been taught that everyone is a winner. In sports like T-ball, every child gets a trophy at the end of the season. This sometimes leads children to believe that they will always be rewarded for a job well done. Although we would like to believe this, it is not always the case. There will be winners and losers. Not everyone will get a medal or trophy. Even though a child may do his or her very best, verbal praise from friends and coaches may be the only reward. Stress the importance of doing the best you can without expecting a trophy or medal.

As a mother, I understand wanting to keep your little ones "under your wing" forever, but this is a great opportunity for your child. He or she will gain independence, form lasting friendships, and make lifelong memories. Children feel a sense of accomplishment when they gain some independence and make their own decisions. He or she may not make the best food choices at the cafeteria, as I found out when my sons have told me they had ice cream or pop for breakfast every day, but that is all part of the experience. All that really mattered was that they enjoyed himself. They came back from the Slet raving about how much fun they had, and that they could not wait to go again.

Jacquie McTaggart once said, "Your child will be better prepared to tackle the bumps on the road of life if he has been given the gift of guided independence." So parents . . . Relax. . . your children are in very capable hands. I am sure their independence will surprise you! I am looking forward to working with all of your children at the upcoming Slet at SUNY Brockport. REPORT OF THE SUPREME PRESIDENT

In compliance with section 4.1 Article (q) of the Constitution and Bylaws of the Slovak Catholic Sokol, I hereby submit my 2018 annual report to the Board of Directors and members for their review. Section 4.1 of the Constitution and Bylaws lists the duties, obligations and responsibilities of the office of the Supreme President.

As I begin this report please take a moment to remember and pray for all members of the Slovak Catholic Sokol, our family members and friends who have died in 2018. May their souls rest in eternal peace!

2018 marked the 113th year from the founding of the Slovak Catholic Sokol and here listed for your review and approval is my report that summarizes my activities, meetings and events I represented the Slovak Catholic Sokol at as your President in 2018.

Since the Society's founding in 1905 its mission is still the same; provide financial security to its members through superior and market accepted insurance and annuity products and to keep the Society financially sound and solvent. This was accomplished through the leadership and guidance from our Supreme Secretary Scott T. Pogorelec, F.I.C. And, I am able to say the Slovak Catholic Sokol is financially stable and solvent.

Working with the Society's professional advisors, PNC Institutional Asset Management, CPS Actuaries, Vision Financial Group CPA's LLP and others our Supreme Secretary has been able to maintain our profitability via a healthy investment portfolio, keep the Society compliant with State Insurance Departments reporting requirements, and enhance our already existing quality customer service functions with operational improvements.

The success of our Society not only comes from the leadership and guidance of our Supreme Secretary, it also is attributed to the excellent work the Home Office staff gives to the organization, the membership and all who they work and come in contact with each

and every day. Your dedication and professionalism is deeply appreciated. I and the Supreme Assembly say "Thank You".

Even though the Slovak Catholic Sokol is in good financial shape with an investment portfolio of \$80,997,059 as of December 31, 2018, this is down from 2017. There are reasons for the decrease in the portfolio, the stock and bond market, which at the end of the 2018 was not performing like it was in 2017. Another contributing factor was the decrease in membership due to deaths, surrenders, lapses, etc. which was more than the number of new members joining the Society. The business that Assemblies, Wreaths and members wrote in 2018 was only 10% of the total business, the other 90% came from our network of professional agents that recommend and sell our products. We have to ask ourselves, what kind of year it would be if we only relied on businesses from our Assemblies, Wreaths and members.

The Supreme Assembly and I thank everyone who signed up a new member in 2018 your efforts contributed to our success. We also want to recognize and thank our Director of Sales, Albert J. Suess, Jr., F.I.C. for the work he does to keep the Society competitive and bringing in the business it needs to grow. 2019 could be a year of growth due to reports that indicate an increase in life insurance sales.

When I read other Fraternal Society publications and compare them to ours, I might be biased, but, I am very proud of the Falcon and the content of the articles printed in it. This does not happen by itself. In 2018 the Falcon went from the newspaper format to a magazine format. This change gave the Falcon a brighter and fresh look which enhanced its appeal and feel. Thank you to our editorial staff, Daniel F. Tanzone, editor and Livia Karak for the work they did to transition from the old to the new format. Also, congratulation to Daniel T. Tanzone on his retirement.

The Slovak Catholic Sokol would not be the fraternal benefit society it is if it were not for its annual events and activities that are organized by the Supreme Physical Fitness Board, Groups, Assemblies and Wreaths. The Supreme Assembly and members Thank You for making our Society shine throughout the year.

In 2019 the Board of Directors were very active not only for doing the duties as outlined for their positions in the Constitution and Bylaws but also taking time to represent the Slovak Catholic Sokol at activities and events when called upon. Thank you for your guidance throughout 2019 and all you have contributed to the success of our great Society.

There is a lot more to report on but space is limited and I would like to use my remaining space to report on my activities.

My report summarizes all of the activities, meetings and events I attended and represented the Society as your Supreme President. As you will read in the report this was a very busy year as well as productive and exciting one.

I have detailed these activities, meeting and events in the articles I submit to the Falcon for publication for all members to read what I did to fulfill my duties as Supreme President.

First Quarter

I attended the annual meeting of the Supreme Physical Fitness Board, January 12-14, 2018 in Boardman, OH. At the meeting I extended greeting to the SFPB on behalf of the Board of Directors and participated in their discussions.

On January 19, 2018 myself and others Slovak Catholic Sokol Supreme offices and member participated in the 45th annual March for Life in Washington, D.C. While at the March for Life, I, our Supreme Chaplain, Reverend Andrew S. HvozdoVIC, and Editor, Daniel F. HOME OFFICE EFFICIENCY

As in previous years, the Home Office continues to make every effort possible to provide courteous and efficient service as needed on a daily basis. The employees are constantly updating and requesting information on behalf of our members. Along with our software provider, the Home Office staff has gone through extensive training in getting information to our members and agents in a quick and efficient manner. With all the technological advances in our world today, our staff has implemented changes to make items more accessible and the changes have proven to be successful.

The Home Office staff is one of our most valuable assets, and I would like to express my gratitude to them for making 2018 a successful year. Their dedication, loyalty, and commitment to the organization and members have been second to none. I would also like to recognize Albert J. Suess, F.I.C., for all his hard work while serving as our Director of Sales/Marketing. Through his efforts, along with our Home Office Staff, we have made great strides in our sales department.

We have undergone many changes in our Editorial Department as the Falcon has transitioned to a monthly magazine style format. We are also proud of our Monthly Newsletter that along with the Falcon, keeps our members informed of all the happenings in our Society. During the past year, we have consistently updated the hardware and software used in our Editorial Department and have made upgrades to our Sokol Website. We have also made significant inroads in the ever-changing world of social media as we look to engage all members of our Society. I would like to thank Livia Karak and Louie Smeriglio for all their hard work and dedication. I would also like to thank our former Editor, Daniel F. Tanzone, for his guidance and commitment during this transition period.

During the year in my capacity as the Supreme Secretary, it was necessary to attend various Financial and insurance seminars, meetings, and classes. New rules and regulations on both the state and federal level continue to emerge. The reporting process to all the life insurance related agencies and State Insurance Departments is an important task, but necessary to protect our fine organization. The Home Office staff and Board of Directors have done a great job meeting all the requirements and making the necessary changes to operate in an efficient manner.

Looking ahead to the future, I am confident that with the support

of our Supreme Officers, Director of Sales and Marketing, and our members, we will continue to make prudent decisions to meet all challenges that may come our way.

STATISTICS

The amount of Premium Income received during the year was \$6,680,420 of which \$2,194,630 was for life insurance premiums and \$4,485,790 was received as annuity premiums. The life insurance premium received was the highest amount received in our Society's history. The face amount of insurance written totaled \$14,034,048 and the total amount of insurance in force was \$234,635,697. The Society has 27,730 members with 30,411 certificates in force and 89 Assemblies/Wreaths. During the year 2018, a total of 511 new members were enrolled in our organization. Assets as of 12/31/2018 were \$85,246,510 and the Unassigned Funds total \$7,750,225. The Solvency ratio is a financially strong 111%.

COMMENTS

Many successful activities were held throughout the year on the local, group, and national levels. The National Tournaments under the direction of our Supreme Director of Sports and Athletics, James C. Matlon, and assisted by the Supreme Physical Fitness Board all proved to be a success for the organization. I would like to commend Supreme Director of Sports and Athletics, James C. God Bless our Board of Directors and all of our Members and the Slovak Catholic Sokol! Zdar Boh!

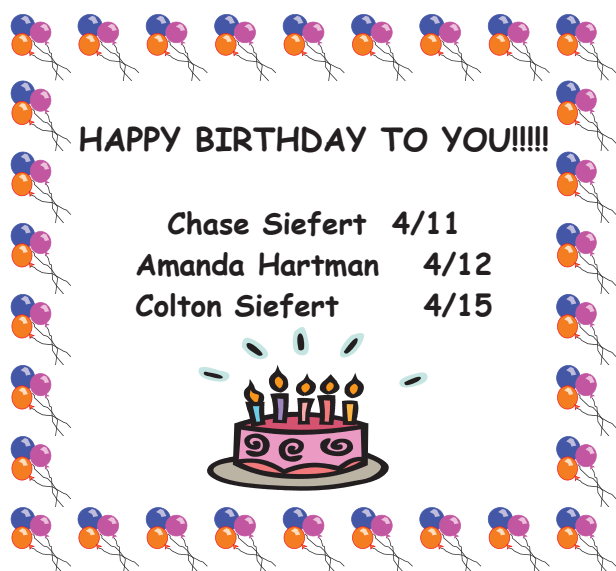

What's making headlines in our ancestral homeland**News and Views from Slovakia...****ZUZANA CAPUTOVA WINS PRESIDENTIAL RACE IN SLOVAKIA**

Zuzana Caputova on Sunday, March 31 was officially announced as the winner of Slovakia's 2019 presidential election on 58.4 percent of the votes in Saturday's run-off against Maros Sefcovic. The official announcement was made by the State Electoral Commission at noon on Sunday.



Caputova received the votes of 1,056,582 people, while Sefcovic obtained 752,403 votes (41.6 percent).

The turnout in the run-off reached 41.79 percent, while it was 48.74 percent in the first round two weeks ago.

Caputova is due to become the first-ever female president of Slovakia, which has had four presidents since it became independent in 1993 – Michal Kovac, Rudolf Schuster, Ivan Gasparovic and Andrej Kiska. She will be appointed Slovakia's first-ever female president on June 15, 2019.

The highest regional turnout in the run-off round of Slovakia's presidential election on Saturday, March 30 was seen in the Bratislava region (54.66 percent), with Kosice region, at the opposite end of Slovakia geographically, also finding itself at the opposite end in terms of turnout on 35.33 percent, the Statistics Office announced on Sunday.

STERLING: USA NOT SEEKING PERMANENT PRESENCE OF ITS TROOPS IN SLOVAKIA

The United States is not seeking to construct a US military base in Slovakia and is not negotiating the permanent presence of US troops in Slovakia, either, US Ambassador to Slovakia Adam Sterling has stressed in a video posted on a social network in connection with the proposed Defence Cooperation Agreement (DCA) between Slovakia and the USA.

Sterling said that he understands the need for a discussion on such an agreement, but it must be based on facts.

"The agreement will provide a legal framework for the two countries to expand military and defence cooperation. Any final agreement would be bilateral, agreed to by both nations and approved via the democratic processes of both nations," explained Sterling, who highlighted the fact that the agreement will allow the USA to invest in Slovakia's military infrastructure, thereby supporting the security of Slovakia and of other NATO allies. "Such an investment would probably also lead to contracts for Slovak companies and good jobs for Slovak workers," stated the ambassador.

Sterling pointed to the fact that the USA has several defence

cooperation agreements or similar agreements in place around the world, including with many other NATO allies. According to him, the agreement is important both for the USA and Slovakia and can "strengthen our shared security and prosperity".

The Slovak Defence Ministry, headed by Peter Gajdos (Slovak National Party/SNS), announced last week that it would no longer participate in talks on receiving financial help as part of the DCA with the United States, claiming that the agreement would put Slovakia's sovereignty in jeopardy. According to the ministry, the offer presented by the United States failed to reflect the operational requests of the Slovak Armed Forces.

The Slovak Foreign Affairs Ministry was surprised by the Defence Ministry's decision, which has also been criticised by President Andrej Kiska and several opposition and coalition MPs. Subsequently, Parliamentary Chair and SNS chair Andrej Danko claimed that no one has refused US funding to repair Slovak air bases because no funds were offered, reiterating that Slovakia's foreign policy orientation hasn't changed.

Gajdos on Thursday also claimed that the funding hadn't been rejected, adding that the negotiations on the DCA need to be completed first and that these talks are the task of the Foreign Affairs Ministry. He also claimed that the Foreign Affairs Ministry hasn't accepted his ministry's comments, and so the latter won't take part in the talks until its remarks are taken into account.



Blessing of the Easter food baskets on Holy Saturday or Easter morning is a tradition among Roman, Byzantine Catholics and Orthodox Christians in Slovakia. Since Roman Catholics and Orthodox Christians fast during Lent, not one morsel of this blessed food is eaten until after Mass on Easter Sunday when it becomes the traditional Easter breakfast. The basket usually contains butter, bread, kraslice(decorated eggs), sausage, ham and/or lamb, smoked meats, cheese, salt, and cake. A candle is placed in the basket so it can be lit during the blessing, and some families tie a bow or ribbon around the basket handle. Everything is covered with a richly embroidered cloth that rests atop the food. It symbolizes Christ's burial shroud. It's usually made of linen and is embroidered with religious symbols related to the Resurrection and the celebration of Easter. These basket covers are passed down from generation to generation.

OBITUARIES

Most Rev. Joseph V. Adamec, Bishop-emeritus of the Altoona-Johnstown Diocese laid to rest

The Most Rev. Joseph V. Adamec, retired Bishop of Altoona-Johnstown, Pa. passed away unexpectedly on March 20. He was 83 years old.

Bishop Joseph was a long-time member of the Slovak Catholic and served for many years as our organization's Episcopal Moderator. He was a regular contributor to our publication over the years. He



was active in the work of the Slovak Catholic Federation where he served as national president and Episcopal Moderator.

A native of Bannister, Mich., he was born there August 13, 1935, son of the late Michael and Alzbeta(Orchran) Adamec, both immigrants from western Slovakia. He attended Michigan State University and studied for the priesthood at the Pontifical Nepomucene College in Rome. He was ordained a priest on July 3, 1960. The following year, he completed studies and was

awarded a Licentiate in Sacred Theology from the Pontifical Lateran University.

Bishop Joseph was ordained for the Diocese of Nitra, Slovakia - the native diocese of his parents. The severe political situation in Czechoslovakia at the time prevented him from fulfilling his desire to serve the Church in the land of his family. Instead, he returned to the United States and began his ministry in his home diocese of Saginaw, Mich.

In Saginaw, Bishop Joseph held a number of diocesan positions including chancellor and secretary to the bishop. He also served as pastor of parishes in Bay City and Saginaw. In 1985, Pope St. John Paul II named him a Prelate of Honor with the title of Monsignor.

On March 17, 1987, Pope St. John Paul II named Msgr. Adamec the Bishop of Altoona-Johnstown, Pa. He was ordained to the episcopacy and installed as the seventh Bishop of Altoona-Johnstown on May 20, 1987. Jozef Cardinal Tomko, Prefect of the Congregation for the Evangelization of Peoples was the principal consecrator and installing prelate.

Bishop Joseph served as ordinary of the diocese until his retirement on Jan. 14, 2011. He was the longest serving Bishop of Altoona-Johnstown. Since retirement, he resided in Hollidaysburg, Pa.

Bishop Joseph was active in the work of the National Conference of Catholic Bishops serving on a number of committees including that of the Aid for the Church in Central and Eastern Europe which greatly assisted in the rebuilding of the Church in Slovakia and Eastern Europe following the fall of communism there. He took an active interest in the work of the American Slovak community, especially in the Slovak Catholic Federation where he was president and served as long-time episcopal moderator. He was a founder of the Conference of Slovak Clergy and was active in our Slovak fraternals. He participated in many Slovak Catholic Sokol conventions, jubilees and other activities. He continued a close collaboration with the Bishops of Slovakia and visited there on numerous occasions.

A viewing took place on March 25 at the Cathedral of the Blessed

Sacrament in Altoona. The funeral liturgy was celebrated in the cathedral on March 26 with Cardinal Justin F. Rigali, Archbishop-emeritus of Philadelphia as principal celebrant. Also present and concelebrating was the Most Rev. Mark L. Barchak, current Bishop of Altoona-Johnstown as well as other bishops and priests. Interment followed in the crypt of the cathedral.

Supreme President Michael J. Horvath headed the delegation of members of the Slovak Catholic Sokol which took part in the funeral rites of Bishop Adamec.

Bishop Joseph was a devoted servant of the Lord who throughout his priestly and episcopal ministry beautifully mirrored our Cyrillo-Methodian heritage of faith. He will be sorely missed. May he enjoy the beatific vision.

Dr. William S. Lesko, dedicated philanthropist and Catholic gentleman, laid to rest at age 82

Dr. William S. Lesko of Franklin Lakes, N.J. and Twin Rivers Farm in Arlington, Vt. passed away peacefully on March 2 at the age of 82.

A native of Passaic, N.J., he was born there January 16, 1937, son of the late Dr. Stephen Lesko and the former Cecil Simpson. His father too was a physician. He was raised in Wallington, N.J. The Lesko family were among the pioneer Slovak immigrants in the area who hailed from what is today eastern Slovakia.

Bill or "Doc" as he would come to be known to his family, close friends and adoring patients, graduated from East Rutherford High School in 1954 where he was a top student and all-state football and baseball player. He received his undergraduate degree from Fordham University in 1958, and following his own father's journey with medicine, went on to the Seton Hall School of Medicine. While in medical school, he married his high school sweetheart, love of his life and partner in all, Joan(Capizzano) Lesko.

While completing his medical training in Ophthalmology, he served in the U.S. Army Reserves. He and Joan began their family, which would ultimately include five children.

In 1968, Dr. Lesko founded North Jersey Eye Associates(NJEA) in Clifton, N.J., where he practiced full time until immediately prior to his illness. NJEA became a bastion of the large surrounding medical community. Dr. Lesko, was recognized as a renowned surgeon and teacher, with a long list of innovations to his credit. He served as President of the medical staffs at St. Mary's Hospital in Passaic, N.J. and the New Jersey Academy of Ophthalmology. He remained committed to the community of Wallington, providing physicals at no cost to the Wallington School System.

Dr. Lesko was an accomplished outdoorsman and enthusiast. He was a coach to local sports teams, a fly fisherman and enjoyed travel with his family. His passion for fishing took him with a cherished group of friends to remote salmon rivers of northern Russia. The waters of Cancun were also a favorite destination and one where he accomplished the rare Super Grand Slam of saltwater fly fishing.

In his later years, Dr. Lesko became an avid beekeeper and conservationist. He was a benefactor of the Battlen Kill Watershed Alliance, a member of Trout Unlimited and served as a trustee of The Windbeam Club.

Dr. Lesko was a coach at heart in every aspect of his life. Whether it was young athletes, young doctors or novice fishermen, he was there to teach. Sports and competition were a lifelong passion for him. He coached Franklin Lakes recreational football and baseball teams

In 2009, Dr. Lesko established the Doctors Lesko Medical Memorial College Scholarship fund which provides an annual grant to deserving members of the Slovak Catholic Sokol who are pursuing medical studies.

In addition to being the beloved husband to Joan for 59 years, Dr. Lesko is survived by his children, William, Jr., Dr. Cecily (Mark Murphy), Greg (Kelly), Glenn (Christine), and Tim (Stephenie) and grandchildren, Graham, Mathew, Emma, Charlie, Will, Alexandra, and Elise. He is also survived by a brother, Steven (Karin) and many loving nieces and nephews. He was predeceased by his siblings Joan, Anne and Daniel.

Family, friends and fellow fraternalists paid their respects to Dr. Lesko at the Vander Plaat-Mermeulen Memorial Home. A Mass of Christian burial was celebrated on March 14 at the Church of the Most Blessed Sacrament in Franklin Lakes, N.J. Entombment followed at Mary Rest Cemetery.

Dr. Lesko was a dedicated professional, philanthropist and community activist. He beautifully mirrored our Cyrilo-Methodian heritage of faith. He was a credit to the Slovak community and will be sorely missed. May he rest in peace.

Centennial of the death of the Slovak Patriot General Milan R. Stefanik, 1880-1919

On May 4 we will observe the 100th anniversary of the death of one of the most important Slovak personalities, General Milan Rastislav Stefanik. General Stefanik was one of the principal founders of the first Republic of Czecho-Slovakia in 1918 along with Thomas G. Masaryk and Eduard Benes. His death on May 4, 1919 at the young age of 39 concluded a very extraordinary life whose efforts led to the liberation of the Slovaks and Czechs.

Milan R. Stefanik was born on July 21, 1880 in the western Slovak village of Kosariska. He was the son of the local Lutheran pastor. From an early age, he strove to lift his Slovak fatherland



up from the social, economic, and cultural oppression of the Magyar rule of Budapest. He enjoyed a great thirst for knowledge. Since he considered science to be fundamental, he registered at the Polytechnical School in Prague. He wavered between this school and the School of Philosophy at Charles University where courses on Astronomy were offered. During the summer semester of 1902 he studied Astronomy in Zurich, Switzerland. A year later, he visited Italy for the first time to visit astronomical observatories there. In November 1904,

he went to France. In 1905, he began his career at the scientific observatory in Meudon. Astronomical research took him to many parts of the world including Tahiti, New Zealand, Australia, Brazil, Morocco, the United States as well as other exotic climes. He soon gained an international reputation in astronomy.

He became a naturalized French citizen in 1912. Following the outbreak of World War I, he volunteered for military service, in the French Air Force, which was still in its infancy. His efforts and abilities soon attracted the attention of the French high command, and was elevated to the rank of brigadier general. In 1915, he organized the Czechoslovak Legion made up of almost 100,000 young Czechs and Slovaks who fought on the allied side. They refused to fight on behalf of Austria-Hungary. They fought on the French, Italian and Russian fronts.

During these years however, Stefanik never forgot his desire to help liberate his homeland from Hapsburg rule. In December 1915, he began collaborating with Thomas G. Masaryk and Eduard Benes with the idea of liberating the Slovaks and Czechs. General Stefanik proved invaluable with his many political and cultural connections in Paris and in Italy. The cause soon enjoyed great support. In 1917, he traveled to the United States where he was welcomed by the strong movement promoting Slovak and Czech liberation most notably by Slovak and Czech organizations united in the Slovak League of America and the Czech National Alliance. He met with Slovak Catholic priests to assure them of the place of the Church in the newly proposed Czecho-Slovak Republic. From New York, he traveled to Washington, D.C. where he received the strong support of the administration of President Woodrow Wilson and his Fourteen Points program.

The long sought dream of the liberation of Stefanik's fatherland finally was realized on October 28, 1918 when the first Republic of Czecho-Slovakia was proclaimed. The original spelling of the new republic with the hyphen reflected the duality of the new Republic. The hyphen disappeared in 1923.

Sadly in the final months of 1918, Masaryk and Benes issued

documents of fundamental importance to the future arrangement of the Czecho-Slovak state, affixing Stefanik's signature without consulting him first. The two then ascribed to themselves all the key offices of the government excluding Stefanik. He was nominated as Minister of War even though the war was over. A new Ministry of National Defense was set up, however Stefanik was not named its head. Such actions certainly indicated the intentions of Masaryk and Benes regarding Stefanik.

The early months of 1919 found Stefanik still in Italy. Finally, he looked forward to a triumphful welcome in his liberated Slovak homeland. Thus at 8:07 a.m. on May 4, 1919, he departed in his "Caproni" a single engine aircraft from Campoformido Airport (Udine) outside Padua. It is said that he indicated that he chose to fly to Bratislava rather than travel by rail "in order not to touch Austrian soil." Approaching Bratislava at 11:30 a.m., on landing, the plane crashed to earth, ablaze. Stefanik and his Italian flight companions were found dead near the airport wreckage. This tragedy ended a very extraordinary life. The unexpected death left Slovaks world-over dismayed. He was a major author of the liberation of Czechs and Slovaks. Interesting enough, the Prague government immediately began bestowing high honors on the Slovak hero. The Prague government even promoted a Stefanik Cult and even went as far as creating the glory of a legend around this deceased individual. All this to promote the ideology, already official, of the "Czechoslovak Nation."

While Stefanik never lived to set foot in a free and independent Czechoslovakia, for the past century he has inspired generations of Slovaks and those of Slovak origin, to promote his legacy during both trying and jubilant years including: Slovak autonomy in 1938; the war-time Slovak Republic, 1939-45; a return to a centralized Czechoslovakia, 1946-48; the advent of 41 years of Communism, 1948-1989; a free and democratic Czech and Slovak Federative Republic, 1989-1992 and finally a free and democratic Slovak Republic which celebrated its 26th anniversary on January 1, 2019.

We celebrate the legacy of General Milan R. Stefanik's greatness on the centennial of his death. May we continue to be inspired by his dedication to freedom and democracy.

The American Slovak community has many monuments to General Stefanik in various parts of the United States. In the board room of our Slovak Catholic Sokol headquarters building a beautiful portrait of this hero graces its walls. It is the work of the late Paul C. Fallat, a noted local artist, who served as Supreme President of the Slovak Catholic Sokol from 1955 until his death in 1973.

TRADITIONS OF A SLOVAK EASTER

Easter is the most significant Christian holiday. Because it is a moveable holiday, its date changes every year. In Slovakia they celebrate Easter for five days – from Thursday until Monday. Every day has its name and importance: Holy Thursday (Green Thursday); Good Friday (Great Friday); Holy Saturday (White Saturday); Easter Sunday and Easter Monday.

As any other Slovak holiday, Easter is also connected with the specific dishes, drinks, habits and superstitions. Preparations for the biggest day of the year starts on Green Thursday. Ladies in the house are busy cooking and baking all types of the Easter goodies. The foods most typical for the Easter are Paska bread, egg cheese – Hrudka, smoked pork ham (of lamb), bacon and sausages, hard boiled eggs and various pastries. Same dishes have different names based on the region.



On White Saturday, housewives take a sample of everything they have prepared, put it in the basket and they go to church to get their food blessed. Blessing of the Easter Food Baskets on Holy Saturday or Easter morning is a tradition among Roman Catholic and Orthodox Christian Central and Eastern European nations. Food from the basket can't be eaten until the Easter Monday and it traditionally becomes Easter breakfast for the family. Typical basket should include Paska bread, egg cheese – Hrudka, smoked pork ham (of lamb), bacon and sausages, butter, hard boiled eggs, various pastries bottle of wine, bit of salt and candle that gets lightened up during the blessing process.

EASTER DECORATIONS

The most important Easter decoration is Kraslica – an egg-



shell with two small holes on the two sides of it. The egg inside is blown out of the shell. The techniques for decorating the eggs are different: the ornament is drawn with melted wax, the egg is then painted, the wax melts and then on the color background there is a white ornament left.

There are two more flowers, rather bushes, and one tree associated with our Easter decorations and Easter itself. The bushes are called "zlatý dážď" (golden rain) and "bahniatka." People collect the branches and put them in the water. Then they hang their kraslice and other decorations on them. The tree associated with Easter is the willow. Men use willow branches to make "korbáč." They use it on Easter Monday to whip single girls.



EASTER MONDAY

"Oblievačka" (water pouring) is a typical Easter Monday custom in Slovakia. The character of oblievačka slightly varies from region to region. On this day men visit their female relatives and friends and pour water on them or spray them with perfume, and whip them gently with special whips made of braided willow rods. According to tradition, pouring water on women will guarantee their beauty and good health throughout the year. Recently oblievačka and sibačka (whipping) have not been as intense as they used to be in the past decades. In many regions, water buckets have been replaced with perfumes, a small syringe filled with water, a water cup, or a water pistol. However, in some villages you may still see young men, sometimes riding on the horses or dressed in traditional folk costumes, who come with rattles and braided whips decorated with colorful ribbons. They may take females out of the houses and douse them with a bucket or buckets filled with cold water. After oblievačka and sibačka, women reward men with sweets, fruit, money, or painted Easter eggs - kraslice.



SLOVAK EASTER BREAD OR PASKA

2 cups milk, 1/2 cup sugar, 2 teaspoons salt, 12 ounces butter (3 sticks), 3 (1/4-ounce) packages active dry yeast, 1 tablespoon sugar, 1 cup warm water (no hotter than 110 F), 3 large eggs (room-temperature), 8 cups all-purpose flour (divided). 1 cup milk (or 1 beaten egg yolk, to wash the dough)

Grease three (7x3-inch) round bread pans and set aside. In a small saucepan, heat 2 cups milk, 1/2 cup sugar, salt, and butter over low heat until butter melts and sugar dissolves. Cool to lukewarm (no hotter than 110 F) and set aside. Dissolve yeast and 1 tablespoon sugar in warm water placed in a mixing bowl or stand mixer bowl that has been warmed. Let proof for 5 minutes. Add eggs, reserved milk mixture, and 4 1/2 cups of the flour. With the dough hook attachment, mix on speed 2 for 1 minute. Continue mixing on speed 2, and add remaining flour 1/2 cup at a time and mix about 2 minutes or until dough clings to hook and cleans sides of the bowl. Continue mixing 2 minutes longer or until dough is smooth and elastic. It will be sticky to the touch. Place dough in greased bowl, turning to grease top. Cover and let rise in warm place about 1 to 2 hours or until doubled. Punch down dough and divide into thirds, reserving a small piece of dough from each to make decorations. Shape each third piece of dough into a round loaf in the prepared pans. Using reserved dough, decorate with a cross in center or braids around the edge. Cover and let rise in warm place 1 to 2 hours or until doubled. Heat oven to 350 F. Gently brush tops of risen dough with milk or beaten egg yolk. Bake 40 minutes or until golden brown. Remove from pans immediately and cool on wire rack.



Zvyky a tradície Veľkej noci na Slovensku

Kresťanské sviatky Veľkej noci majú pôvod v židovskom sviatku pásah, a sú tiež spojené s pohanskými rituálmi víťania jari a zabezpečenia hojnosti úrody. Keďže ide o pohyblivý sviatok, každý rok mu prislúcha iný dátum. Slávi sa vždy v prvú nedeľu po prvom splne mesiaca od jarnej rovnodennosti. Termín preto môže padnúť na obdobie od druhej polovice marca až do konca apríla.

Ako prvá prichádza Popolcová streda, ktorou sa začína štyridsaťdňový pôst končiaci Bielou sobotou. Táto očista tela aj duše mala symbolizovať pôstne obdobie Ježiša Krista na púšti. Pre našich predkov to znamenalo, že jedli iba jedno jedlo denne a museli sa vyvarovať mäsu, rybám, mlieku a vajciam.

Prípravy vrcholia v tzv. Veľkom alebo Svätom týždni, ktorý sa začína Kvetnou nedeľou, pokračuje Modrým pondelkom, Sivým utorokom, Škaredou stredou, Zeleným štvrtkom, Veľkým piatkom, Bielou sobotou, Veľkonočnou nedeľou a končí Veľkonočným pondelkom. V tomto období si kresťania pripomínajú posledný týždeň Ježišova života na zemi. Počas tohto týždňa prebiehajú všetky najdôležitejšie zvyky a tradície.

Na zelený štvrtok sa naši predkovia umývali rannou rosou ešte pred východom slnka, aby boli po celý rok zdraví. Tento deň symbolizuje pre kresťanov predovšetkým poslednú večeru s Ježišom Kristom. Dobytok sa po prvýkrát vyhánal na pašu, na stajnu sa robili cesnakové kríže aby chránili dobytok pred strigami a zlých duchov vyhánali tradičné rapkáče a biče.

Na Veľký piatok sa ľudia kúpali po krk ponorení v potoku, aby nemali vedy, chrasty, lišaje a boli po celý rok zdraví. Ženy verili, že po umytí bude ich pleť očarujúco krásna a jemná, ba dokonca, že im vlasy budú rýchlejšie rásť. Bolo zakázané siať a orať, dokonca nikto nesmel nič robiť na záhrade. Tento deň je v kresťanstve symbolom ukrižovania Ježiša Krista.

Na Bielu sobotu je dôležité mať doma poriadok a končiť s prípravami na hodovanie. V tento deň sa pripravovali obradné jedlá predovšetkým z mäsa a pálili sa tzv. judáše. Spalovaním ohňa zo starého roka sa zbavovali všetkého zlého a zakladal sa v domácnosti nový oheň.

Veľkonočná nedeľa je dňom hojnosti, radosti, veselí a osláv, ktoré pramenia z Kristovho zmŕtvychvstania. Tento deň ukončuje dlhé obdobie pôstu. Po omši sa dávajú posvätiť tzv. košíky hojnosti, ktoré obsahovali všetky pripravené pokrmy. Tradovalo sa, že tomu, kto sa prvý vráti z omše domov, ako prvému dozrie úroda na poli. Stôl hojnosti pripomínal štedrovečerný stôl. Ak ste si mysleli, že naši predkovia zvyšky z posvätných jedál (škrupiny z vajec, kosti) vyhadzovali, ste na veľkom omyle. Zakopávali ich na poli, primiešali do potravy zvieratám alebo spálili v peci.

Veľkonočný pondelok je časom zábavy, kúpačky alebo šibačky. Voda je oddávna symbolom zdravia, krásy a mladosti. Typickým zvykom pre tieto sviatky je na západe populárne šibanie a na východe poriadna oblievačka. Šibačka korbáčom z ôsmich, dvanástich alebo až dvadsiatich štyroch spletených čerstvo narezaných prútov vrby je pokračovaním starej tradície roľníckych rodín. Bitie zeleným prútkom malo zabezpečiť znovuoživenie sily, rast, hojnosť, a hlavne zdravie.

VEĽKONOČNÝ MAZANEC

PRÍSADY: 400 g hladká múka, 100 g polohrubá múka, 100 g krupicový cukor, 1 kocka čerstvé droždie, 150 g rozpustené maslo, 3 ks žltok, 1 PL citrónová kôra, 1 balíček vanilkový cukor, 200 ml vlažné mlieko, štipka soli, mandľové lupienky na dekoráciu, 1 ks žltok na potretie



POSTUP: Do hrnčeka si nalejeme polovicu vlažného mlieka, pridáme rozmixované droždie a lyžicu cukru. Kvások necháme pracovať a medzitým si v miske zmiešame múky, zvyšný cukor, rozpustené maslo, žltky, citrónovú kôru, zvyšné mlieko a štipku soli. Nakoniec vmiešame vykysnutý kvások a rukami vypracujeme cesto, ktoré prikryjeme utierkou a necháme kysnúť asi hodinu. Cesto vyberieme na pracovnú dosku a rúru zapneme na 220°C (430 F). Cesto premiestnime na plech vystlaný papierom na pečenie, opäť ho necháme trochu vykysnúť. Nakoniec ho potrieme žltkom, posypeme mandľovými lupienkami a vložíme piecť do rúry. Po 10 minútach pečenia teplotu znížime na 170°C (340 F) a pečieme ďalších 20 minút.

BARÁNOK

PRÍSADY: 500 g hladká múka, 3 dcl mlieko, 150 g maslo, 1 žltok, 100 g kandizovaný pomaranč, 4 ks vajcia, 120 g cukor, 25 g droždie, štipka soli

POSTUP: Formu na pečenie baránka dobre vymastíme a vysypeme múkou. Bileka vyšľaháme s vanilkovým a práškovým cukrom a prišľaháme žltka. Pridáme múku zmiešanú s kypriacim práškom a zľahka premiešame. Cesto vylejeme do pripravenej formy, zakryjeme s druhou časťou a upečieme.

Po upečení baránka vyklopíme a na mriežke ho necháme vychladnúť. Keď je vychladený, posypeme ho práškovým cukrom.

ZUZANA ČAPUTOVÁ BUDE PRVOU SLOVENSKOU PREZIDENTKOU

Oficiálnou víťazkou druhého kola prezidentských volieb, ktoré sa konali v SR 30. marca, je Zuzana Čaputová so ziskom 58,4 percenta hlasov. Maroš Šefčovič získal 41,59 percenta hlasov. Oficiálne výsledky potvrdila Štátna komisia pre voľby a kontrolu financovania politických strán na tlačovej konferencii v nedeľu 31. marca.

"Na základe takéhoto výsledku volieb, sčítania hlasov aj štátna komisia skonštatovala svojím uznesením, že za prezidentku SR bola zvolená pani Zuzana Čaputová," vyhlásil predseda komisie Eduard Bárany, ktorý zagrataloval víťazke volieb. Poďakoval zároveň všetkým ďalším kandidátom, ktorí sa zúčastnili na voľbách, a tiež tým, ktorí sa podieľali na ich organizácii.

Čaputovú volilo 1.056.582 voličov, Šefčovičovi odovzdalo svoj hlas 752.403 voličov. Volebná účasť dosiahla 41,79 percenta, čo je 1.847.417 voličov. Oproti prvému kolu bola účasť nižšia, vtedy prišlo hlasovať 2.158.859 voličov, čo je 48,74 percenta hlasov.

Slováci si piatykrát v histórii Slovenskej republiky volili prezidenta v priamych voľbách. Slovensko malo dosiaľ štyroch prezidentov. Prvým bol Michal Kováč, ktorého však volil parlament. Priamo si občania volili hlavu štátu prvýkrát v roku 1999, vybrali si Rudolfa Schustera. Po ňom bol dvakrát na čele štátu Ivan Gašparovič a dosiaľ posledným prezidentom je Andrej Kiska. Funkčné obdobie mu uplynie 15. júna, keď bude inaugurovaná jeho nástupkyňa Zuzana Čaputová. Stane sa tak prvou ženou v úrade prezidenta Slovenskej republiky a zároveň vo veku 45 rokov aj najmladšou osobou, ktorá túto funkciu na Slovensku zastávala.
