GEORGE J. KOSTELNIK, OUR LATE SUPREME PRESIDENT, PASSES AWAY

George J. Kostelnik, who served as our Supreme President and most recently as an Honorary Supreme Officer, passed away on December 5 at St. Luke's Hospital in Fountain Hill, PA after a brief illness. He was 92. He was preceded in death by his wife of 50 years Barbara (Knoblauch) Kostelnik.

A native of Bethlehem, PA, he was born of Slovak immigrant parents on

Feb. 27, 1917, to the late Urban Kostelnik and the former Anna Bilik. He attended the former SS. Cyril and Methodius School as was a member of the 1945 class of Liberty High School. He attended the Moravian Preparatory School and Lehigh University. He received his undergraduate degree at West Virginia University School of Mines. He served in the U.S. Army Air Force. He joined Bethlehem Steel Corporation in 1953 and remained with the company until his retirement. He served on numerous local community groups. He was a member

\$63,000 in S.C.S. Scholarship Grants Available to Eligible Members in 2020

We are pleased to announce that the Slovak Catholic Sokol will make available a total of \$63,000 in scholarship grants to eligible members in 2020. Previous recipients of Slovak Catholic Sokol scholarship grants may reapply for a 2020 grant; however, per Convention mandate - a student may receive a maximum of two (2) Slovak Catholic Sokol scholarship grant awards in each category.



A total of 30 Slovak Catholic Sokol college grants of \$1,000 each, two Theodore and Mary Jane Rich Memorial Scholarships one for a male and female in the amount of \$2,000 each, two Emil Slavik Memorial Scholarships one for a male and female in the amount of \$2,000 each, one The Doctors' Lesko Medical Memorial Scholarship in the amount of \$1,000, one Krista L. Glugosh Memorial Scholarship in the amount of \$1,000, one Yencha Scholarship in the amount of \$1,000 and three Slovak Catholic Sokol (SCS) Memorial Scholarships in the amount of \$1,000.

With one application you may apply for all college scholarship grants for which you are eligible. Note that only one grant per applicant will be awarded.

College scholarship eligibility requirements:

SLOVAK CATHOLIC SOKOL (a total of 30, \$1,000 grants will be awarded)

- Must have a minimum of \$3,000 permanent Life Insurance Coverage
- Must be a member of the Slovak Catholic Sokol for at least five years.
- Must have completed one semester of undergraduate studies as a FULL TIME student at an accredited college, university or professional school, or be enrolled in a graduate or professional degree program.
- Must have an accumulated grade point average of at least 2.5 or better
- One parent must be a Slovak Catholic Sokol member
- Essay- "How has being a member of the Slovak Catholic Sokol influenced my life?"

THEODORE AND MARY JANE RICH (one male and one female grant in the amount of \$2,000 will be awarded)

- Same requirements as for SCS scholarship AND
- One parent must be of Slovak Ancestry
- Must be majoring in medical curriculum

EMIL SLAVIK (one male and one female grant in the amount of \$2,000 will be awarded)

- Same requirements as for SCS scholarship AND
- Both parents must be members of the Slovak Catholic Sokol

- Must be majoring in liberal arts, the sciences, pre-law, pre-medical or business curriculum.

THE DOCTORS' LESKO MEDICAL MEMORIAL SCHOLARSHIP (1 grant in the amount of \$1,000 will be awarded)

- Same requirements as for SCS scholarship AND
- Majoring in Nursing or Medical curriculum
- One parent must be of Slovak Ancestry

KRISTA L. GLUGOSH MEMORIAL SCHOLARSHIP (1 grant in the amount of \$1,000 will be awarded)

- Same requirements as for SCS scholarship AND
- Majoring in curriculum with a focus in computer graphics, design or layout

YENCHA SCHOLARSHIP (1 grant in the amount of \$1,000 will be awarded)

- Same requirements as for SCS scholarship AND
- Majoring in Liberal Arts Curriculum

Slovak Catholic Sokol Memorial Scholarship (3 grants in the amount of \$1,000 will be awarded to the applicant that best exemplifies the spirit of volunteerism)

- Same requirements as for SCS scholarship
- Essay- "Describe the one volunteer experience that made the biggest personal impact on you- how/why".

In addition to our college grant program, we make available **18 Catholic High School Grants** in the amount of \$500 each as well as **36 Catholic Grade School Grants** in the amount of \$250 each. SLOVAK CATHOLIC SOKOL COLLEGE SCHOLARSHIP –TIPS FOR SUCCESS

I just wanted to take a moment to highlight the recent changes made to the Slovak Catholic College Scholarship Program. We will continue to use a completely on-line process as we have had few issues with the process over the past several seasons. With the help of our technical webmaster, we have redesigned the application process and you should find it to be much more user friendly. You will find the on-line application on our website at www.slovakcatholicssokol.org beginning November 1, 2019.

To be best prepared for this process a successful applicant should:

- Review the application on-line for required content and gather prior to beginning to complete the form.
- Be prepared to attach both your essay (in PDF or Word format) and a color head and shoulders picture of yourself (in .jpeg format).

Please note, you may want to print a copy for your records prior to submitting. All applicants will receive automatic confirmation that their e-mail has been received.

It really isn't that difficult to qualify for one of our many college scholarships. With now four years of the new College Scholarship Application process behind us, it is clear that there are a few ways to assure that your application will be reviewed.

1. **ANSWER ALL QUESTIONS ON THE APPLICATION.**

For example- if something does not apply to you- say N/A. If you are fully independent from your parents- as in, you are not claimed by them on their tax return, you should indicate that in the space asking for total parent income. Leaving this blank does not tell the whole story.

2. **INCLUDE ALL REQUIREMENTS FOR THE APPLICATION-** i.e. photo; transcript; essay.

Start the process for requesting your transcript NOW.

I have found that sometimes this is the hold up for some applicants.

- **Transcripts-** please note that "official transcript" means that you have requested it from your University or College and that it has been sent directly to me in a sealed envelope. We have not been as strict in the past on this issue, but began holding each applicant to this requirement last season and will continue to do so moving forward.

3. **SUBMIT ALL REQUIRED ELEMENTS PRIOR TO THE DEADLINE.**

The application is clear and I just want to prevent a waste of your time and energy.

Failure to include/complete any of the above items will result in the application being disqualified. To be honest, it is not easy for our committee when we need to disqualify applicants for simple yet important missing requirements.

Lastly, apply for all college scholarships for which you qualify in order to give yourself the best chance at receiving something. There were several applicants who limited themselves to a particular scholarship. Competition was fierce for the larger \$ scholarships, but there seems to be more opportunity with the other scholarship offerings.

Not every applicant receives a scholarship every time they apply. If you have not received one in the past, I encourage you to apply again this year. Before submitting your application- take some time to review the bullet points above in order to assure that your application will be included for consideration.

If for any reason the Grant is not used by the recipient, the entire (or portion of) grant not utilized must be returned.

THE BUST OF GENERAL MILAN RASTISLAV ŠTEFÁNIK UNVEILED IN CEDAR RAPIDS, IOWA



On November 21st Ambassador of the Slovak Republic in the USA Ivan Korčok unveiled the bust of General Milan Rastislav Štefánik, the co-founder of the First Czecho-Slovakia in 1918. At an event organized in the National Czech and Slovak Museum and Library in Cedar Rapids, Iowa, an exhibition about this key figure of Slovak history was opened, as well. The bust commissioned by the Embassy of Slovakia with the support of individual and institutional donors was created by a Slovak-American sculptor Klára Sever.

Milan Rastislav Štefánik (July 21, 1880 – May 4, 1919) was a Slovak politician, diplomat, aviator, and astronomer. During World War I, he served as a general of the French Army and later as the first Minister of War of Czecho-Slovakia.

As one of the leading members of the Czecho-Slovak National Council (the resistance government), he contributed decisively to the cause of Czechoslovak sovereignty. He is considered to be one of the founders of the Czecho-Slovak Republic along with Thomas G. Masaryk and Eduard Benes. – *Photo: Embassy of the Slovak Republic in USA*

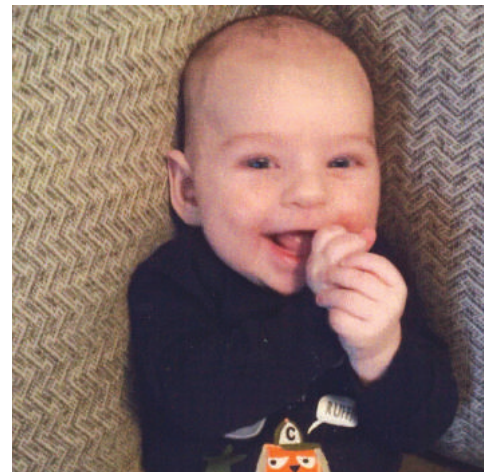

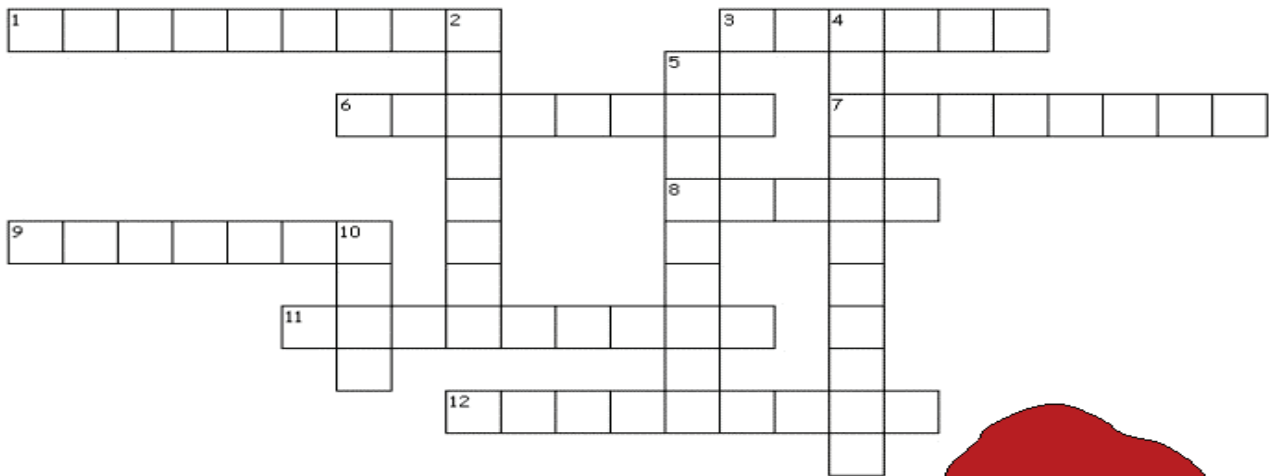

THE FIRST CHRISTMAS CARDS



Though wood engravers produced prints with religious themes in the European Middle Ages, the first commercial Christmas and New Year's card was designed in London, England in 1843.

John Callcott Horsley (1817 – 1903), a British narrative painter and a Royal Academician, designed the first Christmas and New Year's card at the suggestion and request of his friend Sir Henry Cole, who was the first director of the Victoria and Albert Museum. Horsley designed the first Christmas card in 1840, but it went on sale only in 1843, when one thousand cards were offered for 1s each.

The card was not received without controversy, for it showed a family raising their glasses to toast Christmas. Puritans immediately denounced it. The idea was a hit with others. Christmas cards became very popular, and other artists quickly followed Horsley's concept. A particularly popular card was designed by English artist William Egley in 1849.

The first Christmas cards were printed in 1843 in lithography by Jobbins of Warwick Court, Holborn, London, and hand-coloured by an artist named Mason. They were lithographed on stiff cardboard, with the greeting, "A Merry Christmas and a Happy New Year to You." It also states that it was "Published at Summerly's Home Treasury Office, 12 Old Bond Street, London."

Greeting cards were not new. Since Aloys Senefelder perfected lithography in 1796, merchants would send their customers best wishes for the new year. (Lithography is the technique by which large numbers of drawings or texts first drawn on a finely-textured stone could be reproduced on paper.) Christmas cards gradually replaced New Year's card, except in France, where there was a preference for the latter.

Fun Facts about New Year's Eve

- * 1 Million: The estimated amount of people who will gather in New York's Times Square to see the ball drop.
- * 70 percent: In attendance between ages 19-35.
- * 32 percent: In attendance between ages 36-45.
- * 1 Billion: The amount of viewers worldwide who watch Times Square on TV.
- * 2,000: The pounds of confetti expected to rain down on the crowd in Times Square.
- * 49 million: The amount of bubbles in a standard Champagne bottle.

THE STORY OF THE CHRISTMAS CAROL SILENT NIGHT, HOLY NIGHT

The best known Christmas carol Silent Night was written in 1818 by an Austrian assistant priest Joseph Mohr. He was told the day before Christmas that the church organ was broken and would not be repaired in time for Christmas Day. Saddened, he sat down to write three stanzas that could be sung by choir to guitar music. "Stille Nacht, Heilige Nacht" was heard for the first time at that Midnight Mass in St. Nicholas Church in Oberndorf, Austria. The congregation listened as the voices of the Fr. Joseph Mohr and the choir director, Franz Xaver Gruber, rang through the church to the accompaniment of Fr. Mohr's guitar. Today, Silent Night, Holy Night is sung in more than 180 languages by millions of people.

The popularity of Christmas was further spurred on in 1820 by Washington Irving's book *The Keeping of Christmas at Bracebridge Hall*. In 1834, Britain's Queen Victoria brought her German husband, Prince Albert, into Windsor Castle, reintroducing the Christmas tree and carols to the British Empire. In 1837, T.H. Hervey's *The Book of Christmas* became a best seller. Printed books were more popular then ever. The Bible was selling marvelously well. Christmas was here to stay. But it was another title that took Christmas right into people's homes.

SHARING THE CHRISTMAS OPLATKY *A cherished Slovak faith tradition*



The traditional Oplatky are generally enjoyed during the Christmas Eve dinner. However, they can be enjoyed at any dinner during the Christmas observance. As family and friends begin their meal, the head of the household begins the "Stedry Vecer" (bountiful evening) with sharing of the Oplatky, the blessed Christmas wafers eaten with honey. He or she places honey on the Oplatky and shares them with the family and friends assembled for the meal. He then makes the sign of the cross with the honey on the foreheads of all present and shares the Oplatky. The Oplatky, actually Oblatky, since the word comes from the Latin word "oblata" or offering; have been blessed by the priest according to the prescribed formula for the blessing of bread in the Roman Ritual.

The Oplatky are eaten with honey and remind us of the unleavened bread of the Passover. It also reminds us of the manna which God fed the chosen people in the desert following their Exodus from Egypt. Most importantly, they remind us of the Eucharist.

SLOVAK CHRISTMAS RECIPES

NUT AND POPPY SEED ROLL

POPPY SEED FILING

1 pound poppy seeds
2 cups milk
1 1/2 cups sugar
1/2 stick butter
1 cup raisins



WALNUT FILLING:

1 lb. ground walnuts
3/4 cup sugar
4 tbsp. melted butter, plus extra for greasing sheet and brushing
1/4 to 1/2 c. warm milk
1/2 tsp. vanilla flavoring

For both fillings combine all ingredients in a saucepan. Simmer for 30 minutes. Let cool entirely before using as a filling.

DOUGH

1 (.25 ounce) package active dry yeast
1/2 cup warm water
2 tablespoons white sugar
2 cups all-purpose flour, or more if needed
1/2 teaspoon salt
1/4 cup butter
1 egg, separated - white reserved

Mix yeast with water and 2 tablespoons sugar in a small bowl. Allow to stand until the yeast forms a creamy layer. Whisk flour with salt in a bowl; use a pastry cutter to cut 1/4 cup butter into the flour mixture until the mixture resembles coarse crumbs. Pour yeast mixture and egg yolk into flour mixture and stir to make a soft dough. Turn dough out onto a floured work surface and knead until smooth and slightly springy, about 5 minutes. If dough is too sticky, knead in more flour, about 2 tablespoons at a time.

Cut dough into 2 equal pieces. Roll each piece out into a 12x16-inch rectangle. Spread half the filling over each rectangle, leaving a 1-inch border. Fold the 1-inch border back over the filling on all sides and press down. Pick up the shorter side of a dough rectangle and roll it like a jelly roll; repeat with second rectangle. Pinch ends together or tuck ends under to prevent filling from leaking out. Line a baking sheet with parchment paper; place rolls seam sides down on the baking sheet and allow to rise in a warm place until doubled, about 1 hour. Preheat oven to 350 degrees F (175 degrees C).

Beat egg white in a bowl until frothy; brush the rolls with beaten egg white. Bake in preheated oven until dark golden brown on top, 30 to 40 minutes. Remove from oven and cover rolls with a clean kitchen towel until cool to keep crust soft. Cool completely before slicing.

SAUERKRAUT SOUP – KAPUSTNICA

This traditional Slovak soup uses already prepared ingredients, like sauerkraut, smoked ham, and smoked sausage, to make a hearty and warming soup that requires very little prepping time.

2 lbs smoked ribs or ham
4 quarts water
2 bay leaves
1/2 tsp peppercorns
2 tbsp lard
2 onions
1.5oz bacon
4 cloves garlic
1oz dry mushrooms
1 tsp coarsely ground caraway
1 tbsp paprika
25oz sauerkraut squeezed
11oz klobasa 2-3 smoked sausages
sour cream for optional garnish



Put water, whole smoked ham, bay leaves, and peppercorns in a 5 quart pot. Let simmer for at least one hour, if not longer. In a pot of at least 7 quarts, melt lard and saute onions until golden. Meanwhile, soak mushrooms in water. Chop bacon and garlic and add to onions, stirring until garlic is fragrant. Add caraway, then paprika, stir and immediately add in squeezed sauerkraut, reserving the juices. Sauerkraut can be cut shorter beforehand, for easier eating. Stir. Add soaked mushrooms and whole klobasa. Add broth from the smoked ham, and simmer until sauerkraut is soft, about 30 minutes. Cut up ham and klobasa and slice, then add both to pot. Use the reserved sauerkraut juice to add extra saltiness or sourness. Serve with optional sour cream for garnish.

BOBALKY

2 cups whole milk
1/2 cup unsalted butter
7-1/2 cups all-purpose flour
1/2 cup sugar
2 teaspoons salt
2 envelopes active dry yeast, 0.25 ounce packets
2 whole large eggs
2 tablespoons hot water
Honey for drizzling
Poppy seeds for sprinkling

Heat milk and butter over low heat in a saucepan. Heat it just enough to melt butter then remove the pan from the heat and set aside.

In a large mixing bowl combine dry ingredients (flour through yeast). Add milk and butter to the dry ingredients. Then add eggs. Mix well and knead till dough is no longer sticky. Cover the bowl and let the dough rest for 10 minutes. Punch it down and let it rise till doubled in size.

Preheat oven to 400 F. Pull off dough into walnut-sized pieces. Roll into balls and place the balls on sheet pans lined with parchment paper.

Bake at 400 F for 12-15 minutes. Remove pans from the oven and put baked balls into a colander. Pour a small amount of hot milk over the balls then put them in a large bowl. Drizzle with honey and sprinkle with poppy seeds as desired. Toss and serve.

from Slovakia...****EC Predicts Slower GDP Growth
in Slovakia until End of 2021**

Slovakia's real GDP growth will significantly decelerate from last year's level of 4.0 percent to 2.7 percent in 2019 and remain at similar levels – 2.6 percent and 2.7 percent – in 2020 and 2021, respectively, stated the European Commission (EC).

As a result of significant salary growth and record-low unemployment, private consumption will continue to be a significant source of GDP growth, but weaker demand from key trading partners in the EU will "take its toll" in the form of lower exports to those countries, mainly in 2019.

According to the EC, Slovakia has been under pressure from lower foreign demand in 2019, but exports can be expected to increase gradually, probably by 4.5 percent in 2021. Slovakia's trade balance should slip into negative territory in 2019 and then gradually recover in 2020 and 2021. However, this bounce back will depend on the prospects for Slovakia's key trading partners and developments influencing the automotive industry (such as potential US customs charges).

Job creation in Slovakia decelerated in 2019, and the EC stressed that this trend might continue in 2020 and 2021. The unemployment rate is expected to drop to a record low of 5.9 percent in 2019 and to fluctuate around this level in 2020 and 2021 as well. The positive impact of job creation on disposable household incomes is expected to weaken, but strong salary growth should support these incomes. Following this year's significant salary growth in the public sector, salaries will go up only moderately in 2020 and 2021.

The Commission predicted that inflation will remain at a slightly increased level during the monitored period, standing at 2.7 percent in 2019, 2.5 percent in 2020 and 2.2 percent in 2021. Overall inflation should mainly be driven by services, food prices and energy. Food prices, which recorded rapid growth in 2019, should slow down in the next two years.

Slovakia's public finance deficit rose by 0.1 percentage points to 1.1 percent of GDP in 2018. It should fall to 0.9 percent of GDP in 2019. The EC expects it to increase to 1.2 percent in 2020 as a result of Government fiscal measures aimed at reducing the tax burden and the introduction of minimum pensions.

The News Agency of the Slovak Republic (TASR) released a new version of the TASR Pro application on Wednesday, allowing access to agency services via Android and iOS mobile devices, while the upgraded version offers flash and brief story notifications, broader customisation options and other functional enhancements.

"The quality of contents and innovations in their delivery are our priorities. The application is a news agency on a mobile phone. Customers don't need to be on a desktop computer or within the editorial system to know what TASR has released. A notification will alert them to important stories according to the

selected criteria," said TASR general director Vladimír Puchala.

The application is intended for the agency's clients. It's available in the Play Store and App Store under the name TASR Pro 2, and requires a login to use. In addition to agency services, the application also offers the possibility to integrate outputs from WebReport online monitoring or monitoring of TASR's agency service.

"We focused on improving existing functions and added others partly based on user feedback. We think the application will be appreciated not only by media staff, but also by people in communications departments and other professions working with information," said TASR sales and marketing director Rastislav Borsík.

**"N'89-ROAD TO FREEDOM" EXHIBITION
OPENS AT BRATISLAVA CASTLE**

An exhibition titled N'89 – Road to Freedom, capturing the era of late 1980s up to the 1989 Velvet Revolution, opened on Thursday, November 14 at Bratislava Castle.

Organised by the Slovak National Museum, Nation's Memory Institute and Klub 89, the exhibition opening ceremony was also attended by Parliamentary Chair Andrej Danko. "It was an era [the previous communist regime] that had a certain appeal, but, of course, it also had downsides and shortcomings. Key among these [shortcomings] was the fact that we couldn't really say what was on our minds and people always had to be on guard as to whether or not they were under surveillance," claimed Danko.

The organisers decided to expand on the project and add the aspect of freedom perception. "Two generations of young people have grown up in Slovakia since the revolutionary days of 1989 that either hadn't lived through the Velvet Revolution or were barely ten years old and hence didn't really understand political changes in the state. That's why the beginning of the exhibition is set in the mid-1980s and perceptive visitors might familiarise themselves or recall the main restrictions on freedom in communist Czechoslovakia," the organisers wrote on the museum's website.

The exhibition concludes with the first free election of 1990, the destruction of the Klement Gottwald Memorial [dedicated to the Stalinist-era Czechoslovak president-ed.note] and the renaming of Gottwald Square as the present-day Namestie Slobody [Freedom Square]. N'89 – Road to Freedom will stay open until November 22, 2020.

**ANALYSTS: WEAK FOREIGN DEMAND DRAGGED
SLOVAK GDP GROWTH DOWN**

Slovakia's economic growth decelerated significantly to 1.3 percent year-on-year (y-o-y) in the third quarter of 2019, far below expectations, which were at the levels seen in the previous quarter, namely 1.8-2.4 percent y-o-y.

The slowdown was mainly due to lower foreign demand, but certain domestic sectors also weakened, the analysts concurred.

"Slovakia's economy decelerated significantly for the second time this year, and it seems that the economic slowdown in the eurozone, particularly in Germany, has been affecting it strongly," said VUB Banka analyst Michal Lehuta.

Industrial production in July-September fell by 2.6 percent y-o-y, with exports down by 1.5 percent. Negative figures were also posted by the construction sector (minus 3.8 percent) and retail

revenues (minus 2.2 percent y-o-y).

"Despite rapidly rising salaries and growing employment, people aren't spending particularly much in the shops. Nevertheless, domestic demand in 3Q19 in terms of revenues allowed for growth in the sectors of accommodation, restaurants and pubs, transport, miscellaneous expert services, and the sale and repair of vehicles," noted Lehuta.

Slovenska sporitelna bank analyst Katarina Muchova estimates that Slovakia's GDP growth could decelerate to 2.5 percent y-o-y in 2019 and to 2.3 percent in 2020. She pointed out that these figures could turn out to be even lower due to uncertain developments in industry and foreign trade.

With domestic demand remaining sound, Muchova pointed to some external threats to Slovakia's economic performance, most notably Brexit, a slowdown in Germany, the eurozone and China, unresolved foreign-trade disputes and possible protectionist measures at international level.

BUS CRASH NEAR NITRA CLAIMS AT LEAST TWELVE LIVES, INCLUDING FOUR MINORS

Twelve people, including four minors, were killed in a crash involving a bus and a lorry near Nitra on Wednesday, November 13 afternoon, with another 17 people being injured, ministers of interior and health, Denisa Sakova and Andrea Kalavska, respectively, told journalists near the scene.

The bus on the Nitra-Jelenec route was carrying many students returning home from schools in Nitra. Both drivers were injured in the accident.

Two paramedic helicopters and seven paramedic ambulances, apart from the fire-fighter ones, intervened on the scene. The injured were taken to hospitals in Nitra, Nove Zamky, Topolcany and Levice (all Nitra region).

The police called Wednesday, November 13 the most tragic day of this year in Slovakia, as 12 people were killed in the bus crash near Nitra, three women were drowned in the Muran River after it burst its banks, five people committed suicide, two people were hit by trains and two others were killed in other traffic accidents.

MOST SUCCESSFUL SLOVAK FEMALE TENNIS PLAYER EVER CIBULKOVA RETIRES

The most successful Slovak female tennis player ever Dominika Cibulkova announced her retirement from professional tennis on Tuesday, November 12.

Cibulkova, the tennis world champion from 2016, made the announcement at the presentation of her autobiography 'Tenis je mojivot' (Tennis Is My Life) in Bratislava.

"It was my last match at Roland Garros [first round, in late May]. I wanted to absorb it and see whether I've come to terms with it. I believe that today is the perfect day for this [announcement]. I've thought about it for a long time and I'm looking forward to a new life," said Cibulkova with watery eyes.

Cibulkova, who won eight WTA tournaments in singles in her career, recorded her best result as part the Grand Slam series by reaching the finals at 2014 Australian Open. She was fourth in the WTA world ranking in March 2017, whereby she equalled the Slovak best ever of Miloslav Mecir from 1988.

"I was surprised by Dominika's decision. It's a huge loss for Slovak tennis. Dominika was the best-ranked Slovak player in the era of independence [since 1993], she represented the country in an excellent manner for many years in the Fed Cup. She triumphed at the WTA World Championship in Singapore and she was also greatly successful at Grand Slam tournaments, with Australian Open finals and Roland Garros semi-finals being fantastic results. She was a great role model for children and the youth," said Igor Moska, Secretary General of the Slovak Tennis Association.

"She's a diligent and fair woman. She's had to fight out everything hard and alone. She's never got anything for free. With her short figure, it wasn't easy for her to get among the world's best, but she managed it. We've been friends since our childhood, we had the same strength and conditioning coach, we played for Slovan [Bratislava]. She's always been kind-hearted and cheerful," said Dominik Hrbaty, Slovak Davis Cup captain, who partnered Cibulkova in a campaign that resulted in Slovakia's third title at the 2009 Hopman Cup.

Mnohí z nich si spomínajú na tradičné Vianoce, ktoré zažili ešte s ich prastarými rodičmi v neslovenskej krajine alebo si spomínajú na tie, ktoré zažili v časoch, keď ešte žili na Slovensku.

Vianoce sú azda najkrajší kresťanský sviatok. Človek k človeku má v tomto čase bližšie, v hrudiach bijú slovenské srdcia hlasnejšie, náruč sa otvára širšie, ruky viac hladia, ústa viac chvália...

Pre slovenskú národu však celoročne ostáva typické, že si z pokolenia na pokolenie zachováame svoje zvyky, lipneme na starootcovskom dedičstve a nezabúdame na tradičné...

Mnohí z krajanov ešte stále na stromčekoch majú zavesených vyrezávaných drevených anjelíkov, krehké bábiky zo šúpolia, kúsky sušeného ovocia, vlašské oriešky, voskové sviece a na štedrovečernom stole sa tkvie krásna, slovenská výšivka.

A poznáte poveru s orechovou škrupinkou? Keď sa vlašský orech rozpolil, položila sa škrupina na vodu a tomu, komu odplávala najďalej, predpovedala odchod do cudziny. Kto vie, či sa takáto predpoveď ukázala i našim krajanom, ktorých osud zavial ďaleko od svojej domoviny...

Po štedrej večeri mnohí odchádzali do kostola, iní vytvárali živý Betlehem a chodili spoločne koledovať z jedného konca dediny na druhý.

Aj my, tak ako betlehemi skí koledníci, Vám chceme adresovať naše prianie do všetkých kútov zeme, všade tam, kde žijú naši krajanovia. Zo sídla a srdca Matice slovenskej, z Martina, Vám chceme z úprimného srdca zaželať krásne, pokojné, radostné a najmä šťastné a veselé Vianoce, plné vzájomnej lásky a pokoja.

Matica slovenská je hrdá na to, že i dnes, v roku 2019, udržujete slovenské zvyky a cítite sa byť Slovákmi.

KRÁTKE SPRÁVY ZO SLOVENSKA



Slovensko tento rok zaznamenalo nárast počtu žiadostí cudzincov o udelenie azylu. Do konca septembra vyhovel iba štyrom žiadateľom. Vyplýva to z údajov ministerstva vnútra SR. V Európskej únii sa Slovensko neradí k cieľovým krajinám migrantov. Od začiatku tohto januára do konca septembra slovenské úrady dostali 176 žiadostí o azyl. To je takmer toľko ako za celý minulý rok; oproti prvým trom štvrtrokom 2018 počet žiadateľov o azyl na Slovensku stúpol o viac ako štvrtinu.

Bratislavské historické centrum patrí medzi 50 najdrahších nákupných lokalít sveta. Vyplýva to z najnovších údajov spoločnosti Cushman & Wakefield, ktorá každoročne zostavuje rebríček najdrahších nákupných ulíc na svete. Slovenská metropola je oproti vlaňajšku o jednu priečku vyššie. V rebríčku najdrahších ulíc sveta sa bratislavské centrum umiestnilo na 49. mieste. Vlni lokalite patrila 50. priečka, v rebríčku bola doteraz zaraďovaná ako Obchodná ulica. Tentoraz analytici pomenovali nákupnú lokalitu „centrum mesta“, nielen Obchodnú. Reflektujú tým na to, že najdrahšie obchody nie sú na tejto ulici, hoci práve tá je považovaná za jediný nákupný bulvár v meste.

Miera evidovanej nezamestnanosti na Slovensku v októbri tohto roka dosiahla úroveň 4,94 percenta. Medzimesačne klesla o 0,10 percenta medziročne sa znížila o 0,29 percenta. Vyplýva to z najnovšie zverejnených údajov Ústredím práce, sociálnych vecí a rodiny. Nezamestnanosť sa tak podľa ústredia práce vrátila k poklesu a znížila sa v prípade viacerých skupín - mladých ľudí aj v prípade dlhodobo nezamestnaných. Stav disponibilných uchádzačov o zamestnanie dosiahol ku koncu októbra tohto roka 136.192 osôb.

Rozpočet Ústavu pamäti národa na rok 2020 bude doteraz najvyšší v histórii. Podľa návrhu rozpočtu na budúci rok bude ústav hospodáriť s 2 008 292 eur, čo je v porovnaní s rokom 2019 o 92-tisíc eur viac. Materiál schválili členovia výboru Národnej rady Slovenskej republiky pre ľudské práva a národnostné menšiny. Finančné prostriedky ústav použije na ochranu a sprístupnenie dokumentov o činnosti bezpečnostných zložiek štátu v rokoch 1939 – 1989, zhromažďovanie a zverejňovanie informácií o dobe neslobody, sprístupnenie dokumentov prenasledovaným osobám a poskytovanie výsledkov svojej činnosti verejnosti.

ŠTEDROVEČERNÝ STÔL SYMBOLIZUJE HOJNOŠŤ

Počas štedrej večere sa pod biely ľanový obrus sa kládli peniaze alebo hrst' ovsu či jačmeňa, aby sa v budúcom roku rozhojnili.

Na tento deň sa aj v časoch biedy odkladala ušetrená múka, cukor, strukoviny, mak, sušené ovocie, lekvár, med, masť na vyprážanie šišiek aj sladké víno. Večera mala obsahovať aspoň deväť jedál. Ak bolo jedla dostatok, rodinu čakal priaznivý rok.

Cez deň sa nejedlo nič, alebo len málo, pretože až do Druhého vatikánskeho koncilu v roku 1965 platil na Štedrý deň prísny pôst. Deťom rodičia za sebazaprenie sľubovali, že večer uvidia zlatú hviezdu, krokvu alebo prasiatko. Pôstny obed zvyčajne tvorili zemiaky bez masť s riedkou nevaranou kapustnicou.

Výber štedrovečerných jedál ovplyvňoval charakter krajiny. Jedálne lístky sa rôznili v horských a nížinatých oblastiach, v ovocinárskych, vinohradníckych a pastierskych regiónoch, v meste a na dedine. K viac-menej univerzálnym jedlám patrili ob-



látky s medom, kapustnica, zemiaky, varený hrach, fazuľa, opekance, rezance či iné cestoviny a kompót zo sušených sliviek.

S rôznymi druhmi cestovín boli spojené mnohé povery. Varili sa rezance, pirohy, šúľance, halušky a najmä opekance, nazývané aj pupáky alebo bobalky. Veľké pirohy a šúľance symbolizovali napríklad veľké obilné klasy. Vodu z opekancov vyľievali pod ovocné stromy, aby dobre rodili. Do tradičnej kapustnice sa pridávali sušené

hríby a slivky, nie mäso, pretože aj večera mala byť napriek hojnosti pôstna. Z toho istého dôvodu sa v katolíckom prostredí rozšírilo podávanie ryby.

V dnešnej podobe sa začala ryba konzumovať až v minulom storočí. Dovtedy sa jedli najmä slané a údené ryby. Ryba je zároveň symbolom kresťanstva, odvodeným z doby starovekých prenasledovaní. Grécke slovo ichthys – ryba, znamenalo v tajnej reči kresťanov Ježiš Kristus Syn Boží Spasiteľ – Iesus Christos Then Hyois Soter. Po rybe nasledovala v niektorých oblastiach "Ježiškova kašička", čiže krupicová kaša, ktorú jedla celá rodina z jedného veľkého taniera. Rôzne koláče a zákusky sa pridávali až neskôr – našim predkom ich nahrádzal chlieb, ktorý bol pre nich vzácnosťou.

Vianočné jedlá požívali osobitnú úctu. Zo štedrovečerného stola sa nemohlo nič vyhodiť, odkladali sa aj odrobinky, ktoré vraj pomáhali, keď ochorel dobytok.

SLOVENSKÉ VIANOČNÉ RECEPTY

MEDOVÉ KOLÁČIKY

Suroviny:

650 g polohrubej múky, 300 g práškoveho cukru, 2 čajové lyžičky jedlej sódy, 1 čajová lyžička klinčekov, postrúhaná citrónová kôra, 8 polievkových lyžíc horúceho medu, 3 vajcia, mandle

Postup:

Do múky preosejeme cukor, pridáme jedlú sódu, potlčené klinčeky, postrúhanú citrónovú kôru a s horúcim medom, tromi žĺtkami a dvoma bielkami zarobíme cesto (tretí bielok použijeme na potretie). Cesto vyvalkáme na hrúbku 0,5 cm, vykrojíme rôzne tvary, potrieme ich rozšľahaným bielkom a upečieme v rúre predhriatej na 200 °C.



LINECKÉ KOLIEČKA

Suroviny:

600 g múka hladká, 300 g maslo, 200 g cukor práškový, 1 balík prášok kypriaci do pečiva, 1 balík cukor vanilkový, 2 ks nasrúhaný varený žĺtok, 2 ks vajcia, štipka soľ

Postup:

Všetky suroviny zmiešame a vymiesime

hladké cesto, ktoré dáme do chladničky na 2 hodiny. Cesto rozdelíme na 3 kusy a rozvalkáme na hrúbku 4 milimetre. Dáme na plech a pečieme

12 minút v predhriatej rúre na 165 stupňov Celzia (330 F). Vychladnuté zlepieme lekvárom a poprášime vanilkovým cukrom.



KAPUSTNICA

Suroviny:

1 kg kyslá kapusta, 2 ks klobása, 1 ks cibuľa, sušené hríby, 2 PL mletá červená paprika, olej, soľ, bobkový list, 2 PL hladká múka

Postup:

Kyslú kapustu dáme variť do veľkého hrnca, pridáme klobásku a vopred namočené sušené hríby. V inej rajnici dáme na olej pokrájanú cibuľu, papriku, hladkú múku, urobíme zápražku. Klobásku vyberieme, nakrájame na kolieska. Zápražku vle-



jeme do uvarenej kyslej kapusty, necháme prevrieť, miešame. Klobásku hodíme do plievky, ešte prevaríme. Ochutíme soľou, ak treba.

VANILKOVÉ ROŽTEKY

Suroviny:

170 g hladká múka, 110 g maslo, 40 g práškový cukor, 50 g mleté orechy, 1 balíček vanilkový cukor, práškový a vanilkový cukor na obalovanie

Postup:

Zo všetkých surovín vypracujeme cesto, ktoré zabalíme a odložíme na dve hodiny do chladničky. Potom cesto vyberieme a rukami postupne z neho odobierame kúsky, z ktorých urobíme rožteky, ktoré ukladáme na plech vystlaný papierom na pečenie. Pečieme ich vo vyhriatej rúre pri teplote 150°C (300 F) asi 12 minút. Po upčení ich hneď obalíme v zmesi práškového a vanilkového cukru.
