## WHY IS MAY THE MONTH OF MARY?

The ways Mary is honored in May is as varied as the people who honor her.

May, the month in which the earth springs into bloom and we start thinking about planting gardens, family picnics and making vacation plans.



It's also the Month of Mary.

For centuries, the Catholic Church has set aside the entire month of May to honor Mary, Mother of God. Not just a day in May, mind you, but the entire month.

The custom spans both centuries and cultures, with roots going back as far as the Ancient Greeks. In early Greece, May was dedicated to Artemis, the goddess of fecundity.

In Ancient Rome, May was dedicated to Flora, the goddess of blooms, or blossoms. They celebrated ludi florals, or floral games, at the end of April and asked the intercession of Flora for all that blooms.

In medieval times, similar customs abounded, all centering around the practice of expelling winter, as May 1 was considered the start of new growth.

During this period, the tradition of Tricesimum, or "Thirty-Day Devotion to Mary," came into being. Also called, "Lady Month," the event was held from August 15-September 14 and is still observed in some areas.

The idea of a month dedicated specifically to Mary can be traced back to baroque times. Although it wasn't always held during May, Mary Month included thirty daily spiritual exercises honoring Mary.

It was in this era that Mary's Month and May were combined, making May the Month of Mary with special devotions organized on each day throughout the month. This custom became especially widespread during the nineteenth century and remains in practice until today.

The ways Mary is honored in May is as varied as the people who honor her.

It's common for parishes to have a daily recitation of the Rosary during May, and many erect a special May altar with a statue or picture of Mary as a reminder of Mary's month. Additionally, it's a long-standing tradition to crown the statue of Mary during May – a custom known as May Crowning. Often, the crown is made of beautiful blossoms representing Mary's beauty and virtue. It's also a reminder to the faithful to strive to imitate our Blessed Mother's virtue in our own lives. May Crowning, in some areas, is a huge celebration and is usually done outside of Mass, although Mass may be celebrated before or after the actual crowning.

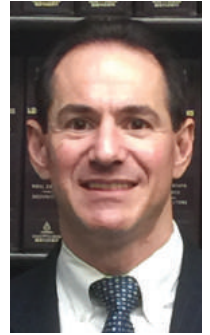
But May altars and crowning's aren't just "church" things. We can and should be doing the same in our homes. When we echo the customs and traditions of the Church in our homes – our domestic churches – we participate more fully in the life of the Church.

If you haven't already, I encourage you to erect a prayer corner in your home. No matter how fancy or simple it is. The main point is that it's a place designated for God, and more specifically, for spending time with him. Just as you need

## 2021 LAW DAY MESSAGE FROM OUR GENERAL COUNSEL

On May 1, 2021, America celebrates Law Day. It is a national day set aside to celebrate the rule of law. In 1958, President Eisenhower proclaimed the first Law Day a "day of national dedication to the principle of government under law." Throughout the years, Law Day has engaged the public in discussion on relevant issues that focus on enhancing knowledge of our governmental structure and legal process. The rule of law is the bedrock of American rights and liberties – in times of calm and unrest alike. The 2021 Law Day theme, "Advancing the Rule of Law Now," reminds us all that we the people share the responsibility to promote the rule of law, defend liberty, and pursue justice. The rule of law is not just a matter of concern to lawyers and judges. It affects people from all walks of life, including, but not limited to, clergy, teachers, workers, physicians, journalists, engineers, architects, public safety officials, military leaders, human rights advocates, environmentalists, and others. It is important that all of us care about the rule of law and do our utmost to be active participants in the civic life of our communities. By analyzing the rule of law on this Law Day, all of us will learn about the principles and values that characterize the rule of law and how it matters in the everyday lives of Americans and others throughout the world.



### HISTORICAL PERSPECTIVE

History provides us with numerous perspectives on the rule of law, including not only its importance, but also its values and principles. There are many historical quotes about law and the rule of law throughout history which can teach us about the role the rule of law has played, both as an idea and in practice. President John F. Kennedy stated, "By strengthening the rule of law, we strengthen freedom and justice." President Johnson remarked, "Thus all who cherish freedom should also cherish law. Liberty and law abide together. In that bond is the foundation of our liberties." President Theodore Roosevelt stated, "Ours is a government of liberty by, through and under law. No man is above it, and no man is below it." President Ronald Reagan in 1984 when he made his Law Day Proclamation stated, "Our unique experience demonstrates that law and freedom must be indivisible partners. For without law, there can be no freedom, only chaos and disorder; and without freedom, law is but a cynical veneer for injustice and oppression."

### RULE OF LAW: WHAT DOES IT MEAN?

The rule of law refers to a system of self-government with a strong and accessible legal process. It features a system based on fair, publicized, broadly understood, and stable laws; and diverse, competent and independent lawyers and judges. The rule of law touches everyone, every day. It affects our safety through workplace and building safety regulations; jobs through fair employment laws; health through health regulations on pollutants and medications; education through legally mandated access to public education; and infrastructure through regulation of roadways and utilities. The rule of law is needed for the military, police, and firefighters to make communities safe; labor organizations to assert workers rights; businesses to sell goods and services which creates jobs and other opportunities to communities; educators to enhance and make available quality education for all children; and public health organizations to protect communities, especially the poor, from sickness.

### PROTECTIONS GUARANTEED BY THE RULE OF LAW

The term rule of law is an expansive concept, and there are many working definitions. What it really means is that the law is the

## REPORTS OF THE SUPREME OFFICERS FOR 2020 PRESENTED AT THE FIRST QUARTERLY MEETING OF THE BOARD OF DIRECTORS HELD MARCH 18-10, 2021 – ZOOM CALL

### REPORT OF THE GENERAL COUNSEL

This report is submitted for the purpose of advising of the activities of the Office of the General Counsel during the year 2020. I have endeavored to fulfill all the duties and obligations of my office to the best of my ability for the good and welfare of the Slovak Catholic Sokol.

This past year was exceedingly trying in so many ways. Everyone focused on the COVID curve, vaccine approval and government assistance for direction.

While 2020 has challenged us in ways we never expected, we have been fortunate during this tumultuous time to have a talented group of Supreme Officers who have guided our organization. Our fraternal continues' to survive and endure because our officers have administered the affairs of the Slovak Catholic Sokol in the highest standards of excellence. As we enter 2021, let us hope that the deadly and crippling virus, through medical advances, becomes a non-issue and we can get back to normalcy.

The by-laws of our organization required that I obtain and study new state and federal legislation pertaining to fraternal organizations. My office continues to monitor all local and federal legislation which may affect the operation of the Slovak Catholic Sokol, directly or indirectly. Particular emphasis is placed upon the review of tax legislation which may attempt to eliminate the tax-exempt status of our organization. To my knowledge, there is no adverse legislation pending which will negatively impact our organization.

In matters concerning contract negotiations, our organization is in the process of collaborating with one of its tenants to sell a piece of real estate on the home office site which formerly served as our print shop decades ago.

Contractual documents have been exchanged between the parties and the buyer has retained the services of an architect and engineer to formalize the site plan and subdivision plot. The City of Passaic Zoning Board of Adjustment would have to render approval of the transaction since garden variety use variance relief is required as a condition of the sale. As a consequence of the delays caused by the global pandemic, further negotiations are pending.

In connection with our lending portfolio, no new mortgage loans were issued in 2020. Over the past decade, the Board of Directors had granted three mortgage loans to qualified members. During this past year, one borrower elected to pay off the mortgage in full ahead of schedule. Consequently, I drafted the requisite discharge of mortgage for filing and recording with the Passaic County Clerk's Office. In addition, at the Supreme President's direction, I prepared a detailed memorandum concerning the policies and procedures governing the Sokol mortgage program to eligible candidates. Further, I continue to verify that property taxes and insurance are being paid by each borrower. Our mortgage portfolio now consists of two (2) loans.

In matters concerning litigation there is one lawsuit pending in the State of Ohio. By way of background, a generous benefactor passed away leaving a Last Will and Testament with specific bequests to various fraternal benefit societies, including the Slovak Catholic Sokol. The will was admitted to probate and later challenged by another heir in Loraine County Probate Court. The case was forwarded to mediation in an attempt to settle all claims. It is anticipated that the matter will be concluded in the near future.

As a member of the Board of Directors, I have attended all virtual meetings and teleconference calls initiated by our Supreme President in order to carry out and administer the business of the Slovak Catholic Sokol. The minutes of each of our Board of Directors' meetings are published in our Sokol Catholic Falcon and my participation is well documented.

During this past year, I have also attended the virtual sessions of the annual meetings of the American Fraternal Alliance and the Association of Fraternal Benefit Counsel.

I continue to serve as President of Group 1 as well as Assembly 162 in Clifton, New Jersey. I have submitted articles and reports to the Slovak Catholic Falcon for publication to keep our membership advised of ongoing activities within the Fraternal Benefit System.

Although 2020 was a complex year filled with unexpected turns, our organization continues to prosper and grow, thanks to the cooperation received from all Supreme Officers. My special thanks to all of you for the pleasure of having the opportunity to work with you for the good of the Slovak Catholic Sokol.

In closing, I urge all of you as concerned leaders to make important contributions to the spirit of progress and good will that are the hallmarks of the Slovak Catholic Sokol. With God's blessing, I am encouraged and confident that our organization will continue to accomplish its goals and objectives.

### REPORT OF THE SUPREME DIRECTOR OF SPORTS AND ATHLETICS

As the Supreme Director of Sports and Athletics, and in compliance with the Bylaws of the Slovak Catholic Sokol, I hereby submit my 2020 Annual Activity Report.

The first event of the year was the Supreme Physical Fitness Board Meeting held in Pittsburgh, Pennsylvania the weekend of January 17<sup>th</sup> through the 19<sup>th</sup>. Before the annual meeting I met with Basil Wahal from the GCU to discuss the 2020 International Bowling Tournament in Cleveland, Ohio and International Golf Tournament at Seven Oaks Country Club and Black Hawk Golf Course in August.

I participated in March 20<sup>th</sup> and 21<sup>st</sup> Zoom calls for the Board of Directors 1st Quarter Meeting. During the meeting all of the Physical Fitness Board recommendations were approved for the 2020 fraternal activities and sporting events. The Board of Directors voted to cancel the 74<sup>th</sup> International Bowling Tournament scheduled for May 15<sup>th</sup> and 16<sup>th</sup> at Brookgate Lanes in Cleveland, Ohio due to the growing COVID-19 Pandemic.

During the month of March, I was able to finalize the golfing, lodging and banquet facilities for the 2021 Golf Tournament at Treasure Lake, in DuBois, Pennsylvania. On March 31<sup>st</sup>, Kutztown University cancelled all events for the summer of 2020, including our Clinic that was scheduled in July.

On April 19<sup>th</sup>, I participated in the Supreme Physical Fitness Board Zoom call as we initialized plans for our first virtual Clinic.

We had an additional Zoom call on May 9<sup>th</sup> to finalize the all of the details and schedule for the virtual Clinic.

I participated in the Board of Directors 2<sup>nd</sup> Quarter 2020 meeting via conference call on Wednesday, June 24<sup>th</sup>. During the meeting, the Board of Directors made the decision to cancel the 2020 International Golf Tournament due to the increase in the number of people contracting COVID-19 and for the health and safety of our members.

The first virtual Clinic Zoom call for all of the Group Leaders was held on Saturday June 13<sup>th</sup>, to discuss the rules and regulations and the addition of the over 30 age group for the 50<sup>th</sup> International Slet. The second Clinic Zoom call was held on Saturday July 18<sup>th</sup> with a separate breakout session to go over the new drills for the 50<sup>th</sup> International Slet.

Since the International Golf Tournament was cancelled, the Fitness Board decided that we would have an International Golf Week, August 10<sup>th</sup>-16<sup>th</sup>, 2020. Our members would continue to practice social distancing at local golf courses, miniature golf, driving ranges or just pose with a club in hand and post pictures on Face Book. We had over 100 members send in pictures from different venues all over the USA and Canada, and 22 pictures were posted in the September issue of our Falcon.

The Board of Directors held their 3<sup>th</sup> Quarter 2020 Meeting via Zoom conference call on Thursday, September 17<sup>th</sup>. The Board of Directors held their 4<sup>th</sup> Quarter Meeting via Zoom conference call on Friday, December 11<sup>th</sup>. At the December meeting, the Board of Directors agreed to postpone the 50<sup>th</sup> International Slet until July 2022 at Kutztown University due to the COVID-19 Pandemic. The Physical Fitness Board would look into promoting a Family Camp in July 2021. I participated in both meetings and we must continue to explore unique ways to communicate with our members at a local level during the Pandemic. The increased participation at the local level will help to increase the number of participants at our International Sporting events, including the 50<sup>th</sup> International Slet in 2022.

I would like to thank all of the members of the Supreme Physical Fitness Board for their help and participation in the multiple Zoom calls in 2020. The following is a list of activities and events I have attended and worked during 2020.

In January, I attended the Supreme Physical Fitness Board

## MINUTES OF THE SUPREME BOARD OF DIRECTORS QUARTERLY MEETING VIA VIRTUAL MEETING – MARCH 19, 2021

### MINUTES OF THE 2021 SLOVAK CATHOLIC SOKOL MUSEUM BOARD OF DIRECTORS

On March 19, 2021 at 1:00 p.m., S.C.S. Museum President Edward D. Moeller called the meeting to order and welcomed everyone to our virtual meeting.

Brother Moeller called upon Supreme Chaplain, Rev. Andrew S. Hvozdozovic, to open the meeting with a prayer. He then called upon Supreme Physical Directress, Katie Swift, to lead the Board in reciting the Pledge of Allegiance.

Brother Moeller proceeded to ask Museum Secretary/Treasurer, James Knis, to conduct the roll call of the Museum Board of Directors. The roll call was conducted, and all ten Directors were present.

The minutes of the 2020 Annual Meeting of the Slovak Catholic Sokol Museum Board held on September 17, 2020 were approved on a motion made by General Counsel, John D. Pogorelec, Jr., Esq. and seconded by the Chairperson of the Supreme Auditors, James Jerek. Motion was approved by a voice vote.

Brother Moeller stated that thanks to the generous donations from members and corporate donors, the Slovak Catholic Sokol Memorial Scholarship Fund continued to accumulate enough funds which has allowed us to offer three \$1,000 scholarships. He acknowledged a generous donation from the PNC Bank was received through the efforts of Mr. Thomas Calimano, Vice-President/Market Director and S.C.S. Portfolio Manager.

Brother Moeller asked Museum Treasurer, James F. Knis, for his report. Brother Knis reported the January 1, 2020 balance was \$16,726.05 and the December 31, 2020 balance was \$19,679.62, for a net increase of \$2,953.57. The museum funds are deposited into two accounts, \$8,274.94 with PNC Bank which earns a minimum amount of interest and \$11,404.68 which earned 2.5% interest with the Sokol Secure Fund. The 2020 total income was \$6,011.57, with \$5,725 coming from donations and the remainder from interest. The Treasurer reported total expenses for 2020 of \$3,058, which represents three \$1,000 scholarships and \$58 for other expenses. The Treasurer advised the Board the names of the donors were published quarterly in the Falcon.

Supreme Secretary, Scott T. Pogorelec, F.I.C., reported that due to the pandemic, there were no visitors to the Museum this past year.

Under new business, Brother Moeller recommended we award four \$1,000 scholarships this year. A motion was made by Supreme Director of Sports and Athletics, James Matlon, seconded by Supreme Physical Directress, Katie Swift. Motion approved by a voice vote.

Supreme Physical Directress, Katie Swift, reported we are closer to getting the video of the Museum done and she is working with one of our members to set up some dates now.

Chairman Moeller asked for a motion to adjourn. The meeting was adjourned on a motion from Supreme Chaplain, Rev. Andrew S. Hvozdozovic and seconded by Supreme Physical Director, John Underation. Motion was approved by a voice vote.

Several questions were presented and addressed in a general discussion. A motion to accept the report was made by Supreme Chaplain, Rev. Andrew S. Hvozdozic and seconded by Supreme Director of Sports and Athletics, James C. Matlon. Approved

President Horvath thanked Brother Secretary and asked if he could present the **Director of Sales Report**.

Brother Secretary reported that as of December 31, 2020, a total of 472 new members have joined our organization through the purchase of life insurance and annuity certificates. The total face amount of insurance issued for 2020 was just under 9 million.

The total number of certificates in force is 30,604, consisting of 29,725 life certificates and 879 annuity certificates.

The total amount of life premium dollars remained strong in 2020. We have built a solid base of renewal premium the last five years primarily through the Legacy Life and Legacy 20.

This past year was a banner year for annuity premium income as we saw exponential growth in premium dollars. Annuity income exceeded 10 million for the first time in our Society's history.

Also discussed was the new 2017 CSO Tables, which have

been instituted on January 1, 2020. Rates will once again have to be adjusted as the maximum valuation rate goes down. Rates will have to be put in place by January 1, 2022.

Brother Secretary also updated the Board on the Agent Sales' Campaigns, as well as the Membership Campaign centered around our 50<sup>th</sup> International Slet in 2022.

A lively discussion ensued regarding future marketing efforts and several questions were presented and addressed to the satisfaction of the Board. President Horvath thanked Brother Secretary for presenting the report and entertained a motion for acceptance, so moved by Supreme Vice-President, Edward D. Moeller, seconded by Chairperson of the Supreme Auditors, James G. Jerek.

Approved

President Horvath then welcomed Allan Ferrone, CPS Actuarial, to present the **Actuarial Report**.

Mr. Ferrone presented the yearly report on the results of the Slovak Catholic Sokol's Annual Statement.

The Sokol assets continue to grow and now stand at just under 98 million, which is an all-time high for the organization.

The Quality of the Sokol's bond portfolio remained at a very high level in 2020. The average NAIC bond quality designation, weighted by amortized value, is 1.65 (where "1.0" is "highest quality" and "2.0" is "high quality"). The Sokol has also lengthened the maturity dates of its bond portfolio. The average duration has increased to about 14.1 years.

Brother Ferrone reported on the operational results in 2020. The amount of money the Sokol collects from investment income and premiums is less than the money being paid out for benefits, insurance/fraternal expenses, dividends, and the amount needed to fund the required increases in reserves. The 2020 expenses were lower than the 2019 expenses, which can be attributed to the Covid-19 Pandemic, but the Home Office is still doing a good job of controlling what they can control. The Home Office will continue to find ways to lower expenses.

Annuity premium income increased dramatically in 2020. The Sokol will need to keep a keen eye on that type of income as the investment yields are being dragged down further.

A discussion ensued regarding the operational results and areas where the Sokol can improve their efforts. Mr. Ferrone answered all questions to the satisfaction of the Board.

President Horvath then called upon Mr. Thomas Calimano, Market Director/Senior Vice-President, and Ms. Cynthia Cole, Fixed Income Specialist, of PNC Institutional Asset Management to present the **PNC Advisor's Report**.

Mr. Calimano discussed PNC's outlook for the financial markets and the economy with the Board. Additionally, he reviewed the investment strategies recently implemented in both the equity and fixed income portfolios and future potential strategic changes in the portfolio. The individually invested bond portfolio for the twelve months ended December 31, 2020 continues to be of high quality with a solid investment grade rating average.

Mr. Calimano and Ms. Cole also discussed future potential portfolio repositioning and PNC's outlook for the financial markets during these difficult times.

Brother Calimano and Sister Cole addressed various questions from the Board concerning our performance outlook. Both

indicated the Society is in a strong financial position, especially in this volatile fiscal environment.

A motion to accept the report was made by Supreme Vice-President, Edward D. Moeller, seconded by Supreme Director of Sports and Athletics, James C. Matlon.

Approved

President Horvath then called upon General Counsel, John D. Pogorelec, Jr., Esq. to present the **Legal Department Report**.

General Counsel updated the Board on the mortgagees currently on file and the closures they have had to sustain due to Covid-19 restrictions. Supreme Treasurer, James F. Knis, made a motion that the General Counsel and Supreme Secretary work with the two existing mortgagees to restructure their current mortgages to resume payment by July 2021, seconded by Supreme Vice-President, Edward D. Moeller.

Brother Counsel also shared with the Board one new mortgage application. The Board mutually decided to issue a moratorium on the granting of any mortgage applications until circumstances in the economy change.

A woman named Anna Jarvis started a campaign for an official holiday honoring **mothers** in 1905, the year her own **mother** died. The first larger-scale celebration of the holiday was in 1908, when Jarvis held a public memorial for her **mother** in her hometown of Grafton, West Virginia.

**Mother's Day** is an occasion which is celebrated in various parts of the world to express respect, honor, and love towards **mothers**. ... It is a **day** which makes people remember the **importance** and significance of **mothers** in their life and is observed as a **day** to give special emphasis to the motherly figures around the world.

### Memorial Day

**Memorial Day 2021** will occur on Monday, May 31. Originally known as Decoration **Day**, it originated in the years following the Civil War and became an official federal holiday in 1971. Many Americans observe **Memorial Day** by visiting cemeteries or **memorials**, holding family gatherings and participating in parades.

On May 5, 1868, General **John A. Logan** issued a proclamation calling for "Decoration Day" to be observed annually and nationwide; he was commander-in-chief of the Grand Army of the Republic (GAR), an organization of and for Union Civil War veterans founded in Decatur, Illinois.

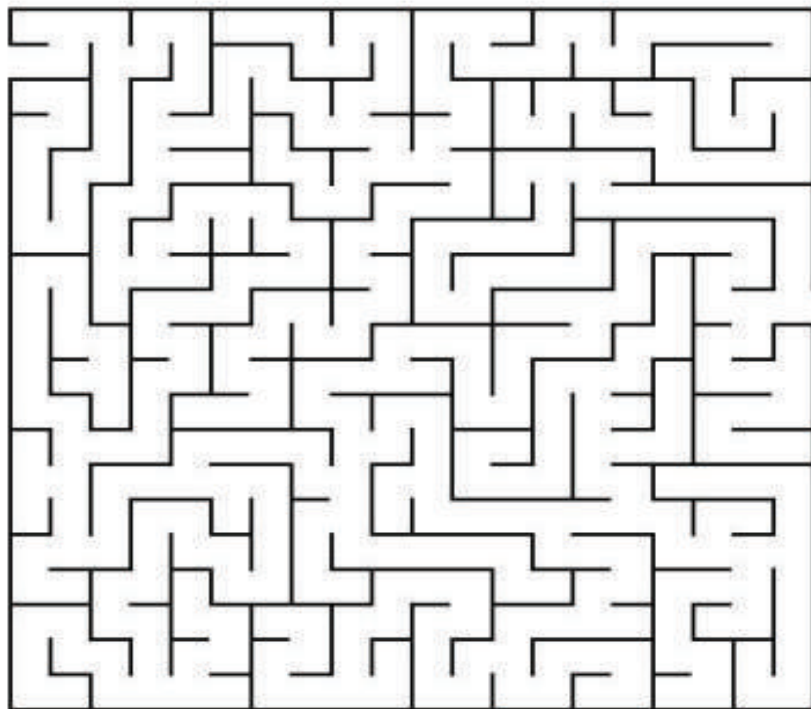

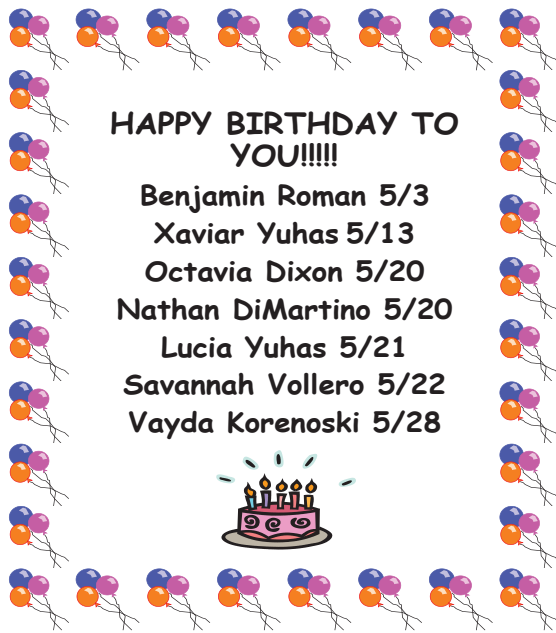

## 2021 LAW DAY MESSAGE FROM OUR GENERAL COUNSEL

ultimate and objective judge of justice, versus a person or people who might be subject to arbitrary decisions, nepotism, favoritism, prejudice, bigotry, bribery, or any other wrongdoing. The rule of law protects us from ethnic, religious, class, or other discriminations in the executions of the law; it protects us from vigilantism and mob rule. People can take the law to the court and not into their own hands. The rule of law protects us from violence, force, and tyranny on the part of government officials by limiting political powers, government and state. It protects us from abuse of power and it applies to everyone in the system.

### RULE OF LAW: PRINCIPLES

Another way of understanding the rule of law is to examine the concept, values, and principles that support and are supported by it. For example, separation of powers and the resultant checks and balances assure that one person or group of people in the government does not amass ultimate power. That system is a fundamental component to American democracy's reliance on the rule of law and "not of men." Judicial independence and accountability are instrumental to separation of powers and the rule of law it protects. An independent, accountable judiciary guarantees that justice will be executed according to the law and not individual's feelings or biases. In America, the framers ensured that the Constitution could be changed with two-thirds vote of the legislative branch and three-fourths of the states—not at the whim of any single individual. Transparency and public accessibility of laws and the legal process – with a free press as a watchdog – assure we maintain a "govern-

ment of laws and not of men."

### ANALYSIS

The centrality of the rule of law in successful societies is experienced, if not acknowledged, in American life every day. Examples of daily practices taken for granted but protected by the rule of law include the free exercise of individual rights – expressing opinions that are unpopular, practicing religions that are not widely understood, and participating in public life at school, in court and in the voting booth.

### CONCLUSION

This year's Law Day theme encourages us all to examine the rule of law, our role in its sustainability, and its role in protecting our communities, our democracy, opportunity, equality, and all that is most precious to us. Advancing the rule of law helps achieve an array of public benefits. We all have a stake in the rule of law, and we can all do our part to strengthen it. I encourage you to join with me in working to advance the understanding of the rule of law during this year's Law Day celebration.

## NEMECKO DAROVALO SLOVENSKU 31 PLŮCNYCH VENTILÁTOROV

Nemecko darovalo Slovensku na pomoc v boji s pandémiou nového koronavírusu 31 plúcnych ventilátorov v hodnote zhruba 150 000 eur. Boli odovzdané na využitie do Ústrednej vojenskej nemocnici v Ružomberku.

lúčne ventilácie spolu s príslušenstvom budú slúžiť pacientom s ťažkým priebehom ochorenia COVID-19.

Z celkového počtu 31 ventilátorov je 25 ventilátorov darom od Ministerstva obrany Spolkovej republiky Nemecko a šesť ventilátorov od Ministerstva zdravotníctva Spolkovej republiky Nemecko.

Obom nemeckým ministerstvám poďakoval minister obrany SR Jaroslav Naď.

Tento prejav solidarity je podľa jeho slov dôkazom dlhodobu nadštandardnej bilaterálnej spolupráce Slovenska s Nemeckom v oblasti obrany a bezpečnosti a zároveň tiež vysokej úrovne spoločných vzťahov v NATO a Európskej únii.

“Plúcne ventilátory sú kľúčové pri liečbe najvážnejších prípadov ochorenia COVID-19. Veľmi nás teší, že sme mohli podporiť ďalšie skvalitnenie zdravotnej starostlivosti,” uviedla nemecká veľvyslankyňa na Slovensku Barbara Wolf.

Vyzvala taktiež, aby bolo naďalej udržiavané spoločné úzke partnerstvo v rámci EÚ a NATO.

Zdravotnícke prístroje boli doručené pre Úrad hlavného lekára Ozbrojených síl SR prostredníctvom nemeckého veľvyslanectva na Slovensku.

## PRÍEMERNÁ MZDA V SR MEDZIROČNE STÚPLA VO VÄČŠINE ODVETVÍ

Priemerná nominálna mesačná mzda na Slovensku vo februári tohto roka medziročne vzrástla vo väčšine sledovaných odvetví. Najväčší nárast zaznamenalo stavebníctvo, kde sa priemerná mzda zvýšila o 4,5 % na 747 eur.

Zvýšenie hrubých mesačných zárobkov vykázali aj veľkoobchod, o 3,7 % na 1 076 eur, či informačné a komunikačné činnosti o 2,5 % na 1 945 eur.

Vo vybraných trhových službách sa priemerná hrubá mzda medziročne zvýšila taktiež o 2,5 % na 1 058 eur, v maloobchode o 1,5 % na 801 eur, v priemysle o 1,2 % na 1 136 eur a v doprave a skladovaní o 0,2 % na 1 009 eur. Informoval o tom Štatistický úrad SR.

Naopak, priemerné hrubé zárobky sa vo februári medziročne znížili v ubytovaní o 19,7 % na 648 eur, v činnostiach reštaurácií a pohostinstiev o 5,4 % na 528 eur a v predaji a oprave motorových vozidiel o 4,5 % na 1 013 eur.

V priemere za dva mesiace tohto roka v porovnaní s rovnakým obdobím vlaňajška sa mzda zvýšila vo vybraných trhových službách o 5,9 % na 1 090 eur, v stavebníctve o 4,1 % na 758 eur, v informačných a komunikačných činnostiach o 1,2 % na 1 969 eur, v priemysle o 1,1 % na 1 157 eur.

Stúpila aj vo veľkoobchode, o 0,9 % na 1 064 eur a v maloobchode o 0,6 % na 802 eur. Oproti rovnakému obdobiu minulého roka sa hrubá mzda za dva mesiace znížila v ubytovaní o 19,1 % na 649 eur, v činnostiach reštaurácií a pohostinstiev o 6,6 % na 524 eur, v predaji a oprave motorových vozidiel o 3 % na 1 039 eur a v doprave a skladovaní o 1,6 % na 1 015 eur.

## VO FEBRUÁRI ZOMRELO V SR O 59 PERCENT VIAC LUDÍ AKO POČAS PREDOSHÝCH ROKOV

Vo februári tohto roka zomrelo o 59 percent viac ľudí ako počas predošlých rokov. V utorok o tom informoval Štatistický úrad SR s tým, že ide o rekordný počet.

Každý piaty zomretý vo februári mal menej ako 65 rokov.

Celkovo počet zomretých do 64 rokov prevýšil priemer o 43 percent. Najhoršia situácia bola v Trnavskom kraji.

Podľa Štatistického úradu SR ovplyvnila druhá vlna pandémie nového koronavírusu počty zomretých na Slovensku zásadným spôsobom. V súhrne za druhý mesiac roka 2021 zomrelo na Slovensku 7 555 ľudí, čo je o 58,6 percenta viac ako bol priemer druhého mesiaca v predošlých piatich rokoch. Celkovo tak zomrelo vo februári takmer o 2800 osôb viac ako vlni či predvlni.

Dynamika rastu počtu zomretých sa veľmi mierne spomalila, ešte v januári dosahovala nadúmrtnosť 75 percent, v decembri minulého roka to bolo 60 percent.

“Na celoslovenskej úrovni bola februárová nadúmrtnosť nižšia ako v januári, ale len nepatrne. Netreba však robiť predčasné optimistické závery, je potrebné počkať, ako sa bude situácia vyvíjať v ďalších mesiacoch. Celkové počty zomretých v porovnaní s predošlými rokmi sú základnými vstupmi na analýzy o vplyve COVID-19 na spoločnosť, neskôr sa doplnia ešte o štruktúry o príčinách úmrtí,” spresnila Zuzana Podmanická, riaditeľka odboru štatistiky obyvateľstva Štatistického úradu SR.

Podľa Štatistického úradu SR bola aj vo februári najhoršia situácia v kategórii mladších seniorov vo veku 65 až 74 rokov.

Nárast zomretých v tejto vekovej skupine sa síce spomalil, ale oproti päťročnému priemeru zomrelo takmer dvojnásobne viac ľudí ako predošlé roky, a to o 92 percent viac.

Dáta o počtoch úmrtí v januári podľa úradu potvrdili, že nadúmrtnosť začala rásť aj vo vekovej skupine do 64 rokov.

Aj vo februári mal každý piaty zomretý menej ako 65 rokov. Celkovo vo februári zomrelo v tejto vekovej kategórii 1 625 osôb, v predošlých rokoch to bývalo 1100 až 1 200 osôb.

“Zatiaľ čo v iných vekových kategóriách nadúmrtnosť vo februári klesla, v skupine ľudí do 65 rokov sa udržala na januárovej výške,” doplnila Podmanická.

Z hľadiska krajov bola situácia najhoršia v Trnavskom kraji, kde zomieralo tento rok vo februári o vyše 90 percent viac ľudí ako v predošlých rokoch.

Nasledoval Nitriansky kraj, v ktorom zaznamenali nárast o 86,4 percenta zomretých. Za ním nasledoval Košický kraj s rastom o 78 percent zomretých.

Banskobystrický a Bratislavský kraj mali prírastok počtu zomretých okolo hranice 50 percent. Najnižší rast počtu zomretých dosiahol v januári Žilinský kraj, kde počet zomretých prevýšil predošlé roky o 15 percent. – *sme.sk*
