# ASSUMPTION OF MARY INTO HEAVEN AUGUST 15<sup>™</sup>

In the late 4th century, <u>Epiphanius of Salamis</u> wrote of his search for reliable traditions concerning the fate of Mary and



his inability to discover any. His inquiry suggests that discussion of Mary's immortality had already arisen in popular circles, and he identifies three beliefs concerning her end: that she died a normal and peaceful death; that she died a martyr; and that she did not die. He suggested tentatively that Chapter 12 of the Book of Revelation, which speaks of a woman "clothed with the Sun" who escapes

"the dragon" by fleeing into the wilderness to be nourished "for a time, and times, and half a time," might possibly be a reference to her immortality, but the early church identified the woman with the church and there is no evidence that an identification with Mary existed before Epiphanius. "No one knows her end," he concludes.

The Dormition/Assumption of Mary makes its first appearance in two apocryphal texts from the third and fourth centuries, the Liber Requiei Mariae ("Book of Mary's Repose"), and the "Six Books Dormition Apocryphon". Both come from heterodox (i.e., proto-heretical) circles, the first having strong Gnostic overtones and the second associated with a sect called the Kollyridians, whom Epiphanius condemned for their excessive devotion to Mary. Notable later apocrypha based on these include De Obitu S. Dominae and De Transitu Virginis, both probably from the 5<sup>th</sup> century, with further versions by <u>Dionysius the Areopagite</u>, and <u>St. Gregory of Tours</u>, among others. The Transitus Mariae was among apocrypha condemned in a 6th-century work called Decretum Gelasium (the "Decree of Gelasius", although not in fact by Pope Galasius I), but by the early 8th century it was so well established that John of Damascus could set out what had become the standard Eastern tradition, that "Mary died in the presence of the Apostles, but that her tomb, when opened, upon the request of St Thomas, was found empty; wherefrom the Apostles concluded that the body was taken up to heaven."

In some versions of the story, the event is said to have taken place in <a href="Ephesus">Ephesus</a>, in the <a href="House of the Virgin Mary</a>. This is a much more recent and localized tradition. The earliest traditions say that Mary's life ended in <a href="Jerusalem">Jerusalem</a>. By the 7th century, a variation emerged, according to which one of the apostles, often identified as <a href="St. Thomas">St. Thomas</a>, was not present at the death of Mary but his late arrival precipitates a reopening of Mary's tomb, which is found to be empty except for her grave clothes. In a later tradition, Mary drops <a href="her girdle">her girdle</a> down to the apostle from heaven as testament to the event. This incident is depicted in many later paintings of the Assumption.

Teaching of the Assumption of Mary became widespread across the Christian world, having been celebrated as early as the 5th century and having been established in the East by Emperor Maurice around AD 600. St. John Damascene records

# MINUTES OF THE SUPREME BOARD OF DIRECTORS QUARTERLY MEETING HELD VIA VIRTUAL MEETING

Thursday, June 24, 2021 – 3:00 p.m.

Supreme President, Michael J. Horvath, **Called to Order** the Quarterly Meeting of the Supreme Board of Directors at 3:00 p.m. on Wednesday, June 24, 2021, and greeted all the members of the Board on the call.

Supreme Chaplain, Rev. Andrew S. Hvozdovic, V.F. offered the **Opening Prayer** leading the Directors in the reading of the Prayer to Practice the Golden Rule.

Supreme Treasurer, James F. Knis, led the Board members in reciting the **Pledge of Allegiance to the Flag**.
Supreme Secretary, Scott T. Pogorelec, F.I.C. was asked

The record will show that all ten members of the Board of Directors are present. Acknowledged

President Horvath informed the Board that they all have received the **Minutes** from our last Board meeting held on March 19, 2021, and published in the May 1, 2021, issue of the Slovak Catholic Falcon. Brother President entertained a motion for their acceptance, so moved by Supreme Treasurer, James F. Knis, seconded by General Counsel, John D. Pogorelec, Jr., Esq.

President Horvath then called upon our Director of Sales, Albert J. Suess, F.I.C., to give a brief overview of the **Membership/Sales and Marketing Report**.

Brother Suess gave a snapshot of the current life and annuity production for the year to date as compared to the 2021 projections.

Brother Albert also gave an update on the **Drive to 50 Campaign**, which will be extended to June 30, 2022.

Brother Albert also updated the Board on our website enhancements and an online application process that is being researched through various vendors.

Several questions were presented and addressed to the satisfaction of the Board and President Horvath thanked Brother Suess for the report. President Horvath then asked for a motion to accept the report, so moved by Chairperson of the Supreme Auditors, James G. Jerek, seconded by Supreme Director of Sports and Athletics, James C. Matlon.

Approved

President Horvath then called upon Mr. Thomas Calimano, Market Director/Senior Vice-President, and Ms. Cynthia Cole, Fixed Income Specialist, of PNC Institutional Asset Management to present the **PNC Advisor's Report**.

Mr. Calimano and Ms. Cole reviewed PNC's outlook for the financial markets and the economy with the Board. Additionally, he reviewed the investment strategies recently implemented in both the equity and fixed income portfolios. Ms. Cole reviewed the portfolio's structure, quality and updated the Board on recent changes within the portfolio. Additionally, Mr. Calimano and Ms. Cole discussed the continued effects of the coronavirus on the fixed income investing, the current level of interest rates, and expectations for potential investment opportunities during the second half of the year.

Mr. Calimano and Ms. Cole addressed various questions from the Board concerning our performance outlook and Mr. Calimano indicated the Society is in a strong financial position, especially in this volatile fiscal environment. The Board members expressed thanks to Mr. Calimano and Ms. Cole for their presentation.

President Horvath then called on the Supreme Director of Sports and Athletics, James C. Matlon, for the **Physical Fitness Board Report**.

Brother Matlon reported that, unfortunately, the Slovak Catholic Sokol 75th Annual International Bowling Tournament was cancelled due to the COVID-19 Pandemic.

Brother Matlon, Brother Underation, and Sister Swift also updated the Board on the virtual meetings that have been held between the Supreme Physical Fitness Board.

The Treasure Lake Resort is ready to host our 66th International Golf Tournament from August 6th-8th and expect to have the largest turnout in many years with additional golfers from the GCU and FCSU. The 2021 Tournament social gatherings will be outside for the health and safety of all participants and guests. The expected number of golfers for the 2021 tournament will allow us to use both the Gold and Silver Course on Saturday and Sunday.

President Horvath thanked Brother Matlon, Brother Underation, and Sister Swift for their report and entertained a motion to accept, so moved by Supreme Chaplain, Rev. Andrew S. Hvozdovic, seconded by Supreme Vice-President, Edward D. Moeller.

Brother President then called upon General Counsel, John D. Pogorelec, Jr., Esq. for the **Legal Department Report**.



the following:

St. Juvenal, Bishop of Jerusalem, at the Council of Chalcedon (451), made known to the Emperor Marcian and Pulcheria, who wished to possess the body of the Mother of God, that Mary died in the presence of all the Apostles, but that her tomb, when opened upon the request of St. Thomas, was found empty; wherefrom the Apostles concluded that the body was taken up to heaven.

The Assumption of Mary was celebrated in the West under **Pope** Sergius I in the 8th century and Pope Leo IV confirmed the feast as official. Theological debate about the Assumption continued, following the Reformation. But the people celebrated the Assumption as part of the cult of Mary that flourished from the Middle Ages. In 1950 Pope Pius XII defined it as dogma for the Catholic Church. Catholic theologian Ludwig Ott stated, "The idea of the bodily assumption of Mary is first expressed in certain transitus-narratives of the fifth and sixth centuries. ... The first Church author to speak of the bodily assumption of Mary, in association with an apocryphal transitus of the <u>B.M.V.</u>, is St. Gregory of Tours." The <u>Catholic</u> writer <u>Eamon</u> Duffy states that "there is, clearly, no historical evidence whatever for it." However, the Catholic Church has never asserted nor denied that its teaching is based on the apocryphal accounts. The Church documents are silent on this matter and instead rely upon other sources and arguments as the basis for the doctrine.

# What's making headlines in our ancestral homeland News and Views from Slovakia...

#### POPE FRANCIS TO VISIT SLOVAKIA IN SEPTEMBER

Pope Francis officially confirmed on Sunday, July 4 that he's set to visit both Slovakia and Hungary in September, the Holy See's news outlet Vatican News reported on the same day.

According to the Slovak Foreign Affairs Ministry, the pope will visit Slovakia on September 12-15.

"It is a great honor for Slovakia that the Holy Father will come to the country for a three-day apostolic visit, which will be both official and pastoral. It's an important moment for Slovakia's relations with the Holy See, as well as for the faithful and for all people committed to Christian and humanist principles," stated chief of Slovak diplomacy Ivan Korcok.

This will be the fourth time the pope pays an apostolic visit to Slovakia, as former pope John Paul II visited the country in 1990, 1995 and 2003.

### 'AIRCAR' PROTOTYPE COMPLETES NITRA-BRATISLAVA FLIGHT IN 25 MINS

The prototype of a Slovak-made flying car called the AirCar has completed its first successful flight from the airport in Nitra to the one in Bratislava, a distance of approximately 80 kilometres (50 miles).

"The machine ran absolutely great," noted Klein, explaining that the flight took roughly 25 minutes at an average speed of 170 kilometres (106 miles) per hour, which is approximately one third of the time it takes an ordinary car to get from one city to the other by road.

The AirCar, however, isn't primarily meant for use in Slovakia or the densely populated central Europe, where there is developed road infrastructure.

Klein was also involved in developing the first Slovak flying car – the Aeromobil. According to him, the two flying cars differ both in appearance and in the way in which they transform themselves from a flying vehicle to a car. The AirCar can complete this process in roughly two-and-a-half minutes.

It remains unclear when it will be possible to order AirCar

models, as the first prototype must first complete the mandatory 50 hours of flight tests. Klein then intends to design a second prototype with an altered design and more powerful drive. The second prototype should be ready for certification by the European Union Aviation Safety Agency (EASA).

### NBS: ECONOMY TO GROW BY 4.5 PERCENT THIS YEAR, RECOVERY CONTINUES

The Slovak economy continues to recover and will grow by 4.5 percent this year, Slovak central bank (NBS) governor Peter Kazimir and NBS vice-governor Ludovit Odor stated on Tuesday at a press conference at which they presented a forecast of economic and monetary developments for the summer of 2021.

The central bank estimates that gross domestic product (GDP) will grow by 5.9 percent year-on-year in 2022 and by 3.8 percent in 2023. According to NBS predictions, Slovakia should return to its pre-crisis trajectory in 2023.

NBS pointed out that the risks that may dampen economic growth are insufficient levels of vaccination among the population, a third wave of the novel coronavirus pandemic in the autumn and a lack of components, mainly in industry.

"There's another phenomenon that has returned after a number of years, and that is inflation or rising prices. Prices of goods and services have started to go up sharply, but in our opinion there is no reason to panic," said Kazimir, adding that this rise in prices will slow down in a few months.

The governor went on to say that the situation on the labour market is slightly worse than last year, which is mainly due to redundancies in the public sector. NBS estimates that nominal salaries will increase by around 5 percent this year and real salaries by about 3 percent.

Odor noted that the first quarter of this year turned out better than expected, and expectations and indicators are very optimistic.

According to NBS, the vaccination rate was an important criterion for making the prediction. The classic scenario assumes a 60-percent vaccination rate among the population and a pessimistic one a 45-percent rate. "NBS is joining other authorities in the country and sounding the alarm. We call on people to be vaccinated against COVID-19 as soon as possible and as much as possible," said the governor, pointing out that the call is based not only on the principle of preserving human lives, but also on the principle of maintaining the chances of a higher standard of living, economic growth and a sound labour market.

### DEFENCE MINISTRY FAILED TO PROVE THAT PURCHASE OF F-16 JETS WAS NECESSARY

The Defence Ministry has failed to prove that the purchase of 14 American F-16 jet fighters in 2018, the most expensive military acquisition in the history of Slovakia, was justified, while the procurement process itself and its approval were not in accordance with the rules, according to a Supreme Audit Office (NKU) analytical report on the procurement of the F-16 jets presented by NKU director Karol Mitrik.

Mitrik pointed to the fact that the former government made a decision to procure the jet fighters at a time when defence strat-

egies hadn't been updated. "And unlike, for instance, Bulgaria, which carried out a similar purchase, the acquisition wasn't even approved by Parliament," he said.

In addition, NKU pointed to the total costs, which involve not only the purchase price but also maintenance costs. "The total sum climbs to about 6.2 billion over the course of 40 years. These facts have never been the subject of parliamentary debate or public discussion," claimed NKU vice-chair Lubomir Andrassy.

Furthermore, the defence ministry has never proven that the F-16 fighters were a more advantageous choice than other options. NKU director Mistrik stated that the procurement also flies in the face of Slovakia's commitment to NATO to modernise its military.

"The purchase of 14 F-16 jet fighters exceeds the 2017 capability targets and drains finances from the delayed project of forming a heavy mechanised brigade. The commitments towards NATO don't include procuring jet fighters," he noted. The contract for 14 F-16 C/D Block 70 jet fighters was concluded by Slovakia in late 2018.

The fighters were supposed to cost 1.6 billion. The agreement also includes equipment and armaments, logistics support and training of flight and ground personnel. The Defence Ministry is currently holding talks with the American side on rearranging the payment instalments.

In its response, the Slovak National Party (SNS), which was in charge of the Defence Ministry at the time of the purchase, told TASR on Friday that NKU's claims stem from absolute ignorance.

SNS pointed out that it was the Slovak Armed Forces that determined the number of fighter jets needed, following consultations with representatives of allied states. In addition, SNS said that the decision to go ahead with the procurement was taken by the entire government and not just former defence minister Peter Gajdos (2016-20).

"Had the Slovak Republic not purchased any aircraft, we would have had foreign armed forces present here by now, paying them more than 60 million yearly to protect our airspace," stated the party.

SNS claimed that it is unprofessional and tendentious to compare American F-16s with Swedish Gripen jets, added that the purchased aircraft can be sold at any time. "And it's always better [to buy] than to rent aircraft in the way the Czech Republic does. When you compare the prices of purchase and rental, it's self-evident," added the party.

### TOTAL OF 6,697 SUSPECTED ADVERSE REACTIONS TO COVID VACCINES

A total of 6,697 cases of suspected adverse reactions to vaccines against COVID-19 had been reported in Slovakia up to Wednesday, June 30, the State Institute for Drug Supervision (SUKL) has noted on its website, adding that 564 of these cases were serious, making up 8.4 percent of the total.

Concerning the Pfizer/BioNTech vaccine, 273 cases of adverse reactions were serious, including one death. The most often reported serious adverse effects were persisting increased blood pressure, especially among patients treated for hypertension, precollapse, collapse or sudden stroke.

As for the Moderna vaccine, 48 cases of adverse reactions were serious, including one death. The most often reported serious adverse effects were temporary paralysis, persisting increased blood pressure, thrombosis, collapse or acute cerebral ischemia.

When it comes to the AstraZeneca vaccine, 238 of the reported adverse reactions were serous, including two deaths. The most often serious side effects were short-term loss of consciousness,

collapse, thrombosis and paresis of the facial nerve. Epileptic fits also occurred among patients being treated for epilepsy.

Regarding the unregistered Sputnik vaccine, one case of a serious side effect has been reported, namely persisting increased blood pressure.

As of July 1, SUKL had registered four deaths with causal links to vaccination, with these links in three cases (following inoculation with the Pfizer/BioNTech, Moderna and AstraZeneca vaccines) defined as possible. The link in one case (following inoculation with the AstraZeneca vaccine) was judged to be probable. "Causal links to vaccination in other cases, including those reported in the media, have been excluded," stated SUKL.

#### SLOVAKIA SELLS BACK TO RUSSIA 160,000 DOSES OF SPUTNIK V VACCINE

Russia has purchased 160,000 doses of the unused Sputnik V vaccine from the Health Ministry, ministry spokeswoman Zuzana Eliasova told TASR on Friday, adding that the Russian side bought them for an identical price at which Slovakia bought them – \$9.95 per dose.

"In line with the contract, the agreed maturity of the purchase price is within 20 working days from the date of delivery," she noted.

The vaccines sold are already outside Slovakia. "We've been left with those that are intended for people who registered for vaccination," said Eliasova, adding that about 10,500 people have been inoculated with the first dose of the Sputnik V vaccine. "Approximately 8,000 people are registered in the waiting room for vaccination, while about 1,500 of them already have a date to get their jab," added the spokeswoman.

Slovakia purchased Sputnik V vaccines in March, and it was originally expected that we'll buy two million doses. The purchase and import of the vaccine unregistered in the EU provoked a government crisis. Vaccination with the first 200,000 doses started on June 7, but interest didn't confirm previous estimates, which is why the Government decided to sell or donate unused vaccines. Initially, the interest of the Western Balkans countries was mainly discussed.







#### POPULAR SUMMER RECIPES

#### **GRILLED HONEY MUSTARD CHICKEN**

1/2 cup of any whole grain mustard

1/2 cup of honey

Juice of 1/2 a lemon

1 garlic clove smashed and minced

1/2 teaspoon paprika

1/2 teaspoon salt

1/4 teaspoon cayenne pepper

1/4 teaspoon red pepper flakes

4 boneless skinless chicken breasts

Whisk all ingredients in a small bowl. Reserve 4 tablespoons of sauce and then pour the remaining honey mustard mixture over the chicken, toss and cover with plastic wrap and let it sit for about 30-45 minutes at room temperature. Preheat the grill on medium-medium high heat, grill chicken for about 6 to 7 minutes per side or until chicken is done. Pour the reserved honey-mustard sauce over chicken and let rest under foil for about 5 minutes.

#### **AVOCADO PASTA SALAD RECIPE**

1 cup mayonnaise

½ cup sour cream

½ bunch fresh cilantro chopped

1 medium avocado diced

1 onion diced

1 banana pepper diced

1 lime juiced

16 ounces penne pasta 1 package, cooked

1 cup cherry tomatoes halved

1/2 cup sliced black olives

seasoned salt to taste

Blend mayonnaise, sour cream, cilantro, avocado, onion, pepper, and lime juice. Combine all but about 1/2 cup of the dressing with cooled pasta. Top with tomatoes and olives. Cover and refrigerate for at least 2-3 hours. Fold tomatoes and olives into cooled salad. Top with reserve dressing and season with salt as desired.

#### ROASTED VEGGIE PASTA SALAD

1 zucchini (diced)

1/2 red onion (diced)

1 yellow squash (diced)

1 small bunch asparagus (sliced)

1 red bell pepper (diced)

Salt and Pepper, to taste

1 (16 ounce) box Rotini pasta

8 ounces balsamic vinaigrette

Preheat oven to 350 degrees. Line baking sheet with tinfoil. Spread out chopped vegetables on tin foil and sprinkle with salt and pepper. Roast vegetables for 12-15 minutes or until softened, and beginning

to brown. While vegetables are cooking, prepare pasta according to box directions. In a large bowl, toss together pasta and cooked vegetables. Pour balsamic dressing over salad and toss until all vegetables and noodles are coated.

#### **GREAT HOT DOG TOPPING IDEAS**

#### **Caramelized Onions**

1 tablespoon butter

2 to 3 large onions, finely sliced (about 5

Water

Kosher salt

Melt butter in a large heavy-bottomed stainless steel or enameled cast iron saucepan over high heat. Add onions and cook, stirring frequently, until bottom of saucepan is glazed in a pale brown fond, about 5 minutes. Add 2 tablespoons water and scrape up fond with wooden spoon. Continue to cook, stirring frequently, until fond has built up again, about 2 minutes longer. Add 2 more tablespoons water and scrape up browned bits. Repeat cooking, adding water, and scraping until onions are completely softened and a deep, dark brown, about 15 minutes total. Season to taste with salt.

#### **Chipotle Mayonnaise**

1/2 cup mayonnaise

1/4 cup sour cream

2 chipotle chiles from 1 can of chipotles in adobo

2 tablespoon freshly squeezed lime juice

Place mayonnaise, sour cream, lime juice, and chipotles in jar of a blender. Puree until smooth and chipotles are completely chopped. Pour into an airtight container, cover, and store in the refrigerator.

#### **Loaded Chili-Topped Hot Dogs**

2 tablespoons olive oil

1 small yellow onion, chopped

3 garlic cloves, finely chopped

1 pound 80/20 lean ground beef

2 tablespoons tomato paste

2 tablespoons chili powder

2 teaspoons kosher salt

1/2 teaspoon cayenne pepper

1 cup amber ale beer

2 tablespoons light brown sugar

1 tablespoon Worcestershire sauce

3/4 cup tomato sauce

1 tablespoon apple cider vinegar

8 (5-inch) beef hot dogs

8 Buttery Brioche Hot Dog Buns, top split

Heat olive oil in a large skillet over mediumhigh. Add onion; cook, stirring often, until softened, about 5 minutes. Add garlic; cook, stirring constantly, until fragrant, about 1 minute. Add ground beef, and cook, stirring to crumble, until lightly browned, about 8 minutes. Push beef mixture to one side of skillet. Add tomato paste, chili powder, salt, and cayenne to empty side of skillet, and cook, stirring constantly, until fragrant and mixture has darkened, 1 to 2 minutes. Stir in beer, brown sugar, and Worcestershire sauce, incorporating beef. Return to a simmer over medium-high, and cook, stirring occasionally, until liquid has almost completely evaporated, 5 to 7 minutes. Stir in tomato sauce, and bring mixture to a simmer. Reduce heat to low, and simmer, stirring occasionally, until flavors meld and chili has thickened slightly, 15 to 20 minutes. (If chili becomes too thick, add water, 1 tablespoon at a time, to loosen.) Remove from heat, and stir in vinegar.

#### **GRILLED CHICKEN WITH PEACHES**

1 3/4 cups pesto, divided

1/2 cup plus 2 tablespoons vegetable oil, divided, plus more for grill

1 3/4 teaspoons kosher salt, divided

3/4 teaspoon freshly ground black pepper, divided

8 small bone-in, skin-on chicken thighs 4 ripe peaches, halved

Whisk 1 1/2 cups pesto, 1/2 cup oil, 1 tsp. salt, and 1/2 tsp. pepper in a medium bowl until smooth. Add chicken to bowl and slide your hand between skin and meat to loosen skin. Rub half of pesto mixture under skin, then half over outside. Cover bowl with plastic wrap and chill at least 1 hour. Prepare a grill for medium-high heat. Season chicken with remaining 3/4 tsp. salt and 1/4 tsp. pepper. Grill chicken, skin side down, covered, until golden brown and lightly charred, 7-9 minutes. Turn and grill until cooked through and an instant-read thermometer inserted into thickest part of thigh registers 165°F, 5-7 minutes. Transfer chicken to a plate. Brush peach halves with oil. Reduce heat to medium and grill peaches, cut side down, until warmed through, 2-3 minutes. Whisk remaining 1/4 cup pesto and 2 Tbsp. oil in a small bowl. Arrange chicken and peaches on a platter and drizzle pesto sauce over. Serve remaining sauce alongside.


# ARCHBISHOP CYRIL VASIL, S.J. RETURNS TO SERVE IN SLOVAKIA

Samotný pápež František návštevu oboch krajín potvrdil v nedeľu, 4. júla pri príhovore a modlitbe Anjel Pána vo Vatikáne. Na Slovensko pápež príde na pozvanie prezidentky Zuzany Čaputovej.

"Som rád, že môžem oznámiť, že od 12. do 15. septembra, keď Pán Boh dá, pôjdem na Slovensko, aby som prišiel na pastoračnú návštevu," uviedol pápež, ktorý zároveň poďakoval všetkým, ktorí cestu pripravujú. Pápež pritom osobitne pozdravil slovenských pútnikov na vatikánskom Námestí svätého Petra, tí tam prišli so zástavami.

Pápež aj tlačový odbor Svätej stolice zároveň potvrdili, že pred návštevou Slovenska hlava katolíckej cirkvi 12. septembra zavíta do maďarskej metropoly Budapešť "pri príležitosti svätej omše na záver 52. medzinárodného eucharistického kongresu".

Návšteva pápeža Františka bude v poradí štvrtou apoštolskou návštevou Svätého Otca na Slovensku.

Pápež Ján Pavol II. navštívil Slovensko spolu trikrát, v roku 1990 počas návštevy Česko-Slovenska zavítal do Bratislavy, v ére samostatnosti na Slovensko pricestoval v roku 1995, keď prišiel do Bratislavy, Nitry, Šaštína, Košíc, Prešova, Levoče a Tatier. V roku 2003 pricestoval do Banskej Bystrice, Rožňavy a Bratislavy. - *TASR* 

#### MATIČNÁ VÝSTAVA V BRATISLAVE PRIPOMENULA 85 ROKOV VZŤAHOV S AMERICKÝMI SLOVÁKMI

Pred 85 rokmi sa vrátila delegácia Matice slovenskej z polročnej kultúrnej misie po slovenských krajanských centrách v USA a Kanade. Dom Matice slovenskej v Bratislave v spolupráci s Krajanským múzeom Matice slovenskej venoval tejto významnej udalosti slovenských a krajanských dejín panelovú výstavu na Hviezdoslavovom námestí v Bratislave v júli.

Nad výstavou s názvom Cesta slovenskou Amerikou prevzal záštitu predseda Úradu pre Slovákov žijúcich v zahraničí Milan Ján Pilip. "Pre náš úrad, ktorý okrem morálnej a finančnej podpory našich krajanov v oboch severoamerických štátoch – v USA aj Kanade, rôznymi formami a s mimoriadnou pozornosťou uchováva a ďalej šíri historickú pamäť o jednej z kľúčových komunít slovenskej diaspóry vo svete, vrátane posolstiev jej výnimočných osobností, je poctou, ak môže dať práve takejto prezentácii v hlavnom meste všetkých Slovákov vo svete – Bratislave, symbolickú pečať a zajedno i vklad svojej partnerskej súčinnosti s Maticou slovenskou," ozrejmil M. J. Pilip.

Ako dodala riaditeľka Krajanského múzea MS Zuzana Pavelcová, matičná cesta slovenskou Amerikou v rokoch 1935 a 1936 naštartovala vzťahy a starostlivosť o Slovákov v zámorí. "Dodnes nikto neprekonal túto mimoriadnu kultúrnu misiu delegácie Matice slovenskej v zložení z popredných predstaviteľov Matice – Jozef Cíger Hronský, Karol Plicka, Konštantín Čulen a Jozef Cincík. Výstavou chceme priblížiť domácej slovenskej verejnosti dejiny našich krajanov v Amerike, ktoré sú neodlučiteľne späté s Maticou slovenskou," vyjadrila sa Z. Pavelcová.

Výstavné panely boli pre záujemcov bezplatne prístupné na Hviezdoslavovom námestí v Bratislave od 19. do 31. júla 2021. Vernisáž výstavy s kultúrnym programom sa uskutočnila 22. júla. - **Veronika Grznárová,** hovorkyňa Matice slovenskej

#### OĽANO CHCE ZASTAVIŤ PROCES ASIMILÁCIE SLOVÁKOV V ZAHRANIČÍ AJ ZRUŠENÍM ZÁKAZU DVOJITÉHO OBČIANSTVA

Vládna strana Obyčajní ľudia a nezávislé osobnosti (OĽaNO) plánuje zastaviť proces asimilácie Slovákov v zahraničí podporou výučby slovenčiny v zahraničí či zrušením zákazu dvojitého občianstva, priblížil predseda Ústavnoprávneho výboru Národnej rady a poslanec hnutia OĽaNO Milan Vetrák pri príležitosti dňa Slovákov žijúcich v zahraničí ..

Jeho stanovisko poskytol Peter Dojčan z mediálneho tímu hnutia OĽaNO. Dodal, že poslanci Národnej rady z hnutia OĽaNO a ministerstvo kultúry v súčasnosti spolupracujú na vybudovaní Múzea a Pamätníka slovenského vysťahovalectva v Bratislave.

Dojčan priblížil, že počet Slovákov v zahraničí klesol za takmer 30 rokov o viac ako milión osôb. Vetrák podotkol, že tento proces asimilácie chcú zastaviť.

"K takým opatreniam patrí podpora vzdelávania v slovenskom jazyku v zahraničí, podpora vedecko-výskumných projektov, lektorátov, osvetovej a duchovnej činnosti, zvýšenie počtu vysokoškolských štipendií na Slovensku, zvýšenie finančnej podpory prostredníctvom dotácií, moderná návratová politika, zrušenie zákazu dvojitého občianstva, elektronické voľby zo zahraničia, či nový zákon o Slovákoch žijúcich v zahraničí a nová koncepcia starostlivosti štátu o nich," zdôraznil Vetrák.

Dojčan dodal, že Slováci pracujúci či študujúci v zahraničí majú pre domovský štát obrovský potenciál. Napríklad z hospodárskeho hľadiska podľa údajov Svetovej banky predstavujú remitencie, teda peniaze, ktoré Slováci posielajú zo zahraničia svojim rodinám, asi dve percentá HDP, čo je zhruba dve miliardy eur.

Prínos slovenských zahraničných komunít vyzdvihla aj ministerka kultúry Natália Milanová (OĽaNO). Ocenila, že mnohí z nich slovenskú kultúru šíria a reprezentujú aj mimo Slovenska.

Aj predseda poslaneckého klubu OĽaNO Michal Šipoš poďakoval zahraničným Slovákom, ktorí nezabúdajú na svoje korene a naďalej sa o osud svojej vlasti zaujímajú.

"My sme však občanom sľúbili nielen nástup právneho štátu, ale aj hĺbkovú modernizáciu hospodárstva a verejných služieb, na čo je pripravených niekoľko veľkých investičných schém. K tejto rekonštrukcii štátu pozývame aj našich zahraničných Slovákov, ktorých skúsenosti a zručnosti sú naozaj často neoceniteľné," dodal.

Deň Slovákov žijúcich v zahraničí si Slovensko 5. júla pripomína od roku 1993, teda od vzniku samostatnej Slovenskej republiky.

#### KRÁTKE SPRÁVY ZO SLOVENSKA



Zariadeniam v cestovnom ruchu vo Vysokých Tatrách chýba personál, ide najmä o čašníkov, chyžné či recepčné. Vyhraté majú podľa nej tí zamestnávatelia, ktorí počas pandémie zamestnancov neprepustili. V súčasnosti je takmer nemožné získať do sektora cestovného ruchu kvalifikovaný personál. Ústredie práce, sociálnych vecí a rodiny evidovalo napríklad v okrese Poprad v máji tohto roka celkovo 146 voľných pracovných miest v gastrosektore. Ako informovala Marianna Šebová z kancelárie riaditeľa ústredia, išlo najmä o pozície čašník a someliér, ktorých hľadali viac ako 60. Za nimi nasledovali kuchári a predavači jedál za pultom či pri okienku. Podnikatelia v cestovnom ruchu však hľadali aj hoteľových recepčných, pomocníkov do kuchyne či barmanov. Pred rokom v máji ponúkal pracovný trh v okrese 209 voľných miest, dominovali pozície ako kuchári, čašníci a someliéri. O prácu v oblasti cestovného ruchu v regióne Vysokých Tatier prišlo v dôsledku pandémie odhadom dvetisíc ľudí.

Bývalým zamestnancom ŠtB a ďalším predstaviteľom komunistického režimu siahne štát po auguste na dôchodky. Stále však nie je jasné, o koľko peňazí môžu prísť. Politici sa totiž sporia o to, ako veľmi môžu skrátiť penzie tejto skupine ľudí tak, aby tým neporušili ich práva. V konečnom dôsledku to môže zavedenie novinky do praxe napokon oddialiť. Pochybnosti o správnosti zákona, ktorý parlament schválil v druhom čítaní v júni, má najmä prezidentka Zuzana Čaputová. So samotným zámerom zákona súhlasí, a preto ho podpísala, no pomerne netradične zároveň avizuje, že má voči prijatým úpravám výhrady.

Minimálna mesačná mzda na Slovensku by mala od začiatku budúceho roka stúpnuť o 23 eur na 646 eur. Minimálna mesačná mzda na Slovensku sa od začiatku tohto roka zvýšila z 580 eur na 623 eur. Najnižšie hrubé zárobky tak v tomto roku dosahujú 57 percent z priemernej hrubej mzdy na Slovensku za rok 2019. Najnižší hrubý zárobok za každú odpracovanú hodinu od začiatku tohto roka stúpol na 3,580 eura z pôvodných 3,333 eura.

Spotrebiteľské ceny sa podľa údajov štatistického úradu zvýšili v priemere o 0,6 percenta a dynamika ich medziročného rastu sa tak zrýchlila z 2,2 percenta až na 2,9 percenta. Silný vplyv na júnovú infláciu mali rastúce ceny potravín, ceny v stavebníctve, ale napríklad aj ceny dovoleniek, zhodli sa viacerí analytici. Odhad celoročnej inflácie v roku 2021 pravdepodobne ekonómovia prehodnotia a bude podľa nich atakovať hranicu dvoch percent. Prekvapil najmä pokračujúci nárast sezónnych cien zeleniny, ktoré zvyknú v júni už klesať s príchodom novej úrody, ale aj niektorých ďalších potravín. Infláciu nahor zdvíhala aj dopytová inflácia, ktorú ovplyvnili najmä vyššie ceny dovoleniek či zvyšujúce sa ceny v stavebníctve. Čeny potravín v júni vzrástli v priemere o 0,5 percenta, po štatistickom zohľadnení zvyčajných sezónnych faktorov sa pritom zvýšili o viac ako jedno percento. Ceny potravín k zrýchleniu medziročnej inflácie prispeli až 0,45 percentuálneho bodu a boli tak zodpovedné za približne dve tretiny júnového zrýchlenia inflácie.
