

#### Thoughts from our Supreme Chaplain, Rev. Andrew S. Hvozdovic THE LORD IS RISEN! ALLELUIA!

And behold, there was a great earthquake; for an angel of the Lord descended from heaven, approached, rolled back the stone, and sat upon it. His appearance was like lightning, and his clothing was white as snow. The guards were shaken with fear of him and became like dead men. Then



the angel said to the women in reply, "Do not be afraid! I know that you are seeking Jesus the crucified. He is not here, for he has been raised just as he said." <u>Matthew</u> <u>28:2–6b</u>

What an experience that must have been! Mary Magdalene and the other Mary went to the tomb early in the morning to pay tribute to our Lord's sacred body. They brought the oils and perfumes that they planned on placing on his beat-

en and bruised body. They came to offer Him their last act of love. But as the women arrived, the earth quaked, and the angel of God appeared to them.

As they left, Scripture says they then left the tomb quickly, "fearful yet overjoyed." All they could think about was telling the other disciples of their encounter when another incredible joy befell them. Jesus Himself met them on the way. In their amazement, the women fell at His feet and did Him homage. Not the homage they planned on doing to a dead body, but the homage due to a risen Savior. They worshipped Him. Jesus then spoke: "Do not be afraid. Go tell my brothers to go to Galilee, and there they will see me" (Mt. 28:10).

It was true. All they had hoped for came true. They saw Jesus arrested. They saw Him beaten. They saw Him falsely accused. They saw Him sentenced to death. And they saw Him die. Now for the miracle of miracles, they saw their Savior alive. Every hope that they had come true. Everything came to fruition in that moment. All that was lost was restored a hundredfold.

The Resurrection of Christ is not simply an event that took place long ago. It's an event that continues to take place when we patiently walk with our Lord through the trials, crosses, and sufferings of life, with hope and trust in His power to do all good things. Evil always loses in the end when we remain steadfast in our hope in Him.

As we celebrate the reality of the Resurrection of Christ, ponder the promise He has spoken to you. If you have surrendered all to Him and died to the world of sin, keep your eyes now on the Resurrection. Have hope in Him and in His power to breathe new life into your heaviest cross.

Sometimes we have hope in our own ideas of the Resurrection. We ask for some hope to come true because we think it is what we need. Do you maintain your hope in Christ even when all seems lost?

Reflect, today, upon the unfathomable plan that God has for your life. Know that if you remain faithful until the end, our Lord will bring forth greater joys in your life than you could ever think possible. It may not happen according to your schedule or your wishes, but it will happen in accordance with His perfect divine will. Do not doubt. Do not be afraid. Have hope and trust and anticipate the moments when the power of the Resurrection brings forth the greatest joys you could ever imagine.

My Resurrected Lord, I trust You with all my mind, heart, soul and strength. I believe that You are faithful to perfection and that Your fidelity will never fail. Give me hope when I need it the most and help me to keep my eyes on the glory that awaits. You have conquered all evil. May I always trust in You!

With all the technological advances in our world today, our staff has implemented changes to make items more accessible and the changes have proven to be successful. I would also like to thank and congratulate our former Director of Sales, Albert J. Suess, on his retirement. Albert was given the task in 2009 to build an agency force from scratch for the Society and the goal has most certainly been accomplished. We thank him for his service to the Slovak Catholic Sokol.

During the past year, we have consistently updated the hardware and software used in our Editorial Department and have made upgrades to our Sokol Website. We have also made significant inroads in the ever-changing world of social media as we look to engage all members of our Society. I would like to thank Livia Karak and Louie Smeriglio for all their hard work and dedication.

During the year in my capacity as the Supreme Secretary, it was necessary to attend various Financial and insurance seminars, meetings, and classes. New rules and regulations on both the state and federal level continue to emerge. The reporting process to all the life insurance related agencies and State Insurance Departments is an important task, but necessary to protect our fine organization. The Home Office staff and Board of Directors have done a great job meeting all the requirements and making the necessary changes to operate in an efficient manner.

Looking ahead to the future, I am confident that with the support of our Supreme Officers and our members, we will continue to make prudent decisions to meet all challenges that may come our way.

#### **STATISTICS**

The amount of Premium Income received during the year was \$5,525,000 of which \$1,915,000 was for life insurance premiums and \$3,610,000 was received as annuity premiums. The face amount of insurance written totaled \$5,100,000 and the total amount of insurance in force was \$239,476,000. The Society has 26,673 members with 29,804 certificates in force and 78 Assemblies/Wreaths. Assets as of 12/31/2020 were \$99,750,407 and the Adjusted Unassigned Funds total \$7,208,000. The Solvency ratio is a financially strong 107%.

#### COMMENTS

Many successful activities were held throughout the year on the local, group, and national levels. The National Tournaments under the direction of our Supreme Director of Sports and Athletics, James C. Matlon, and assisted by the Supreme Physical Fitness Board all proved to be a success for the organization. I would like to commend Supreme Director of Sports and Athletics, James C. Matlon, Supreme Physical Director, Martin Degnan, and Supreme Physical Directress, Katie Swift, and the entire Supreme Physical Fitness Board on a job well done.

## Important to All Tournament Entrants Read Carefully Information Given Below Rules and Regulations of Annual Slovak Catholic Sokol Bowling Tournament

The purpose and aim of our organization in sponsoring annual bowling championships is to promote good sportsmanship, fraternalism and national interest in the Slovak Catholic Sokol.

As you know, each year the Supreme Assembly, recognizing the great importance of bowling in our organization, donates \$60.<sup>00</sup> to the prize fund for each team entry entered in the International Tournament. This financial contribution on the part of our organization is added to the regular prize fee collected by the bowlers. All prize fees collected will be refunded 100% in prizes.

In order to successfully operate our tournaments, we must have cooperation and exact adherence to all entry rules and regulations which govern teams and individuals.

Please read these rules carefully. Do not overlook any detail. Comply with all requests at time entry blank is being filled out and when sending it in with the proper money order, certified check or check. Be sure you have the bowlers affidavits as of all sanctioned league averages for 21 games or more in accordance with our rules governing averages. This will speed up the mailing of prizes after results have been checked. Remember that false information will result in forfeiture of all rights to prizes.

#### **RULES AND REGULATIONS**

1. The Slovak Catholic Sokol Championship Tournament is open to all members of our organization, both male and female (no juniors) who are in good standing and have been members for at least (3) three months SPL or (1) one year for all other policies, prior to the date of tournament with a minimum of \$3,000.<sup>00</sup> coverage. Policy Holders - no Social Members. As mandated by the 2007 Convention, all new members enrolled after January 1, 2008 will require a new minimum of \$5,000.<sup>00</sup> of insurance coverage to participate in the programs after January 1, 2020.

2a. All members of the competing teams must be members of the same Assembly or Wreath. There is no limit to the number of teams from each Assembly or Wreath.

2b. An Assembly or Wreath not having enough bowlers to make up a team may combine with another Assembly or Wreath to make up a team.

3. Doubles teams may be from any Assembly or Wreath for both Men and Women Divisions.

4. All participants must be certified by the respective Assembly or Wreath Financial Secretary and may enter only once for each division.

5. High Score recognition automatically extended to USBC members. Eligible nonmembers can qualify for high score recognition at their option by paying a \$5.<sup>00</sup> participation fee. Affiliated membership is \$21.<sup>00</sup>.

6. There will be at least one prize for each (10) ten entries in each event, and each (20) twenty entries for All-Events for Men and Women.

7. All-Events (optional), shall be handicap. This prize fund is a separate entry (\$5.<sup>00</sup>) and no tournament expense fee is assessed for this. Only those entrants paying this fee are eligible. Please indicate All-Events entries by placing an "X" before names in Team Entry space on Entry Form side.

8. Prize fee will be  $10.^{00}$  per bowler per event. Cost of bowling and tournament expenses  $13.^{00}$  per bowler per event. Total =  $23.^{00}$  per event.

9. No entry money will be returned for any reason.

10. The United States Bowling Congress rules and regulations apply to all bowlers.

11. The Championship in both Men's and Women's Divisions will receive individual championship shirts. In the event of a tie for championship, lowest team handicap will receive shirts, cash prizes will be divided equally. 12a. Handicap (Men) allowed will be 85% of the difference between 240 and last season's 2021-2022 highest sanctioned league average of at least 21 games. Bowlers who have no established average will use their highest sanctioned league average of at least 21 games as of January 1, 2023. A male bowler whose current average of 21 games or more at time of entry is (10) pins or more higher than the previous season's average must use his current average. Male bowlers who have no established average for this year or last year will be listed as 175 average and will be handicapped accordingly. If the bowler does not have a sanctioned average over the last two years, but has competed in the Joint Fraternal Tournament, the most recent 5 year history of Joint Fraternal Tournaments will be used. If none of the above apply, the average of 175 for men will be used. Male bowlers with an average over 240 will receive no handicap and will bowl scratch in the tournament.

12b. All participants will be governed by rerating requirements of USBC Rule 319e. Average to be adjusted accordingly. Failure to use the current average shall disqualify score if submitted average is lower than correct average thereby resulting in a lower classification of more handicap. Prize winnings shall be based on the submitted average if it is higher. However corrections in averages may be permitted up to the completion of the first game of a series.

12c. Handicap (Women) allowed will be 85% of the difference between 200 and last season's 2021-2022 highest sanctioned league average of at least 21 games. Bowlers who have no established average will use their highest sanctioned league average of at least 21 games as of January 1, 2023. A female bowler whose current average of 21 games or more at time of entry is (10) pins or more higher than the previous season's average must use her current average. Female bowlers who have no established average for this year or last year will be listed as 150 average and will be handicapped accordingly. If the bowler does not have a sanctioned average over the last two years, but has competed in the Joint Fraternal Tournament, the most recent 5 year history of Joint Fraternal Tournaments will be used. If none of the above apply, the average of 150 for women will be used. Female bowlers with an average over 200 will receive no handicap and will bowl scratch in the tournament.

13. Bowlers may choose to bowl in their respective gender team and doubles event or on a mixed team or mixed doubles team but cannot participate in both divisions. Singles and All Events are gender specific. Mixed team and mixed doubles scores will be used to calculate All Events specific to the gender of the bowler. Must have 6 teams and 10 doubles teams to hold the mixed events.

14. Teams wishing to bowl all nine games as Team, Double and Singles in one day or a specific day or time must submit that request at time of entry. (Only if necessary)

15. List team names in order of lineup to bowl. The USBC substitute rule will be used in the event it is necessary. Average certification must accompany entry form.

16. All teams must bowl according to the published schedule. In order to ensure your choice of schedule time, send entries in early.

17. Bowlers have 48 hours from completion of tournament to notify manager of error in score.

18. Every consideration will be granted to request date/time preferences for out-of-town teams and individual bowlers. The success of the tournament depends upon all participants.

19. Bowlers need not report information as required by USBC (Rule 319d provision) for tournament prize winnings.

Supreme Director of Sports and Athletics, James (Jim) Matlon, welcomed everyone to the meeting.

Supreme Physical Fitness Board Member Janice Matlon followed with a prayer.

Supreme Physical Fitness Board Member Rob Palchanis led the Pledge of Allegiance.

Supreme Assistant Director of Sports and Athletics, Frank Laury, conducted roll call. Members who were present: Supreme President—Michael J. Horvath; Supreme Secretary—Scott T. Pogorelec; Supreme Director of Sports and Athletics—James C. Matlon; Assistant Director of Sports and Athletics—Frank P. Laury, III; Supreme Physical Director—Martin Degnan; Supreme Assistant Physical Director—Dusan Dorich; Supreme Physical Directress— Katie Swift; Supreme Assistant Physical Directress—Nancy Kropolinsky; Supreme Physical Fitness Board Members—Janice Matlon and Robert R. Palchanis, III.

**Opening Remarks**

Supreme Assistant Physical Directress Nancy Kropolinsky said that we all come together for the betterment and good of what we are doing. She also said that she felt less stress and that we were steady, calm, and efficient. The leaders set the good tone that trickled down to everyone else.

Brother Dusan said that it was really good to go to Dorney Park to have a time to just relax, take a break, and then get to work the next day.

Brother Jim said that despite the adversity and having to push back the Clinic multiple times, moving forward with a positive attitude. It was strange to not have Group 14 there, but we continued anyway.

#### 2022 Bowling & Golf Tournaments

Moving on to a recap of 2022's Golf Tournament, Brother Frank acknowledged and praised Supreme Physical Fitness Board Member Kristen Popik for helping with all of the logistics of making golf run smoothly. Sister Katie made a motion to close the evening session, and Brother Rob seconded the motion. All were in favor.

#### Second Session: Saturday, January 14<sup>th</sup> – 9:30 AM 2023 Main Event – 50<sup>th</sup> International Slet at Kutztown University

Sports Director Jim Matlon opened the meeting by asking what details we would like to share about the Slet.

Supreme Physical Directress Katie Swift questioned whether we move forward with version 2 of the Slet schedule. She wanted each member of the Board to share his or her opinion.

Brother Dusan thought we should keep version 1 of the

schedule with an April 1 deadline for registration. Brother Marty agreed with version 1. Brother Rob felt that we should keep version 1. Brother Frank felt that version 2 would be best. Sister Janice thought that version 2 is best. Sister Nancy thought that version 2 is best.

Sister Nancy wonders how many people we can run through track and field in the time allotted in version 2.

Brother Jim gave his opinion about definitely needing two days, but that would also fit in with version 2.

Supreme Secretary Scott Pogorelec agreed that we can fit all events in version 2. He cited the fact that in Brockport when we had weather delays, we were still able to fit it all in. It would also save the organization money to decrease a day and put the savings towards more events and supplies within the days we have.

Supreme President Mike Horvath thought that we could accomplish all that we need to do in three days. The Supreme Board is going to support the Slet no matter what it is. We have to figure out what is doable and what we are comfortable with.

Brother Scott was happy overall to see that we took the effort to create a schedule that would reduce a day especially with the financial constraints of a convention year.

Brother Frank mentioned that we need a lunch slot/plan for Thursday because it was accidentally omitted. We can shift an opening Mass to Friday morning so that 12:00—1:00 can be lunch. We then adjusted Friday's schedule accordingly.

50th Anniversary shirts and souvenirs for all participants

Sister Nancy brought up t-shirt ordering and was wondering if she was in charge of ordering the t-shirts again, and we agreed that she is.

#### 50th International Slet Gala Dinner

In general, members of the Supreme Physical Fitness Board were all discussing the schedule and some basic logistics regarding how many medals and trophies we need for events and judges we need for drilling.

Closing ceremonies will include Mass.

The gala will include a dinner and dance in a separate place. We can display old uniforms and/or put them in there as a costume in the photo booth. This will include a DJ. Sister Jacque Manyak will compile an old video that would include as many years as possible. It will include cuts of old videos and old photos. This is going to be 15-20 minutes total. Then we can have the week in review with

pictures running in the background.

Brother Frank will compile a week in review at the Slet to be shown at the Gala dinner

Sister Katie said we should have a poster contest for Slet participants to compete in and get the posters printed. Brother Marty said he would be in charge of that.

Brother Marty will find a local DJ and a photo booth.

50<sup>th</sup> International Slet Celebration/Souvenir Book

Brother Jim led us through a money request document for the funds we are going to ask for to go towards various parts of the Slet.

One major task with the souvenir booklets, as one of the items listed, is to ask people to write a welcome letter such as: Brother Scott as Secretary, Brother Mike as President, the governor of PA, the president of Kutztown University, Brother Jim as Sports Director, the Slovak ambassador to the US, Brother Fr. Andy as chaplain, and maybe the leader of the local diocese. It would be good to look up who we have asked in past books. Also, we can ask for other fraternal organizations to congratulate us in written form.

Brother Jim said that we should connect on monthly Zoom calls from here forward.

Brother Jim asked about the sponsorship that would be done by Dick's Sporting Goods, and Brother Marty is going to look into that.

#### 2023 International Sporting Events

Brother Jim needs workers for bowling and golf.

Sister Kristen will work at the bowling tournament on May 19<sup>th</sup>-20<sup>th</sup> at AMF Airport Lanes in Buffalo, NY.

Brother Rob will work at the golf tournament on August 18th-20<sup>th</sup> at the Kensington Golf Course in Canfield, OH.

Brother Jim also asked us to look into what the Governance Committee will be working on next weekend.

Brother Mike explained that this committee is created to look closely at the bylaws who then will become the Bylaw Committee.

Sister Katie wants to be able to create a new sanctioned event such as SNPJ or a future spring golf event. Mike said that a recommended bylaw should be created so that all events that use the Slovak Catholic Sokol name. This recommendation is coming from the fact that there was confusion as to how a Central District golf tournament could have happened in 2022 without official approval.

Sister Katie also wants to add a bylaw to hold people accountable, such as the Group Presidents. They should have to submit a yearly report. The Board discussed and mutually agreed upon recommendations to submit to the Bylaws Committee to support this. **Final Discussions on the 50<sup>th</sup> International Slet from July 13<sup>th</sup>-16<sup>th</sup> at Kutztown University in Kutztown, PA** 

Sister Katie said that at the 2022 Clinic and a recent Board of Directors meeting it was brought up as to whether or not we can have a gymnastics exhibition at Closing Ceremonies. We would have to decide on the criteria for the routine submitted and ask those interested in participating to submit their video by July 1. Sister Katie is suggesting that they choose a song to then demonstrate some basic gymnastics moves with some safety limitations.

Sister Katie and Brother Jim reviewed the track events we have for the 30+ age group and make sure the Board agrees on all of them.

The Board then reviewed all of the important upcoming deadline dates for 2023.

#### Slet Assignments for the Physical Fitness Board

Nancy handed out a list of all responsibilities that were accomplished in past Slets. She requested that we please review it to see what we think is still relevant and what we still need to add, especially in light of the 50<sup>th</sup> Slet. We would decide on roles at the next Zoom call.

Brother Jim did a recap of the main events and follow-up items that we need to accomplish and look at, and we agreed on meeting by Zoom on February 7 at 9:00 Eastern.

Sister Katie also wondered what our best method of communication is among Board members and among physical directors and directresses. She said that she would look into possible apps we can use for this.

Sister Katie said that we need to continue to post on Facebook and make posts to the Slovak Catholic Sokols page.

Board members mentioned some of the main tasks we need to do as an immediate follow-up to this meeting in order to be prepared for February 7.

Sister Janice led closing prayer.

## **OBITUARIE**

#### SISTER MARGUERITE HRUBY, SS.C.M.

Sister Marguerite Hruby died at Nazareth Center in Danville, PA on February 14, 2023, on the Feast of Saints Cyril and Methodius.



She was the daughter of Ignatius and Margaret (Dirda) Hruby, who had been married by Father Matthew Jankola. Ursula Bernardine Hruby was born in Bridgeport, CT, on November 14, 1935. After graduating from Saint Cyril Academy in 1953, she received an RN from St Vincent's

School of Nursing in Bridgeport, CT in 1956. She said that she found the mottos of these two schools to be a guiding force throughout her life; St Cyril Academy's motto was, "Enter to Learn, Leave to Serve," and St Vincent's was "The charity of Christ urges us..."

Sister Marguerite entered the Sisters of Saints Cyril and Methodius from St Cyril and Methodius Parish in Bridgeport, CT on February 2, 1957, and was professed on Aug.13, 1959. She said on her 60th Anniversary as a Sister that entering the Community was not a surprise since she had two aunts who were Sisters of Saints Cyril and Methodius; Sister Margaret Dirda and Sister Genevieve Dirda, and an older sister, Sister William Hruby who also entered the Community.

Sister Marguerite served in the ministry of healing for her entire Religious Life, as a nurse, Director of nursing, and Administrator of Maria Joseph Manor, and later as a Congregational Consultant for health issues. She received her Masters in Public Administration with a graduate certificate in gerontology from Marywood University. It was her masters' thesis on independent living for Seniors which planted the seeds for what eventually bloomed as The Meadows at Maria Joseph Manor. Sister Marguerite was present in 1962 when Bishop George L Leech blessed and dedicated the new home for the aged, and she was present in 2012 when Bishop Joseph P McFadden celebrated the 50th anniversary of the facility.

Sister Marguerite's life of service was rooted in the Gospel, summed up in two favorite quotes, "The Son of Man did not come to be served, but to serve, "and "Whatsoever you do to the least of these, you do to Me." Sister Marguerite was preceded in death by her parents and a sister, Cecelia and brother, William,

## KASIGARDA – MÚZEUM VYSŤAHOVALECTVA Z ÚZEMIA SLOVENSKA DO SEVERNEJ AMERIKY

V obci Pavlovce nad Uhom v okrese Michalovce dokončujú múzeum, ktoré bude mapovať vysťahovalectvo z územia Slovenska do Severnej Ameriky. Otvorené by malo byť od 6. mája. Informovala o tom hovorkyňa Ministerstva obrany (MO) SR Martina Kakaščíková.

Historik docent Martin Javor kúpil domček v Pavlovciach nad Uhom, ktorý dal zrekonštruovať. Plánuje v ňom otvoriť prvé múzeum vysťahovalectva zo Slovenska do Severnej Ameriky nazvané Kasigarda. Dedinská stavba navyše predstavuje jeden z posledných "amerikánskych domov" postavených v tomto regióne. Zemlianka, prezývaná tiež Harajdova chyža, ktorá stojí od konca 19. storočia, sa po 129 rokoch výrazne zmenila.

Martin Javor, docent histórie na Filozofickej fakulte Prešovskej univerzity, sa zaoberá výskumom vysťahovalectva z územia Slovenska. Podľa jeho slov "je neuveriteľné, že nám takmer tretina národa za posledných 150 rokov emigrovala, a my o nich vieme veľmi málo." To bol aj jeden z dôvodov, prečo založil Kasigardu – Múzeum vysťahovalectva z územia Slovenska do severnej Ameriky.

Onedlho sa bude môcť verejnosť pozrieť na vyše 4 000 zbierkových predmetov, ktoré vypovedajú o časti našej histórie, ktorá doposiaľ nebola takto podrobne zmapovaná. #### SLOVENSKÁ VLÁDA ODOBRILA DAROVANIE MIGOV UKRAJINE

Slovensko pošle na Ukrajinu stíhačky MiG-29 a časť systému protivzdušnej obrany Kub. Dočasne poverená vláda Eduarda Hegera o tom rozhodla 17. marca. Darovanie strojov, náhradných dielov a protilietadlových rakiet Kyjevu sa uskutoční na základe medzivládnej dohody a Bratislava za to dostane kompenzácie od spojencov. Celý proces darovania by mal trvať niekoľko týždňov.

"Vláda jednohlasne schválila medzinárodnú dohodu a rozhodla o darovaní MiG-29 a systému protivzdušnej obrany Kub na Ukrajinu," ozrejmil dočasne poverený premiér Heger. Dodal, že darovanie podľa neho prebehlo čisto ústavnou formou a prezidentka Zuzana Čaputová je o tom informovaná. Stíhačky majú podľa Hegera slúžiť na ochranu a nie na útok. Naď dodal, že Slovensko získa asi 200-miliónov eur vysokú kompenzáciu z Európskeho mierového nástroja a USA by mali Slovensku doručiť vojenskú techniku v hodnote približne 700-miliónov dollárov.

Slovensko na Ukrajinu pošle celkovo 13 lietadiel. Tri migy majú pochádzať ešte z Československej socialistickej republiky a majú byť použité výhradne na náhradné diely.

Podľa dočasne povereného ministra obrany Jaroslava Naďa rokovania o darovaní prebiehali viac ako pol roka. Naď pripomenul, že Ukrajina má fabriku na servisovanie sovietskych strojov a majú aj pilotov, ktorí na nich vedia lietať.

#### ŽERBO REZY

*Kvások:* 3 polievkové lyžice mlieko, 1 polievková lyžica práškový cukor, 20 gramov droždie

Cesto: 500 g polohrubá múka, 2 kusy vajce, 250 gmaslo

Plnka: slivkový lekvár, 200 gramov mleté orechy, 200 g práškový cukor, 1 balík vanilkový cukor

S vlažným mliekom si pripravíme kvások, rozpustíme v mlieku



s cukrom droždie. Do preosiatej múky pridáme kvások, vajíčka, mäkké maslo a vymiesime hladké cesto. Rozdelíme na tri časti. Prvú časť vyvaľkáme a dáme na vymastený plech, potrieme lekvárom a posypeme orechami zmiešanými s

práškovým cukrom, na to vývaľkáme druhý plát a znova potrieme lekvárom a posypme orechami s cukrom a prikryjeme tretím plátom. Necháme na plechu na teplom mieste aspoň 20 - 30 minút.Popicháme vidličkou a vrch cesta potrieme mliekom. Pečieme na 200 stupňov asi 25 minút a po vychladnutí polejeme čokoládovou polevou alebo posypeme práškovým cukrom.

#### PUNČOVÝ REZ

*Piškótové cesto:* 4 kusy vajce, 4 polievkové lyžice kryštálový cukor, 4 polievkové lyžice olej, 4 polievkové lyžice voda, 5 polievkové lyžice polohrubá múka, štipka, prášok do pečiva

*Trené farebné cesto:* 6 kusy vajce, 2 hrnčeky práškový cukor, 250 g masla, 2 hrnčeky polohrubá múka, 1 balík prášok do pečiva, 1 polievková lyžica kakao

*Sirup na poliatie:* 100 ml rum, 100 ml malinový sirup, 400 ml voda, punčová aróma



Poleva: 6 polievkové lyžice citrónová 🔤

šťava, 2 polievkové lyžice voda, práškový cukor, džem

*Piškótové cesto:* Vajíčka vyšľaháme s cukrom do peny, pridáme vodu, olej, múku s práškom do pečiva. Cesto rozotrieme na papier na pečenie a upečieme plát. Postup zopakujeme a upečieme.

*Trené cesto:* Žĺtka s cukrom a Herou vyšľaháme do peny pridáme muku s práškom do pečiva. Nakoniec jemne vmiešame sneh z bielkov. Cesto rozdelíme na 3 časti. Jednu časť necháme bledú, druhú časť zafarbíme kvapkou červenej



gélovej farby a do tretej časti vmiešame kakao. Cesto pomocou lyžice kladieme striedavo na papier na pečenie. Upečieme. Prvý plát natrieme džemom naň položíme trojfarebný plát ktorý polejeme sirupom. Sirup pripravíme zmiešaním vody, sirupu, rumu a pár kvapiek punčovej arómy. Poliaty plat potrieme džemom a položíme naň druhý plat z piškótového cesta.

Vrch natrieme polevou. Polevu pripravíme vymiešaním citrónovej šťavy, vody a práškového cukru a kvapky červenej gélovej farby. Cukru pridáme toľko aby nám vynikla hustá poleva. Keď poleva zaschne zákusok pokrájame.

#### **ORECHOVÉ ŽĹTKOVÉ REZY**

*Cesto:* 6 bielok, 250 g práškový cukor, 150 gpolohrubá múka, 250 g maslo, 300 gmleté orechy 1 balík prášok do pečiva *Žĺtková poleva:* 6 žĺtokov, 250 gramov práškový cukor *Cesto:* Mäkké maslo si vyšľaháme s cukrom, postupne pridáme

orechy a na striedačku tuhý sneh z bielkov a preosiatu múku zmiešanú s práškom do pečiva. Plech vymastíme a vysypeme múkou, naň vylejeme cesto a pečieme na 180 stupňov C asi 30-35 minút.



*Žĺtková poleva:* Žĺtka vyšľaháme s cukrom do penista. Ešte na horúci koláč vylejem trošku polevy a spravíme akoby škrupinku z nej, na tenko a až potom vylejeme zvyšok polevy a zahladíme. Necháme úplne uschnúť a vychladnúť. Koláč je najlepšie krájať nahriatym nožom.

#### VEĽKONOČNÝ VENIEC Z KYSNUTÉHO CESTA

500 g hladkáhladká múka, 250 ml mlieko, 2 ks žĺtok, 100 g rozpustené maslo, ½ kocka čerstvé droždie, ½ balíček prášok do pečiva, 5 polievková lyžica cukor, 2 ks vanilínový cukor, ½ čajová lyžička soli, nastrúhaná citrónová kôra, hrozienka, sušené brusnice, plátky mandlí, orechy (podľa chuti), na potretie: vajce, mlieko, rozpustené maslo

Do 1 dl vlažného mlieka si rozpustíme droždie, pridáme 1 polievkovú lyžicu cukru, vymiešame a necháme nakysnúť. Do

väčšej misky pridáme hladkú múku, zbytok mlieka, žĺtky, kvások, rozpustené maslo, prášok do pečiva, zvyšný cukor, vanilínový cukor a soľ. Vymiesime hladké nelepivé cesto. Nakoniec zapracujeme nastrúhanú citrónovú kôru.



Môžeme pridať aj hrozienka namáčané v rume alebo brusnice, plátky mandlí, nasekané orechy - podľa chuti. Cesto poprášime múkou, prikryjeme utierkou a necháme vykysnúť na teplom mieste 1 až 1,5 hodiny. Vykysnuté cesto si preložíme na múkou vysypanú dosku a ozdelíme ho na tri časti. Z každej časti si vypracujeme dlhé valčeky, ktoré na konci spojíme a upletieme vrkoč a spojíme do kruhu. Preložíme na plech vymastený tukom. Ak chceme otvor, do vnútra venca vložíme hrubý sklenený pohár dnom hore, ktorý sme si potreli tukom,aby sa cesto neprilepilo. Necháme ho ešte na teplom mieste podkysnúť. Veniec potrieme vyšľahaným vajíčkom zmiešaným s mliekom a rozpusteným maslom. Posypeme plátkami mandlí. Pečieme pri teplote 180 oC 10 minút. Potom teplotu znížíme na 150 oC a pečieme približne 20 minút podľa potreby, záleží aké veľké pletenky zvolíme.
