
FREQUENTLY ASKED QUESTIONS ABOUT MARY

What does it mean to have a devotion to Mary?

A devotion to Mary is when we grow in relationship with her in order to grow closer to her beloved Son. We trust her intercession and guidance will lead us to Heaven.

What are the main devotions to

Mary?



The Miraculous Medal was revealed in a Marian apparition to St. Catherine Labouré. The Virgin told her that "all who wore this sacramental would receive great graces".

Similarly, Our Lady gave St. Simon

Stock a brown scapular. This scapular is two pieces of cloth attached by a rope that goes over one's chest and back. Our Lady promised that those who died faithfully wearing it, she would bring to Heaven.

The Seven Sorrows' devotion is similar to the Rosary. It focuses on Mary's seven sorrows, which are based on the prophecy of Simeon.

Why is the Rosary so important?

Though sometimes we feel it is mundane, the Rosary is a beautiful means to invite Mary's presence into our prayer journey in a regular way. As you pray each decade, you are invited to direct your attention to one of the Mysteries of the Rosary where events from Mary and Jesus's life are recalled.

They are called Mysteries because they invite you to hold various tensions, such as Mary as both virgin and mother, Jesus as both human and divine, and the paradox of strength and resurrection found in the midst of vulnerability and death. Through meditating on the Holy Rosary, we enter into the mysteries of Christ's life, death, and resurrection.

Do Catholics worship Mary? Why do Catholics care so much about Mary?

Worship is reserved for God alone. Mary is venerated as the Mother of Jesus. Catholics honor Mary, just as Jesus did. Catholics recognize that it is by her and through her that we reach Jesus because it was by her and through her that we received him as our Savior and Redeemer.

We acknowledge Mary's importance in Salvation History and Jesus' life. For this reason, we look to her with love, just as Christ did.

Why ask for her intercession when you can just pray to Jesus?

LAW DAY MESSAGE FROM OUR GENERAL COUNSEL

President Joseph R. Biden has signed a proclamation designating May 1, 2024 as Law Day throughout the Unit-

ed States. This marks the 67th annual observance of this special day set aside to commemorate the law.

It is appropriate that at least one day be set aside for giving thought to the importance of law and the part it plays in making our way of life possible.

Our society is a government of law, not of men. What this means is that we, the people, have set rules to guide our own conduct and have agreed to obey these rules. It means that every citizen



has rights which no other citizen should violate. The humblest and poorest person can go into court against any man or woman and demand his or her rights. Government itself cannot ignore these established rights.

Respect for Law also means that every citizen has an equal obligation to organize his or her life so that it does not conflict with the rights of others. It means that if government by law is to survive, the great majority of the people must accept the rules and live under that law.

The law is the same for all men and women; the affluent and the poor are equally bound to obey the same laws.

Law Day on May 1, 2024 occurs at about the same time that the professional basketball season is concluding. Perhaps they don't seem to be related but they definitely are because a basketball game is almost exactly like our lives under the law.

The game of basketball is governed by rules which amount to laws. It is played by people who are members of a team which could be called citizens. The team members can do their complaining themselves or do it through their coach, just as citizens can do their own complaining or do it through their congressional and legislative representatives.

Disputes are settled by referees just as a judge settles disputes between citizens. A coach may appeal a referee's decision just as a citizen's lawyer may appeal a judge's decision to a higher court.

Violations of the basketball rules result in penalties and so does violation of the law. Good sportsmanship is expected and rewarded just as good citizenship is expected and rewarded. A player may miss a shot but he or she usually gets another chance; if a citizen violates a law, he or she usually gets a second chance to make good.

Did you ever consider that each time we recite the Pledge of Allegiance, we renew our commitment to providing the benefits of liberty and the reality of justice for all?

The fact that we continue to strive to be one nation, under God, with liberty and justice for all, is a tribute to the memory of the millions of Americans who, throughout our history, have been willing to die to secure or preserve these ideals.

OTHER ACTIVITIES

As Supreme Vice President, I have represented the organization at various functions including the Fraternal Societies of Greater Pittsburgh Golf Outing, the Western Pennsylvania Slovak Radio Hour Banquet and served on various boards of Fraternal Associations.

KIDS KORNER

As Supreme Vice President, I continue to provide the Kids Korner in the Falcon Newspaper monthly expanding to three pages. I try to provide interesting monthly facts suitable for children along with various puzzles and games. In the summer in conjunction with the Kids Korner is a Summer Reading program also.

REPORT OF THE GENERAL COUNSEL

This report is submitted to the Board of Directors of the Slovak Catholic Sokol for the purpose of advising of the activities of the Office of the General Counsel since our 34th Quadrennial Convention which was held in Scranton, Pennsylvania, on August 5th through August 8th, 2023.

To all of the delegates at 34th Quadrennial Convention, I extend my Heartfelt thanks and support in re-electing me as their General Counsel. Congratulations to new incoming officers on their election, and special thanks to departing officers for their services on behalf of the Slovak Catholic Sokol.

Since my return from the Convention, I have collaborated with the members of the Post-Convention By Law Committee, namely Brother Michael Horvath, Brother Scott Pogorelec and Sister Kathy Watkins, to review the By-Laws passed at the Convention. The new By-Laws have been published, sent to all Insurance Departments of the States in which we are licensed, and made available to the membership.

As a member of the Board of Directors, I have attended two (2) meetings called by our Supreme President. The minutes of the meetings have been published in the Slovak Catholic Falcon and my participation at these meetings is well-documented.

In matters concerning contract negotiations, I have continuously briefed the membership concerning the status of the sale of the tract of land where our former print shop was located. I am pleased to report that on October 18, 2023, the City of Passaic Planning

Board approved the proposed subdivision, a long standing condition precedent to the closing of title. Preparations are being made to officially close title in the spring of 2024 after the board resolution is adopted and published in the local newspaper.

There were no new mortgages issued during the past year and our mortgage portfolio remains at two (2) mortgages. With respect to the two (2) mortgages on file, I continue to verify that the property taxes and insurance are all paid to date and current.

On the local level, I have been re-elected to serve as President of Group 1 and President of Assembly 162 in Clifton, New Jersey. I continue to attend as many Sokol functions as time permits, and I continue to enroll as many new members as possible.

The delegates at our 34th Quadrennial Convention have made it clear that meaningful changes were needed to our Society's By-Laws to improve our fraternal structure, governance and management practices. I am confident that the changes approved by the delegates will enhance the financial strength of the Slovak Catholic Sokol, help it to continue to grow, and meet the challenges 'in the fraternal financial services industry. Responsible leadership, disciplined governance and effective decision making will keep our society on a solid and stable path.

REPORT OF THE SUPREME DIRECTOR OF SPORTS AND ATHLETICS

As the Supreme Director of Sports and Athletics, and in compliance with the Bylaws of the

Slovak Catholic Sokol, I hereby submit my 2023 Annual Activity Report.

The first event of the year was the Supreme Physical Fitness Board Meeting held in Pittsburgh, Pennsylvania the weekend of January 13th through the 15th. Prior to the meeting I met with Basil W ahal from the GCU to discuss our combined 2023 International Bowling and Golf Tournaments. The Supreme Physical Fitness Board held monthly zoom calls from February through June to finalize all of the assignments for our 50th International Slet.

I attended the Board of Directors 1st Quarter Meeting held in Scranton, Pennsylvania from March 17th through the 19th. The Board of Directors approved all the recommenda-

tions the Physical Fttness Board proposed for our 2023 sporting events.

The 77th .International Bowling Tournament was held on May 19th-2023 at AMF Airport Lanes in Buffalo, New York. The Slovak Catholic Sokol had 42 bowlers, 34 men and 8 women for the tournament. The GCU, FCSU and NSS had 60 participants for a combined total of 102 bowlers. Kathleen Smolkowicz from Reading, Pennsylvania was the winner of the Frank S. Petruff Memorial Sports A ward. The results of the 2023 bowling tomnament and pictures were published in the Falcon and posted on our web site.

The Board of Directors held their 2nd Quarter 2023 Meeting via zoom on Wednesday June 28th. During the meeting the Fitness Board members confirmed completion of all action items for the upcoming historic 50th International Slet. I was in charge of the 50th International Slet Souvenir Book and mailed out Ad Forms to all Supreme Officers, Honorary Officers, Groups, Assemblies and Wreaths. I received 48 Ads that raised \$5,040 to pay for the Souvenir Book and help with Slet expenses. The completed Souvenir Books were handed out to the Slet participants and guests on Saturday night at the Closing Ceremonies and at our Convention in August.

The 50th International Slet was held at Kutztown University, on July 13th through the 16th.

There were eight participating Groups and a total of 138 participants including Fitness Board Members and chaperones. I organized the trip to Dorney Amusement Park on Thursday afternoon including dinner at the park for the Slet participants. A new age group, 30 plus was added for the historic Slet which was successful with 28 participants. I set-up all of the heats for the 37 track events and hired Lexicon Timing, who posted the track times on their web site for all participants and guests to view the results seconds after each track event. I also completed all of the scoring sheets to record the height and distances for our 33 field events.

Congratulations to all of the participants at our historic 50th International Slet and to Group 4, Milwaukee, Wisconsin who finished in 1st Place after the scoring was verified and was also first place for Team and Individual Drill. Group 5, Cleveland, Ohio was the the Track & Field and Vo Ueyball champions and finished in 2nd place in a very close race with Group 4. Group 19, Toronto, Ontario, Canada was the recipient of the John J. Stofko Spirit Award. Frank Laury big provided a majority of the track & field equipment and all of the metals, ribbons, plaques and trophies for the participants who won awards at our Slet .

I attended the 33rd Quadrennial Convention that was held at the Hilton Hotel in Scranton, Pennsylvania, August 5th through the 8th. Members of the Fitness Board helped with the social trip to the New York RailRiders baseball game on Saturday evening. Prior to the Convention, I participated in the Bylaw Zoom Meeting that was held on July 20th. The Convention delegates made the decision to keep the Supreme Physical Fitness Board as part of the Supreme Assembly for the next four years.

The final tournament of the year was the 68th International Golf Tournament from August 18th through the 20th at Kennsington Golf Club in Caufield, Ohio and Flying 'B" Golf Course in Salem, Ohio. A total of 165 golfers participated, 109 from the Slovak Catholic Sokol and 52 from the FCSU and 4 from the GCU. The Friday Hospitality and Saturday Banquet was held

The golf article including Flight Winners and all prize money recipients a total of \$5,896 were published in the Falcon and also posted on our website. The prize money checks were mailed early September after all of the scores and handicaps were verified. The flight winners and best scratch scores received championship golf shirts. The golf tournament financial report was also submitted to the Home Office after the championship golf shirts were mailed out.

I participated in the Board of Directors 3th Quarter 2023 Meeting via conference call on Thursday, September 21st. I also attended the 4th Quarter 2023 Board of Directors Meeting on Sunday December 3r^d, in Fort Lauderdale, Florida. Memorial Day

Memorial Day is a U.S. holiday to honor those who died in military service. It's observed on the last Monday of May and originated in the years following the Civil War. Initially, the holiday was called Decoration Day. This was due to the early tradition of decorating graves. Graves were decorated with flowers, wreaths, and flags. On May 5th, 1868, General John A. Logan of the Grand Army of the Republic made a proclamation. The proclamation was to commemorate soldiers lost in the Civil War. This is widely accepted as the holiday's origin.

In 1873, New York declared Memorial Day a legal holiday. Later, several states and cities followed suit. However, it wasn't until 1971 that Congress passed the Uniform Monday Holiday Act. The act commemorated Memorial Day as the last Monday of May. After World War I, the holiday became an occasion for honoring all of those who died in active military duty.


Presently, the holiday is celebrated every year at Arlington National Cemetery. The president or vice president puts a wreath on the Tomb of the Unknown Soldier. The Tomb of the Unknown Soldier is an important memorial site at Arlington. Small American flags are also placed on each grave at the cemetery. Traditionally, people celebrate with parades, wearing red poppies, and taking a moment of silence at 3 p.m. their local time.

Today we have the opportunity to reflect upon and celebrate the system of justice under which we live. Freedom of religion, speech, press and association guaranteed by our Constitution enables us to enjoy a life of liberty without fear of unwarranted governmental interference.

It is fitting and appropriate that we set aside this day to give thanks for the privilege of living in this democratic society.

When compared with the lives of oppressed people throughout the world, including our suffering brethren in Ukraine, our good fortune is being citizens of the United States is incalculable.

Some of you may question the responsibility you have as a participant in shaping and protecting our laws and the system of justice. Each of us must share in the responsibility of preserving our laws and our system of justice. This means that every American citizen, like shareholders in a corporation, holds stock in the joint venture called American Justice. But the stakes are much higher and the potential dividends much greater than in any corporation.

Citizens inherit their share of America as a birthright, an inheritance that has grown in value for over two centuries

ELECTION24: PETER PELLEGRINI OFFICIALLY ANNOUNCED AS WINNER OF PRESIDENTIAL ELECTION

Peter Pellegrini on Sunday, April 7 was officially announced as the winner of Slovakia's 2024 presidential election on 53.12 percent of the votes in Saturday's April 6 run-off against Ivan

Korcok, who gained 46.87 percent.



Pellegrini received the votes of 1,409,255 people, while Korcok obtained 1,243,709 votes. The difference between the two candidates was 165,546 votes.

The turnout in the run-off

reached 61.14 percent, while it was 51.91 percent in the first round two weeks ago.

Slovaks were electing their president in a direct election for the sixth time in the history of independent Slovakia. Slovakia has had five presidents so far. The first one was Michal Kovac, who was elected by parliament, however. The public elected their head of state for the first time directly in 1999, choosing Rudolf Schuster. He was twice followed by Ivan Gasparovic at the helm of the country. The next president was Andrej Kiska, and Zuzana Caputova is the current head of state. Her term in office will expire on June 15 when her successor Peter Pellegrini will be inaugurated.

PREMIER: IMPORTANT FOR SLOVAKIA THAT AID FOR UKRAINE IS BILATERAL MATTER

The most important thing for Slovakia at the upcoming extraordinary European Council summit is to guarantee that military aid to Ukraine is a bilateral matter, Prime Minister Robert Fico (Smer-SD) said at a meeting of the parliamentary committee for European affairs, adding that he doesn't expect any surprises at the summit.

The premier noted that the summit, which will take place on April 17-18, will focus primarily on the single market and competitiveness, but also on the situation in the Middle East and Ukraine.

For Slovakia, the double quality of food will be an important topic, which, according to the prime minister, should be highlighted. "We see no reason for Slovak citizens to be second-class citizens," stressed Fico.

The premier also particularly welcomes the idea of how to help industry and the economy in the European Union in contrast to climate change targets "The green deal is unsustainable. We all know that," said Fico, adding that he will support all sensible steps that will limit what he saw as meaningless climate targets.

In the context of Ukraine, the summit will also discuss the

delivery of air-defence systems. The prime minister pointed out that Slovakia has nothing more to give to Ukraine, criticising the previous government for providing Ukraine with the S-300 system. He stated that he would never have have done so. However, if provisions are put forward at the summit which say that such support is a bilateral matter, Fico won't attack them.

The head of the cabinet also mentioned the joint meeting of the Slovak and Ukrainian governments, pointing to the various forms of assistance that Slovakia is providing to Ukraine, for example, assistance with mine clearing. At the same time, however, he reiterated that the conflict in Ukraine doesn't have a military solution in his view.

FICO AT EU SUMMIT REJECTS HARMONISATION OF CORPORATE INCOME TAXES

Prime Minister Robert Fico (Smer-SD) made no secret of his scepticism towards the proposed plans for a better economic future of the EU following an extraordinary two-day summit of the European Union (EU) in Brussels on Thursday, April 18.

Before discussing the protection of the single market, building a capital markets union and strengthening competitiveness, the leaders listened to a report on the future of the single market by former Italian Prime Minister Enrico Letta. Fico pointed out that during the talks with Letta, Slovakia had taken particular care to include the social aspects of the report.

The prime minister noted that the EU had had several ambitious economic plans so far and suggested that their objectives hadn't been achieved. "Now the next agenda is how to deepen the single market and help the EU's competitiveness. The United States in particular has been mentioned in relation to private capital," he said, adding that this situation also applies to Slovakia, where people have huge savings of capital in the second savings pillar in addition to banks. He noted that this money isn't used for the development of Slovakia, but, as elsewhere in the EU, a huge amount of money goes to the USA, from where it comes to Europe as investments.

The Slovak premier explained that the government's duty is to kick-start the economy through all available resources, whether from the state budget, EU and other funds, and also through private capital, which, according to him, is also stated in the Government Manifesto. He welcomed the summit's conclusions, which also referred to the use of private resources to boost the domestic economy and, from the EU's point of view, to European objectives.

The leaders also discussed how to combine the objectives of the European Green Deal with support for industry. According to Fico, several states are aware that green ambitions are hampering economic development, which is why the conclusions call for a balance and "reasonableness" of climate goals linked to economic development.

In his view, the proposals for harmonisation of corporate taxes were impassable for Slovakia. "Taxes are a national power. Despite this, some big countries have tried to find ways to push words like convergence or harmonisation. I appreciate that the Visegrad Four [V4] countries [the Czech Republic, Hungary, Poland, Slovakia] and others were of the same mind on

this and rejected it. We rejected this very hard," he explained. However, he agreed with proposals for harmonisation at EU level as regards the resolution of bankruptcies of insolvent firms.

PRESIDENT SUPPORTS CIVIC COLLECTION TO PURCHASE AMMUNITION FOR UKRAINE

I support the 'Ammunition for Ukraine' civic collection, President Zuzana Caputova posted on a social network adding that she's also proud that many in Slovakia care about the fate of neighbouring Ukraine.

"I support this initiative because it's the right thing to do. Our contributions to this initiative are an expression of solidarity and assistance to the victims of unprovoked aggression," wrote the head of state.

The civic collection responds to the initiative of the Czech Republic to purchase artillery rounds for Ukraine and its army. So far, the collection has raised more than €2.14 million. Czech Prime Minister Petr Fiala said on Thursday (April 18) that the Czech government had found a way to use the funds from the civic collection in Slovakia for the benefit of the initiative.

More than 20 European countries have already joined the Czech initiative, however, Slovakia as a country hasn't done so. According to Prime Minister Robert Fico (Smer-SD), the conflict in Ukraine doesn't have a military solution.

SS. CYRIL AND METHODIUS APPEAL OF THE SLOVAK CATHOLIC FEDERATION

The Saints Cyril and Methodius Appeal is in its 46th year raising money to assist the Pontifical Slovak College of Saints Cyril and Methodius in Rome with its day-to-day operations. VÍŤAZOM PREZIDENTSKÝCH VOLIEB **JE PETER PELLEGRINI**

Bratislava 7. apríla (TASR) - Oficiálnym víťazom druhého kola prezidentských volieb je Peter Pellegrini so ziskom 53,12 percenta hlasov. Ivan Korčok získal



46,87 percenta hlasov. Oficiálne výsledky potvrdila Štátna komisia pre volby a kontrolu financovania politických strán na nedeľnej tlačovej konferencii.

Pellegriniho volilo 1.409.255 voličov, Korčokovi odovzdalo svoj hlas 1.243.709 voličov. Rozdiel medzi oboma kandidátmi je 165.546 hlasov. Volebná účasť dosiahla 61,14 percenta, čo je 2.671.279 voličov. Oproti prvému kolu bola účasť vyššia, vtedy prišlo hlasovať 2.265.656 voličov,

čo je 51,91 percenta hlasov.

Slováci si šiestykrát v histórii Slovenskej republiky volili prezidenta v priamych voľbách. Slovensko malo dosiaľ piatich prezidentov. Prvým bol Michal Kováč, ktorého však volil parlament. Priamo si občania volili hlavu štátu prvýkrát v roku 1999, vybrali si Rudolfa Schustera. Po ňom bol dvakrát na čele štátu Ivan Gašparovič. Nasledoval Andrej Kiska a dosial poslednou prezidentkou je Zuzana Čaputová. Funkčné obdobie jej uplynie 15. júna, keď bude inaugurovaný jej nástupca Peter Pellegrini.

Peter Pellegrini sa narodil 6. októbra 1975 v Banskei Bystrici. Je absolventom Ekonomickej fakulty Univerzity Mateja Bela v Banskej Bystrici, odbor financie, bankovníctvo, investovanie, a Ekonomickej fakulty Technickej univerzity v Košiciach.

Za poslanca Národnej rady (NR) SR bol prvýkrát zvolený v roku 2006, keď kandidoval za Smer-SD. Poslancom parlamentu sa stal aj po voľbách v roku 2010.

Po predčasných parlamentných voľbách pôsobil v rokoch 2012 - 2014 ako štátny tajomník Ministerstva financií SR. Od júla do novembra 2014 zastával post ministra školstva, 25. novembra 2014 nahradil odstupujúceho Pavla Pašku (Smer-SD) vo funkcii predsedu NR SR.

Podpredsedom vlády pre investície a informatizáciu sa stal po parlamentných voľbách v roku 2016. Počas politickej krízy po vražde Jána Kuciaka a jeho snúbenice bol začiatkom marca 2018 dočasne poverený vedením ministerstva kultúry namiesto Mareka Maďariča (Smer-SD), ktorý sa funkcie vzdal.

Prezident Kiska poveril 15. marca 2018 Pellegriniho zostavením novej vlády po tom, ako tretia vláda Roberta Fica podala demisiu. Na čele vlády zloženej zo zástupcov strán Smer-SD, SNS a Most-Híd bol od 22. marca 2018 do 20. marca 2020.

V predvolebnej kampani počas volieb do NR SR, ktoré sa konali 29. februára 2020, bol volebným lídrom strany

Zámer založiť novú politickú stranu oznámil Pellegrini 10. júna 2020. Stranu Hlas-SD zaregistrovali 11. septembra 2020 a 28. novembra sa konal ustanovujúci snem strany,

Po predčasných parlamentných voľbách 30. septembra 2023 sa stala strana Hlas-SD spolu so Smerom-SD a SNS súčasťou vládnej koalície.

Za predsedu Národnej rady SR zvolili poslanci 131 hlasmi Petra Pellegriniho 25. októbra 2023. Svoju kandidatúru na post prezidenta SR oficiálne oznámil 19. januára 2024 v priestoroch Štátnej opery Banská Bystrica.

V prvom kole prezidentských volieb, ktoré sa konalo 23. marca 2024, skončil na druhom mieste, keď získal 834.718 hlasov voličov, čo bolo 37,02 %. Spolu s víťazom prvého kola Ivanom Korčokom (958.393 hlasov, 42,51 %) postúpil do druhého kola, ktoré sa uskutočnilo 6. apríla.

V druhom kole prezidentských volieb, ktoré sa konalo 6. apríla 2024, ho podporilo 53,12 percenta voličov (1.409.255 hlasov). Ivan Korčok získal 46,87 percenta, teda 1.243.709 hlasov.

Filmová spoločnosť, ktorá horor natáčala, sa dohodla s produkčnou firmou Frame Film, ktorú vedie Rastislav Kuril a zároveň v júni 2022 došlo k dohode s Audiovizuálnym fondom. Prvá klapka padla v auguste.

Najväčšími regiónmi z pohľadu obratu sú Európa (40 %), Severná Amerika (25 %) a Čína (20 %). Materiál na výrobu vozidiel nakúpil vlani v objeme 9,7 miliardy eur, z ktorých 26 % utŕžili lokálni, slovenskí dodávatelia. Prvé miesto si drží Nemecko (32 %) a na tretej priečke je Maďarsko (20 %). Volkswagen Slovakia vyrobil na Slovensku od roku 1991 viac ako sedem miliónov vozidiel. Je pilierom slovenského exportu a zároveň najväčším súkromným zamestnávateľom v krajine.

Medziročná inflácia sa z februárovej hodnoty 3,4 desatiny percenta znížila v marci na 2,3 a bola tak najnižšia od začiatku leta 2021. Oproti februáru vzrástli spotrebiteľské ceny tovarov a služieb o desatinu percenta. Informoval o tom Štatistický úrad.

Vlani sa slovenskými občanmi stalo vyše 1 100 cudzincov. Vyplýva to zo štatistik, ktoré pre Pravdu poskytlo ministerstvo vnútra. Najčastejšie o udelenie slovenského pasu žiadajú štátni príslušníci Srbska, vlani rezort vyhovel 409 žiadostiam o občianstvo prisťahovalcom z tejto balkánskej krajiny. Druhou najpočetnejšou skupinou záujemcov sú Ukrajinci, slovenské pasy ich vlani získalo 141. V priebehu posledných štyroch rokov ministerstvo vnútra celkovo udelilo štátne občianstvo 3,5 tisíca cudzincom.
