

Thoughts from our Supreme Chaplain, Rev. Andrew S. Hvozdovic IMMACULATE HEART OF MARY

The month of August is dedicated to the Immaculate Heart. Since the 16th century Catholic piety has assigned entire months to special devotions.



The physical heart of Mary is venerated (and not adored as the Sacred Heart of Jesus is) because it is united to her person and is the seat of her love (especially for her divine Son), virtue, and inner life. Such devotion is an incentive to a similar love and virtue.

This devotion has received new emphasis in this century from the visions given to Lucy Dos Santos,

oldest of the visionaries of Fatima, in her convent in Tuy, in Spain, in 1925 and 1926. In the visions Our Lady asked for the practice of the Five First Saturdays to help make amends for the offenses committed against her heart by the blasphemies and ingratitude of men. The practice parallels the devotion of the Nine First Fridays in honor of the Sacred Heart.

On October 31, 1942, Pope Pius XII made a solemn Act of Consecration of the Church and the whole world to the Immaculate Heart. Let us remember this devotion year-round, but particularly through the month of August.

MINUTES OF THE SUPREME BOARD OF DIRECTORS QUARTERLY MEETING HELD VIA VIRTUAL MEETING

Wednesday, June 26, 2024 - 3:00 p.m.

Supreme President, Larry M. Glugosh, **Called to Order** the Quarterly Meeting of the Supreme Board of Directors at 3:00 p.m. on Wednesday, June 26, 2024, and greeted all the members of the Board on the call.

Supreme Chaplain, Rev. Andrew S. Hvozdovic, offered the **Opening Prayer**.

Supreme Treasurer, Michael J. Horvath, led the Board members in reciting the **Pledge of Allegiance to the Flag.**

Supreme Secretary, Scott T. Pogorelec, F.I.C. was asked to take the **Roll Call** and the following members responded:

The record will show that nine members of the Board of Directors are present and Supreme Director of Sports and Athletics, Kathleen S. Watkins is excused.

Acknowledged

President Glugosh informed the Board that they all have received the **Minutes** from our last Board meeting held on April 6, 2024, and published in the June 1, 2024, issue of the Slovak Catholic Falcon. Brother President entertained a motion for their acceptance, so moved by General Counsel, John D. Pogorelec, Jr., Esq., seconded by Chairperson of the Supreme Auditors, James C. Matlon.

Approved

President Glugosh then called upon our Supreme Secretary, Scott T. Pogorelec, F.I.C., to give a brief overview of the **Sales Report.**

Brother Secretary gave a snapshot of the current life and annuity production for the year to date as compared to the 2024 projections. Also discussed was future marketing and sales campaigns to be considered over the next few years.

Several questions were presented and addressed to the satisfaction of the Board and President Glugosh thanked Brother Secretary for the report. President Glugosh then asked for a motion to accept the report, so moved by Supreme Treasurer, Michael J. Horvath, seconded by Supreme Chaplain, Rev. Andrew S. Hvozdovic. Approved

President Glugosh then called upon Mr. Thomas Calimano, Market Director/Senior Vice-President, of PNC Institutional Asset Management to present the **PNC Advisor's Report.**

Mr. Calimano reviewed PNC's outlook for the financial markets and the economy with the Board. Additionally, he reviewed the investment strategies recently implemented in both the equity and fixed income portfolios.

Mr. Calimano reviewed the portfolio's structure and quality and updated the Board on recent changes within the portfolio. Additionally, Mr. Calimano discussed fixed income investing, the current level of interest rates, and expectations for potential investment opportunities during the second half of the year.

Mr. Calimano addressed various questions from the Board concerning our performance outlook and Mr. Calimano indicated the Society is in a strong financial position, especially in this volatile fiscal environment. The Board members expressed thanks to Mr. Calimano for PNC's presentation.

Supreme Director of Sports and Athletics, Kathleen S. Watkins, supplied the Board with the **Physical Fitness Board Report.**

The 78th Annual Bowling Tournament was held on May 17th & 18th in Pittsburgh, PA. The Slovak Catholic Sokol had a total of 45 members participating. Robert Palchanis, III and Nancy Kropolinsky worked the bowling tournament, and the article and pictures will be published in the July edition of the Falcon. The winner of the Frank S. Petruff Memorial Sports Award for Bowling was Bob Macko, from Barberton, OH.

The 2024 Golf Tournament will be held at Treasure Lake Golf Resort from August 9th-August 11th. We have already received 29 applications for the annual event and are expecting well over 100.

Supreme Physical Director, Dusan Dorich, and Supreme Physical Directress, Katie Swift, also updated the Board on the Virtual Clinic in preparation for the 51st International Slet.

President Glugosh thanked Sister Watkins, Sister Swift, and Brother Dorich for their report and entertained a motion to accept, so moved by General Counsel, John D. Pogorelec, Jr., Esq., seconded by Chairperson of the Supreme Auditors, James C. Matlon.

Brother President then called upon General Counsel, John D. Pogorelec, Jr., Esq. for the **Legal Department Report.**

Counsel reported that there is one item to report on:

 Brother John updated the Board on the sale of the print shop in the rear of the Home Office Building and the potential sale of the entire property. A deadline date will be given on behalf of the Society to the potential buyers of the print shop. Brother Counsel and Brother Secretary will keep the Board posted on any developments. After a brief discussion regarding the above item, President Glugosh entertained a motion to approve the report, so moved by Supreme Treasurer, Michael J. Horvath, seconded by Supreme Physical Directress, Katie Swift.

President Glugosh thanked the General Counsel and called upon Chairperson of the Scholarship Committee, Andrea M. Tadlock, for the **Scholarship Committee Report.**

Sister Tadlock reported that the committee was able to manage all business through email communication and a committee virtual call on Thursday, May 2, 2024.

The winner's photos appeared in the June 1, 2024, issue of the Falcon publication. Checks will be mailed out from the Home Office in July to the applicants who were selected for a grant. Sister Tadlock reported that 22 Slovak Catholic Sokol College Grant winners were selected, 1 Theodore and Mary Jane Rich Memorial Grant, 2 Emil Slavik Memorial Grant, 1 Doctors Lesko Medical Memorial Grant, 1 Yencha Family Grant and 4 Museum Memorial Grants were awarded.

In addition, 7 Slovak Catholic Sokol Abbot Jerome M. Koval, O.S.B Memorial High School Grants and 13 Slovak Catholic Sokol Grade School Grant recipients were selected.

Several recommendations were presented by Sister Tadlock and the Board agreed with them which would improve the application process. The website will be updated accordingly, and the applications will become available in November of 2024.

President Glugosh called for a motion to accept the report submitted by Sister Tadlock, so moved by Chairperson of the Supreme Auditors, James C. Matlon, seconded by Supreme Physical Director, Dusan Dorich.

President Glugosh questioned if there was any **Unfinished Business** to discuss.

Brother President updated the Board on the F.O.T.Y celebration for our 2023 recipient, Agnes Evanko. 
JOIN HANDS DAY IN STRATFORD, CT





August 6, 1965 - Voting Rights Act Passed

President Johnson passed a law. The purpose of this law was to ensure that black people could vote. The law aimed to prevent tests on literacy, knowledge, and character from stopping them.

Another thing the Act did was to approve Federal voting examiners to register people to vote. This bill

aimed to increase the number of voters in areas with historical discrimination.

August 11, 1841 – Frederick Douglass Gives his First Anti-Slavery Speech

Frederick Douglass was an escaped slave who became an anti-slavery campaigner. He gave an account of his life as a slave at an anti-slavery convention on Nantucket Island on this date. The Massachusetts Antislavery Society asked Douglass to be a lecturer after his resoundingly successful speech.

Douglass learned to read as a child and knew that education was the way to escape slavery and gain freedom. He successfully escaped by train in 1838.

August 16, 1896 - The Start of the Gold Rush

On this date, prospectors discovered gold in Rabbit Creek, a tributary of the Klondike River. This sparked the incredible event of the Great Klondike Gold Rush. This event saw around 100,000 people migrate to the Canadian Yukon region in the hope of finding gold. The gold rush lasted until 1899.

August 17, 1978 - The First Balloon Trip **Across the Atlantic**

The first hot air balloon trip across the Atlantic Ocean began on this day in 1978. Max Anderson, Larry Newman, and Ben Abruzzo, from Albuquerque, New Mexico, flew from Presque Isle, Maine on August 11.

Their balloon, the Double Eagle II, took them 3,000 miles across the ocean in a journey that lasted 137 hours. On August 17, they landed in Miserey in France, about 60 miles away from the capital of Paris.

August 18, 1920 - Women Gain the Right to Vote in the US

The 19th Amendment to the U.S. Constitution came into effect on this day in 1920. It gave women the right to vote. Women fought for a long time to get this, starting from the beginning of the United States.

In 1865, Susan B. Anthony and Elizabeth Cady Stanton signed a petition to let women vote. Women gained the right to vote in the Constitution 55 years later.

August 21, 1959 – Hawaii Becomes the 50th State

President Dwight D. Eisenhower made Hawaii the 50th state in the Union when he signed a proclamation on this day.

A small group of white planters and businessmen overthrew Hawaii's last queen. Queen Lili'uokalani. in 1893. President Grover Cleveland condemned the coup, but the temporary government established the Republic of Hawaii. Hawaii became a part of the United States in 1898. However, it took more than 60 years for Hawaii to achieve statehood.

August 24, 79 A.D. - Vesuvius Erupts

Mount Vesuvius erupted in 79 A.D., destroying Pompeii, an Italian city, in its famous volcanic eruption. It also affected the cities of Stabiae and Herculaneum. Today, you can visit Pompeii and see much of the city preserved as it was when the eruption took place.

SLOVAKIA READY TO CONTRIBUTE €105 MILLION TO AID PACKAGE FOR UKRAINE

Washington, July 11 (TASR) - Slovakia is ready and willing to support the creation of a new NATO financial package to assist Ukraine, which would mean an increase in Slovakia's contribution by almost €105 million, said President Peter Pellegrini following the first day of talks at the NATO summit in Washington, adding that the condition is that Slovakia can include this amount in defence spending when assessing how it has implemented a level of at least 2 percent of gross domestic product (GDP) in this area.

"I declared in my speech that Slovakia is ready and willing to support the creation of a new financial package under the auspices of NATO, to which Slovakia will have to contribute an amount approaching €105 million. However, Slovakia can include in this amount any activities that the Slovak government or the Defence Ministry is carrying out or will carry out in relation to Ukraine and in relation to NATO," the Slovak head of state told a press conference in the US capital.

"Our condition is that we'll be able to include this amount in expenditures on investments in our defence, which is reported as a percentage of GDP," stressed Pellegrini. In this context, he declared that Slovakia has already reached and even slightly exceeded the set threshold of 2 percent of GDP this year.

FICO HAS PHONE CALL WITH UKRAINIAN PREMIER, CONFIRMS OFFER OF HOSPITALISATION

Bratislava, July 9 (TASR) - Prime Minister Robert Fico (Smer-SD) spoke on the phone with his Ukrainian counterpart Denys Shmyhal, confirming to him the offer to hospitalise in Slovakia child cancer patients from Kiev, TASR was told by the Government Office's press and information department on Tuesday.

They agreed that the technical transport and subsequent hospitalisation will be arranged by health ministers. Fico thanked Shmyhal for the expressions of support for him following the assassination attempt.

"The premiers further agreed that the governments will shortly exchange an assessment of the implemen-

tation of the commitments made at the joint meeting of the Slovak and Ukrainian governments in Michalovce (Kosice region) and will start the preparation of the next joint meeting of the governments," said the Government Office, adding that the Ukrainian prime minister invited the Slovak government to a meeting in Ukraine, with the second half of September or early October 2024 being set as a tentative date. "The prime ministers agreed that the joint negotiation of the governments will be an excellent opportunity for an open and fair dialogue on a whole range of issues," said the office.

Fico congratulated Ukraine on the opening of negotiations on the country's accession to the EU. The Slovak cabinet is ready to provide technical assistance to the Ukrainian government in these talks.

PRESIDENT DENOUNCES SHOOTING AT TRUMP AND ESCALATION OF VIOLENCE INTO POLITICS

Bratislava, July 14 (TASR) - I strongly condemn the shooting at U.S. presidential candidate Donald Trump and I'm deeply concerned about the escalation of violence into politics around the world, President Peter Pellegrini posted on a social network on Sunday, stressing that the use of violence in the pursuit of one's political opinion must always be condemned in the strongest possible terms.

"The citizens of the United States, and of all other democratic countries of the world, should decide about their president at the polls, not by shooting in the streets," wrote the Slovak head of state.

According to Pellegrini, the use of violence to assert one's political opinion must always be condemned in the strongest possible terms and the perpetrators justly punished so that people don't lose confidence in democracy and democratic state institutions, and don't start to take "justice" into their own hands.

Ú.S. presidential candidate Donald Trump was shot in the ear during a rally in Pennsylvania, in an attack now being investigated as an assassination attempt. The attacker was shot dead and law enforcement officials said they hadn't yet identified a motive. One spectator at the rally was killed and two critically injured.

SLOVAKIA FACES MANY CHALLENGES, ONE OF BIGGEST IS AGEING POPULATION

Bratislava, July 19 (TASR) - Education and talent development, modernisation of health care, the ability to cope with the impacts of climate change - these are some of the biggest challenges Slovakia has ahead of it, Slovakia's central bank (NBS) governor Peter Kazimir pointed out in connection with a document called 'Structural Challenges 2024' published by the central bank on Friday.

According to NBS, one of the biggest challenges for Slovakia's society and economy is the ageing of the population. "Slovakia is ageing. There are more and more old people and pensioners, there will be fewer and fewer working people. These are not hypothetical calculations. We will feel it significantly in 10-15 years," stressed Kazimir.

The central bank has calculated that the number of people of working age in Slovakia will fall by 280,000 over the next 15 years. As a result, their ratio to the postworking-age population over 65 will fall from the current 3.7 to 2.8.

Part of the solution lies in more intensive employment of both pensioners and young people, especially women. A well thought-out strategy will also be needed to attract talent and labour from abroad. However, even this alone won't solve the labour market problems. "Today, neither Slovakia nor any European country is ready to accept such a number of foreigners to compensate for the shortfall of domestic players," said the NBS governor.

"We have to figure out how to accomplish more with fewer people. In this, unfortunately, we've been less and less successful lately. The productivity of our employees is growing more and more slowly," pointed out Kazimir.

Modern technology, digitisation and the advent of artificial intelligence offer possible solutions for the future. However, according to Kazimir, Slovakia isn't yet ready to use them. More sophisticated investments also require educated people, he stressed. "Our education system cannot offer them to the Slovak economy to the extent we need them. In addition, many talented people, not only young people, are leaving us for abroad," he added, commenting on the NBS findings.

IF FARMERS AREN'T TAKEN SERIOUSLY, THEY WILL BE SEEN IN STREETS MORE OFTEN

Bratislava, February 22 (TASR) - If farmers' demands are not taken seriously, they will be seen in the streets more often, Slovak Agriculture and Food Chamber (SPPK) chairman Emil Macho told a news conference held in front of the Parliament's building on Thursday.

According to Macho, every political leadership over the past 30 years treated the agricultural and food sector as a necessary evil.

"Several political leaderships have succeeded each over in parliament over 30 years. Every single one of them, which has been in power since 1993, has taken Slovakia's agricultural and food industry as a necessary evil. They focused more on Slovakia producing cars and steel," specified Macho.

The SPPK chief stated that Slovak agriculture wants to be a firm part of the national economy. "It will be hard to fix the mistakes that were made in the food and agriculture industry in the past. There are no short, only long-term solutions. We need a dialogue, we need politicians to listen to us," he underlined.

A convoy of protesting farmers stopped their tractors in front of the residence of the European Commission's (EC) Representation in Slovakia on Thursday, with the Slovak Agriculture and Food Chamber (SPPK) presenting its demands and handing them over to the representation. According to Macho, farmers reject the strict environmental restrictions of the EU, growing red tape and the liberalisation of farm commodity imports from third countries. They also demand that direct subsidies should be paid out as soon as possible. Farmers want to produce and not to be clerks, stated Macho.

SPPK organised protests by farmers across Slovakia on Thursday. According to Macho, more than 2,200 tractors and 4,000 farmers took to the streets. "We are doing this primarily for the sake of people, for us, for our children, for the sake of the generation that will come after us, so that not only Slovakia, but the whole of Europe will be able to feed its population with healthy, high-quality food," said Macho.

SS. CYRIL AND METHODIUS APPEAL OF THE SLOVAK CATHOLIC FEDERA-

EUCHARISTIC PROCESSION AND DEVOTIONS IN DANVILLE, PA

Benediction of the Blessed Sacrament, and a Eucharistic Procession visiting several shrines located on the grounds of Villa Sacred Heart, in Danville, PA, were part of "8 Days of Eucharistic Joy" celebrated by the Diocese of Harrisburg, PA on June 6.

The celebration in Danville was one of several Diocesanwide events, scheduled in conjunction with the National Eucharistic Revival. "We all need to rekindle a reverence for the Holy Eucharist – that is why we are doing these 8 Days of Eucharistic Joy," Bishop Timothy Senior said of the celebrations. They began with the ordination of four priests on June 1 and included a local portion of the National Eucharistic Pilgrimage in the Hanover area June 4, the consecration of the Diocese to the Sacred Heart of Jesus June 7 and a Mass and procession at the State Capitol on June 8, as well as the Pilgrimage and Procession in Danville, at the Motherhouse of the Sisters of Saints Cyril and Methodius.

For the Eucharistic celebration in Danville, over 150 pilgrims gathered at Maria Hall for Adoration and then joined in a Eucharistic Procession and recitation of the Rosary along the Villa grounds to the Basilica of Saints Cyril and Methodius, where Bishop Senior gave his homily. "Our hope is in the Real Presence," Bishop Senior said. "He gave us the Eucharist to perpetually be with us.... We become more like Jesus the more we receive the Eucharist."

6 CHÝB, KTORÝMI NIČÍTE VITAMÍNY **V OVOCÍ A ZELENINE**

- 1. Z ovocia a zeleniny odstraňujte len to najnutnejšie. Možno vás prekvapí, že práve okrajové listy šalátov, kapusty. kelu a ďalších podobných zelenín obsahujú najviac cenných látok. Automaticky ich nevyhadzujte len preto, že sú okrajové.
- 2. Zdraviu prospešná kyselina askorbová, teda vitamín C pri každom narušení plodu, napríklad krájaním či strúhaním vplyvom kyslíka a enzýmov oxiduje na kyselinu dehydroaskorbovú. A hoci táto má na ľudský organizmus rovnaké účinky. ako pôvodná, nie je tepelne stabilná. Riziko oxidácie napríklad vitamínu C počas krájania ovocia a zeleniny eliminujete použitím nerezového noža.
- 3. Obsah zdraviu prospešných látok sa znižuje aj pri prílišnom namáčaní plodov. Vo vode rozpustné látky po určitom čase prechádzajú z ovocia alebo zo zeleniny do vody, v ktorej ich máčate. Ak ju následne len zlejete bez využitia, oberiete sa nielen o vitamín C, ale aj vitamíny skupiny B a mnohé ďalšie minerálne látoky.
- 4. Zbytočne dlhé varenie alebo ohrievanie pokrm znehodnocuje. Pri dlhšej tepelnej úprave dochádza k úbytku vitamínu C, vitamínu K aj kyseliny listovej. Straty v prípade zeleniny dosahujú straty vitamínu C 60 až 100 percent, kým pri krátkodobom dusení len 10 až 25 percent. Spôsoby prípravy a metódy spracovania ovocia a zeleniny majú významný vplyv aj na množstvo antioxidantov.
- 5. Zeleninu ani ovocie nevystavujte slnku. Straty zdraviu prospešných látok spôsobuje aj slnečné žiarenie. Najviac ovplyvňuje obsah vitamínu C, vitamínu A, vitamínov B2, BB5, BB6 a kyseliny listovej. Zelenina napríklad počas krátkeho pobytu na slnku stráca až 50 percent vitamínu C, kým v tieni za rovnaký čas len 15 percent.
- 6. Pozor aj pri zaváraní. Treba si uvedomiť, že aj v tomto prípade je, podobne ako pri varení, teplota rozkladu enzýmov, ktoré následne rozkladajú vitamín C 50 °C. Vysoko aktívne enzýmy sa nachádzajú hlavne v šaláte, póre, kôpre, karfiole, kapuste, zemiakoch, mrkve a tiež v ovocí, ako sú hrušky či jablká. Takéto enzýmy dokážu rozložiť 70 až 100 percent kyseliny askorbovej (vitamínu C).

OVOCNÉ A ZELENINOVÉ ŠŤAVY

Ovocné a zeleninové šťavy posilňujú imunitu a zlepšujú trávenie. Možno pridať aj orechy, vločky, mlieko či jogurt, vďaka čomu tiež zasýtia.



Ovocné šťavy obsahujú najmä vitamíny, minerálne látky, antioxidanty a enzýmy, tiež vlákninu a jadierka.

Semienka obohacujú nápoj o dôležité omega 6- a omega 3-mastné kyseliny. Využitie týchto živín je

optimálne, organizmus ich vie dokonale spracovať a využiť na posilnenie imunity, zlepšenie tráviacich pochodov. Jeden pohár smoothie denne je pre dobrý zdravotný stav postačujúci, pričom je dôležité kombinovať ho so zdravou stravou a životosprávou.

Pri konzumácii ovocných štiav je dobré uvedomiť si, že zvyčajne sú zdravšie a hodnotnejšie tie, ktoré si z poctivých surovín (celého ovocia a zeleniny) či jogurtu, mandľového mlieka a podobne, vyrobíte doma sami. Pri príprave smoothies je dobré myslieť aj na to, ako a v akom množstve ich osladíte. Med či stévia sú vhodné, skúsiť môžete aj javorový sirup, ale nepreháňajte to s množstvom.

Mnohé ovocné šťavy, najmä tie komerčné, obsahujú veľa pridaných cukrov alebo zložiek s vysokým obsahom cukru, ako sú ovocné šťavy a sirupy. To môže viesť k výkyvom hladiny cukru v krvi a zvýšenému riziku cukrovky. Kyslosť a obsah cukru v smoothie môžu erodovať zubnú sklovinu a prispieť k zubným problémom, ak sa konzumujú často. Predpripravené alebo kupované smoothie môžu obsahovať skryté zložky ako konzervanty, umelé príchute a farbivá, ktoré nemusia bvť zdravé.

Konkrétne množstvo ovocnej šťavy denne závisí od celkového kalorického príjmu človeka a nastavených cieľov. V priemere si môže dospelý človek dopriať denne 2 až 3 dcl čistej ovocnej šťavy, zeleninovej o 1 – 2 dcl viac. Ideálne je, ak sa rozriedia s čistou alebo minerálnou vodou v pomere 1:2.

Ideálne je robiť šťavu maximálne z 4-5 druhov plodov, alebo menej. Mrkva a jablko chutia dobre so všetkým.

KRÁTKE SPRÁVY ZO SLOVENSKA



Tragická udalosť v Monkovej doline si vyžiadala dva ľudské životy a štyroch zranených. Ľudia zostali zakliesnení v prístrešku po zásahu vodnej lavíny. Zahynuli dve ženy, jedna z nich je aj česká občianka.

Slovensko zápasí s tropickými teplotami. Klimatológ Milan Lapin z Fakulty matematiky, fyziky a informatiky Univerzity Komenského v Bratislave povedal že júl 2024 mal na Slovensku priemer teploty blízky rekordným hodnotám z rokov 2015 a 2021 a leto 2024 sa zrejme zapíše medzi päť najteplejších za posledných 143 rokov.

Klimatické zmeny prinášajú najmä v letných mesiacoch čoraz extrémnejšie výkyvy počasia, vrátane rýchleho striedania období výrazného sucha a prívalových dažďov. Tie vedú k zosuvom pôdy, záplavám a povodniam, hlavne ak majú vodné toky neudržiavané korytá a obce v ich povodí zanesenú kanalizáciu.

Podľa údajov Ministerstva životného prostredia SR, povodňové škody a ďalšie náklady spojené s povodňami vlani presiahli hodnotu 7 miliónov eur. V porovnaní s rokom 2022 táto suma narástla na viac ako trojnásobok. Vyše polovicu z nej predstavovali škody na majetku fyzických osôb. Najčastejšie pritom išlo o oblasti v čiastkovom povodí riek Bodrog, Slaná, Ipeľ, Dunaj, Váh a Hornád.

Milan Rastislav Štefánik bol jednou z najvýznamnejších osobností slovenských dejín. Uviedol to prezident SR Peter Pellegrini pri príležitosti 144. výročia Štefánikovho narodenia. Poukázal na jeho prínos pri vzniku Československej republiky. "Svojím politickým talentom, diplomatickou stratégiou a schopnosťou reagovať na zmenenú mocenskú situáciu po prvej svetovej vojne využil podmienky na vznik Československej republiky. Svojím úsilím vytvoril základ pre národno-emancipačný proces, ktorý vyústil do vzniku samostatnej Slovenskej republiky," pripomenula hlava štátu na sociálnej sieti. Milan Rastislav Štefánik sa narodil 21. júla 1880 v Košariskách. Zahynul 4. mája 1919 pri leteckej nehode. Lietadlo prvého a zároveň posledného československého ministra vojny sa zrútilo neďaleko Ivanky pri Dunaji. Pri havárii dvojplošníka Caproni Ca.33 zahynula aj celá posádka lietadla.

Firmám po celom Slovensku chýbajú desiatky tisíc ľudí, najviac ich potrebuje priemysel. Zamestnanci chýbajú najmä v automobilovom priemysle, opravách strojov a zariadení a taktiež aj v potravinárstve.

Slovensko poslalo na olympijské hry do Paríži najmenšiu výpravu v histórii. Pod piatimi kruhmi bude bojovať o medaily iba 28 slovenských športovcov. V prognózach úspešnosti jednotlivých krajín sa Slovensko objavuje na spodných priečkach. Pre porovnanie, z poslednej letnej olympiády v Tokiu Slováci priniesli domov štyri medaily – dve striebra a po jednom zlatom a bronzovom kúsku.

PREZIDENT: PRÍLET F-16 JE VÝZNAMNÝ PRE OBRANU SLOVENSKA

Bratislava 22. júla (TASR) - Prílet prvých dvoch slovenských F-16 zo Spojených štátov amerických je pre obranu Slovenska významný. Uviedol to hlavný veliteľ Ozbrojených síl SR a prezident Peter Pellegrini v rámci slávnostného ceremoniálu, ktorý sa uskutočnil pri príležitosti pondelkového príletu lietadiel.

Predošlé stíhačky MiG-29 sa podľa prezidenta už v čase nákupu F-16 dostávali na koniec životnosti. Ponuka lietadiel z USA bola podľa prezidenta najvýhodnejšia. Nové stíhačky podľa neho zaistia aj lepšiu kooperáciu medzi partnermi v NATO.

Ochrana slovenského neba je podľa neho aj vecou hrdosti a znakom suverenity. "Sme vďační, že sme sa v prípade núdze mohli spoľahnúť na lietadlá našich českých, maďarských a poľských priateľov," povedal prezident.

Na ceremoniáli sa zúčastnil aj vicepremiér a minister obrany Robert Kaliňák (Smer-SD), ktorý vyzdvihol, že po dvoch rokoch môže SR opäť začať budovať suverénnu ochranu svojho vzdušného priestoru. "Práve dnes, po dvoch rokoch v zásade absencie všetkých obranných prostriedkov, keď sme protivzdušné zariadenia, ako aj všetky bojové lietadlá odovzdali, sa začína budovať nová mozaika. A dnes dva nie malé, ale dva veľké črepy do tejto mozaiky budúcej suverénnej ochrany vzdušných síl máme pred sebou," vyhlásil.

Poďakoval pilotom aj technikom, ktorí absolvovali potrebný výcvik. "Dostávate do rúk kusy najmodernejšej techniky, a preto vám želám, aby ste sa vy o ňu dobre starali a ona vám dobre slúžila," dodal. Zároveň poďakoval susedným štátom za pomoc s ochranou vzdušného priestoru SR za posledné dva roky. Minister tiež vyzdvihol, že priestory pre stíhačky, technikov i posádku sa podarilo vybudovať za osem týždňov. Po jeho príhovore si slovenská strana symbolicky prebrala kľúče od stíhačiek.

Veľvyslanec USA na Slovensku Guatam Rana povedal, že stíhačky F-16 pomôžu Slovensku brániť svoj vzdušný priestor. Aj podľa neho pomôžu nové stíhačky lepšej kooperácii medzi spojencami v NATO. Spomenul tiež, že Ukrajina čelí útoku Ruska, preto je posilnenie obrany Slovenska dôležité. "Tieto stíhačky robia zo Slovenska silnejšiu krajinu a posilňujú aj NATO," povedal.

Poďakoval sa tiež predstaviteľom štátu za silnejšie ukotvenie Slovenska v západných štruktúrach. Partnerstvo medzi Národnou gardou amerického štátu Indiana a slovenskou armádou, ktoré má tento rok 30. výročie, je príletom stíhačiek podľa neho posilnené.

Kontrakt na 14 stíhačiek F-16 C/D Block 70 americkej výroby uzavrelo Slovensko koncom roka 2018. Dodanie lietadiel sa pre pandémiu oneskorilo.

Slovensko si v USA oficiálne prevzalo prvé dve stíhačky koncom februára tohto roka. Obe lietadlá sa pred príletom do SR využívali na výcvik slovenských technikov. Tretia stíhačka by mala na Slovensko priletieť do konca tohto roka.
