POPE FRANCIS TO SLOVAK PILGRIMS: 'BEAR WITNESS JOYFULLY TO HOPE THAT DOES NOT DISAPPOINT'

Pope Francis on Friday shared a message with Slovak pilgrims, including



Slovakia's President Peter Pellegrini, in Rome for the 2025 Jubilee Year of Hope.

In a written message released by the Vatican, the Holy Father welcomed approximately 4,300 Slovak pilgrims who

began their jubilee pilgrimage this week with the celebration of Mass at the Basilica of St. John Lateran.

"I would very much have liked to be present with you to share this moment of faith and communion, but I am still in convalescence and so I will join you through prayer and with all my affection," the pope's message read.

Pellegrini on Thursday posted on X that he "promised" the Holy Father that he would join his country's national pilgrimage to Rome when he visited the Vatican in December of last year.

Archbishop Bernard Bober of Košice, chair of the Conference of Slovak Bishops, is also among the group of pilgrims made up of hundreds of lay faithful, consecrated men and women, priests, and bishops who plan to pass through the jubilee Holy Doors and visit the tombs of apostles and martyrs in Rome over the next few days.

In his message, the Holy Father en-

couraged participants to continue their country's "rich Christian tradition" as witnesses of hope and joy, following in the footsteps of countless saints — including patron Sts. Cyril and Methodius — "who have irrigated [Slovakia] with the Gospel of Christ for more than a thousand years."

"Your pilgrimage is a concrete sign of the desire to renew faith, to strengthen the bond with the successor of Peter, and to bear witness joyfully to the hope that does not disappoint (cf. Romans 5:5), because it is born of the love that sprang from the pierced heart of Christ and poured into us by the Holy Spirit," the pope said.

Describing faith as "a treasure to be shared with joy," the Holy Father said welcoming God's "plan" does not mean having all the answers but rather trusting that "wherever he leads us, he precedes us also with his grace."

"Every time brings with it challenges and hardships, but also opportunities to grow in confidence and in abandonment to God," he said, adding: "Our 'yes,' simple and sincere, can become a tool in the hands of God to achieve something great."

Entrusting the Slovak group to their patroness Our Lady of the Seven Sorrows to guide and protect them on their journey, the pope concluded his message with a special blessing for their families and country.

"Sisters and brothers, continue to walk together, pastors and faithful, keeping your eyes on Jesus, our salvation ... Do not forget to pray for me," he said.



Upon the completion of my first year as a member of the Board of Directors, I would like to express my heartfelt gratitude to the delegates of the 34th Quadrennial Convention held August 5th through the 8th, 2023, in Scranton, PA, for the honor of serving as your Supreme Vice-President. Thank you for your support and trust in my leadership.

Board of Directors Meetings

I have attended the quarterly Board of Directors meetings. It has been a rewarding experience collaborating with my fellow Board members as we collectively strive to guide the Slovak Catholic Sokol (S.C.S.) into a promising future.

S.C.S. Scholarship

The Scholarship Committee convened via email and a virtual meeting on May 2nd, 2024, to select the recipients of the 2024-2025 Collegiate, Catholic High School, and Catholic Grade School scholarship programs. The committee comprised the following members: Larry M. Glugosh, Supreme President; Scott T. Pogorelec, F.I.C., Supreme Secretary; John D. Pogorelec, Esq., General Counsel; and Katie Swift, Supreme Physical Directress.

The Scholarship Committee awarded a total of 22 Slovak Catholic Sokol Grants. One Theodore and Mary Jane Rich Memorial Grant, two Emil Slavik Memorial Grants, one Doctors Lesko Medical Memorial Grant, one Yencha Family Grant, and four Museum Memorial Grants were granted. Furthermore, seven Slovak Catholic Sokol Abbot Jerome M. Koval, O.S.B. Memorial High School Grants, and thirteen Slovak Catholic Sokol Grade School Grants were also awarded to deserving recipients. Congratulations to the 2024-2025 grant winners.

The Scholarship Committee was pleased to introduce the John J. Yanosick Memorial Scholarship for the 2025-2026 academic year. This scholarship was initiated by Joan Yanosick and the South Side Sokol Club to honor the legacy of Group 14's John Yanosick, who is fondly remembered as Uncle Jack. Additionally, the Glugosh family has expanded the eligibility criteria to encompass applicants pursuing degrees in computer science, information technology, or related fields. We extend our heartfelt gratitude to Joan Yanosick, the South Side Sokol Club, and the Glugosh family for their unwavering commitment to supporting academic endeavors.

Lastly, the S.C.S. website scholarship pages were updated, and new application forms were created to improve the process for grant applicants.

Kids' Corner

I have continued the publication of the Kids' Corner in the Falcon Newspaper and introduced an opportunity for members under 16 to win an Amazon gift card by submitting monthly puzzles. A new winner is randomly selected after each Falcon publication.

The summer reading program has been maintained to promote literacy among our young members, with new prizes to reward participants for their dedication. I am actively seeking ad-

REPORT OF THE GENERAL COUNSEL

In accordance with the governing provisions contained in Section 4.11 of the Constitution and By-Laws, the undersigned submits this report to the first quarterly meeting of the Board of Directors of the Slovak Catholic Sokol to detail the activities of the General Counsel during calendar year 2024.

During the past year, my office continued to review new state and federal legislation pertaining to fraternal benefit societies in the various states in which the Slovak Catholic Sokol is licensed to do business. The objective is to determine whether pending legislation will have an adverse effect on or ability to continue to do business within each particular state. Particular emphasis is placed upon review of tax legislation which may attempt to eliminate the tax-exempt status of our organization. Currently, there is no adverse legislation pending which negatively impacts our organization.

With regard to contracts and pending real estate matters, I have continuously briefed our membership that our organization had entered into a contract with one of its long-standing tenants, Tri County Plumbing, to sell a parcel of real estate on the home office site which had previously served as our print shop for many years. I am pleased to inform you that the print shop was sold and the transaction officially closed title on November 8, 2024. Net proceeds from the sale, after accounting for adjustments, amounted to \$184,575.60. The legal work performed on the file was quite extensive and included the following: numerous telephonic communications with Buyer's attorney; draft and prepare written communications to Buyer's Attorney; receipt and review of written communications from Buyer's attorney; receipt and review of Resolution adopted by the City of Passaic Planning Board; receipt and review of Neglia engineering report with final conditions to be satisfied; telephonic communications with Valerie Mason, Branch Manager, Foundation Title; telephonic communications with Ali Kopetsky,

Processor/Closer, Foundation Title; review responses to email communications from senior title officer concerning Constitution and Bv-Laws of the Slovak Catholic Sokol: review commitment for title insurance, specifically Schedule A, Schedule B, Part I, Schedule B, Part II - Exceptions, Schedule C, tax assessment search, and judgment search; draft and prepare conveyance documents pertaining to the minor subdivision and ancillary title documents; draft and prepare conveyance documents pertaining to the transfer of Lot 10.01 Slovak Catholic Sokol to Thermal Blockchains; review of Parking/Loading Easement, Utility Easement, License Agreement, Ingress/Egress Easement, and Maintenance and Pedestrian Easement; receipt and review of ALTA and RESPA; completion of closing statement for client; meeting at the home office with Supreme Secretary Scott T. Pogorelec to attend to the execution of closing documents; attend to the closing of title and disbursement of deposit check from trust account.

With regard to the home office site itself, after careful consideration, the Board decided to explore further options to market and sell the building, based on the recommendation from CPS Actuaries. Consequently, at the December quarterly meeting, the Board instructed the undersigned to communicate with our professionals to have the building re-appraised. The revised appraisal of the building determined a value of \$3,503,000.00. In addition, during the past year, the Supreme Secretary and I have met on several occasions with a licensed real estate broker and prospective buyer who expressed an interest in purchasing the building and property. More meetings will be scheduled at a later date; I will advise of the status of future contract negotiations.

Last year, I had the pleasure of serving on the Scholarship

Advisory/Selection Committee with Supreme President Larry Glugosh, Vice-President Andrea Tadlock, and Supreme Secretary Scott Pogorelec. Consequently, we declared 50 winners of our 2024 Slovak Catholic Sokol Scholarship grants. Grants were awarded to young Sokols and Sokolky to assist in their various educational pursuits in Catholic grade school, high school, college, and graduate school.

While on the subject matter of scholarships, I drafted and prepared legal documentation establishing a new scholarship, specifically, the Declaration for the John J. Yanosick "Uncle Jack" Memorial Scholarship Fund. By way of background, the decedent dedicated over 50 years to the youth of Group 14, Assembly 16 and Wreath 22. His devotion to the fundamentals of the Sokol organization was exemplified through ensuring the fraternal aspects of the society. In doing so, he held various offices as Assembly 16 Sports Director, Trustee, Board of Director Sokol Club, and Group 14 Sports Director. Joan Yanosick and the South Side Sokol Club wished to create a scholarship fund to provide financial assistance for members of the Slovak Catholic Sokol. The express provisions of the trust read as follows:

- 1. The Sokol shall award one (1) scholarship on an annual basis; and
- 2. Eligibility for the scholarship shall be restricted to a college or trade school student and a member of the Slovak Catholic Sokol for a minimum of three (3) years and one (1) parent or guardian for one (1) year; and
- 3. The scholarship shall be funded from the interest and dividends earned from the principal received in the amount of TWENTY-FIVE THOUSAND (\$25,000) DOLLARS received in 2024, and such other amounts as the Grantors may, in their discretion, determine to fund said scholarship fund; and
- 4. Selection of the successful recipients shall be based upon scholarship ability, financial need, and participation in the activities of the Slovak Catholic Sokol, with a preference to a member from Group 14; and
- 5. The Board of Directors shall have the power to change the amount and number of 5. The Board of Directors shall have the power to change the amount and number of scholarships awarded in any given year, with the consent of the Grantors.

After drafting and preparing the legal documentation, the declaration was subsequently executed, notarized and filed with the home office. The grant for the first year shall be \$1,000 dollars and apply to this year's round of scholarship appropriations.

In matters concerning litigation, there were no new lawsuits filed against the organization during this past year. Our mortgage portfolio is in good standing. There were no new mortgages issued during the past year and our portfolio contains two mortgages. Both mortgagors are current with their obligations. I continue to verify that the property taxes and insurance are all paid up to date.

As a member of the Board of Directors, I have attended all meetings called by our Supreme President. My participation at these meetings is well-documented in the minutes of these meetings published in our Sokol magazine, the Slovak Catholic Falcon. We continue to conduct virtual conference call meetings so all Board members are present via the computer in an effort to reduce the expenses incurred by the organization.

As a governing body, we continue to explore any opportunities which would benefit our membership. I am confident that the membership growth will continue, which is vital for the future of the Slovak Catholic Sokol.

In regard to our investment portfolio, 2024 posted a second

exceptional year for equities, but core bond strategies produced modest returns even with interest rate cuts by the Federal Reserve. Equity returns of 18.5% outperformed the 16.99% return of the S&P 500. Fixed income returns of 1.50% outperformed the 1.25% of the Bloomberg Aggregate Bond Index. The repositioning we accomplished in the third and fourth quarter realized capital gains, reduced risk, increased average quality in the bond portfolio and the average yield to maturity acquired was between 5.00% to 5.15%. Overall, it was a good year. We continued to provide required liquidity, effectively managed risk, began repositioning the portfolio to reduce duration, increase yield to maturity and efficiently balanced gains and losses. I wish to thank Thomas Calimano, Senior Vice President, PNC Institutional Asset Management, and his team for providing wisdom and guidance in overseeing our investment portfolio throughout the years.

In conclusion, I wish to extend my thanks and gratitude to my fellow Supreme Officers for their contributions to strengthen our organization by making decisions in the best interest of our beloved Slovak Catholic Sokol. May the Board conduct all deliberations in the spirit of fraternalism.

KIA SLOVAKIA PRODUCED RECORD NUMBER OF 351,000 CARS LAST YEAR

The Kia Slovakia carmaker manufactured more than 351,000 vehicles at its plant in Teplicka nad Vahom (Zilina region) in 2024, a record for the factory, Kia Slovakia spokesman Tomas Potocek told a news conference.

The Kia Sportage continues to be the model produced in the largest numbers.

The three main export markets of Kia Slovakia in 2024 were the United Kingdom, Germany and Spain.

A total of 351,270 vehicles left the production plant's lines last year, 0.3 percent more than in the previous year. "The biggest demand was for the Sportage model, with more than 221,000 being manufactured in 2024. The remaining 129,000 vehicles were four versions of the Kia Ceed model," said Potocek. Electric versions accounted for a quarter of the vehicles produced.

As many as 18 percent of the company's exports went to the United Kingdom, 11 percent to Germany, and 9 percent to Spain. They were followed by exports to Poland, Italy, France and the Czech Republic. The company exported its cars to 83 countries in total, while more than 7,800 cars remained on the Slovak market.

Kia Slovakia is the only company operated by Kia Corporation in Europe. Its plant was built between 2004-2006, and it launched production in December 2006. It employs up to 3,800 people.

FOREIGN MINISTRY SUMMONS AMBASSADOR OF UKRAINE OVER UKRAINIAN REMARKS

The Foreign and European Affairs Ministry summoned Ukrainian Ambassador to Slovakia Myroslav Kastran, conveying to him sharp criticism over the statements of the Ukrainian side, which the ministry considers to be interference in the internal affairs of Slovakia.

Ukrainian President Volodymyr Zelenskyy repeatedly spoke critically against Slovak Prime Minister Robert Fico. He accused Fico of choosing Russia over the USA and its partners when it comes to gas. Speaking at the World Economic Forum last week, Zelenskyy also pointed to the Slovak premier, who he said wasn't seeking access to US gas but "is not losing hope of using the US security umbrella".

A contract for the transit of Russian natural gas through Ukraine expired at the end of 2024, and the country has decided not to renew it. Premier Fico subsequently threatened Ukraine with a halt in electricity supplies and a reduction in support for Ukrainians who have taken refuge in Slovakia in the wake of the war in Ukraine.

PRESIDENT: NEW STYLE OF PURSUING FOREIGN POLICY INTERESTS GAINING

The world is changing dynamically and a new style of promoting foreign policy interests is gaining strength, President

Peter Pellegrini stated at a meeting with heads of diplomatic missions and representatives of international organisations accredited in Slovakia.

The head of state thus continued the tradition of the New Year's reception, which is a thanks for the cooperation so far and an opportunity to deepen mutual relations with countries from all over the world.

The president further stated in his address that it's necessary to face new challenges. "In the field of security, energy and migration policy, the uncompromising pursuit of national interests dominates. This poses a major challenge for every institution, including the EU, to keep pace with the world, especially with China and the USA," Pellegrini told around 90 diplomats and representatives of international organisations. It's clear, he said, that the EU can't move forward without the courage to make fundamental changes.

Pellegrini confirmed that Slovakia is pursuing a foreign policy oriented towards all four cardinal directions, adding that Slovakia's place is in the EU and NATO, which, according to him, guarantee internationally recognised borders, free and secure economic development. "New times are coming and it's necessary to prepare for them. It isn't impossible that the EU will have to take more responsibility for its own security, and along with it also Slovakia," noted the president.

GORAL COMMUNITY OFFICIALLY RECOGNISED AS ETHNIC MINORITY IN SLOVAKIA

The Goral community [which mainly lives in the north of Slovakia, close to the Polish border - ed. note] will become 15th officially recognised ethnic minority in Slovakia, according to a decision made by the government at its away-from-home session in Cerveny Klastor (Presov region), based on Premier Robert Fico's proposal.

Gorals have welcomed this decision, claiming that it will enable them to preserve their traditions and spread them further

"This is a source of satisfaction for Gorals, as the Goral community occupies all of northern Slovakia, from the town of Stara Lubovna (Presov region) up to upper Moravia - Jablunkov. We are unique in the environment in which we grow up, we are shaped, we profess values such as hard work, responsibility, family and faith in God. We want the Goral culture to be preserved for future generations," said Pavol Bekes, mayor of the village of Zdiar (Presov region).

Bekes pointed out that thanks to being included on the list of ethnic minorities, the community will be able to obtain money from the state budget for its activities and thus further develop its culture. In Zdiar, it would finance, for example, folklore ensembles and the promotion of Gorals at home and abroad. "We are already part of the intangible cultural heritage in Slovakia, and we would like to be included on the UNESCO list along with the [Gorals among the] Poles and the Czechs," added Bekes.

Gorals applied for inclusion in the list of ethnic minorities back in 2023. The mayor of Zdiar estimates that some 70,000 people in Slovakia belong to this community. The exact number will be known after the next census.

There will now be 15 ethnic minorities in Slovakia. The previous ethnic minority to be recognised in Slovakia was the Vietnamese one in 2023.

MARTIN DEGNAN AWARDED POSTHUMOUSLY AS THE 2024 FRATERNALIST OF THE YEAR

The Fraternalist of the Year celebration was held on March 29, 2025 at Wyoming Valley Country Club in Wilkes-Barre, PA in honor of our 2024 Fraternalist of the Year, Martin Degnan, our former Supreme Assistant Physical Direrctor. He passed on October 2, 2024.

He was a member of Assembly 59, Group 7, Father Joseph Murgas, in Wilkes-Barre, PA, where he served as vice president and physical director. He was a member in the North End Slovak Citizens Club, North Wilkes-Barre and the Polish American Veterans Club of Plains Township.

He was a dedicated Sokol always willing and able to lend a hand in his own Group, Assembly and International level. Marty held various positions on the Physical Fitness Board for over 20 years. The Sokol family was truly a huge part of Marty's life and he was very proud of his membership.



A NEW SCHOLARSHIP FOR STUDENTS STUDYING SLOVAK AT THE UNIVERSITY OF PITTSBURGH

The University of Pittsburgh is the only university in North America offering a minor in the Slovak language and culture. In order to help sustain the Slovak Program, Slovak Catholic Sokol member Professor Michael J. Kopanic, Jr. has funded a permanent scholarship for students who are studying advanced Slovak at the University of Pittsburgh.

THE MICHAEL KOPANIC, PHD FUND SCHOLARSHIP

Beginning in the 2025-2026 academic year students currently studying Slovak courses in the Department of Slavic Languages and Literatures are invited to apply for the **Michael Kopanic**, **PhD Fund Scholarship**. Eligible recipients must be in good academic standing, currently enrolled in a Slovak course, and have committed to taking Slovak course(s) within the next academic year.

Michael J. Kopanic, Jr. is an Adjunct Professor of History at the University of Maryland Global Campus (UMGC) and a former editor of *Jednota*, the publication of the First Catholic Slovak Union. He has earned degrees from Youngstown State University (A.B.), the University of Notre Dame (M.A.), and the University of Pittsburgh (Ph.D.). At UMGC, Professor Kopanic has served as Course Chair and Course Coordinator for European history courses and received an outstanding teaching award in 2012. He also administers three Facebook sites: Learning the Slovak Language and Culture, Slovak History, and the Slovak Studies Association.

Professor Kopanic has contributed numerous articles to the Slovak Catholic Sokol and other Slovak-American publications, *Naše rodina*, and many academic publications, and edited the books *Slovaks in America* and Illustrated Slovak History. A former Czechoslovak Genealogical Society International board member, he serves on the Academic Committee of the Museum of Slovak Emigration to North America, is an academic consultant for Global Slovakia and is on the editorial board of the journal *Kultúrne dejiny* (Cultural History, Ružomberok, Slovakia). He is currently working on a book about Slovak traditional customs.

Prof. Kopanic has always had a keen interest in history and this translated into a wish to learn more about his ancestors while attending college. He wanted to communicate in Slovak with his baba (grandmother) and Slovak-born mother, who emigrated before World War II. This inspired his wish to learn the Slovak language and culture. When studying for a doctorate in history, he found that only the University of Pittsburgh continually offered courses in Slovak, so he transferred to Pitt from the University of Toronto. His quest to learn culminated in his first trip to his mother's ancestral home, and four years later, a year-long stay for doctoral research in communist Czechoslovakia. Since then he has made over 20 trips to Slovakia, including attending the Slovak summer school at Comenius University in Bratislava, Studia Academica Slovaca.

Professor Kopanic has devoted his entire life to learning more about Slovaks and their culture. From their birth, he has spoken with his daughters only in Slovak, and hoped they would carry on the culture and language with their children. Furthermore, he decided that he wished to help others with the same yearning to advance their education. In consulting with the Slovak Studies Program and the Slavic Department, he was told that what the Program needed most was funding for those wishing to learn Slovak. Thus he decided to fund an endowed scholarship for students studying advanced Slovak. It is his hope that the Slovak Studies Program will continue to flourish, and as an historian, he said that he wants it to be alive and thriving for hundreds of years into the future.

On Tuesday, February 18, 2025, the University of Pittsburgh's Slavic Department held a reception to highlight the achievements of the program. The Slavic Department offers language courses in Russian, Polish, BCMS (Bosnian-Croatian-Montenegrin-Serbian), Slovak, and Ukrainian. The undergraduate program features a Russian major, and minors in Polish, Slovak, and BCMS. Summer courses and study-abroad opportunities are available through the Summer Language Institute.

The University of Pittsburgh is the only school of higher education in the USA which has a permanent chair of Slovak Studies and offers a minor in the language. Currently, Renáta Kamenárová serves as the Teaching Assistant Professor and Director of the Slovak Studies Program.

Slavic Department faculty and students presented several interesting talks about their learning experiences during the summer program abroad, including Abby Kraus, another Slovak Studies student, and students of Polish and BCMS. All found studying abroad a very rewarding and enriching cultural experience. Slovak Catholic Sokol member Professor Michael J. Kopanic, Jr. also attended the reception. LAW DAY MESSAGE FROM THE OFFICE OF OUR GENERAL COUNSEL

On May 1, 2025, Law Day is celebrated throughout the United States. On this day, all Americans affirm the essential role of the rule of law in the development and

preservation of our free society.



This year marks the 68th annual observance of this special day set aside to commemorate the law. The idea for this commemoration was conceived in 1957 by the then President of the American Bar Association, and in 1958, President Dwight D. Eisenhower established Law Day by Presidential Proclamation. Subsequently, in 1961, May 1st was set aside by Joint Resolution of Congress as Law Day.

The purpose of Law Day is to call the attention of every American citizen to both the principles and practice of American law and justice. It is the day to reflect on our legal heritage, the role of law in our society, and the rights we, as Americans, enjoy under the Constitution.

Law Day is an appropriate time for all citizens to recognize that each of us has a personal responsibility when it comes to the law. Respect for law is a state of mind which must be taught and practiced daily. There must be a broad sense of citizen responsibility and a sincere desire for order and justice. Part of this process requires that just laws be passed and followed by vigorous enforcement. The public attitude should be public condemnation of those who violate laws or take the law into their own hands instead of tolerance, indifference, and condonation. Those who obey and follow the prophecies of the law should be given respect and appreciation. Law enforcement officials should be given public support to encourage them to discharge their duties in a fair manner.

PO VW ZASTAVUJE VÝVOZ ÁUT DO USA JAGUAR LAND ROVER

Jaguar Land Rover (JLR) zastavil s okamžitou platnosťou dodávky áut do USA, ako rekciu na clá prezidenta Donalda Trumpa. Zabolí to aj závod v Nitre, kde z liniek schádzajú modely Defender a Discovery.

V nitrianskom závode automobilky JLR, ktorý zamestnáva približne 4 800 ľudí, schádzajú z liniek modely Land Rover Defender a Land Rover Discovery. Teraz sa ale k americkým zákazníkom nedostanú.

"USA sú dôležitým trhom pre luxusné značky JLR," uviedol hovorca britskej automobilky vo vyhlásení. "Prijímame krátkodobé opatrenia vrátane vývozu áut do USA v apríli, v čase, keď pripravujeme naše strednodobé až dlhodobé plány."

Jaguar Land Rover predal vlani približne 430 000 vozidiel, z ktorých takmer štvrtina skončila v Severnej Amerike, uvádza automobilka vo svojej výročnej správe. V januári spoločnosť vykázala 17-percentný pokles štvrťročného zisku pred zdanením.

Krok automobilky je najnovším príkladom globálneho dosahu Trumpovej colnej politiky, pričom aj ostatné automobilky prehodnocujú svoje obchodné stratégie.

Jaguar Land Rover, ktorý vlastní indická Tata Motors, je podľa objemu jedným z najväčších britských výrobcov. Zastavenie vývozu áut do USA sa však dotkne aj slovenského závodu automobilky JLR v Nitre, kde sa vyrábajú modely Land Rover Defender a Discovery. Tento podnik zamestnáva vyše 4 800 ľudí.

Británia uviedla, že sa sústreďuje na snahu zabezpečiť obchodnú dohodu s Washingtonom. Predpokladá sa, že JLR má v USA zásoby dovezených áut na niekoľko mesiacov, ktoré nebudú podliehať novým clám, informovali noviny Times of London.

HOLLYWOODSKY FILM MATCHBOX SA TOČÍ NA SLOVENSKU

Natáčanie hollywoodskeho akčného trháku Matchbox na Slovensku sa blíži do finále, pričom posledné dni strávil štáb najmä v okolí Žiliny a na Kysuciach. Herci a produkčný tím si popri pracovnom nasadení nachádzajú čas aj na objavovanie krás Slovenska.

Akčný film inšpirovaný legendárnymi autami sa nakrúca priamo na slovenských cestách. Pozorným obyvateľom mesta a okolia neušli známe tváre ako John Cena či Jessica Biel, ktoré sa objavili priamo na natáčaní. Nechýbali ani kaskadéri, ktorí mali na starosti nebezpečné scény. Veľká časť produkcie prebieha na diaľničnom úseku, kde koncom marca vyrástla rozsiahla filmová základňa – stany, vrtuľníky, športové autá, motorky aj kamióny, ktoré budú súčasťou filmových scén.

Matchbox, pod taktovkou režiséra Sama Hargrava, oživuje spomienky na ikonické autíčka z 50. rokov minulého storočia. Okrem Johna Cenu a Jessicy Biel sa vo filme objaví aj Danai Gurira, známa napríklad z marvelovskej série Black Panther.

Natáčanie si vyžiadalo aj dočasné uzávery niektorých úsekov ciest, no zároveň prinieslo do regiónu jedinečný hollywoodsky ruch, aký sa len tak nevidí. Slovensko sa opäť ukazuje ako atraktívna destinácia pre svetové filmové produkcie.

MÁTE VYSOKÝ KRVNÝ TLAK?

Kľúčom k boji proti vysokému tlaku majú byť potraviny bohaté na draslík. Nový výskum z University of Waterloo naznačuje, že zvýšenie pomeru draslíka ku sodíku v strave môže byť účinnejšie pri znižovaní krvného tlaku než len samotné obmedzenie príjmu sodíka. Štúdia bola nedávno publikovaná v časopise American Journal of Physiology – Renal Physiology.

Vysoký krvný tlak postihuje viac ako 30 percent dospelej populácie na svete. Je hlavnou príčinou koronárnej choroby srdca a mŕtvice a môže viesť aj k ďalším ochoreniam, ako sú chronické ochorenia obličiek, srdcové zlyhávanie, nepravidelný srdcový rytmus a demencia.

Výskum naznačuje, že zvýšenie príjmu potravín bohatých na draslík – ako sú banány alebo brokolica – môže mať priaznivejší vplyv na krvný tlak než len zníženie sodíka.

Dnešná strava však býva oveľa bohatšia na sodík a chudobnejšia na draslík. To by mohlo vysvetľovať, prečo sa vysoký krvný tlak vyskytuje predovšetkým v priemyselne vyspelých spoločnostiach, a nie v izolovaných komunitách.

Výskum zároveň ukazuje, ako pohlavie ovplyvňuje vzťah medzi draslíkom a krvným tlakom. Štúdia zistila, že muži si vyvinú vysoký krvný tlak ľahšie než ženy pred menopauzou, ale zároveň u mužov lepšie funguje zvýšený pomer draslíka k sodíku.

KRÁTKE SPRÁVY ZO SLOVENSKA



Členské štáty EÚ v stredu hlasovali za návrh Európskej komisie (EK) na zavedenie obchodných protiopatrení voči Spojeným štátom a zhodli sa na tom, že clo na tovary z USA sa začne vyberať od 15. apríla. Návrh EK zaviesť odvetné opatrenia vznikol v reakcii na marcové rozhodnutie administratívy USA uvaliť clá na dovoz ocele a hliníka z EÚ. Komisia spresnila, že EÚ považuje americké clá za "neopodstatnené a škodlivé", pretože spôsobujú hospodársku ujmu obom stranám a zároveň aj globálnej ekonomike a zdôraznila, že EÚ uprednostňuje rokovania s USA, ktoré by priniesli "vyvážené a vzájomne prospešné" výsledky. Komisia, podľa viacerých tlačových agentúr, pripravuje aj ďalší zoznam tovarov, ktoré môže zaťažiť clami v odpovedi na takzvané recipročné clá, ktoré pred týždňom oznámil americký prezident Donald Trump a ktoré znamenajú 20-percentné colné zaťaženie tovarov z Európy a 25-percentné clá na automobily. Americké produkty z tohto druhého zoznamu by mali podliehať clám od 16. mája.

Vlani navštívilo 13 slovenských jaskýň 476.765 ľudí. Oproti roku 2023 bola návštevnosť vyššia. V posledných rokoch je najnavštevovanejšou jaskyňou Belianska jaskyňa. Po Belianskej jaskyni je najnavštevovanejšou Demänovská jaskyňa slobody. Najnižšiu návštevnosť má Brestovská jaskyňa.

Na Slovensku v roku 2023 evidovali pôrodnice 48.812 pôrodov, pri ktorých sa narodilo 49.375 detí. Ide o historicky najnižšie počty od sledovaného roku 1996. Dlhodobo najvyššia pôrodnosť v Bratislavskom kraji sa v posledných rokoch presunula na východné Slovensko. Vyplýva to z dát Národného centra zdravotníckych informácií. Počet zaznamenaných pôrodov predstavuje medziročný pokles o 3970 v porovnaní s rokom 2022. Od roku 1996 išlo o najnižší počet pôrodov s poklesom o 10.972. Pôrody prvorodičiek predstavovali 42,9 percenta.

V komore národnostných menšín, ktorá tvorí súčasť Rady vlády SR pre národnostné menšiny, bude mať jedným členom zastúpenie aj goralská národnostná menšina. Vyplýva to zo zmeny a doplnenia štatútu rady, ktoré schválila vláda SR. Rada vlády SR pre národnostné menšiny ako samostatný poradný orgán kabinetu vznikol definitívne schválením jej štatútu na konci októbra 2024. Nadväzuje na činnosť predchádzajúceho Výboru národnostných menšín a etnických skupín, plní funkciu konzultatívneho orgánu pri koordinácii verejných politík i zabezpečovaní účasti príslušníkov národnostných menšín na riešení vecí týkajúcich sa národnostných menšín. oblasť implementácie Európskej charty regionálnych alebo menšinových jazykov. Goralov ako 15. oficiálnu národnostnú menšinu v SR uznali rozhodnutím vlády na konci januára 2025.
