This Christmas carries a special grace, for it unfolds within the Jubilee Year of Hope — a sa-



cred time when the Church invites us to rediscover the mercy, renewal, and joyful expectation that come from faith in Christ.

# SS. CYRIL AND METHODIUS APPEAL OF THE SLOVAK CATHOLIC FEDERATION

The Saints Cyril and Methodius Appeal is in its 47th year raising money to assist the Pontifical Slovak College of Saints Cyril and Methodius in Rome with its day-to-day operations. The Appeal relies upon the generosity of individual donors in addition to collections taken up in personal parishes of Slovak ancestry. A direct mailing asking for donations was sent in January to local district and branch leaders from the four Catholic Slovak Fraternal Organizations, members of the Slovak Catholic Federation, clergy with Slovak ancestry, and previous donors.

A total of \$21,713.00 has been received from 169 donors for the 2025 Appeal, as of October 13. Among the 56 gifts received from various Catholic Slovak Fraternal Branches and Districts, donations totaling \$1,910.00 have been received from Assembly 11, Assembly 23, Assembly 24, Assembly 34, Assembly 48, Assembly 59, Assembly 78, Assembly 162, Assembly 182, Group 1, Group 7, Group 12, Group 17, Wreath 54, and the home office of the Slovak Catholic Sokol. Donations to date have also been received from 5 parishes, 21 clergy and religious, and 87 individuals. On behalf of the Pontifical College, thank you for your continued generosity and support.

Anyone who wishes to contribute to the 2025 Appeal but did not receive a solicitation letter in January is asked to fill out the information in the box at the bottom of this article and mailing it along with your check payable to the Slovak Catholic Federation to the address provided. Donations in any amount are deeply appreciated and are acknowledged. Gifts received after November 30, 2025 will be credited toward the 2026 Appeal. Thank you again for your goodness and generosity.

Theodore Roosevelt once said, "It is not what we have that will make us a great nation; it is the way in which we use it." Group 16 and Assembly 36 honor



the revitalization of nature and its use in their community by supporting the Burgess-Shadbush Nature Center.

The history of Burgess-Shadbush Nature Center.

In 1955, the United States Department of Defense initiated the construction of a Nike Missile Base in Utica, Michigan, primarily to safeguard Detroit from potential Soviet attacks during the Cold War era. The site included sections of Spring Hill farm, historically recognized in the 1830s as an Underground Railroad Station where enslaved individuals seeking freedom traveled northward towards Canada. The base featured missile silos surrounded by earth berms, along with a missile support and command center, and a battalion launch headquarters. Radar stations were also established on the site. By October 1957, the facility was operational, housing 20 Nike missiles. In 1962, these Ajax missiles were replaced by Hercules missiles, which offered enhanced range and accuracy and were capable of carrying nuclear warheads. However, with the advent of Intercontinental Ballistic Missiles (ICBMs) in 1974, these systems became obsolete, leading to the decommissioning of the complex. The dismantling process involved filling the missile silos, leveling the fuel mixing berms, and demolishing certain structures, while key buildings such as the missile support and power buildings remained. The property was subsequently transferred to the Department of Natural Resources. Following the site's closure, local community efforts, including those by Utica Community Schools and nature educator Jo-Ann Burgess transformed the area into an educational space, opening classrooms to teach children about the importance and awareness of nature. In the early 2000s, the Burgess-Shadbush Nature Center was designated by Shelby Township. The Nature Center is a log building constructed from 10-foot diameter white pine logs and contains live animals, natural history, and interactive displays about history and nature. There are several miles of nature trails on the grounds, including a boardwalk trail through a tamarack swamp leading to a pavilion at the Clinton River.

The Co-named Shadbush refers to a group of trees and shrubs commonly found on the site. These plants are often called Serviceberry, Shadblow, or Juneberry. Known for their beauty throughout all seasons, Shadbush varieties are an important part of nature's landscape. (Refer to "Gardening with Nature plants.)

The Nature Center provides classroom and outdoor experiences to support children's learning and development, including creativity, cooperation, and awareness of nature. To support the Burgess-Shadbush Nature Center's mission, Group 16 and Assembly 36 made a \$100 donation to continue the education and utilization of the center.

We are grateful for Group 16 and Assembly 36's dedication to supporting their community and nurturing a profound respect for the natural world. Their compassion shines brightly, igniting a passion in others to not only embrace the beauty of nature but also learn from and protect it for generations to come.

May their Sokol Spirit continue to thrive through their generosity, and may they be blessed in all their inspirational endeavors!

### **KEY FACTS ABOUT VETERANS DAY**

The holiday started as Armistice Day on November 11, 1919, to commemorate the end of World War I.

Change to Veterans Day: In 1954, President Dwight D. Eisenhower signed legislation changing the name to Veterans Day to honor all veterans of all wars, not just WWI.

Date: The holiday is always on November 11th, marking the anniversary of the armistice that ended WWI.

Historical significance: From 1971 to 1977, the Uniform Monday Holiday Act moved the celebration to the fourth Monday in October for three-day weekends. However, the public preferred the original date, so President Gerald Ford signed a law in 1975 to return it to November 11<sup>th</sup>.

**Difference from Memorial Day:** Veterans Day honors all who have served in the U.S. military, living or dead. Memorial Day is a different holiday specifically for remembering and honoring those who died in service.

**Spelling:** The official name is "Veterans Day," without an apostrophe, because it's not a day belonging to one or more veterans, but a day of honor for all. Commemorations: A significant event is the annual memorial ceremony held at the Tomb of the Unknown Soldier at Arlington National Cemetery.

### "THE HISTORY OF THE BURGESS-SHADBUSH NAUTRE CENTER"

In 1954 the Untied States Defense Department decided to construct a Nike Missile Base in Utica Michigan. The U.S. Army leased sections of Spring Hill farm which was historically known in the 1830's as an underground Railroad Station for slaves from the South who were seeking freedom on their way to Canada.

Construction began on the site in 1955. This was during the Cold War with Russia to protect Detroit from Soviet Bombers. Missile Silos were built with earth berms surrounding the Ajax rocket fuel mixing building. Other buildings were missile support and command center and battalion Launch headquarters. Radar stations were built and by October 1957 the site was armed with 20 Nike missiles and operational.

In 1962 the Ajax missile was replaced with the Hercules missile which had improved range and accuracy and equipped with a nuclear warhead that could take out several bombers at one time. These missiles became obsolete with creation of the Intercontinental Ballistic Missile in 1974.

The site was dismantled by filling in the silos, leveling the fuel mixing berms and demolition of some buildings. The missile support building and power buildings remained and the property was signed over to the Department of Natural Resources. Soon after the closing of the site, at the behest of Utica community schools and nature educator Jo-Ann Burgess, classrooms were opened for children teaching the value and awareness of Nature.

In the early 2,000's the Burgess-Shadbush Naute Center was designated by Shelby Township. The Nature Center is a log building constructed from 10' diameter white pine logs and contains live animals, natural history, and historical and interactive displays. There are several miles of nature trails on the grounds including a boardwalk trail through a tamarack swamp leading to a Pavillion at the Clinton River.

The Co-named Shadbush is for the various trees and shrubs featured on the site. The Shadbush is a common group which is sometimes called Service berry, Shadblow or Juneberry. It is an all-season beautiful variety of Nature plants.

The Nature Center provides classroom and outdoor experiences to support child learning and development skills such as creativity, cooperation, and the awareness of nature.





### Sides Dishes for the Thanksgiving Menu

### GREEN BEANS WITH CARAMELIZED ONIONS AND ALMONDS

Kosher salt

3 pounds green beans

1/2 cup skin on sliced almonds

3 tablespoons unsalted butter

5 tablespoons extra-virgin olive oil

2 large onions, sliced thin

2 tablespoons chopped fresh thyme leaves

Freshly ground black pepper

Fill a large high sided skillet with some water, adding enough to be just shy of the rim of the pan by about 1 inch. Place over high heat and bring up to boil; add a big pinch of salt and the green beans. Cook for about 5 minutes, the beans should still be crisp. Drain the beans and then run them under some cold water to stop them from cooking. Reserve the beans while you start the onions. Return the skillet you cooked the beans in to the cook top over medium heat. Add the almonds and toast stirring every now and then until golden, about 3 to 5 minutes. Remove the almonds from the skillet and reserve. Return the skillet to the heat and add the butter and olive oil and heat until the butter has melted. Add the

onions, season with salt and pepper, and cook stirring frequently until the onions caramelize, 20 to 25 minutes. Add the thyme, and cook for another 5 minutes. Add the cooked cooled green beans and almonds, and stir well to combine. Season with salt and pepper, to taste.

### **HOLIDAY ROASTED VEGETABLES**

3/4 lb. Brussels sprouts, trimmed and halved

2 large carrots, peeled and sliced into 1/2" pieces

extra-virgin olive oil

1 tbsp. balsamic vinegar

1 tsp. chopped rosemary leaves

1 tsp. chopped thyme leaves

1/2 c. toasted pecans

1/2 c. dried cranberries

Preheat oven to 400 degrees F. Scatter vegetables on a large sheet pan. Toss with enough olive oil to coat each piece, then toss with balsamic vinegar. Season with salt and pepper. Scatter herbs around the pan. Bake for 20-25 minutes, until the vegetable are tender, shaking the pan halfway through. Before serving, toss roasted veg-

etables with pecan and cranberries.

### **BAKED CREAM CORN**

6 slices bacon, chopped

Cooking spray

3 c. corn kernels (fresh, canned, or frozen and thawed)

1/4 c. all-purpose flour

2 c. shredded Cheddar

1 jalapeño, minced

1 tbsp. sugar

2 large eggs, lightly beaten

1/4 c. melted butter

1 c. milk

kosher salt

Freshly ground black pepper

Preheat oven to 375 degrees F. In a medium skillet over medium heat, cook bacon until crisp. Transfer to a paper towel-lined plate; drain. Spray a baking dish with cooking spray. Add corn, flour, 1 1/2 cups cheddar, jalapeño, sugar, cooked bacon, beaten eggs, melted butter, and milk. Season generously with salt and pepper and mix together until combined. Top with remaining 1/2 cup cheddar. Bake 1 hour, then let cool 20 minutes to firm up.

### **EASY CRANBERRY STUFFING**

1 large sourdough boule, cut into cubes 6 tbsp. butter, divided, plus more for baking dish

2 apples, cored and chopped

1 c. dried cranberries

2 medium onions, chopped

Kosher salt

Freshly ground black pepper

2 tbsp. freshly chopped parsley, plus more for garnish


1/2 tbsp. freshly chopped sage

1/2 tbsp. freshly chopped thyme leaves

1/2 tbsp. freshly chopped rosemary

2 c. low-sodium vegetable (or chicken) broth

Tear or slice bread into cubes and leave out overnight to dry out or place it on baking sheets and bake at 200 degrees F for 20 minutes. Preheat oven to 350 degrees F and butter a large baking dish. In a large skillet over medium heat, melt butter. Add onion, celery, and apple and cook until soft and fragrant, 8 minutes. Stir in parsley, sage, thyme, and rosemary and cook until fragrant, 1 minute more. Season with salt and pepper. Stir in remaining 3 tablespoons butter and parsley. Place bread and cranberries in a large bowl and add onion mixture and chicken broth. Transfer mixture to prepared baking dish and cover with foil. Bake until cooked through, 45 minutes, then remove foil and cook until bread is golden, 15 minutes more. Garnish with parsley before serving.





# RASI: MPS' SALARIES TO BE FROZEN NEXT YEAR

Salaries and flat-rate allowances for members of Parliament will be frozen next year, and along with 10-percent higher taxation in comparison to that faced by ordinary people, this will result in an effective reduction in their incomes, House Chair Richard Rasi (Voice-SD) announced alongside the heads of the coalition parliamentary caucuses Jan Richter (Smer-SD), Robert Puci (Voice-SD) and Roman Michelko (SNS).

Legislator's salaries will decrease by €220 per month, or by €2,600 annually, according to an agreement reached by the governing coalition.

Rasi pointed out that MPs' salaries are linked to the average salary in Slovakia, which is expected to rise next year. Without such an intervention, this would have also increased the salaries of MPs and other constitutional officials.

"I consider it extremely important that, in difficult times, not only the state should save money, but also politicians themselves," stated Rasi. "This declaration is a sign of solidarity from us — politicians and MPs representing the coalition and our parliamentary caucuses — showing that consolidation efforts will affect us personally as well".

According to Rasi, the salary adjustments will be submitted by the coalition as an amending proposal during the second reading of the consolidation measures package, which was scheduled to begin September 23, 2025.

"I expect that all 150 MPs will support this, including those in the current opposition, who, when in government, did absolutely nothing, remarked Rasi, who added that the need for fiscal consolidation stems directly from the economic management of previous governments.

Discussions on the salaries of other constitutional officials are also underway among coalition party leaders. "The public will be informed in the coming days about additional measures via which politicians will contribute to the consolidation by reducing their own salaries," he added.

### SLOVAKIA HAS NO AIR DEFENCE, PELLEGRINI WARNS AFTER DRONE INCIDENT IN POLAND

The violation of Polish airspace by Russian drones in September was a very dangerous matter, stated President Peter Pellegrini during his visit to Japan, calling for a de-escalation in tension.

In this context, he said that Slovakia doesn't have air defence. In his view, this is a gamble with the security of the country.

The Polish military shot down several drones after multiple violations of the country's airspace.

"I'd like to point to what I often say, which is that the Slovak Republic is in a very dangerous position today, as it doesn't have and doesn't possess any means of air defence," stressed the head of state. If a similar situation were to occur

in Slovakia, said the president, people could only hope that drones wouldn't fall on a populated area.

According to Pellegrini, the absence of air defence is a gamble with security, so there's a need to do everything possible to ensure that Slovakia provides such a system. He described the situation in Poland as "a big reminder and a warning finger".

Pellegrini currently has no information about the risk of a targeted attack on Slovakia. However, he's concerned about technical failures that could cause a drone or missile attacking targets near the Slovak border to deviate from its trajectory and hit an unintended target. "Slovakia today is naked and barefoot and unable to react immediately if our airspace is violated by a drone, as was the case in Poland," he stated.

# PRESIDENT: CONSTITUTIONAL MAJORITY ON CHANGES TO CONSTITUTION

President Peter Pellegrini fully respects the decision of Parliament to amend the Slovak Constitution and noted that, at a time of deep societal division in Slovakia, a constitutional majority sends out a strong signal that there is consensus across the political spectrum on a specific issue and that such agreement must be respected.

The President's Office told TASR that President Pellegrini will thoroughly review the constitutional amendment upon its delivery and will express his official position within the legal timeframe. He indicated that a similar approach will be taken also regarding the forthcoming fiscal consolidation package for next year.

On September 26, 2025 the Parliament approved the government's amendment to the Constitution. It will enshrine the definition of two genders – male and female – in the Constitution. The amendment also introduces a guarantee of equality between men and women in terms of pay for work performed and further addresses child adoption and the educational process.

# RRZ LOWERS SLOVAK ECONOMIC GROWTH FORECASTS FOR 2025 AND 2026

The Council for Budgetary Responsibility (RRZ) has revised downward its economic growth expectations for both the current and following year, citing a harsher-than-expected impact of ongoing fiscal consolidation on the Slovak economy, as well as the structure of the planned consolidation package for next year.

The revised economic growth estimate for 2026 drops by more than one percent, although it assumes a smaller consolidation effort than currently announced, RRZ reported.

"Other contributing factors include ongoing global uncertainty and a worsening economic outlook in countries more closely tied to the Slovak economy," the experts noted.

RRZ now expects economic growth in 2025 to reach 0.9 percent. Uncertainty surrounding US tariffs and global economic developments is, according to analysts, resulting in slower performance in domestic industry.

A deteriorating outlook for the European economy is expected to delay a modest recovery in foreign trade until at least 2027.

Inflation could reach 4.1 percent, driven in part by faster

price growth in food and market services.

In addition to the negative outlook for the European economy, macroeconomic developments in Slovakia in 2026 will also be shaped by the impact of the announced consolidation package and the final form of energy subsidies, RRZ noted.

As a significant portion of cost-saving measures has not yet been specified and energy subsidies are expected to further increase budget expenditures, the council estimates the total net volume of government measures at €1.7 billion.

"A significant part of the detailed consolidation measures sofar (over 80 percent) relies on increasing state revenues, primarily through higher labour taxation. An agreement reached between the EU and the USA on tariffs could help reduce global uncertainty and slightly boost investment activity," experts stated.

In the following years, economic growth is expected to stabilise at around 1.5 percent. The gradual introduction of the new ETS2 emissions trading system may slow progress towards long-term inflation targets, RRZ added.

The year 2027 will be influenced by the launch of Volvo's new car plant and the expected lack of consolidation efforts in the election year. Post-election years 2028 and 2029 are projected to see renewed fiscal consolidation.

The labor market is anticipated to experience a gradual decline in workforce due to ongoing demographic changes, the council added.

### NEXT LOCAL ELECTIONS TO BE HELD IN 2026, TERM EXTENSION REJECTED

The debate on extending the current term of local governments is definitively closed, and the next municipal elections will take place as planned in 2026, TASR learnt from the Parliament Office's press department on October 20, 2025.

This decision emerged from a discussion held on the same day between House Chair Richard Rasi (Voice–SD) and representatives of all municipalities and regions in Slovakia. They unanimously agreed that any extension of their current term would violate constitutional principles and existing legal standards.


Rasi discussed the issue with the heads of the Slovak Association of Towns and Municipalities (ZMOS), the Association of Self-Governing Regions of Slovakia (SK8), and the Union of Slovak Cities (UMS). Also present was Deputy Interior Minister Michal Kalinak.

According to Rasi, the debate on the upcoming municipal elections is now definitively closed. He declared that the election date will be announced in due time at the end of October 2026.

The idea to postpone the municipal and regional elections by one year was introduced in October by Prime Minister Robert Fico during a congress of Smer-SD.

He proposed moving the elections to 2027, after the parliamentary elections, arguing that local elections should also reflect the outcomes of the general elections.

The Historic Town of Banská Štiavnica and the Technical Monuments in its Vicinity is an outstanding example of an important mining settlement that has developed since the Middle Ages. Located in the mountains of Štiavnické Vrchy, this extensive property covers a total area of 20,632 ha and includes the urban centre of Banská Štiavnica as well as the surrounding landscape featuring vital relics of the mining and metallurgical activities of the past, especially gold and silver.

The town of Banská Štiavnica, the oldest mining town in Slovakia, was established in the 13<sup>th</sup> century, although evidence of mining dates back to the late Bronze Age. While it served as an important town during the Middle Ages, the surviving urban centre was formed during the 16<sup>th</sup> century. It is characterized by the grand Late Gothic and Renaissance burgher houses, the town hall, and the Late Gothic Church of Saint Catherine.

The establishment of the first Mining and Forestry Academy in Europe in 1762 demonstrates the importance of this town as a centre for the education of mining experts. Moreover, an extensive complex of technical works, connected with mining and processing of polymetallic ores, can be found in the town and in its vicinity. Surviving components include shafts, tunnels, mining towers, a knocking tower, and a sophisticated water management system. The system of artificially built water reservoirs - ponds and collecting ditches - built in the 16th century and developed in the 18th century, served the needs of the mining industry and provided fresh drinking water for the town. It was the most modern work of its type until the 19th century. After this time, the exhaustion of mineral resources has led to decline in the historic urban structure, the water management system, and much of the mining infrastructure.

### ĽUDOVÍT ŠTÚR 210 ROKOV OFICIÁLNA VÝROČNÁ RAZBA



Slovenská história sa môže popýšiť množstvom významných osobností, medzi ktoré patrí Ľudovít Štúr. Narodil sa 28. októbra 1815 v Uhrovci. Bol mimoriadne nadaný žiak, študoval v Rabe, v Bratislave a v Halle. Okrem slovenčiny sa učil ďalších dvanásť jazykov. Za svoj krátky 41-ročný život stihol neskutočne veľa. "Ako jazykovedec, politik, národný buditeľ, básnik, spisovateľ a kodifikátor spisovnej slovenčiny zohral kľúčovú úlohu v procese formovania slovenskej národnej identity a kultúry," zdôrazňuje jeho neoceniteľný prínos pri zrodení slovenského národa riaditeľ spoločnosti Moja mincovňa SK Luboš Krčil. Sústredil okolo seba mladé pokolenie básnikov a spisovateľov a stal sa rešpektovaným vodcom celej štúrovskej generácie.

Počas národného obrodenia zohral kľúčovú úlohu národný krst štúrovcov na Devíne v roku 1836. Štúrovci si toto miesto nevybrali náhodne. Na hrade, ktorý je národným a historickým symbolom, prijali stredné slovanské mená a sľúbili vernosť vlasti a obetu pre národ. Ľúbostné a manželské vzťahy Štúr dokonca pokladal za prekážku v oddanej práci pre národ. Krst bol výrazom národnej hrdosti, medzi štúrovcami upevnil pocit spolupatričnosti a určil ďalšie smerovanie národného hnutia.

Po odvolaní Štúra z funkcie námestníka Katedry reči a literatúry českoslovanskej na bratislavskom evanjelickom lýceu a po prijatí rozhodnutia, že pre svoje politické aktivity má zákaz prednášať, štúrovec Janko Matúška v roku 1844 vyjadril svoj nesúhlas básňou, ktorá opisuje búrku nad Tatrami. Silné slová básne Nad Tatrou sa blýska nevyjadrovali len hnev voči politickému útlaku a maďarizácii, ale aj nádej na lepšiu a spravodlivejšiu budúcnosť pre Slovákov. V roku 1993 sa po vyhlásení samostatnosti stala oficiálnou hymnou Slovenskej republiky.

Impulz na založenie kultúrneho spolku Tatrín vznikol na pamätnom stretnutí Štúra, Hurbana a Hodžu v roku 1843 na fare v Hlbokom, na ktorom sa dohodli na uzákonení spisovnej slovenčiny. Spolok mal za cieľ šíriť kultúru a literatúru v slovenskom jazyku, a tým podporovať národné povedomie. Tiež sa usiloval o ochranu a posilnenie národnej identity Slovákov, ktorá bola ohrozená maďarizačnými snahami.

Slováci, bratia! Tak sa začínala otvorená výzva na

začatie celonárodnej ozbrojenej vzbury proti maďarskej nadvláde. Vedúcou osobnosťou revolučných rokov 1848 – 1849 bol Ľudovít Štúr, ktorý prešiel od slov činom. Slovenské povstanie bolo vyhlásené 18. septembra na čele so Slovenskou národnou radou, ktorá vznikla vo Viedni ako prvý slovenský nezávislý reprezentatívny národnopolitický orgán. Na akte jej založenia v Myjave účastníci oficiálne vypovedali poslušnosť uhorskej vláde a proklamovali autonómiu Slovenska v rámci monarchie. "Štúr si veľa od toho pre Slovákov sľuboval, ale počiatočné úspechy povstania vystriedalo vzápätí sklamanie, smútok a porážka," pripomína riaditel' Tatra mincovne Libor Veselý. Hoci povstanie bolo potlačené a revolúcia zlyhala, ukázalo sa, že Slováci sú odhodlaní bojovať za svoje práva a slobodu. Po povstaní Štúr žil pod policajným dozorom v Modre. Jeho život vyhasol 12. januára 1856, keď podľahol zraneniam z vianočnej poľovačky.

### Dokument na ochranu slovenského národa

Rastúca frustrácia zo slabého politického postavenia Slovákov vyústila do prijatia Memoranda slovenského národa v roku 1861 v Turčianskom Sv. Martine. Tento dokument vyjadroval požiadavky slovenského národa voči uhorskej vláde – zrovnoprávnenie slovenského jazyka, jeho zavedenie do školstva a administratívy, ako aj autonómia pre slovenský národ v rámci Uhorska. Aj keď memorandum neprinieslo okamžité výsledky, malo zásadný význam pre ďalší rozvoj slovenského národného hnutia.

### STAČÍ JEDNO DENNE

Jablká majú vysoký obsah vitamínu C, antioxidantu, ktorý pomáha správnemu fungovaniu imunitného systému pri boji s chorobami. Vitamín C tiež zlepšuje



vstrebávanie železa z rastlinných potravín a je potrebný pre tvorbu kolagénu. Plod je tiež bohatý na fytochemikálie, vrátane kvercetínu, katechínu, chlorogénovej kyseliny a epikatechínu, ktoré majú silné antioxidačné účinky.

Jablká, najmä so šupkou, sú bohatým zdrojom vlákniny, polyfenolov a ďalších živín, ktoré podporujú zdravie srdca.

Jablká sú dobrým zdrojom pektínu, rozpustnej vlákniny, ktorá zlepšuje trávenie.

Jablká obsahujú veľa vody a vlákniny, no málo kalórií, čo môže podporovať reguláciu hmotnosti tým, že zasýtia a znížia denný príjem kalórií. môžu poškodiť váš mozog a narušiť pamäť

L'udia, ktorí zjedia dve porcie celého ovocia denne (napr. jablká), majú o 36 % nižšie riziko vzniku cukrovky 2. typu v porovnaní s tými, ktorí skonzumujú menej než polovicu porcie.

Jablká sú bohaté na antioxidanty, ktoré môžu znižovať riziko rakoviny neutralizovaním voľných radikálov spôsobujúcich rakovinu.

Antioxidanty v ovocí a zelenine môžu prospievať kognitívnym funkciám, najmä u starších ľudí.

### PREHREŠKY, KTORÉ DOKÁŽU ZNEHODNOTÍŤ VAŠU ZELENINU

Väčšina zeleniny je najzdravšia surová, aj keď to neplatí o každej. Ak však neholdujeme surovej strave, v bežnom živote väčšinu konzumujeme nejako tepelne upravenú, či už samotnú alebo ako súčasť rôznych pokrmov. Aj vtedy si však zelenina dokáže uchovať vitamíny a minerály – ak ju správne pripravujeme a vyhneme sa niektorým chybám.

Varenie vo vode namiesto v pare – Dlhotrvajúce teplo vitamínom v zelenine neprospieva. Za najhorší spôsob prípravy považujú odborníci varenie vo vode. Namiesto toho sa odporúča varenie v pare a dusenie. Pri týchto spôsoboch prípravy zelenina neprichádza do kontaktu s vodou (alebo len s veľmi malým množstvom) a zložky rozpustné vo vode sa tak zo zeleniny nevyplavujú, ako je to v prípade varenia vo vode.

Vylievanie vody z varenia – Ak varíte zeleninu vo vode, určite by ste ju nemali vylievať. Dôvodom je, že vitamíny rozpustné vo vode, napríklad vitamíny C, B1, B2 a B6, ako aj kyselina listová, prechádzajú do vody, takže je naozaj škoda ju vyhodiť. Voda z varenia zeleniny je ideálna napríklad na omáčku, na prípravu polievok alebo na podlievanie dusených jedál.

Rozmrazenie mrazenej zeleniny - Zelenina z mrazničky je dobrou alternatívou čerstvej. Obsah živín je takmer taký dobrý ako u čerstvých druhov - ak ju správne pripravíte. To znamená, že ju treba vložiť z mrazničky rovno do hrnca, teda ju pred prípravou nenechať rozmraziť. Pri rozmrazovaní sa strácajú vitamíny a stopové prvky a k horšiemu sa mení aj konzistencia zeleniny.

Nezohľadniť rôzne časy varenia – Rôzne druhy zeleniny potrebujú rôzny čas tepelnej prípravy. Preto ak potrebujete pripraviť rôzne druhy zeleniny, nedávajte ju do hrnca alebo na plech naraz. Ak to urobíte, jedna časť bude príliš mäkká a druhá ešte neuvarená. Najskôr dajte do hrnca tvrdšiu zeleninu, ako je kaleráb alebo mrkva, potom karfiol či brokolicu. Mäkšie druhy, ako sú paradajky, cuketa alebo paprika, pridajte neskôr. Prípadne, ak to recept umožňuje, môžete zeleninu nakrájať - tvrdé druhy na malé kúsky a mäkké na väčšie. Tým sa zabezpečí, že sa zelenina pripraví rovnomerne a môžete ju dať robiť všetku naraz.

Udržiavať zeleninu v teple – Ak sa zelenina po dovarení udržiava v teple, môže stratiť až 70 % vitamínov. Pripravenú zeleninu, ktorú ste nepoužili, nechaj-te čo najrýchlejšie vychladnúť a uložte do chladničky. Ohrievajte ju, až keď ju budete chcieť skonzumovať.

### KRÁTKE SPRÁVY ZO SLOVENSKA

Minimálna mzda na Slovensku porastie. Namiesto 816 eur, čo je jej aktuálna výška, to od budúceho roku bude 915 eur. Zvýšenie mzdy o 100 eur a viac sa bude týkať asi 200-tisíc najmenej zarábajúcich Slovákov. Pôjde o jeden z najvyšších rastov minimálnej mzdy. Minimálne mzdy stúpnu asi o 12 percent, čo by vraj mohlo znamenať, že zmeny prinesú aj výrazný nárast reálnych platov. Polepšiť by si vraj nemali len tí, ktorí zarábajú najmenej, ale všetci, ktorí pracujú aj cez víkendy a v noci. Príplatky za prácu v neštandardnom čase sú totiž od polovice roku 2023 nadviazané na rast minimálnej mzdy.

Na obnovu 31 slovenských hradov vyčlenil v minulom a tomto roku rezort práce z Európskeho sociálneho fondu v rámci projektu Ľudia a hrady 11,5 milióna eur, z ktorých je aktuálne vyčerpaných už 11 miliónov eur. S projektmi podobného charakteru chce rezort pokračovať aj v budúcom roku. Projekt obnovy hradov odštartoval v roku 2011 exminister kultúry Daniel Krajcer, ktorý je aktuálne poradcom ministra práve pre záchranu hradov. Slovenské hrady podľa ministra vstávajú z popola a vidieť to nielen pri návšteve hradov, ale v mnohých prípadoch i z ciest v rôznych kútoch Slovenska. Na projekte pracuje 450 nezamestnaných. Ľudí, ktorí by si inak veľmi ťažko hľadali prácu. Ministerstvo práce z eurofondov financuje časť mzdy týchto pracovníkov.

Slovensko a Spojené arabské emiráty (SAE) plánujú do budúcnosti posilniť vzájomnú hospodársku spoluprácu. Sústrediť sa chcú predovšetkým na dva strategické projekty, ktoré sa týkajú rozvoja prístavov v Bratislave. Investície do nich by mali presiahnuť miliardu eur. Vyplýva to z Dohody medzi vládou SR a vládou SAE o hospodárskej spolupráci. Za strategický projekt pre splnenie cieľov tejto dohody obe vlády považujú vybudovanie a prevádzkovanie nového multimodálneho nákladného prístavu v Bratislave na Dunaji v lokalite Pálenisko a rekonštrukciu oblasti bratislavského prístavu na Dunaji v lokalite zimného prístavu. Investícia do prvého projektu by mala predstavovať najmenej 250 miliónov eur a do druhého minimálne 1 miliardu eur.

Občianske združenie (OZ) Svetielko nádeje podporilo v Banskej Bystrici zavedenie inovatívnej imunoterapie onkologicky chorých detí, ktoré pomaly reagujú na štandardnú liečbu. Novú formu využila Klinika pediatrickej onkológie a hematológie Slovenskej zdravotníckej univerzity v Detskej fakultnej nemocnici s poliklinikou. Bolo to použitie liečiva, ktoré banskobystrický kolektív prvýkrát nasadil 4,5-ročnému chlapcovi. Leukémia u neho pomalšie reagovala na štandardnú liečbu, pre čo ho zaradili do skupiny vysokorizikových pacientov, u ktorých je vyššie riziko návratu ochorenia. Svetielko nádeje uvádza, že liek cielene pôsobí na leukemické bunky aktiváciou vlastného imunitného systému. Preto má oproti chemoterapii menej nežiaducich účinkov. Liečba si však vyžaduje nepretržité podávanie infúzie počas 28 dní.
