**REFLECTION ON THE CORPORAL
WORKS OF MERCEY**

The Corporal Works of Mercy call Christians to make God's love visible through concrete action.



Rooted in Jesus' words in Matthew 25—"Whatever you did for one of these least brothers of mine, you did for me"—they remind us that faith is not only something we profess but something we live.

To feed the hungry and give drink to the thirsty challenges me to notice not only physical hunger but also the hidden poverty around me. It invites generosity, even when giving costs time, comfort, or resources. In serving basic human needs, I encounter Christ himself, often in unexpected places.

To clothe the naked and shelter the homeless confronts the dignity of every human person. These works push me beyond charity that is convenient toward compassion that restores worth. They remind me that no one should be reduced to their circumstances and that solidarity requires both action and advocacy.

To visit the sick and visit the imprisoned are perhaps the most demanding works of mercy, because they require presence more than solutions. They call me to overcome fear, judgment, and discomfort. In accompanying those who suffer or are forgotten, I learn that mercy is often expressed simply by being there listening, praying, and loving without conditions.

Finally, **to bury the dead** teaches reverence for life even after death and affirms our hope in the resurrection. It is an act of mercy that comforts the grieving and reminds us of the eternal perspective of our faith.

Living out the Corporal Works of Mercy transforms both the one who serves and the one who is served. They draw me out of self-centeredness and into a deeper relationship with Christ, who identifies himself with the poor, the suffering, and the marginalized. Through these works, the Church becomes the hands and feet of Christ in the world, witnessing to a love that is active, sacrificial, and real.

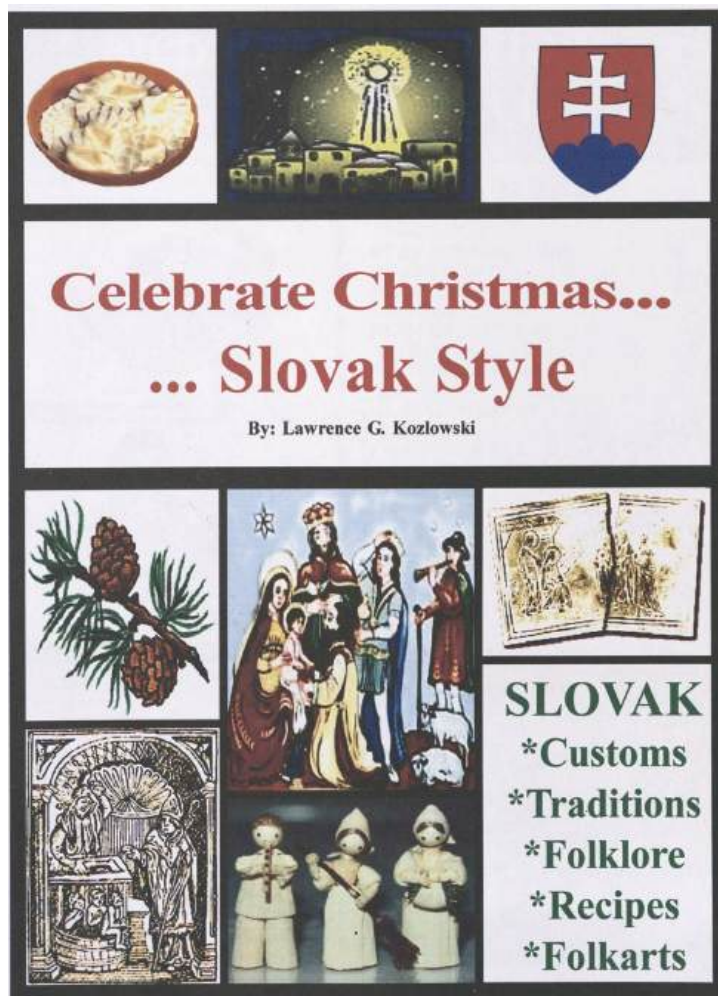
If you are interested in carrying on Slovak traditions, I highly recommend a series of booklets by Larry Kozlowski.

Animal fats such as butter and lard were used in baking instead of cooking oils except during Advent and Lent. In addition to the production of honey, bees wax (candles) and mead (fermented honey wine) were made. Today the word Gingerbread is often considered synonymous with the words Honey Cake or Honey Spice Cake, but this is not the case. A true Honey or Honey Spice Cake begins with honey and/or spices. A true Gingerbread is made from dough to which honey, sugar, spices, and ginger are added. Learn more and buy this amazing booklet!

- The first Winter Olympic Games were held in 1924, in Chamonix, France.

Shortly after vespers on Sunday evening, October 19, 2025, Fr. Joachim Pastirik, OSB passed into eternity at Regina Health Center. He had been under hospice care since inoperable cancer was found a month earlier. "Fr. Joe" as he was known by so many, spent his life bringing the joy of Christ to many lives.

Born in Lakewood, Ohio with his twin brother John on December 9, 1941, Joseph Pastirik is the son of John (deceased) and Margaret (Bobovnick). He attended Sts. Cyril and Methodius Elementary School and graduated from Benedictine High School with his brother John in 1960. After two years of studies at St.



John's University in Minnesota, he entered the Benedictine Order at St. Andrew's Abbey in Cleveland and received the religious name of 'Joachim' after the saintly father of the Blessed Virgin Mary.

He completed his Bachelor's degree in classical languages from Borromeo Seminary-College in 1965 and continued studies for the priesthood at Blessed Sacrament and St. Mary's Seminary being awarded a Master of

Divinity degree in 1969 when he was ordained with his classmates Fr. Dominic Mondzelewski, OSB and Fr. Timothy Buyansky, OSB by Bishop William Cosgrove on June 7, 1969.

Fr. Joachim taught senior theology, technical drafting, studio art, and art appreciation at Benedictine High School from 1969 to 2001. He earned a B.A. in art education from Baldwin-Wallace College in 1976. His third floor art studio was one of the most popular classrooms at BHS during those years with a relaxed atmosphere and background music conducive to fostering creativity. The free-flowing conversations in the art room also became a means for Fr. Joachim to offer guidance and practical advice to students who would hesitate to bring up some topics with their parents. He was moderator of the Benedictine Parent-Booster Club, a position he held for over 20 years.

Fr. Joachim forged many life-long friendships with former students and encouraged a number of them into successful art-related careers. He celebrated more weddings than most of his brother monks and continued to minister to many of these families through times of joy, challenge, and sorrow over the years.

It is hard to find a photo of Fr. Joachim without a smile because he enjoyed making others smile and laugh. He was famous for giving out pictures of the "Smiling Jesus" and would liven up Christmas parties at nursing homes or Booster Club meetings or abbey gatherings in costume as Santa, Pope John Paul II, or any number of celebrities and personages.

Fr. Joachim's command of the Slovak language was much appreciated in his work with numerous Slovak-American frater-

nals and organizations. He was a member of the First Catholic Slovak Union (Jednota), First Catholic Slovak Ladies Association (Ženská Jednota), Slovak Catholic Federation, Slovak League of America, Cleveland Slovak Radio Club, and served as chaplain to Group 5 (Northern Ohio) Slovak Catholic Sokols and Cleveland Slovak Zemplin Club.

Together with his talented brother John, Fr. Joe has added energy and fun to many fundraisers, dinners, anniversary parties, and weddings with his rendition of a variety of dance styles from polka and csardas to "electric slide" and line dancing. His own musical talent contributed to the prayer life of the monastery where he served as one of the abbey organists since the time he was a seminarian.

In the monastery, Fr. Joachim has also served his confreres generously in a variety of positions: Subprior (3rd superior) 1991-1995 and Prior (2nd superior), 1995-1999. He served on the Senior Council, was a member of the abbey evaluation committee and served as a community barber for over four decades.

He offered weekend assistance at the following parishes in the Diocese of Cleveland: St. Peter (Lorain) 1969-1972, St. Charles (Parma) 1972-1975, Assumption Parish (Broadview Heights) 1975-1991, St. Barbara (Cleveland) 1991-1994, Sts. Cyril and Methodius (Lakewood) 1994-2014.

Due to declining health, Fr. Joachim moved to Regina Health Center in Richfield, Ohio, in December of 2014. He continued to enliven fellow residents and staff by drawing, celebrating Mass, assisting with the sacraments and visiting. As time went on, he lost the use of his legs and was confined to a wheel chair. However, he never lost that interest in others, continued to use his talents in the various activities at Regina Center, and enjoyed the company of his confreres, who visited him monthly as a community.

A month before his death, Fr. Joachim was diagnosed with inoperable metastatic cancer. He decided to let things take their course. He passed away peacefully on the evening of Sunday, October 19.

The community received the body in the abbey church at 2:30pm on Thursday, October 23, followed by a wake and Mass of Resurrection at 7:00pm that evening. Burial was Friday morning, October 24, in the monastic plot at Calvary Cemetery in Cleveland. Please remember our confrere, Fr. Joachim in the customary Masses and prayers. May the Loving Lord, whom Fr. Joachim served, and the many people touched by his service, smile and good humor, welcome him into the heavenly realms.

ÚPN ZVEREJNIL VYŠETROVATEĽOV ŠTB Z KRAJSKÝCH ÚTVAROV 1966 - 1971

Ústav pamäti národa (ÚPN) na svojej webovej stránke zverejnil organizačnú a personálnu rekonštrukciu útvarov vyšetrovania Štátnej bezpečnosti (ŠtB) na Slovensku v rokoch 1966 až 1971, ktorá dopĺňa doteraz zverejnených vyšetrovateľov ŠtB.

„Zoznam doplnilo 82 príslušníkov, ktorí v rokoch 1966 až 1971 pôsobili na slovenských krajských útvaroch vyšetrovania ŠtB a na doteraz nezverejnenej Správe vyšetrovania ŠtB Ministerstva vnútra Slovenskej socialistickej republiky. Z nich 12 nebolo doteraz zverejnených na iných útvaroch ŠtB,“ priblížil hovorca ÚPN Michal Miklovič. Spolu s aktuálne zverejnenými príslušníkmi Ústav pamäti národa od roku 2007 zverejnil 5301 príslušníkov útvarov ŠtB na Slovensku.

Útvary vyšetrovania Štátnej bezpečnosti vyšetrovali vybrané, predovšetkým politické trestné činy, spolupracovali najmä s kontrarozviedkovými útvarmi ŠtB. Podieľali sa tým na ochrane komunistického režimu pred tzv. vnútorným a vonkajším nepriateľom. Celoštátnu Správu vyšetrovania ŠtB so sídlom v Prahe dopĺňali celoslovenské a krajské útvary vyšetrovania ŠtB a útvary vyšetrovania ŠtB vo vojenskej kontrarozviedke.

FICO DOSTAL POZVANIE DO USA

Premiér SR Robert Fico informoval, že dostal pozvanie na návštevu Spojených štátov amerických a stretnutie s prezidentom USA Donaldom Trumpom. Pozvanie mu doručil štátny tajomník ministerstva energetiky USA James P. Danly.

„Je pre mňa cťou, že mi osobitný posol amerického prezidenta D. Trumpa odovzdal písomné pozvanie na návštevu USA a stretnutie s ním,“ uviedol premiér vo svojom príspevku na sociálnej sieti.

Podľa Fica má byť súčasťou plánovanej návštevy aj podpora spolupráce v oblasti energetiky. „Chceme spoločne podporiť podpísanie medzivládnej dohody medzi SR a USA o spolupráci v jadrovej energetike a vymeniť si názory na najaktuálnejšie svetové témy,“ napísal predseda vlády.

Premiér zároveň uviedol, že časový rámec jeho návštevy by mal byť spojený s významnými udalosťami v Spojených štátoch. „Časovým rámcom mojej návštevy budú oslavy 250-teho výročia nezávislosti USA a konanie Majstrovstiev sveta vo futbale,“ dodal.

Pozvanie od amerického prezidenta premiér vníma ako potvrdenie smerovania slovenskej zahraničnej politiky. Podľa jeho slov „suverénna zahraničná politika orientovaná na všetky štyri svetové strany prináša svoje výsledky“. Zároveň tvrdí, že Slovensko má „rešpekt, dostáva ponuky na investície.

Robert Fico v tejto súvislosti pripomenul, že sa v tomto roku stretol s prezidentmi Číny, Ruskej federácie, Brazílie, Vietnamu, Juhoafrickej republiky, rokoval s najvýznamnejším hráčom v EÚ s nemeckým spolkovým kancelárom“ a absolvoval desiatky iných dôležitých bilaterálnych stretnutí“.

KYSLÁ KAPUSTA POSILNÍ VÁŠ ORGANIZMUS

Kyslá kapusta sa považuje za veľmi zdravú potravinu, o jej účinkoch na naše zdravie niet pochýb. Podobne je na tom aj šťava z kyslej kapusty a rozhodne má nášmu telu čo ponúknuť. Obsahuje dôležité vitamíny a minerály, ako aj baktérie mliečneho kvasenia, ktoré sú prospešné pre trávenie a takisto pre zdravie čriev. Zjesť iba kapustu a a šťavy sa zbaviť by preto bolo chybou.

Pri výrobe kyslej kapusty necháme kvasiť bielu kapustu. Živiny obsiahnuté v bielej kapuste sa zachovávajú a výnimočné látky si uchováva aj šťava z kyslej kapusty. Tá okrem iného poskytuje cenný vitamín C, ktorý podporuje imunitný systém a takisto vitamín K, ktorý je spojený so zdravými kosťami. Netreba opomenúť kyselinu listovú a vitamín B12, ktoré hrajú dôležitú úlohu pri tvorbe krvi.

Špeciálny význam však majú baktérie mliečneho kvasenia, ktoré šťava v značnej miere obsahuje a ktoré vznikajú počas fermentácie. Vďaka tomu je šťava z kyslej kapusty prírodným probiotikom, ktoré podporuje črevnú flóru a tým aj zdravie čriev. A to naozaj výrazne.

Keďže trávenie a zdravie čriev ide ruka v ruku s našou hmotnosťou, šťava z kyslej kapusty je nápomocná pri chudnutí. Existuje aj špeciálna diéta, pri ktorej sa šťava z kyslej kapusty pije ráno a kyslá kapusta sa konzumuje na poludnie aj večer.

Šťava má mierne laxatívne účinky a môže u niektorých ľudí spôsobovať zažívacie ťažkosti – hnačky, plynatosť. Piť by sa mala iba v malom množstve – nie viac ako jeden pohár denne.

ŠALÁT S KYSLEJ KAPUSTY

½ brokolice, 1 nakrájaná červená paprika, ½ hrnček kyslej kapusty, 2 strúčiky cesnaku, 2 lyžičky nastrúhaného čerstvého zázvoru, 2 lyžice olivového oleja, himalájska soľ podľa potreby.

Brokolicu rozoberieme na malé ružičky. Dáme ju na 5 minút variť do pary, popripade ju vložíme do vriacej vody na cca 3 minúty. Červenú papriku nakrájame na drobné kocky. Kyslú kapustu vložíme do misky a premyjeme ju pod tečúcou vodou, aby nebola veľmi slaná. Potom ju nakrájame na menšie kúsky. Brokolicu necháme vychladnúť a zmiešame ju spolu s paprikou a kyslou kapustou. Do misky si nastrúhame čerstvý zázvor, pretlačíme cesnak, pridáme olivový olej a spolu premiešame. Takto pripravený dressing vmiešame k zelenine.

NOVOROČNÉ TRADÍCIE A POVERY

Jedlo: Bravčové (symbol hojnosti), šošovica, hrach. Hydina sa nejedla, aby šťastie neuletelo.

Práca: Na Nový rok sa nemalo prať, šiť, vynášať smeti (kvôli šťastiu) ani robiť ťažkú prácu, aby sa únava neprehnala celým rokom.

Vnútorné prostredie: Dom mal byť čistý a bez hádok, aby bol taký celý rok. Používali sa zvončeky alebo soľ na odohnanie zla.

Ohňostroj: Vznikol z tradície vyhánania zlých duchov (pôvodne bičom).

Pozitívna nálada: Vyhýbanie sa plaču a smútku, aby sa nepremenili na celý rok.

KRÁTKE SPRÁVY ZO SLOVENSKA

Slováci a Slovenky zo svojho života však strávia v zdraví len necelé tri štvrtiny. Potom prichádzajú choroby, ktoré znižujú kvalitu života a zvyšujú finančné výdaje jednotlivcov a ich rodín. Ako sa môžu lepšie vyzbrojiť do ťažších časov? Pomôcť môžu zdravší život, prevencia i zodpovedné finančné správanie. Až tretina Slovákov nemá žiadne úspory, tretina má nasporených maximálne 2 000 eur a len 8 % Slovákov má nasporených vyše 20-tisíc eur. Za uplynulé štvrtstoročie sa priemerná dĺžka života Slovákov zvýšila o päť rokov. Pre porovnanie, kým priemer EÚ bol vlni 81,7 roka, pričom muži sa dožívali 79 a ženy 84 rokov, na Slovensku to bolo 78,1 roka (muži 74,9 roka a ženy 81,5 roka). Najdlhšie žijú Taliani, Švédi a Španieli (84 rokov), najkratšie Bulhari, Rumuni a Lotyš (menej ako 77 rokov), ukazujú údaje Eurostatu. Najčastejšou príčinou úmrtia Slovákov zostávajú dlhodobé kardiovaskulárne ochorenia nasledované rakovinou. Spolu tvoria až 70 percent dôvodov skonu. Štatistika ochorení má rovnakú prvú priečku, no na druhé miesto sa dostali duševné ochorenia nasledované cukrovkou.

V spoločnosti ZVS holding v Dubnici nad Váhom spustili do prevádzky novú výrobnú linku na veľkokalibrovú delostreleckú muníciu. Ide o najmodernejšie zariadenie svojho druhu v Európe a výrazne prispeje k zvýšeniu výrobných kapacít v Dubnici nad Váhom na asi 280-tisíc kusov 155-milimetrových delostreleckých nábojov ročne.

Americká zbrojárska spoločnosť Lockheed Martin oznámila, že dokončila výrobu všetkých stíhačiek typu F-16 Block 70 pre Slovensko. Kontrakt na 14 stíhačiek F-16 C/D Block 70 americkej výroby uzavrelo Slovensko koncom roka 2018 s cieľom zmodernizovať svoje vzdušné sily a nahradiť vtedy nepoužívané stíhačky MiG-29, ktoré boli spolu so systémami protivzdušnej obrany medziasom odovzdané ako pomoc Ukrajine napadnutej Ruskom.

Dodanie amerických stíhacích lietadiel na Slovensko sa oneskorilo pre pandémiu ochorenia COVID-19. Slovenské vzdušné sily majú k dispozícii zatiaľ sedem z objednaných strojov, prvé z nich prileteli na vojenské letisko v Kuchyni pri Malackách v lete minulého roka. Zvyšné majú byť dodané postupne do roku 2027.

Kompletné letky lietadiel F-16 Block 70 umožnia Slovensku zabezpečiť svoju protivzdušnú obranu a podporovať hliadkovanie NATO prostredníctvom moderných, plne interoperabilných stíhacích lietadiel. Tieto lietadlá sa priamo pripájajú k systémom NATO a majú podporu misií, ktoré už teraz vykonávajú prevádzkovatelia lietadiel F-16 v celej Európe. – TASR
